FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Social Services**, **Missouri Department of Transportation**, **Missouri Consolidated Health Care Plan**, and **Missouri Department of Conservation** assume the proposal will have no fiscal impact on their organizations.

Officials from the **Department of Public Safety (DPS)** defer to the Missouri Consolidated Health Care Plan for response regarding the potential fiscal impact of the proposal.

Officials from the **DPS - Missouri State Highway Patrol** defer to the Missouri Department of Transportation for response regarding the potential fiscal impact of the proposal on their organization.

Officials from the **Department of Insurance (INS)** estimate 100 insurers and HMOs may be required to submit amendments to their policies to comply with the proposal. Policy amendments must be submitted to the INS for review along with a \$50 filing fee. One-time additional revenues to the Insurance Dedicated Fund are estimated to be \$0 to \$5,000.

Additional staff and expenses are not being requested with this single proposal, but if multiple proposals pass during the legislative session that require policy form reviews, the INS will need to request additional staff to handle the increase in workload.

FISCAL IMPACT - Small Business

The proposal may impact small businesses that provide insurance coverage for employees if health insurers increase premiums as a result of the proposal.

DESCRIPTION

This proposal specifies that if the usual and customary retail price of a prescription drug is less than the copayment applied by a health maintenance organization or health insurer, then the enrollee is only required to pay the usual and customary retail price of the prescription drug.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
