No direct fiscal impact to small businesses would be expected as a result of this proposal.


DESCRIPTION

Current law states that any health care professional licensed, registered, or certified in this state may be deployed to provide care in the event of a declared emergency, subject to approval by the state emergency management agency. This proposal provides that any health care professional licensed, registered, or certified in any state who volunteers may be deployed to provide emergency care. This proposal also provides that health care professionals deployed by the Governor shall be immune from civil liability in the delivery of health care necessitated by the emergency, except for willful or wanton acts or omissions.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
