#### FISCAL ANALYSIS

#### **ASSUMPTION**

Officials from the Missouri Department of Transportation, Department of Public Safety (DPS) - Director's Office, and Missouri Department of Conservation assume the proposal will have no fiscal impact on their organizations.

Officials from the **DPS - Missouri State Highway Patrol** defer to the Missouri Department of Transportation for response regarding the potential fiscal impact of this proposal on their organization.

Officials from the **Department of Social Services** state the proposed legislation will not have a fiscal impact on Medicaid as Missouri Medicaid is exempt from providing chiropractic services per Section 376.1230, RSMo.

Officials from the **Missouri Consolidated Health Care Plan (HCP)** state the proposal would restrict health carriers from imposing a copayment amount for chiropractic services that is higher than the copayment amount for other services. Currently, the HCP plans offer chiropractic care in the same manner as any medical condition. Therefore, the proposal has no fiscal impact to HCP.

#### <u>ASSUMPTION</u> (continued)

Officials from the **Department of Insurance (INS)** estimate approximately 100 insurers would submit amendments to their policies to comply with this proposal. Policy amendments must be submitted to the INS for review along with a \$50 filing fee. One-time additional revenues to the Insurance Dedicated Fund are estimated to be \$5,000.

Additional staff and expenses are not being requested with this single proposal, but if multiple proposals pass during the legislative session which require policy form reviews, the INS will need to request additional staff to handle the increase in workload.

#### FISCAL IMPACT - Small Business

The proposal may fiscally impact small business chiropractic offices.

### **DESCRIPTION**

This proposal requires health insurers to pay or reimburse licensed chiropractors at the same rate as other health care providers if the service can be legally performed by the chiropractor.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
