FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Elementary and Secondary Education** assume the proposed elimination of the summer school penalty and the gifted penalty included in last session's school funding formula will not increase the cost of the formula. Since there has been no penalty through FY06 and there has been no way to project penalties for FY07, eliminating the summer school or gifted penalty before such provisions become effective will not increase the cost of the SB 287 (2005) formula.

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

This proposed legislation removes the proportional adjustment in state aid for diminishing enrollment in summer school and gifted programs.

The proposal contains an emergency clause. Its effective date will coincide with the effective date of the funding formula adopted last session (SB 287).

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
