FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of the Secretary of State (SOS)** assume many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this proposal for Administrative Rules is less than \$1,500. The SOS recognizes this is a small amount and does not expect additional funding would be required to meet these costs. However, SOS also recognizes that many such bills may be passed in a given year and that collectively the costs may be in excess of what the SOS can sustain with their core budget. Any additional required funding would be handled through the budget process.

Officials from the **Department of Elementary and Secondary Education** state DESE has already begun the process of developing standards for high-quality early childhood education. The work is consistent with the wording in the proposed legislation. There will be continued meetings to complete this project that will require travel and lodging costs; however, DESE does not expect those costs to be significant.

Oversight assumes that since the process has already begun, resources have been available to begin development of the standards for high-quality early childhood education. There does not appear to be a reduction in funding in the areas of early childhood education for the FY 07

FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

This proposed legislation requires the Department of Elementary and Secondary Education (DESE) to develop, by June 30, 2007, standards for early childhood education which will be applicable to public preschool programs that receive federal Title I funds or Missouri preschool project funds.

The standards must include, among other items, an assessment of needs; a focus on cognitive, language, physical, and social/emotional development; and highly qualified, properly certified teachers.

In developing the standards, the DESE must involve representatives of many groups, including the business community, existing early childhood programs, school districts, and private and faith-based providers.

This legislation is not federally mandated and would not require additional capital improvements or rental space.
