FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

DESCRIPTION

This bill defines "fire department" as it relates to the laws regarding the jurisdiction and duties of the State Fire Marshal. Fire departments must file a fire department registration form within 60 days after January 1, 2007; and the State Fire Marshal may issue each fire department an identification number based upon the registration. A volunteer fire protection association is required to identify and register its boundaries, which cannot overlap another district, with its county governing body.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
