FISCAL IMPACT - Small Business

Small businesses that are grocery or convenience stores could be impacted as a result of this proposal.

DESCRIPTION

This proposal adds grocery and convenience stores to the list of donors that in good faith can donate any canned or perishable food to a bona-fide charity or nonprofit organization for free distribution without being subject to criminal penalty or civil damages arising from the condition of the food, unless an injury is caused by the gross negligence, recklessness, or intentional misconduct of the donor.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
