FISCAL IMPACT - Small Business

The proposal may have a positive fiscal impact on barber establishments that change location or ownership as a result of being able to continue operations for 45 days before obtaining a new license.

DESCRIPTION

This proposal allows a 45-day grace period for obtaining a new sanitary license when a barber shop changes ownership or location. During this period, inspections will be conducted without requiring the business to close or deviate from its regular hours of operation.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
