The proposal may impact small businesses if a professional employee in the business or business owner has his/her licensed revoked.

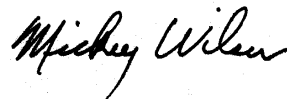
### DESCRIPTION

This proposal expands the authority of the State Board of Registration for the Healing Arts to revoke the professional license of any person licensed under Chapter 334, RSMo, who has been found guilty of a felony. Currently, it only applies to physicians.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
