DESCRIPTION

Currently, the Executive Director of the Missouri Veterans Commission approves and administers veterans' programs in which the historical significance of veteran service can be dedicated to outreach and education inside public schools, veteran cemeteries, veteran homes, and other institutions. The Veterans' Historical Education Trust Fund finances these programs and is administered by the commission. This proposal transfers the administration of these programs and the fund to the Lieutenant Governor.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
