## FISCAL ANALYSIS

### **ASSUMPTION**

Officials from the Department of Health and Senior Services, Department of Public Safety – Missouri State Highway Patrol, – Division of Alcohol and Tobacco Control, – Director's Office, Boone County Sheriff's Department, and the Springfield Police Department assume the proposal would have no fiscal impact on their agencies.

Officials from the **Office of State Courts Administrator** assume the proposed legislation would have no fiscal impact on the courts.

Officials from the **Office of Prosecution Services** assume the proposal would not have a significant direct fiscal impact on county prosecutors.

Officials from the Office of the State Public Defender, Columbia Police Department, Greene County Sheriff, Jackson County Sheriff, Kansas City Police Department, St. Louis County Police Department, and the St. Louis Metropolitan Police Department did not respond to Oversight's request for fiscal impact.

#### FISCAL IMPACT - Small Business

No direct fiscal impact to small businesses would be expected as a result of this proposal.

#### **DESCRIPTION**

Currently, full information concerning alcohol breath tests is made available to the person who is tested, upon his or her request. The proposed legislation specifies that full information means the type of test administered and the procedures followed, the time of the collection of the blood or breath sample analyzed, the numerical results of the test indicating the alcohol content of the blood and breath, the type and status of any permit which was held by the person who performed the test, and the date of the most recent required maintenance of any breath testing instrument used for the test. Full information does not include manuals, schematics, software of the instrument used, or information in the possession of the manufacturer.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
