AN ACT

To repeal sections 374.046, 381.003, 381.009, 381.011, 381.015, 381.018, 381.021, 381.022, 381.025, 381.028, 381.031, 381.032, 381.035, 381.038, 381.041, 381.042, 381.045, 381.048, 381.051, 381.052, 381.055, 381.058, 381.061, 381.062, 381.065, 381.068, 381.071, 381.072, 381.075, 381.078, 381.081, 381.085, 381.088, 381.091, 381.092, 381.095, 381.098, 381.101, 381.102, 381.105, 381.108, 381.111, 381.112, 381.115, 381.118, 381.121, 381.122, 381.125, 381.131, 381.141, 381.151, 381.161, 381.171, 381.181, 381.191, 381.201, 381.211, 381.221, 381.231, and 381.241, RSMo, and section 381.410 as enacted by conference committee substitute for senate bill no. 664, eighty-eighth general assembly, second regular session, and section 381.412 as enacted by house committee substitute for senate bill no. 148, eighty-ninth general assembly, first regular session, and sections 381.410 and 381.412 as enacted by conference committee substitute for house substitute for house committee substitute for senate committee substitute for senate bill no. 894, ninetieth general assembly, second regular session, and to enact in lieu thereof forty-three new sections relating to consumer protection and preventing fraud in the business of insurance and the regulation of title insurance, with penalty provisions.

Be it enacted by the General Assembly of the state of Missouri, as follows:

18 381.125, 381.410, and 381.412, to read as follows:

374.046. 1. [(1) The director may issue cease and desist orders whenever it appears to
2 him upon competent and substantial evidence that any person is acting in violation of any law
3 of this state or any rule or regulation promulgated by the director relating to the business of
4 insurance. Before any cease and desist order shall be issued, a copy of the proposed order
5 together with an order to show cause why such cease and desist order should not be issued shall
6 be served either personally or by certified mail on any person named therein.

7 (2) (a) Upon issuing any order to show cause the director shall notify the person named
8 therein that the person is entitled to a public hearing before the director if a request for a hearing
9 is made in writing to the director within fifteen days from the day of the service of the order to
10 show cause why the cease and desist order should not be issued.

11 (b) The cease and desist order shall be issued fifteen days after the service of the order
12 to show cause if no request for a public hearing is made as above provided.

13 (c) Upon receipt of a request for a hearing the director shall set a time and place for the
14 hearing which shall not be less than ten days or more than fifteen days from the receipt of the
15 request or as otherwise agreed upon by the parties. Notice of the time and place shall be given
16 by the director not less than five days before the hearing.

17 (d) At the hearing the person may be represented by counsel and shall be entitled to be
18 advised of the nature and source of any adverse evidence procured by the director and shall be
19 given the opportunity to submit any relevant written or oral evidence in his behalf to show cause
20 why the cease and desist order should not be issued.

21 (e) At the hearing the director shall have such powers as are conferred upon him in
22 section 374.190.

23 (f) At the conclusion of the hearing, or within ten days thereafter, the director shall issue
24 the cease and desist order as proposed or as subsequently modified or notify the person that no
25 order shall be issued.

26 (g) The circuit court of Cole County shall have jurisdiction to review any cease and
27 desist order of the director under the provisions of sections 536.100 to 536.150, RSMo; and, if
28 any person against whom an order is issued fails to request judicial review, or if, after judicial
29 review, the director's cease and desist order is upheld, the order shall become final.

30 **2.] If the director determines based upon substantial and competent evidence that**
31 **a person has engaged, is engaging, or is about to engage in an act, practice, omission, or**
32 **course of business constituting a violation of the laws of this state relating to insurance in**
33 **chapter 354, RSMo, and chapters 374 to 385, RSMo, or a rule adopted or order issued**
34 **thereunder or that a person has materially aided, is materially aiding, or is about to**
35 **materially aid an act, practice, omission or course of business constituting a violation of the**
36 **laws of this state relating to insurance in chapter 354, RSMo, and chapters 374 to 385,**
37 **RSMo, or a rule adopted or order issued thereunder, the director may order the following**
38 **relief:**

39 (1) An order directing the person to cease and desist from engaging in the act,
40 practice, omission, or course of business;

41 (2) A curative order or order directing the person to take other action necessary
42 or appropriate to comply with the insurance laws of this state;

43 (3) Order a civil penalty or forfeiture as provided in section 374.049; and

44 (4) Award reasonable costs of the investigation.

45 **2. In determining any relief sought, the director shall consider, among other**
46 **factors, whether:**

47 (1) The violations are likely to continue or reoccur;

48 (2) Actual injury or harm was suffered by consumers;

49 (3) Restitution has been made to aggrieved consumers;

50 (4) The act, practice, omission, or course of business was detected as part of a
51 regular self-audit or internal compliance program and immediately reported to the
52 director; and

53 (5) The act, practice, omission, or course of business had been previously detected,
54 but inadequate policies and procedures were implemented to prevent reoccurrence.

55 **3. Unless the director determines that a summary order is appropriate under**
56 **subsection 4 of this section, the director shall provide notice of the intent to initiate**
57 **administrative enforcement by serving a statement of the reasons for the action upon any**
58 **person subject to the proceedings. A statement of reasons, together with an order to show**

59 cause why a cease and desist order and other relief should not be issued shall be served
60 either personally or by certified mail on any person named therein. The director shall
61 schedule a time and place at least ten days thereafter for hearing, and after notice of and
62 opportunity for hearing to each person subject to the order, the director may issue a final
63 order under subsection 6 of this section.

64 4. If the director determines that section 375.014, 375.144, or 375.310 is being
65 violated and consumers are being aggrieved by such violations, the order issued under
66 subdivision (1) of subsection 1 of this section may be summary and be effective on the date
67 of issuance. Upon issuance of the order, the director shall promptly serve each person
68 subject to the order with a copy of the order and a notice that the order has been entered.

69 5. A summary order issued under subsection 4 of this section shall include a
70 statement of the reasons for the order, notice that within five days after receipt of a request
71 in a record from the person the matter will be scheduled for a hearing, and a statement
72 whether the department is seeking a civil penalty or costs of the investigation. If a person
73 subject to the order does not request a hearing and none is ordered by the director within
74 thirty days after the date of service of the order, the order becomes final as to that person
75 by operation of law. If a hearing is requested or ordered, the director, after notice of and
76 opportunity for hearing to each person subject to the order, may modify or vacate the
77 order or extend it until final determination.

78 6. If a hearing is requested or ordered under subsection 2 or 5 of this section, a
79 hearing before the director or a hearing officer designated by the director shall be
80 provided. A final order shall not be issued unless the director makes findings of fact and
81 conclusions of law in a record in accordance with the provisions of chapter 536, RSMo, and
82 procedural rules promulgated by the director. The final order may make final, vacate, or
83 modify the order issued under subsection 5 of this section.

84 7. In a final order under subsection 6 of this section, the director may impose a civil
85 penalty or forfeiture as provided in section 374.049. No civil penalty or forfeiture may be
86 imposed against a person unless the person has engaged in the act, practice, omission, or
87 course of business constituting the violation.

88 8. In a final order, the director may charge the actual cost of an investigation or
89 proceeding for a violation of the insurance laws of this state or a rule adopted or order
90 issued thereunder. Such funds may be paid to the director to the credit of the insurance
91 dedicated fund.

92 9. The director is authorized to issue subpoenas, compel attendance of witnesses,
93 administer oaths, hear testimony of witnesses, receive evidence, and require the production
94 of books, papers, records, correspondence, and all other written instruments or documents

95 relevant to the proceeding and authorized in contested cases under the provisions of
96 chapter 536, RSMo, and procedural rules promulgated by the director.

97 **10. Statements of charges, notices, orders, and other processes of the director may**
98 **be served by any person authorized by the director in the manner provided by law for**
99 **service of process in civil actions or by registering or certifying and mailing a copy thereof**
100 **to the person affected by such statement, notice, order, or other process at his or its**
101 **residence or principal office or place of business. The verified return by the person so**
102 **serving such statement, notice, order, or other process, setting forth the manner of such**
103 **service shall be proof of the same and the return postcard receipt for such statement,**
104 **notice, order, or other process, registered and mailed as aforesaid shall be proof of the**
105 **service of the same.**

106 **11. If a petition for judicial review of a final order is not filed in accordance with**
107 **section 374.055, the director may file a certified copy of the final order with the clerk of a**
108 **court of competent jurisdiction. The order so filed has the same effect as a judgment of the**
109 **court and may be recorded, enforced, or satisfied in the same manner as a judgment of the**
110 **court.**

111 **12. If a person violates or does not comply with an order under this section, the**
112 **director may under section 374.048 petition a court of competent jurisdiction to enforce the**
113 **order. The court shall not require the director to post a bond in an action or proceeding**
114 **under this section. If the court finds, after service and opportunity for hearing, that the**
115 **person was not in compliance with the order, the court may, in addition to relief authorized**
116 **in section 374.048, adjudge the person in civil contempt of the order. A violation of or**
117 **failure to comply with an order under this section is a level three violation under section**
118 **374.049. The court may impose a further civil penalty against the person for contempt in**
119 **an amount not less than five thousand dollars but not greater than one hundred thousand**
120 **dollars for each violation and may grant any other relief the court determines is just and**
121 **proper in the circumstances.**

122 **13. Until the expiration of the time allowed under section 374.055 for filing a**
123 **petition for judicial review, if no such petition has been filed within such time or, if a**
124 **petition for review has been filed within such time, then until the transcript of the record**
125 **in the proceeding has been filed in the circuit court of Cole County, the director may at any**
126 **time, upon such notice and in such manner as he shall deem proper, modify or set aside in**
127 **whole or in part any order issued by the director under this section.**

128 **14. The enforcement authority of the director under this section is cumulative to**
129 **any other statutory authority of the director.**

130 **15. The director is authorized to issue administrative consent orders in the public**
131 **interest as complete or partial settlement of any investigation, examination or other**
132 **proceeding, which curative orders may contain any provision necessary or appropriate to**
133 **assure compliance with the insurance laws of this state, require payment of restitution to**
134 **be distributed directly or by the director to any aggrieved consumers, civil penalties or**
135 **voluntary forfeiture, reimbursement for costs of investigation or examination, or any other**
136 **relief deemed by the director to be necessary and appropriate. Any remaining matters not**
137 **addressed in settlement may be submitted to the director through a contested proceeding**
138 **under this section.**

139 **16. (1) Any person willfully violating any provision of any cease and desist order of the**
140 **director after it becomes final, while the same is in force, upon conviction thereof shall be**
141 **punished by a fine of not more than one hundred thousand dollars or [one year in jail] by**
142 **imprisonment of up to ten years or by both such fine and [jail sentence] imprisonment.**

143 **(2) In addition to any other penalty provided, violation of any cease and desist order shall**
144 **subject the violator to suspension or revocation of any certificate of authority or license as may**
145 **be applicable under the laws of this state relating to the business of insurance.**

146 **[3. (1) When it appears to the director that there is a violation of the laws of this state**
147 **or any rule or regulation promulgated by the director relating to the business of insurance, and**
148 **that the continuance of the acts or actions of any person as herein defined would produce injury**
149 **to the insuring public or to any other person in this state, or when it appears that a person is doing**
150 **or threatening to do some act in violation of the laws of this state relating to insurance, the**
151 **director may file a petition for injunction in the circuit court of Cole County, Missouri, in which**
152 **he may ask for a temporary injunction or restraining order as well as a permanent injunction to**
153 **restrain the act or threatened act. In the event the temporary injunction or restraining order or**
154 **a permanent injunction is issued by the circuit court of Cole County, Missouri, no person against**
155 **whom the temporary injunction or restraining order or permanent injunction is granted shall do**
156 **or continue to do any of the acts or actions complained of in the petition for injunction, unless**
157 **and until the temporary injunction or restraining order or permanent injunction is vacated,**
158 **dismissed or otherwise terminated.**

159 **(2) Any writ of injunction issued under this law may be served and enforced as provided**
160 **by law in injunctions issued in other cases, but the director of the insurance department shall not**
161 **be required to give any bond as preliminary to or in the course of any proceedings to which he**
162 **is a party as director under this section, either for costs or for any injunction, or in case of appeal**
163 **to either the supreme court or to any appellate court.**

164 **4.] 17. The term "person" as used in this [section] chapter shall include any individual,**
165 **partnership, corporation, association or trust, or any other legal entity.**

374.047. 1. If the director determines based upon substantial and competent evidence that a corporation or insurer with a certificate of authority under the laws relating to insurance has willfully engaged in an act, practice, omission or course of business constituting a level three, four, or five violation of the laws of this state relating to insurance in chapter 354, RSMo, and chapters 374 to 385, RSMo, or been convicted of any felony or misdemeanor under any state or federal law, the director may, after hearing, issue an order suspending or revoking the certificate of authority.

2. Prior to issuance of the order under this section, the director shall give at least thirty days' notice with a statement of reasons for the action and afford such corporation or insurer the opportunity for a hearing upon written request. If such corporation or insurer requests a hearing in writing, a final order of suspension or revocation shall not be issued unless the director makes findings of fact and conclusions of law in a record in accordance with the contested case provisions of chapter 536, RSMo, and procedural rules promulgated by the director.

3. The enforcement authority of the director under this section is cumulative to any other statutory authority of the director.

374.048. 1. If the director believes that a person has engaged, is engaging, or is about to engage in an act, practice, omission, or course of business constituting a violation of the laws of this state relating to insurance in chapter 354, RSMo, and chapters 374 to 385, RSMo, or a rule adopted or order issued thereunder or that a person has, is, or is about to engage in an act, practice, omission, or course of business that materially aids a violation of the laws of this state relating to insurance in chapter 354 and chapters 374 to 385, RSMo, or a rule adopted or order issued thereunder, the director may maintain an action in the circuit court of any county of the state or any city not within a county to enjoin the act, practice, omission, or course of business and to enforce compliance with the laws of this state relating to insurance or a rule adopted or order issued by the director.

2. In an action under this section and on a proper showing, the court may:

(1) Issue a permanent or temporary injunction, restraining order, or declaratory judgment;

(2) Order other appropriate or ancillary relief, which may include:

(a) An asset freeze, accounting, writ of attachment, writ of general or specific execution, and appointment of a receiver or conservator, that may be the director, for the defendant or the defendant's assets;

(b) Ordering the director to take charge and control of a defendant's property, including accounts in a depository institution, rents, and profits; to collect debts; and to acquire and dispose of property;

21 (c) Imposing a civil penalty or forfeiture as provided in section 374.049;

22 (d) Upon the showing of financial loss, injury, or harm to identifiable consumers,
23 imposing an order of restitution or disgorgement directed to a person that has engaged in
24 an act, practice, omission, or course of business in violation of the laws or rules relating to
25 insurance;

26 (e) Ordering the payment of prejudgment and post judgment interest;

27 (f) Ordering reasonable costs of investigation and prosecution; and

28 (g) Ordering the payment to the insurance dedicated fund an additional amount
29 equal to ten percent of the total restitution or disgorgement ordered, or such other amount
30 as awarded by the court, which shall be appropriated to an insurance consumer education
31 program administered by the director; or

32 (3) Order such other relief as the court considers necessary or appropriate.

33 3. The director shall not be required to post a bond in an action or proceeding
34 under this section.

35 4. The case may be brought in the circuit court of Cole County, any county or city
36 not within a county in which a violation has occurred, or any county or city not within a
37 county which has venue of an action against the person, partnership, or corporation under
38 other provisions of law.

39 5. The enforcement authority of the director under this section is cumulative to any
40 other authority of the director to impose orders under other provisions of the insurance
41 laws of this state.

42 6. If the director determines it to be in the public interest, the director is authorized
43 to enter into a consent injunction and judgment in the settlement of any proceeding under
44 the laws of this state relating to insurance in chapter 354 and chapters 374 to 385, RSMo.

45 7. A "Consumer Restitution Fund" shall be created for the purpose of preserving
46 and distributing to aggrieved consumers, disgorgement, or restitution funds obtained
47 through enforcement proceedings brought by the director. In addition to the equitable
48 powers of the court authorized in this section, the court may order that such funds be paid
49 into the consumer restitution fund for distribution to aggrieved consumers. The director
50 shall distribute such funds to those persons injured by the unlawful acts, practices,
51 omissions, or courses of business by the subject of the proceeding. Notwithstanding the
52 provisions of section 33.080, RSMo, any funds remaining in the director's consumer
53 restitution fund at the end of any biennium shall not be transferred to the general revenue
54 fund, but if the director is unable with reasonable efforts to ascertain the aggrieved
55 consumers, the funds may be transferred to the insurance dedicated fund to be used for
56 consumer education.

374.049. 1. Violations of the laws of this state relating to insurance in chapter 354 and chapters 374 to 385, RSMo, or a rule adopted or order issued by the director, are classified for the purpose of civil penalties and forfeitures into the following five categories:

- (1) Level one violations;**
- (2) Level two violations;**
- (3) Level three violations;**
- (4) Level four violations; and**
- (5) Level five violations.**

2. An order to impose a civil penalty or forfeiture, when imposed by the director in an administrative proceeding under section 374.046 on a person for any violation of the laws of this state relating to insurance in chapter 354 and chapters 374 to 385, RSMo, or a rule adopted or order issued by the director, shall be an order to pay an amount not exceeding the following:

- (1) No civil penalty or forfeiture for a level one violation;**
- (2) One thousand dollars per each level two violation, up to an aggregate civil penalty or forfeiture of fifty thousand dollars per annum for multiple violations;**
- (3) Five thousand dollars per each level three violation, up to an aggregate civil penalty or forfeiture of one hundred thousand dollars per annum for multiple violations;**
- (4) Ten thousand dollars per each level four violation, up to an aggregate civil penalty or forfeiture of two hundred fifty thousand dollars per annum for multiple violations;**
- (5) Fifty thousand dollars per each level five violation, up to an aggregate civil penalty or forfeiture of two hundred fifty thousand dollars per annum for multiple violations.**

3. An order to impose a civil penalty or forfeiture, when imposed by the court in an enforcement proceeding under section 374.048 on a person for any violation of the laws of this state relating to insurance in chapter 354 and chapters 374 to 385, RSMo, or a rule adopted or order issued by the director, shall be an order to pay an amount not exceeding the following:

- (1) No civil penalty or forfeiture for a level one violation;**
- (2) One thousand dollars per each level two violation, up to an aggregate civil penalty or forfeiture of fifty thousand dollars per annum for multiple violations;**
- (3) Five thousand dollars per each level three violation, up to an aggregate civil penalty or forfeiture of two hundred thousand dollars per annum for multiple violations;**
- (4) Twenty thousand dollars per each level four violation, up to an aggregate civil penalty or forfeiture of one million dollars per annum for multiple violations;**

37 (5) One million dollars per each level five violation, with no limit to civil penalties
38 or forfeitures for multiple violations;

39 4. No civil penalty or forfeiture may be imposed against a person, unless the person
40 has engaged in the act, practice, omission, or course of business constituting the violation.

41 5. Any violation of the laws of this state relating to insurance in chapter 354 and
42 chapters 374 to 385, RSMo, which is not classified or does not authorize a specific range
43 for a civil penalty or forfeiture for violations shall be classified as a level one violation. In
44 bringing an action to enforce a rule adopted by the director, unless the conduct that
45 violates the rule also violates the enabling statute, the violation shall be classified as a level
46 one violation.

47 6. The civil penalties or forfeitures set forth in this section establish a maximum
48 range. The court or the director in administrative enforcement shall consider all of the
49 circumstances, including the nature of violations, to determine whether and to any extent
50 a civil penalty or forfeiture is justified.

51 7. In any enforcement proceeding, the court or director in administrative
52 enforcement may enhance the civil penalty or forfeiture with a one classification step
53 increase under this section if the violation was knowing. The court or director in
54 administrative enforcement may enhance the civil penalty or forfeiture with a two level
55 increase if the violation was knowingly committed in conscious disregard of the law.

56 8. In any enforcement proceeding, the court or director in administrative
57 enforcement may enhance the civil penalty or forfeiture with a one classification step
58 increase under this section if the violations resulted in actual financial loss or injury to
59 consumers.

60 9. In any enforcement proceeding, the court or director in administrative
61 enforcement shall reduce the civil penalty or forfeiture on that person with a one
62 classification step reduction under this section if, prior to receiving notice of the violation
63 from the department, the person detects the violation through a regular self-audit or
64 internal compliance program reasonably designed to detect and prevent insurance law
65 violations and immediately reports the violation to the director.

66 10. Any civil penalty or forfeiture recovered by the director shall be paid to the
67 treasurer and distributed to the public schools as required by Article IX, section 7 of the
68 Missouri Constitution.

69 11. The penalties and forfeitures authorized by this section govern all actions and
70 proceedings that are instituted on the basis of conduct occurring after August 31, 2006.

 374.051. 1. Any applicant refused a license by order of the director under sections
2 374.755 and 374.787, and section 375.141, RSMo, may file a petition with the

3 administrative hearing commission alleging that the director has refused the license. The
4 administrative hearing commission shall conduct hearings and make findings of fact and
5 conclusions of law. The director shall have the burden of proving cause for refusal.

6 2. If a proceeding is instituted to revoke or suspend a license of any person under
7 sections 374.755 and 374.787, and section 375.141, RSMo, the director shall refer the
8 matter to the administrative hearing commission. The administrative hearing commission
9 shall conduct hearings and make findings of fact and conclusions of law in such cases. The
10 director shall have the burden of proving cause for discipline. The administrative hearing
11 commission shall submit its findings of fact and conclusions of law to the director for final
12 disposition. If cause is found, the director may determine appropriate discipline.

13 3. Hearing procedures before the director or the administrative hearing
14 commission and judicial review of the decisions and orders of the director and of the
15 administrative hearing commission, and all other procedural matters under this chapter
16 shall be governed by the provisions of chapter 536, RSMo. Hearings before the
17 administrative hearing commission shall also be governed by the provisions of chapter 621,
18 RSMo.

374.055. 1. Except as otherwise provided, any interested person aggrieved by any
2 order of the director under the laws of this state relating to insurance in chapter 354 and
3 chapters 374 to 385, RSMo, or a rule adopted by the director, or by any refusal or failure
4 of the director to make an order under any of such provisions, shall be entitled to a hearing
5 before the director in accordance with the provisions of chapter 536, RSMo. A final order
6 issued by the director is subject to judicial review in accordance with the provisions of
7 chapter 536, RSMo.

8 2. Any rule adopted by the director is subject to judicial review in accordance with
9 the provisions of chapter 536, RSMo.

381.003. 1. Sections 381.003 to 381.412 shall be known and may be cited as the
2 "Missouri Title Insurance Act".

3 2. Except as otherwise expressly provided in this chapter and except where the
4 context otherwise requires, all provisions of the laws of this state relating to insurance and
5 insurance companies generally shall apply to title insurance, title insurers, and title agents.

381.009. As used in this chapter, the following terms mean:

2 (1) "Abstract of title" or "abstract", a written history, synopsis, or summary of the
3 recorded instruments affecting the title to real property;

4 (2) "Affiliate", a specific person that directly, or indirectly through one or more
5 intermediaries, controls, or is controlled by, or is under common control with, the person
6 specified;

- 7 (3) "Affiliated business", any portion of a title insurance agency's business written
8 in this state that was referred to it by a producer of title insurance business or by an
9 associate of the producer, where the producer or associate, or both, have a financial
10 interest in the title agency;
- 11 (4) "Associate", any:
- 12 (a) Business organized for profit in which a producer of title business is a director,
13 officer, partner, employee, or an owner of a financial interest;
- 14 (b) Employee of a producer of title business;
- 15 (c) Franchisor or franchisee of a producer of title business;
- 16 (d) Spouse, parent, or child of a producer of title insurance business who is a
17 natural person;
- 18 (e) Person, other than a natural person, that controls, is controlled by, or is under
19 common control with, a producer of title business;
- 20 (f) Person with whom a producer of title insurance business or any associate of the
21 producer has an agreement, arrangement, or understanding, or pursues a course of
22 conduct, the purpose or effect of which is to provide financial benefits to that producer or
23 associate for the referral of business;
- 24 (5) "Control", including the terms "controlling", "controlled by", and "under
25 common control with", the possession, direct or indirect, of the power to direct or cause
26 the direction of the management and policies of a person, whether through the ownership
27 of voting securities, by contract other than a commercial contract for goods or
28 nonmanagement services, or otherwise, unless the power is the result of an official position
29 or corporate office held by the person. Control shall be presumed to exist if a person,
30 directly or indirectly, owns, controls, holds with the power to vote, or holds proxies
31 representing ten percent or more of the voting securities of another person. This
32 presumption may be rebutted by showing that control does not exist in fact. The director
33 may determine, after furnishing all persons in interest notice and opportunity to be heard
34 and making specific findings of fact to support the determination, that control exists in
35 fact, notwithstanding the absence of a presumption to that effect;
- 36 (6) "County" or "counties" includes any city not within a county;
- 37 (7) "Direct operations", that portion of a title insurer's operations which are
38 attributable to business written by a bona fide employee;
- 39 (8) "Director", the director of the department of insurance, or the director's
40 representatives;

- 41 (9) "Escrow", written instruments, money or other items deposited by one party
42 with a depository, escrow agent, or escrowee for delivery to another party upon the
43 performance of a specified condition or the happening of a certain event;
- 44 (10) "Escrow, settlement or closing fee", the consideration for supervising or
45 handling the actual execution, delivery, or recording of transfer and lien documents and
46 for disbursing funds;
- 47 (11) "Financial interest", a direct or indirect legal or beneficial interest, where the
48 holder is or will be entitled to five percent or more of the net profits or net worth of the
49 entity in which the interest is held;
- 50 (12) "Foreign title insurer", any title insurer incorporated or organized under the
51 laws of any other state of the United States, the District of Columbia, or any other
52 jurisdiction of the United States;
- 53 (13) "Geographically indexed or retrievable", a system of keeping recorded
54 documents which includes as a component a method for discovery of the documents by:
- 55 (a) Searching an index arranged according to the description of the affected land;
56 or
- 57 (b) An electronic search by description of the affected land;
- 58 (14) "Net retained liability", the total liability retained by a title insurer for a single
59 risk, after taking into account any ceded liability and collateral, acceptable to the director,
60 and maintained by the insurer;
- 61 (15) "Non-United States title insurer", any title insurer incorporated or organized
62 under the laws of any foreign nation or any province or territory;
- 63 (16) "Premium", the consideration paid by or on behalf of the insured for the
64 issuance of a title insurance policy, closing protection, or any endorsement or special
65 coverage. Premium shall include the amount to be remitted to the title insurer, plus the
66 underwriting charge as defined in subdivision (31) of this section. Premium does not
67 include any sales commission retained by an agent or agency, the consideration paid for
68 abstract or title search or examination fees, settlement, or escrow services, noninsurance-
69 related information services, or any other items or services not specified in this chapter;
- 70 (17) "Producer", any person, including any officer, director, or owner of five
71 percent or more of the equity or capital of any person, engaged in this state in the trade,
72 business, occupation, or profession of:
- 73 (a) Buying or selling interests in real property;
- 74 (b) Making loans secured by interests in real property; or

75 (c) Acting as broker, agent, representative, or attorney of a person who buys or
76 sells any interest in real property or who lends or borrows money with the interest as
77 security;

78 (18) "Qualified depository institution", an institution that is:

79 (a) Organized or, in the case of a United States branch or agency office of a foreign
80 banking organization, licensed under the laws of the United States or any state and has
81 been granted authority to operate with fiduciary powers;

82 (b) Regulated, supervised, and examined by federal or state authorities having
83 regulatory authority over banks and trust companies;

84 (c) Insured by the appropriate federal entity; and

85 (d) Qualified under any additional rules established by the director;

86 (19) "Referral", the directing or the exercising of any power or influence over the
87 direction of title insurance business, whether or not the consent or approval of any other
88 person is sought or obtained with respect to the referral;

89 (20) "Search", "search of the public records", or "search of title", a search of those
90 records established by the laws of this state for the purpose of imparting constructive
91 notice of matters relating to real property to purchasers for value and without knowledge;

92 (21) "Security" or "security deposit", funds or other property received by the title
93 insurer as collateral to secure an indemnitor's obligation under an indemnity agreement
94 under which the insurer is granted a perfected security interest in the collateral in
95 exchange for agreeing to provide coverage in a title insurance policy for a specific title
96 exception to coverage;

97 (22) "Subsidiary", an affiliate controlled by a person directly or indirectly through
98 one or more intermediaries;

99 (23) "Title agency" or "title insurance agency", an authorized person who issues
100 title insurance on behalf of a title insurer. An attorney licensed to practice law in this state
101 who issues title insurance as a part of his or her law practice, but does not maintain or
102 operate a title insurance business separate from such law practice is not a title agency;

103 (24) "Title agent", "agent", or "title insurance agent", an attorney licensed to
104 practice law in this state who issues title insurance as part of his or her law practice, but
105 who is not affiliated with or acting on behalf of a title agency, or an authorized person who,
106 on behalf of a title agency or on behalf of a title agent not affiliated with a title agency,
107 performs one or more of the following acts in conjunction with the issuance of a title
108 insurance commitment or policy:

109 (a) Determines insurability;

110 (b) Performs searches;

- 111 (c) Handles escrows, settlements, or closings; or
112 (d) Solicits or negotiates title insurance business;
113 (25) "Title insurance business" or "business of title insurance":
114 (a) Issuing as insurer or offering to issue as insurer a title insurance policy;
115 (b) Transacting or proposing to transact by a title insurer any of the following
116 activities when conducted or performed in contemplation of and in conjunction with the
117 issuance of a title insurance policy:
118 a. Soliciting or negotiating the issuance of a title insurance policy;
119 b. Guaranteeing, warranting, or otherwise insuring the correctness of title searches
120 for all instruments affecting titles to real property, any interest in real property,
121 cooperative units, and proprietary leases and for all liens or charges affecting the same;
122 c. Handling of escrows, settlements, or closings;
123 d. Executing title insurance policies;
124 e. Effecting contracts of reinsurance; or
125 f. Abstracting, searching, or examining titles;
126 (c) Guaranteeing, warranting, or insuring searches or examinations of title to real
127 property or any interest in real property;
128 (d) Guaranteeing or warranting the status of title as to ownership of or liens on real
129 property by any person other than the principals to the transaction;
130 (e) Promising to purchase or repurchase for consideration an indebtedness because
131 of a title defect, whether or not involving a transfer of risk to a third person; or
132 (f) Promising to indemnify the holder of a mortgage or deed of trust against loss
133 from the failure of the borrower to pay the mortgage or deed of trust when due if the
134 property fails to yield sufficient proceeds upon foreclosure to satisfy the debt, when one or
135 both of the following conditions exist:
136 a. The security has been impaired by the discovery of a previously unknown
137 property interest in favor of one who is not liable for the payment of the mortgage or deed
138 of trust; or
139 b. Perfection of the position of the mortgage or deed of trust which was assured to
140 exist cannot be obtained, notwithstanding timely recordation with the recorder of deeds
141 of the county in which the property is located; or
142 (g) Doing or proposing to do any business substantially equivalent to any of the
143 activities listed in this subdivision in a manner designed to evade the provisions of this
144 chapter;
145 (26) "Title insurance commitment" or "commitment", a preliminary report,
146 commitment, or binder issued prior to the issuance of a title insurance policy containing

the terms, conditions, exceptions, and other matters incorporated by reference under which the title insurer is willing to issue its title insurance policy. A title insurance commitment is not an abstract of title;

(27) "Title insurance policy" or "policy", a contract insuring or indemnifying owners of, or other persons lawfully interested in, real property or any interest in real property, against loss or damage arising from any or all of the following conditions existing on or before the policy date and not excepted or excluded:

(a) Title to the estate or interest in land being otherwise than as stated in the policy;

(b) Defects in or liens or encumbrances on the insured title;

(c) Unmarketability of the insured title;

(d) Lack of legal right of access to the land;

(e) Invalidity or unenforceability of the lien of an insured mortgage;

(f) The priority of a lien or encumbrance over the lien of any insured mortgage;

(g) The lack of priority of the lien of an insured mortgage over a statutory lien for services, labor, or material;

(h) The invalidity or unenforceability of an assignment of the insured mortgage;

or

(i) Rights or claims relating to the use of or title to the land;

(28) "Title insurer" or "insurer", a company organized under the laws of this state for the purpose of transacting the business of title insurance and any foreign or non-United States title insurer licensed in this state to transact the business of title insurance;

(29) "Title plant", a set of records encompassing at least the most recent forty-five years, consisting of documents, maps, surveys, or entries affecting title to real property or any interest in or encumbrance on the property, which have been filed or recorded in the jurisdiction for which the title plant is established or maintained. The records in the title plant shall be geographically indexed or retrievable as to those records containing a legal description of affected land, and otherwise by name of affected person;

(30) "Underwrite", the authority to accept or reject risk on behalf of the title insurer;

(31) "Underwriting charge", the charge that is reasonably necessary to determine the insurability of the resale of an owner-occupied residential property whose value does not exceed the median value within its geographic region, with such determination of insurability made in accordance with sound underwriting practices based upon a reasonable examination of records revealed in the abstract, title search, or other sources.

381.015. 1. When a title insurance commitment issued by a title insurer, title agency, or title agent includes an offer to issue an owner's policy covering the resale of

3 owner-occupied residential property, the commitment shall incorporate the following
4 statement in bold type:

5 "Please read the exceptions and the terms shown or referred to herein carefully.
6 The exceptions are meant to provide you with notice of matters which are not covered
7 under the terms of the title insurance policy and should be carefully considered."

8 2. A title insurer, title agency, or title agent issuing a lender's title insurance policy
9 in conjunction with a mortgage loan made simultaneously with the purchase of all or part
10 of the real estate securing the loan, where no owner's title insurance policy has been
11 requested, shall give written notice, on a form prescribed or approved by the director, to
12 the purchaser-mortgagor at the time the commitment is prepared. The notice shall explain
13 that a lender's title insurance policy is to be issued protecting the mortgage-lender, and
14 that the policy does not provide title insurance protection to the purchaser-mortgagor as
15 the owner of the property being purchased. The notice shall explain what a title policy
16 insures against and what possible exposures exist for the purchaser-mortgagor that could
17 be insured against through the purchase of an owner's policy. The notice shall also explain
18 that the purchaser-mortgagor may obtain an owner's title insurance policy protecting the
19 property owner at a specified cost or approximate cost, if the proposed coverages are or
20 amount of insurance is not then known. A copy of the notice, signed by the
21 purchaser-mortgagor, shall be retained in the relevant underwriting file at least fifteen
22 years after the effective date of the policy.

23 3. A violation of any provision under this section is a level one violation under
24 section 374.049, RSMo.

381.018. 1. The title insurer shall not allow the issuance of its commitments or
2 policies by a title agency or title agent not affiliated with a title agency unless there is in
3 force a written contract between the parties which sets forth the responsibilities of each
4 party or, where both parties share responsibility for particular functions, specifies the
5 division of responsibilities.

6 2. The title insurer shall maintain an inventory of all policy numbers allocated to
7 each title agency or title agent not affiliated with a title agency.

8 3. The title insurer shall have on file proof that the title agency or title agent is
9 licensed by this state.

10 4. The title insurer shall establish the underwriting guidelines and, where
11 applicable, limitations on title claims settlement authority to be incorporated into contracts
12 with its title agencies and title agents not affiliated with a title agency.

13 5. If a title insurer terminates its agency with a title agency licensed under this
14 chapter, the insurer shall, within seven days of the termination, notify the director of the

15 reasons for termination, including any information that is required to be reported under
16 subsection 5 of section 375.022, RSMo.

17 6. A violation of any provision under this section is a level two violation under
18 section 374.049, RSMo.

381.019. 1. A title insurer, title agency or title agent participating in residential
2 closings using the Housing and Urban Development settlement statement (form HUD-1)
3 shall provide clear and conspicuous disclosure of charges. The director may adopt rules
4 not in conflict with provisions of the federal Real Estate Settlement Procedures Act, as
5 amended, under section 381.042 to implement disclosure of the following:

6 (1) Premium as defined in section 381.009, including the underwriting charge
7 retained by the title agency or title agent;

8 (2) Abstract or title search fee;

9 (3) Settlement or closing fees;

10 (4) Policy issuance fees under section 381.113; and

11 (5) Any other associated fees along with a concise description.

12 2. A violation of any provision under this section is a level two violation under
13 section 374.049.

381.022. 1. A title insurer, title agency, or title agent not affiliated with a title
2 agency may operate as an escrow, security, settlement, or closing agent, provided that all
3 funds deposited with the title insurer, title agency, or title agent not affiliated with a title
4 agency in connection with any escrow, settlement, closing, or security deposit shall be
5 submitted for collection to or deposited in a separate fiduciary trust account or accounts
6 in a qualified depository institution no later than the close of the next business day after
7 receipt, in accordance with the following requirements:

8 (1) The funds shall be the property of the person or persons entitled to them under
9 the provisions of the escrow, settlement, security deposit, or closing agreement and shall
10 be segregated for each depository by escrow, settlement, security deposit, or closing in the
11 records of the title insurer, title agency, or title agent not affiliated with a title agency, in
12 a manner that permits the funds to be identified on an individual basis and in accordance
13 with the terms of the individual instructions or agreements under which the funds were
14 accepted; and

15 (2) The funds shall be applied only in accordance with the terms of the individual
16 instructions or agreements under which the funds were accepted.

17 2. It is unlawful for any person to:

18 (1) Commingle personal or any other moneys with escrow funds;

19 (2) Use escrow funds to pay or indemnify against debts of the title insurance agent
20 or of any other person;

21 (3) Use escrow funds for any purpose other than to fulfill the terms of the
22 individual escrow after the necessary conditions of the escrow have been met;

23 (4) Disburse any funds held in an escrow account unless the disbursement is made
24 under a written instruction or agreement specifying under what conditions and to whom
25 such funds may be disbursed or under an order of a court of competent jurisdiction; or

26 (5) Disburse any funds held in a security deposit account unless the disbursement
27 is made under a written agreement specifying:

28 (a) What actions the indemnitor shall take to satisfy his or her obligation under the
29 agreement;

30 (b) The duties of the title insurer, title agency, or title agent not affiliated with a
31 title agency with respect to disposition of the funds held, including a requirement to
32 maintain evidence of the disposition of the title exception before any balance may be paid
33 over to the depositing party or his or her designee; and

34 (c) Any other provisions the director may require by rule or order.

35 3. Notwithstanding the provisions of subsection 2 of this section, any interest
36 received on funds deposited in connection with any escrow, settlement, security deposit, or
37 closing may be retained by the title insurer, title agency, or title agent not affiliated with
38 a title agency as compensation for administration of the escrow or security deposit, unless
39 the instructions for the funds or a governing statute provides otherwise.

40 4. A violation of any provision under this section is a level three violation under
41 section 374.049, RSMo.

 381.023. 1. A title insurer shall, at least annually, conduct an onsite review of the
2 underwriting, claims, and escrow practices of the title insurance agency or agent with
3 which it has a contract. If the title insurance agency or agent does not maintain separate
4 fiduciary trust accounts for each title insurer it represents, the title insurer shall verify that
5 the funds held on its behalf are reasonably ascertainable from the books of account and
6 records of the title insurance agency or agent.

7 2. Each title insurer authorized to do business in Missouri shall adopt and utilize
8 the following standards and procedures for the on-site review of title insurance agents and
9 agencies. On-site review documentation, work papers, summaries, and reports shall be
10 maintained by each title insurer for a period of at least four years and shall be made
11 available to the director for examination upon request. A report shall be prepared by the
12 title insurer at the completion of the on-site review setting forth the title insurer's findings.
13 On-site review findings shall include, but not be limited to, the following:

- 14 (1) A review of contracts between the title insurer and the title insurance agency
15 or agent;
- 16 (2) A statement of financial condition of the title insurance agency or agent,
17 certified by the title insurance agent or designated agent of the agency under oath or by
18 affirmation as being a true and accurate representation of financial condition;
- 19 (3) A review of management practices related to conflicts of interest, affiliated
20 business arrangements, and regulatory compliance;
- 21 (4) Reconciliation of orders with commitments, title searches, title policies, and
22 collection of premiums;
- 23 (5) A review of the procedures for tracking issued commitments;
- 24 (6) A review of the practices to cancel commitments on transactions that do not
25 close;
- 26 (7) A review of the procedures for follow-up after closing to track status of
27 outstanding conditions required for timely issuance of policies;
- 28 (8) A review of the procedures for voiding policies;
- 29 (9) A review of the tracking of open escrow, security, settlement or closing files;
- 30 (10) A review of issued policy reports to the title insurer by the title insurance
31 agency or agent;
- 32 (11) A review of any files awaiting policy issuance that includes a determination of
33 the average length of time between closing and the issuance of the title policy; and
- 34 (12) A review of a three-way reconciliation of bank balance, book balance and
35 escrow trial balance for each individual escrow bank account.
- 36 3. If the agent or agency is an agent or agency for two or more title insurers, the
37 title insurers may cooperate in complying with the requirements of this section.
- 38 4. The title insurer shall provide a copy of the report of each such review it
39 performs to the director. The director may promulgate rules setting forth the minimum
40 threshold level at which a review would be required, the standards thereof and the form
41 of report required.
- 42 5. A violation of any provision under this section is a level two violation under
43 section 374.049, RSMo.
- 381.024. 1. It is unlawful for any title agency or title agent not affiliated with an
2 agency to deny reasonable access or in any manner fail to cooperate with its underwriters
3 in the title insurers' reviews of the agency's or agent's escrow, settlement, closing and
4 security deposit accounts.
- 5 2. It is unlawful for any title agency or title agent not affiliated with an agency,
6 appointed by two or more title insurers, to deny any of the title insurers reasonable access

7 to the fiduciary trust accounts in connection with providing escrow or closing settlement
8 services, and any or all of the supporting account information in order to ascertain the
9 safety and security of the funds held by the title agency or title agent.

10 3. A violation of any provision under this section is a level two violation under
11 section 374.049, RSMo.

381.025. 1. A title insurer, title agency, title agent, or other person shall not give
2 or receive, directly or indirectly, any consideration for the referral of title insurance
3 business, escrow, closing, or other service provided by a title insurer, title agency, or title
4 agent.

5 2. A violation of any provision under this section is a level three violation under
6 section 374.049, RSMo.

7 3. If the director fails to initiate a proceeding to enforce this section within forty-
8 five days following receipt of written notice of such violation, any title insurer, title agency,
9 or title agent doing business in the same county may maintain an action for injunctive relief
10 against a title insurer, title agency, or title agent violating any provision of this section. In
11 any action under this subsection, the court may award to the successful party the court
12 costs of the action together with reasonable attorney fees.

381.026. 1. The settlement agent shall record all deeds and security instruments for
2 real estate closings handled by it within five business days after completion of all conditions
3 precedent thereto.

4 2. Nothing in this chapter shall be deemed to prohibit the recording of documents
5 prior to the time funds are available for disbursement with respect to a transaction in
6 which a title insurer, title agency, or title agent not affiliated with a title agency is the
7 settlement agent, provided all parties to whom payment will become due upon such
8 recording consent thereto in writing.

381.027. A title insurer is liable for the defalcation, conversion, or misappropriation
2 by a licensed title insurance agent or agency of funds held in trust by the agent or agency
3 under section 381.022. If the agent or agency is an agent or agency for two or more title
4 insurers, any liability shall be borne by the title insurer upon which a title insurance
5 commitment or policy was issued prior to the illegal act. If no commitment or policy was
6 issued, each title insurer represented by the agent or agency at the time of the illegal act
7 shares in the liability in the same proportion that the premium remitted to it by the agent
8 or agency during the one-year period before the illegal act bears to the total premium
9 remitted to all title insurers by the agent or agency during the same time period.

381.028. 1. No title insurer, title agency, or title agent shall participate in any
2 transaction in which it knows that a producer or other person requires, directly or

3 indirectly, or through any trustee, director, officer, agent, employee, or affiliate, as a
4 condition, agreement, or understanding to selling or furnishing any other person a loan,
5 or loan extension, credit, sale, property, contract, lease, or service, that the other person
6 shall place a title insurance policy of any kind with the title insurer or through a particular
7 title agency or agent.

8 2. It is unlawful for any title insurer, title agency, title agent, or any employee or
9 representative thereof, to:

10 (1) Pay, allow or give, or offer to pay, allow or give, directly or indirectly, as an
11 inducement to insurance, or after insurance has been effected, any rebate, discount,
12 abatement, credit or reduction of the premium named in the policy of insurance, or any
13 special favor or advantage in the dividends or other benefits to accrue thereon, or any
14 valuable consideration or inducement whatever, not specified or provided for in the policy,
15 except to the extent provided for in the applicable filing with the director;

16 (2) Pay, allow or give, or offer to pay, allow or give, directly or indirectly, to the
17 insured or any person acting as an agent, representative, attorney, or employee of the
18 owner, lessee, mortgagee, existing, or prospective, of the real property or interest therein
19 which is the subject matter of title insurance or as to which a service is to be performed,
20 any commission or part of its fee or charges, or any other consideration as inducement or
21 compensation for placing any order for a title insurance policy or for performance of any
22 escrow or other service by the insurer, title agency, title agent, or employee, or
23 representative thereof; or

24 (3) Issue any policy or perform any service in connection with which it or any agent
25 or other person has paid or contemplates paying, allowing or giving any commission,
26 rebate, inducement, or other consideration that would violate subdivision (2) of this
27 section.

28 3. A violation of any provision under this section is a level three violation under
29 section 374.049, RSMo.

381.032. 1. Premium rates shall not be excessive, inadequate or unfairly
2 discriminatory. Premium rates are excessive if they are likely to produce a long-run profit
3 that is unreasonably high for the insurance provided or if expenses are unreasonably high
4 in relation to services rendered. Premium rates are inadequate when they are clearly
5 insufficient to sustain projected losses and expenses and the use of such rates, if continued,
6 will tend to create a monopoly in the market.

7 2. Unfair discrimination exists if, after allowing for practical limitations, price
8 differentials fail to reflect equitably the differences in expected losses and expenses. A rate
9 is not unfairly discriminatory because different premiums result for policyholders with like

10 loss exposures but different expenses, or like expenses but different loss exposures, so long
11 as the rate reflects the differences with reasonable accuracy.

12 3. Due consideration shall be given to past and prospective loss and expense
13 experience within and outside of this state, to catastrophe hazards and contingencies, to
14 events or trends within and outside of this state, and to all other relevant factors, including
15 judgment.

16 4. Premium rates may contain a provision for contingencies and an allowance
17 permitting a reasonable profit. In determining the reasonableness of profit, consideration
18 should be given to all investment income attributable to premiums and reserves.

19 5. Premiums shall contain a separate provision for the underwriting charge. The
20 underwriting charge shall reasonably reflect the cost of goods, services, and property
21 values in various regions of the state. The underwriting charge shall be reflective of similar
22 charges that would prevail in an environment that is neither without competition nor is
23 excessively competitive. For a title policy written by a title agency or title agent, this charge
24 shall be retained by the title agency or agent.

381.033. 1. Every title insurer shall file with the director all premium rates and
2 supplementary rate information which is to be used in this state. Such rates and
3 supplementary rate information and supporting information required by the director shall

6 2. Rates filed under this section shall be filed in such form and manner as
7 prescribed by the director. Whenever a filing is not accompanied by such information as
8 the director has required under this section, the director shall so inform the insurer within
9 thirty days.

10 3. All rates, supplementary rate information and any supporting information, not
11 otherwise confidential under section 374.070, RSMo, shall, as soon as filed, be open to
12 public inspection at any reasonable time. Copies may be obtained by any person on
13 request and upon payment of a reasonable charge.

381.034. 1. A rate may be disapproved at any time subsequent to the effective date.
2 The director may disapprove a rate if the director finds that the rate is inadequate,
3 excessive or unfairly discriminatory under section 381.032.

4 2. The insurer whose rates have been disapproved shall be given a hearing upon
5 a written request made within thirty days after the disapproval order.

6 3. Whenever an insurer has no legally effective rates as a result of the director's
7 disapproval of rates or other act, the director shall on request of the insurer specify interim
8 rates for the insurer that are high enough to protect the interests of all parties and may

9 order that a specified portion of the premiums be placed in an escrow account approved
10 by the director. When new rates become legally effective, the director shall order the
11 escrowed funds or any overcharge in the interim rates to be distributed appropriately,
12 except that refunds of less than ten dollars per policyholder shall not be required.

381.038. 1. No title insurance policy shall be written unless and until the title
2 insurer, title agent, or agency has:

3 (1) Caused a search of title to be made from the evidence prepared from a title
4 plant of the county where the property is located as herein defined, or if no such title plant
5 of the county exists, or the owner of such plant refuses to furnish the title insurer, title
6 agent, or agency desiring to insure, such title evidence at a reasonable charge and within
7 a reasonable period of time, then such policy of title insurance shall be based upon the best
8 title evidence available. An attorney licensed to practice law in this state may upon
9 personal inspection use the best evidence available in any county and is not subject to the
10 provisions of the title plant requirement of this chapter. The records on which the title
11 plant is based on shall show all prior matters affecting the title to the property or interest
12 therein for a continuous period of time of at least the most recent forty-five years; and

13 (2) Caused to be made a determination of insurability of title in accordance with
14 sound underwriting practices.

15 2. Except when allowed by regulations promulgated by the director, no title
16 insurer, title agent, or agency shall knowingly issue any owner's title insurance policy or
17 commitment to insure without showing all outstanding, enforceable recorded liens or other
18 interests against the title which is to be insured.

19 3. Evidence of the examination of title and determination of insurability generated
20 by a title insurer, title agency, or title agent shall be preserved and maintained by such
21 insurer, agency, or agent for as long as appropriate to the circumstances but in no event
22 less than fifteen years after the title insurance policy has been issued. Instead of retaining
23 the original evidence, the title insurer or title agent or agency may in the regular course of
24 business establish a system whereby all or part of the evidence is recorded, copied, or
25 reproduced by any process that accurately and legibly reproduces or forms a durable
26 medium for reproducing the contents of the original.

27 4. Records relating to escrow and security deposits shall be preserved and retained
28 by a title insurer engaged in direct operations, title agency, and title agent for as long as
29 appropriate to the circumstances but, in no event less than seven years after the escrow or
30 security deposit account has been closed.

31 5. All title insurance policies shall be issued promptly, but no more than forty-five
32 days, after closing, unless there are special circumstances that prevent the issuance of the
33 policy.

34 6. This section shall not apply to a title insurer acting as coinsurer if one of the
35 other coinsurers has complied with this section.

36 7. A violation of any provision under this section is a level two violation under
37 section 374.049, RSMo.

 381.042. 1. The director under the authority in section 374.045, RSMo, may issue
2 rules, regulations, and orders necessary to carry out the provisions of this chapter.

3 2. Any rule or portion of a rule, as that term is defined in section 536.010, RSMo,
4 that is created under the authority delegated in this section shall become effective only if
5 it complies with and is subject to all of the provisions of chapter 536, RSMo, and, if
6 applicable, section 536.028, RSMo. This section and chapter 536, RSMo, are nonseverable
7 and if any of the powers vested with the general assembly pursuant to chapter 536, RSMo,
8 to review, to delay the effective date, or to disapprove and annul a rule are subsequently
9 held unconstitutional, then the grant of rulemaking authority and any rule proposed or
10 adopted after August 28, 2006, shall be invalid and void.

 381.045. 1. If the director determines that a person has engaged, is engaging, or is
2 about to engage in a violation of this chapter or a rule adopted or order issued pursuant
3 thereto, or a person has materially aided, is materially aiding, or is about to materially aid
4 an act, practice, omission, or course of business constituting a violation of this act or a rule
5 adopted or order issued pursuant thereto, the director may issue such administrative
6 orders as authorized under section 374.046, RSMo. The director of insurance may also
7 suspend or revoke the license of a producer under 375.141, RSMo, or the certificate of
8 authority of any title insurer as authorized under section 374.047, RSMo, for any such
9 willful violation.

10 2. If the director believes that a person has engaged, is engaging, or is about to
11 engage in a violation of this chapter or a rule adopted or order issued pursuant thereto, or
12 that a person has materially aided, is materially aiding, or is about to materially aid an act,
13 practice, omission, or course of business constituting a violation of this act or a rule
14 adopted or order issued pursuant thereto, the director may maintain a civil action for relief
15 authorized under section 374.048, RSMo.

16 3. Nothing contained in this section shall affect the right of the director to impose
17 any other penalties provided for in the laws relating to the business of insurance.

18 4. Nothing contained in this chapter is intended to or shall in any other manner
19 limit or restrict the rights of policyholders, claimants, and creditors.

381.048. 1. The director may bring an action in a court of competent jurisdiction to enjoin violations of the Real Estate Settlement Procedures Act, 12 U.S.C. Section 2607, as amended.

2. A violation of any provision under the federal Real Estate Settlement Procedures Act, as amended, is a level two violation under section 374.049, RSMo.

381.052. No person other than a domestic, foreign, or non-United States title insurer organized on the stock plan and duly licensed by the director shall transact title insurance business as an insurer in this state.

381.055. Subject to the exceptions and restrictions contained in this chapter, a title insurer shall have the power to:

(1) Do only title insurance business;

(2) Reinsure title insurance policies; and

(3) Perform ancillary activities, unless prohibited by the director, including examining titles to property and any interest in property and procuring and furnishing related information and information about relevant real and personal property, when not in contemplation of, or in conjunction with, the issuance of a title insurance policy.

381.058. 1. No insurer that transacts any class, type, or kind of business other than title insurance shall be eligible for the issuance or renewal of a license to transact the business of title insurance in this state nor shall title insurance be transacted, underwritten, or issued by any insurer transacting or licensed to transact any other class, type, or kind of business.

2. A title insurer shall not engage in the business of guaranteeing payment of the principal or the interest of bonds or mortgages.

3. (1) Notwithstanding subsection 1 of this section, and to the extent such coverage is lawful within this state, a title insurer is required to issue closing or settlement protection to the buyer, lender, and seller's interest if the title insurer issues a commitment, binder, or title insurance policy. Such closing or settlement protection shall conform to the terms of coverage and form of instrument as required by the director and may indemnify a proposed insured solely against loss of settlement funds only because of the following acts of a title insurer's named title agency or title agent:

(a) Theft or other improper acts or omissions with regard to escrow or settlement funds; and

(b) Failure to comply with written closing instructions by the proposed insured when agreed to by the title agency or title agent relating to title insurance coverage.

(2) The charge for issuance of the closing or settlement protection letter shall be filed as a rate with the director under section 381.032 as a component of the premium. The

21 entire charge for the closing or settlement protection letter shall be retained by the title
22 insurer.

23 (3) A title insurer shall not provide any other coverage which purports to indemnify
24 against improper acts or omissions of a person with regard to escrow, settlement, or closing
25 services.

381.062. In order to be licensed to do an insurance business in this state, a title
2 insurer shall establish and maintain a minimum paid-in capital of not less than eight
3 hundred thousand dollars and, in addition, surplus of at least eight hundred thousand
4 dollars.

381.065. 1. The net retained liability of a title insurer for a single risk in regard to
2 property located in this state, whether assumed directly or as reinsurance, shall not exceed
3 the aggregate of fifty percent of surplus as regards policyholders plus the statutory
4 premium reserve less the company's investment in title plants, all as shown in the most
5 recent annual statement of the insurer on file with the director.

6 2. For purposes of this chapter:

7 (1) A single risk shall be the insured amount of any title insurance policy, except
8 that, where two or more title insurance policies are issued simultaneously covering
9 different estates in the same real property, a single risk shall be the sum of the insured
10 amounts of all the title insurance policies; and

11 (2) A policy under which a claim payment reduces the amount of insurance under
12 one or more other title insurance policies shall be included in computing the single risk sum
13 only to the extent that its amount exceeds the aggregate amount of the policy or policies
14 whose amount of insurance is reduced.

15 3. A title insurer may obtain reinsurance for all or any part of its liability under its
16 title insurance policies or reinsurance agreements and may also reinsure title insurance
17 policies issued by other title insurers on single risks located in this state or elsewhere.
18 Reinsurance on policies issued on properties located in this state may be obtained from any
19 title insurers licensed to transact title insurance business in this state, any other state, or
20 the District of Columbia and which have a combined capital and surplus of at least one
21 million six hundred thousand dollars.

22 4. The director may waive the limitation of this section for a particular risk upon
23 application of the title insurer and for good cause shown.

381.068. In determining the financial condition of a title insurer doing business
2 under this chapter, the general investment provisions of sections 379.080 to 379.082, RSMo,
3 shall apply; except that, an investment in a title plant or plants in an amount equal to the
4 actual cost shall be allowed as an admitted asset for title insurers. The aggregate amount

5 of the investment shall not exceed twenty percent of surplus to policyholders, as shown on
6 the most recent annual statement of the title insurer on file with the director.

381.072. 1. In determining the financial condition of a title insurer doing business
2 under this chapter, the general provisions of the laws regulating the business of insurance
3 requiring the establishment of reserves sufficient to cover all known and unknown
4 liabilities including allocated and unallocated loss adjustment expense, shall apply; except
5 that, a title insurer shall establish and maintain:

6 (1) (a) A known claim reserve in an amount estimated to be sufficient to cover all
7 unpaid losses, claims, and allocated loss adjustment expenses arising under title insurance
8 policies for which the title insurer may be liable, and for which the insurer has discovered
9 or received notice by or on behalf of the insured or escrow or security depositor;

10 (b) Upon receiving notice from or on behalf of the insured of a title defect in or lien
11 or adverse claim against the title of the insured that may result in a loss or cause expense
12 to be incurred in the proper disposition of the claim, the title insurer shall determine the
13 amount to be added to the reserve, which amount shall reflect a careful estimate of the loss
14 or loss expense likely to result by reason of the claim;

15 (c) Reserves required under this section may be revised from time to time and shall
16 be redetermined at least once each year;

17 (2) A statutory or unearned premium reserve established and maintained as
18 follows:

19 (a) A domestic title insurer shall establish and maintain an unearned premium
20 reserve computed in accordance with this section, and all sums attributed to such reserve
21 shall at all times and for all purposes be considered and constitute unearned portions of
22 the original premiums. This reserve shall be reported as a liability of the title insurer in
23 its financial statements;

24 (b) The unearned premium reserve shall be maintained by the title insurer for the
25 protection of holders of title insurance policies. Except as provided in this section, assets
26 equal in value to the reserve are not subject to distribution among creditors or stockholders
27 of the title insurer until all claims of policyholders or claims under reinsurance contracts
28 have been paid in full, and all liability on the policies or reinsurance contracts has been
29 paid in full and discharged or lawfully reinsured;

30 (c) The unearned premium reserve shall consist of:

31 a. The amount of the unearned premium reserve on August 28, 2006; and

32 b. A sum equal to fifteen cents for each one thousand dollars of net retained
33 liability under each title insurance policy, excluding mortgagee's policies simultaneously

34 issued with owner's policies or owner's leasehold policies of the same or greater amount,
35 on a single risk written on properties located in this state and issued after August 28, 2006;

36 (d) Amounts placed in the unearned premium reserve in any year in accordance
37 with paragraph (c) of this subdivision shall be deducted in determining the net profit of the
38 title insurer for that year;

39 (e) A title insurer shall release from the unearned premium reserve a sum equal to
40 ten percent of the amount added to the reserve during a calendar year on July first of each
41 of the five years following the year in which the sum was added, and shall release from the
42 unearned premium reserve a sum equal to three and one-third percent of the amount
43 added to the reserve during that year on each succeeding July first until the entire amount
44 for that year has been released. The amount of the unearned premium reserve or similar
45 unearned premium reserve maintained before August 28, 2006, shall be released in
46 accordance with the law in effect immediately before August 28, 2006;

47 (f) a. Each domestic and foreign title insurer shall file annually with the audited
48 financial report required under section 375.1032, RSMo, an actuarial certificate made by
49 a member in good standing of the American Academy of Actuaries, or by an actuary
50 permitted to make such certificate by the commissioner, superintendent or director of the
51 department of insurance of the state of incorporation of a foreign title insurer;

52 b. The actuarial certification shall conform to the annual statement instructions for
53 title insurers adopted by the National Association of Insurance Commissioners and shall

55 annual statement. The reserves analyzed under this section shall include reserves for
56 known claims, including adverse developments on known claims, and reserves for incurred

58 (g) Each domestic and foreign title insurer shall establish a supplemental reserve
59 in the amount by which the actuarially certified reserves exceed the total of the known
60 claim reserve and statutory premium reserve as set forth in the title insurer's annual
61 financial report, subject to this subdivision.

62 2. A foreign or alien title insurer licensed to transact title insurance business in this
63 state shall maintain at least the same reserves on title insurance policies issued on
64 properties located in this state as are required of domestic title insurers, unless the laws of
65 the jurisdiction of domicile of the foreign or alien title insurer require a higher amount.

381.075. 1. Sections 375.570 to 375.750, RSMo, and sections 375.1150 to 375.1246,
2 RSMo, shall apply to all title insurers subject to this chapter, except as otherwise provided
3 in this section. In applying such sections, the court shall consider the unique aspects of title

4 insurance and shall have broad authority to fashion relief that provides for the maximum
5 protection of the title insurance policyholders.

6 2. Security and escrow funds held by or on behalf of the title insurer shall not
7 become general assets and shall be administered as secured claims as defined in section
8 375.1152, RSMo.

9 3. Title insurance policies that are in force at the time an order of liquidation is
10 entered shall not be canceled except upon a showing to the court of good cause by the
11 liquidator. The determination of good cause shall be within the discretion of the court. In
12 making this determination, the court shall consider the unique aspects of title insurance
13 and all other relevant circumstances.

14 4. The court may set appropriate dates that potential claimants must file their
15 claims with the liquidator. The court may set different dates for claims based upon the title
16 insurance policy than for all other claims. In setting dates, the court shall consider the
17 unique aspects of title insurance and all other relevant circumstances.

18 5. As of the date of the order of insolvency or liquidation, all premiums paid, due
19 or to become due under policies of the title insurers, shall be fully earned. It shall be the
20 obligation of title agencies, title agents, insureds, or representatives of the title insurer to
21 pay fully earned premium to the liquidator or rehabilitator.

381.076. As a condition of doing business in this state, each title insurer shall be
2 liable for an assessment to pay all unpaid title insurance claims, including claims under
3 section 381.027, on real property in this state for any title insurer which is liquidated with
4 unpaid outstanding claims. The director, as receiver, shall assess all title insurers on a pro
5 rata basis determined by their writings in this state for amounts necessary to pay the
6 claims. A title insurer is not required to pay an amount in excess of one-tenth of its surplus
7 as to policyholders.

381.085. 1. A title insurer shall not deliver or issue for delivery or permit any of
2 its authorized title agencies or title agents to deliver in this state, any form, in connection
3 with title insurance written, unless it has been filed with the director thirty days prior to

5 2. Forms covered by this section shall include:

6 (1) Title insurance policies, including standard form endorsements;

7 (2) Title insurance commitments issued prior to the issuance of a title insurance
8 policy; and

9 (3) Closing or settlement protection letters.

10 3. Any term or condition related to an insurance coverage provided by an approved
11 title insurance policy or any exception to the coverage, except those ascertained from a

12 search and examination of records relating to a title or inspection or survey of a property
13 to be insured, may only be included in the policy after the term, condition or exception has
14 been filed with the director and approved as herein provided.

381.112. For purposes of the premium tax imposed by sections 148.320 and 148.340,
2 RSMo, the premium income received by a title insurer shall mean the amount within the
3 definition of "premium" contained in section 381.009.

381.113. 1. A policy issuance fee to be established by rule of the director, but no
2 more than two dollars, is imposed on each title insurer for every title insurance policy
3 issued in the state of Missouri. The policy fee is not a tax and shall be reported and paid
4 separately from premium and retaliatory taxes.

5 2. All funds received under the provisions of this section shall be transmitted by the
6 director of the department of insurance to the department of revenue for deposit in the
7 state treasury to the credit of the department of insurance dedicated fund established
8 under section 374.150, RSMo. Expenditures necessitated by this act may be paid from
9 funds appropriated from the department of insurance dedicated fund by the general

11 3. The director may promulgate rules setting forth the standards for remittance of
12 the policy fees. Any rule or portion of a rule, as that term is defined in section 536.010,
13 RSMo, that is created pursuant to the authority delegated in this section shall become
14 effective only if it complies with and is subject to all of the provisions of chapter 536,
15 RSMo, and, if applicable, section 536.028, RSMo. This section and chapter 536, RSMo, are
16 nonseverable and if any of the powers vested with the general assembly pursuant to
17 chapter 536, RSMo, to review, to delay the effective date, or to disapprove and annul a rule
18 are subsequently held unconstitutional, then the grant of rulemaking authority and any
19 rule proposed or adopted after August 28, 2006, shall be invalid and void.

381.115. 1. It is unlawful for any person to act in the capacity of a title agency,
2 unless the person is a licensed business entity producer under subsection 2 of section
3 375.015, RSMo.

4 2. It is unlawful for any person to act in the capacity of a title agent, unless the
5 person is a licensed individual producer under subsection 1 of section 375.015, RSMo.

6 3. It is unlawful for any title insurer to contract with any person to act in the
7 capacity of a title agency or title agent with respect to risks located in this state unless the
8 person is licensed as required in this section.

9 4. An individual employed by a title insurer, or licensed title agency, or title agent
10 to whom the insurer, agency, or agent delegates authority to act on that agency's or agent's
11 behalf shall be individually licensed as an individual producer under subsection 1 of

12 section 375.015, RSMo, if such employee performs any of the functions defined in
13 subdivision (24) of section 381.009. The director may adopt rules, regulations, and
14 requirements relating to licensing and practices of persons acting in the capacity of title
15 agencies or agents. These persons may include title agencies, title agents, employees of title
16 insurers, title agencies, or title agents, and persons acting on behalf of title insurers, title
17 agencies, or title agents. This subsection is not intended to include persons performing
18 clerical functions.

19 5. Every title agency licensed in this state shall:

20 (1) Exclude or eliminate the word insurer, insurance company, or underwriter from
21 its business name, unless the word agency is also included as part of the name; and

22 (2) Provide, in a timely fashion, each title insurer with which it places business any
23 information the title insurer requests in order to comply with reporting requirements of
24 the director.

25 6. A title agency or title agent licensed in this state prior to the effective date of this
26 chapter shall have ninety days after the effective date of this chapter to comply with the
27 requirements of this section.

28 7. If the title insurer, agency, or title agent delegates the title search to a third party,
29 such as an abstract company, the insurer, agency, or agent must first obtain proof that the
30 third party is operating in compliance with rules and regulations established by the
31 director and the third party shall provide the insurer, agency, or agent with access to and
32 the right to copy all accounts and records maintained by the third party with respect to
33 business placed with the title insurer. Proof from the third party may consist of a signed
34 statement indicating compliance, and shall be effective for a three-year period.

35 8. A violation of any provision under this section is a level three violation under
36 section 374.049, RSMo.

381.118. 1. Each title agency shall designate an individual as a qualified principal,
2 who as a condition of licensure, shall successfully pass an examination developed by the
3 producer advisory board established by section 375.019, RSMo, and approved by the
4 director. Each title agent shall successfully pass an examination developed by the producer
5 advisory board and approved by the director. Upon request by a title agency or agent and
6 for good cause, the director, by order, may waive the requirements of this subsection.

7 2. Each title agent licensed to sell title insurance in this state, unless exempt under
8 subsection 8 of this section, shall successfully complete courses of study as required by this
9 section. Any person licensed to act as a title agent shall, during each two years, attend
10 courses or programs of instruction or attend seminars equivalent to a minimum of sixteen

11 hours of instruction. The initial such two-year period shall begin January first of the year
12 next following the effective date of this chapter.

13 3. Subject to approval by the director, the courses or programs of instruction which
14 shall be deemed to meet the director's standards for continuing educational requirements
15 shall include, but not be limited to, the following:

16 (1) An insurance-related course taught by an accredited college or university or
17 qualified instructor who has taught a course of insurance law at such institution;

18 (2) A course or program of instruction or seminar developed or sponsored by any
19 authorized insurer, recognized agents' association or insurance trade association. A local
20 agents' group may also be approved if the instructor receives no compensation for services;

21 (3) Courses approved for continuing legal education credit by the Missouri Bar.

22 4. A person teaching any approved course of instruction or lecturing at any
23 approved seminar shall qualify for one and one-half times the number of classroom hours
24 as would be granted to a person taking and successfully completing such course, seminar
25 or program, but the credit may be credited no more than once a year.

26 5. Excess classroom hours accumulated during any two-year period may be carried
27 forward to the two-year period immediately following the two-year period in which the
28 course, program, or seminar was held.

29 6. For good cause shown, the director may grant an extension of time during which
30 the educational requirements imposed by this section may be completed, but such extension
31 of time shall not exceed the period of one calendar year. The director may grant an
32 individual waiver of the mandatory continuing education requirement upon a showing by
33 the licensee that it is not feasible for the licensee to satisfy the requirements prior to the
34 renewal date. Waivers may be granted for reasons including, but not limited to:

35 (1) Serious physical injury or illness;

36 (2) Active duty in the armed services for an extended period of time;

37 (3) Residence outside the United States; or

38 (4) Licensee is at least seventy years of age and is currently licensed as a title agent.

39 7. Every person subject to the provisions of this section shall furnish in a form
40 satisfactory to the director, written certification as to the courses, programs, or seminars
41 of instruction taken and successfully completed by such person. A filing fee shall be paid
42 by the person furnishing the report as determined by the director to be necessary to cover
43 the administrative cost related to the handling of such certification reports, subject to the
44 limitations imposed in subsection 9 of this section.

45 8. The provisions of this section shall not apply to those natural persons holding or
46 applying for a license to act as a title agent in Missouri who reside in a state that has

47 enacted and implemented a mandatory continuing education law or regulation pertaining
48 to title agents. However, those natural persons holding or applying for a Missouri agent
49 license who reside in states which have no mandatory continuing education law or
50 regulations shall be subject to all the provisions of this section to the same extent as

52 9. Rules necessary to implement and administer this section shall be promulgated
53 by the director of the department of insurance, including, but not limited to, rules
54 regarding the following:

55 (1) The producer advisory board established by section 375.019, RSMo, shall be
56 utilized by the director to assist the director in determining acceptable content of courses,
57 programs and seminars to include classroom equivalency;

58 (2) Every applicant seeking approval by the director of a continuing education
59 course under this section shall pay to the director a filing fee of fifty dollars per course,
60 except that such total fee shall not exceed two hundred fifty dollars per year for any single
61 applicant. Fees shall be waived for local agents' groups if the instructor receives no
62 compensation for services. Such fee shall accompany any application form required by the
63 director. Courses shall be approved for a period of no more than one year. Applicants
64 holding courses intended to be offered for a longer period must reapply for approval;

65 (3) The director has the authority to determine the amount of the filing fee to be
66 paid by title agents at the time of license renewal, which shall be set at an amount to
67 produce revenue which shall not substantially exceed the cost of administering this section,
68 but in no event shall such fee exceed ten dollars per biennial report filed.

69 10. All funds received under the provisions of this section shall be transmitted by
70 the director of the department of insurance to the department of revenue for deposit in the
71 state treasury to the credit of the department of insurance dedicated fund. All
72 expenditures required by this section shall be paid from funds appropriated from the
73 department of insurance dedicated fund by the general assembly.

74 11. When a title agent pays his or her biennial renewal fee, such agent shall also
75 furnish the written certification and filing fee required by this section.

76 12. Any rule or portion of a rule, as that term is defined in section 536.010, RSMo,

381.122. The director may during normal business hours examine, audit and
2 inspect any and all books and records maintained by a title agency, title insurance agency,
3 title agent, or title insurance agent under this chapter.

381.125. 1. Whenever the business to be written constitutes affiliated business,
2 prior to commencing the transaction, the title insurer, title agency, or title agent shall
3 ensure that its customer has been provided with disclosure of the existence of the affiliated
4 business arrangement and a written estimate of the charge or range of charges generally
5 made for the title services provided by the title insurer, title agency, or agent.

381.412. 1. A settlement agent who accepts funds for closing a sale of an interest in real estate shall require a buyer, seller or lender who is not a financial institution to convey such funds to the settlement agent as certified funds. A check:

(1) Drawn on an escrow account of a licensed real estate broker, as regulated and described in section 339.105, RSMo;

(2) Drawn on an escrow account of a title insurer or title insurance agency licensed to do business in Missouri;

(15) "Net retained liability", the total liability retained by a title insurer for a single risk, after taking into account any ceded liability and collateral, acceptable to the director, and maintained by the insurer;

(17) "Premium", the consideration paid by or on behalf of the insured for the issuance of a title insurance policy or any endorsement or special coverage. It does not include consideration paid for settlement or escrow services or noninsurance-related information services;

(b) Regulated, supervised and examined by federal or state authorities having regulatory authority over banks and trust companies;

The notice shall explain that a lender's title insurance policy is to be issued protecting the mortgage-lender, and that the policy does not provide title insurance protection to the purchaser-mortgagor as the owner of the property being purchased. 2 [381.031. As used in sections 381.011 to 381.241, the following terms

4 (1) "Alien title insurer", any title insurer incorporated or organized under
5 the laws of any foreign nation or any province or territory thereof;

6 (2) "Applicant", a person, whether or not a prospective insured, who
7 applies to a title insurer or title agent, or agency for a title insurance policy and
8 who, at the time of the application, is not a title agent or agency;

A title insurer, before issuing any title insurance policy covering property located in this state, shall deposit with the director of the department of insurance, hereinafter referred to as the director, a sum of four hundred thousand dollars, which shall be held for the security and protection of the holders or beneficiaries under its title insurance policies.

6. If sections 381.011 to 381.241 require a greater amount of capital and surplus or deposits than that required of a title insurer prior to September 28, 1987, such title insurer shall have three years after September 28, 1987, to comply with any such increased requirement.

7. The provisions of sections 375.950 to 375.990, RSMo, shall apply to the impairment of capital, liquidation, and rehabilitation of title insurers.】

2 [381.052. No person other than a domestic, foreign or non-United States
3 title insurer organized on the stock plan and duly licensed by the director shall
4 transact title insurance business as an insurer in this state.]

2 [381.055. Subject to the exceptions and restrictions contained in this
3 chapter, a title insurer shall have the power to:

- 3 (1) Do only title insurance business;
4 (2) Reinsure title insurance policies; and

The records on which the title plant is based on shall show all prior matters affecting the title to the property or interest therein for a continuous period of time of at least:

- (a) The past ten years, by two years after September 28, 1987;

 - (c) The past twenty years, by four years after September 28, 1987; and
 - (d) The past twenty-seven years, by five years after September 28, 1987;

(2) Caused to be made a determination of insurability of title in accordance with sound underwriting practices.

Except when allowed by regulations promulgated by the director, no title insurer, title agent, or agency shall knowingly issue any owner's title insurance policy or commitment to insure without showing all outstanding, enforceable recorded liens or other interests against the title which is to be insured.

3. Evidence of the examination of title and determination of insurability shall be preserved and retained in the files of the title insurer or its title agent or agency for a period of not less than fifteen years after the title insurance policy has been issued. Instead of retaining the original evidence, the title insurer or title agent or agency may in the regular course of business establish a system whereby all or part of the evidence is recorded, copied, or reproduced by any process that accurately and legibly reproduces or forms a durable medium for reproducing the contents of the original.

4. This section shall not apply to:

- (1) A title insurer assuming liability through a contract of reinsurance;
- (2) A title insurer acting as coinsurer if one of the other coinsuring title insurers has complied with this section; or
- (3) Policies of title insurance issued prior to the expiration of one year after September 28, 1987.]

[381.072. In determining the financial condition of a title insurer doing business pursuant to this chapter, the general provisions of the insurance code requiring the establishment of reserves sufficient to cover all known and

4 unknown liabilities including allocated and unallocated loss adjustment expense,

6 (1) (a) A known claim reserve in an amount estimated to be sufficient

b. The actuarial certification shall conform to the annual statement instructions for title insurers adopted by the National Association of Insurance Commissioners and shall include the actuary's professional opinion of the insurer's reserves as of the date of the annual statement. The reserves analyzed pursuant to this section shall include reserves for known claims, including adverse developments on known claims, and reserves for incurred but not reported claims;

(g) a. Each domestic and foreign title insurer shall establish a supplemental reserve in the amount by which the actuarially certified reserves exceed the total of the known claim reserve and statutory premium reserve as set forth in the title insurer's annual financial report, subject to this subdivision;

b. The supplemental reserve required pursuant to this section shall be phased in as follows:

i. Twenty-five percent of the otherwise applicable supplemental reserve is required until December thirty-first of the year next following January 1, 2001;

ii. Fifty percent of the otherwise applicable supplemental reserve is required until December thirty-first of the second year following January 1, 2001;

iii. Seventy-five percent of the otherwise applicable supplemental reserve is required until December thirty-first of the third year following January 1, 2001;

iv. One hundred percent of the supplemental reserve is required after December thirty-first of the fourth year following January 1, 2001.]

[381.075. 1. Sections 375.570 to 375.750, RSMo, and sections 375.1150 to 375.1246, RSMo, shall apply to all title insurers subject to the title insurance act, except as otherwise provided in this section. In applying such sections, the court shall consider the unique aspects of title insurance and shall have broad authority to fashion relief that provides for the maximum protection of the title insurance policyholders.

2. Security and escrow funds held by or on behalf of the title insurer shall not become general assets and shall be administered as secured claims as defined in section 375.1152, RSMo.

3. Title insurance policies that are in force at the time an order of liquidation is entered shall not be canceled except upon a showing to the court of good cause by the liquidator. The determination of good cause shall be within the discretion of the court. In making this determination, the court shall consider the unique aspects of title insurance and all other relevant circumstances.

4. The court may set appropriate dates that potential claimants must file their claims with the liquidator. The court may set different dates for claims based upon the title insurance policy than for all other claims. In setting dates, the court shall consider the unique aspects of title insurance and all other relevant circumstances.

5. As of the date of the order of insolvency or liquidation, all premiums paid, due or to become due under policies of the title insurers, shall be fully earned. It shall be the obligation of title agencies, title agents, insureds or representatives of the title insurer to pay fully earned premium to the liquidator or rehabilitator.}]

[381.078. A title insurer shall only declare or distribute a dividend to shareholders with the prior written approval of the director, as would be permitted pursuant to subdivision (1) of subsection 1 of section 382.210, RSMo.]

[381.081. 1. A domestic title insurer shall establish and maintain an unearned premium reserve computed in accordance with this section, and all sums attributed to such reserve shall at all times and for all purposes be considered and constitute unearned portions of the original premiums. This reserve shall be reported as a liability of the title insurer in its financial statements.

2. The unearned premium reserve shall be maintained by the title insurer for the protection of holders of title insurance policies. Except as provided in this section, assets equal in value to the reserve are not subject to distribution among creditors or stockholders of the title insurer until all claims of policyholders or claims under reinsurance contracts have been paid in full, and all liability on the policies or reinsurance contracts has been paid in full and discharged or lawfully reinsured.

3. A foreign or alien title insurer licensed to transact title insurance business in this state shall maintain at least the same reserves on title insurance policies issued on properties located in this state as are required of domestic title insurers, unless the laws of the jurisdiction of domicile of the foreign or alien title insurer require a higher amount.

4. The unearned premium reserve shall consist of:

(1) The amount of the unearned premium reserve on September 28, 1987; and

(2) A sum equal to fifteen cents for each one thousand dollars of net retained liability under each title insurance policy, excluding mortgagee's policies

simultaneously issued with owner's policies or owner's leasehold policies of the same or greater amount, on a single risk written on properties located in this state and issued after September 28, 1987.

5. Amounts placed in the unearned premium reserve in any year in accordance with subdivision (2) of subsection 4 of this section shall be deducted in determining the net profit of the title insurer for that year.

6. A title insurer shall release from the unearned premium reserve a sum equal to ten percent of the amount added to the reserve during a calendar year on July first of each of the five years following the year in which the sum was added, and shall release from the unearned premium reserve a sum equal to three and one-third percent of the amount added to the reserve during that year on each succeeding July first until the entire amount for that year has been released. The amount of the unearned premium reserve or similar unearned premium reserve maintained before September 28, 1987, shall be released in accordance with the law in effect immediately before September 28, 1987.]

[381.085. 1. A title insurer or authorized rate service organization shall not deliver or issue for delivery or permit any of its authorized title agencies or title agents to deliver in this state, any form, in connection with title insurance written, unless it has been filed with the director and approved by the director or thirty days have elapsed and it has not been disapproved as misleading or violative of public policy. Each violation of this subsection is a class C violation as that term is defined in section 381.045.

2. Forms covered by this section shall include:

(1) Title insurance policies, including standard form endorsements; and

(2) Title insurance commitments issued prior to the issuance of a title insurance policy.

3. After notice and opportunity to be heard are given to the insurer or rate service organization which submitted a form for approval, the director may withdraw approval of the form on finding that the use of the form is contrary to the legal requirements applicable at the time of withdrawal. The effective date of withdrawal of approval shall not be less than ninety days after notice of withdrawal is given.

4. Any term or condition related to an insurance coverage provided by an approved title insurance policy or any exception to the coverage, except those ascertained from a search and examination of records relating to a title or inspection or survey of a property to be insured, may only be included in the policy after the term, condition or exception has been filed with the director and approved as herein provided.]

[381.088. 1. A title insurer may satisfy its obligation to file premium rates, rating manuals and forms as required by this chapter by becoming a member of, or a subscriber to, a rate service organization, organized and licensed

pursuant to the provisions of this chapter, where the organization makes the filings, and by authorizing the director in writing to accept the filings on the insurer's behalf.

2. Nothing in this chapter shall be construed as requiring any title insurer, title agency or title agent to become a member of, or a subscriber to, any rate service organization. Nothing in this chapter shall be construed as prohibiting the filing of deviations from rate service organization filings by any member or subscriber.]

[381.091. 1. If a domestic title insurer becomes insolvent, is in the process of liquidation or dissolution, or is in the possession of the director:

(1) Such amount of the assets of such title insurer equal to the unearned premium reserve then remaining may be used by or with the written approval of the director to pay for reinsurance of the liability of such title insurer upon all outstanding title insurance policies or reinsurance agreements to the extent to which claims for losses by the holders thereof are not then pending. The balance of assets, if any, equal to the unearned premium reserve, may then be transferred to the general assets of the title insurer;

(2) The net assets of the unearned premium reserve shall be available to pay claims for losses sustained by holders of title insurance policies then pending or arising up to the time reinsurance is effected. If claims for losses exceed such other assets of the title insurer, such claims, when established, shall be paid pro rata out of the surplus assets attributable to the unearned premium reserve to the extent of such surplus, if any.

2. If reinsurance is not obtained, assets equal to the unearned premium reserve and assets constituting minimum capital, or so much as remains thereof after outstanding claims have been paid, shall constitute a trust fund to be held and invested by the director for twenty years, out of which claims of policyholders shall be paid as they arise. The balance, if any, of the trust fund shall, at the expiration of twenty years, revert to the general assets of the title insurer.]

[381.092. 1. Every title insurer that shall propose its own premium rates and every title insurance rating organization shall propose premium rates that are not excessive nor inadequate for the safety and soundness of any title insurer, which do not unfairly discriminate between risks in this state which involve essentially the same exposure to loss and expense elements, and which shall give due consideration to the following matters:

- (1) The desirability for stability and responsiveness of rate structures;
- (2) The necessity of assuring the financial solvency of title insurance companies in periods of economic depression;
- (3) The necessity for paying dividends on the capital stock of title insurance companies sufficient to induce capital to be invested therein; and

12 (4) A reasonable level of profit for the insurer.

13 2. Every title insurer that shall propose its own rates and every title
14 insurance rating organization may adopt basic classifications of policies or
15 contracts of title insurance which shall be used as the basis for rates.]

[381.095. 1. If the director shall find in his review of rate filings that the
2 filings provide for, result in, or produce rates that are not unreasonably high, and
3 are not inadequate for the safeness and soundness of the insurer, and are not
4 unfairly discriminatory between risks in this state involving essentially the same
5 hazards and expense elements, the director shall approve such rates. Prior to
6 such approval the director may conduct a public hearing with respect to a rate
7 filing. An approval shall continue in effect until the director shall issue an order
8 of disapproval pursuant to the requirements and procedure provided for in

37 director finds that such filing or a part thereof fails to meet the requirements of
38 this chapter, stating when within a reasonable period thereafter, such filing or a

39 part thereof shall be deemed no longer effective. Copies of such order shall be
40 sent to the applicant and to every such title insurer and title insurance rating
41 organization. The order shall not affect any contract or policy made or issued
42 prior to the expiration of the period set forth in the order.]

2 [381.098. 1. A corporation, an unincorporated association, a partnership
3 or an individual, whether located within or outside this state, may make
4 application to the director for license as a rating organization for title insurers,
5 and shall file therewith:

6 (1) A copy of its constitution, its articles of agreement or association or
7 its certificate of incorporation, and of its bylaws, rules and regulations governing
8 the conduct of its business;

9 (2) A list of its members and subscribers;

10 (3) The name and address of a resident of this state upon whom notices
11 or orders of the director or process affecting such rating organization may be

15 2. If the director finds that the applicant is competent, trustworthy and
16 otherwise qualified to act as a rating organization, and that its constitution,

47 subscribership within thirty days after it was made, the title insurance company
48 may request a review by the director as if the application had been rejected. If the
49 director finds that the title insurance company has been refused admittance to the
50 title insurance rating organization as a subscriber without justification, the
51 director shall order such rating organization to admit the title insurance company
52 as a subscriber. If the director finds that the action of the title insurance rating
53 organization was justified, the director shall make an order affirming its action.】

2 [381.101. 1. All title insurers licensed in this state shall establish and
maintain reserves against unpaid losses and loss expenses.

3 2. Upon receiving notice from or on behalf of the insured of a title defect
4 in or lien or adverse claim against the title of the insured that may result in a loss
5 or cause expense to be incurred in the proper disposition of the claim, the title
6 insurer shall determine the amount to be added to the reserve, which amount shall
7 reflect a careful estimate of the loss or loss expense likely to result by reason of
8 the claim.

9 3. Reserves required under this section may be revised from time to time
10 and shall be redetermined at least once each year.】
11

2 [381.102. Every member of or subscriber to a title insurance rating
organization shall adhere to the filings made on its behalf by such organization,
3 except that any title insurance company which is a member of or subscriber to
4 such a rating organization may file with the director a uniform percentage of
5 decrease or increase to be applied to any or all elements of the fees produced by
6 the rating system so filed for a class of title insurance which is found by the
7 director to be a proper rating unit for the application of such uniform decrease or
8 increase, or to be applied to the rates for a particular area, or otherwise deviate
9 from the rating plans, policy forms or other matters which are the subject of
10 filings pursuant to this chapter. Such deviation filing shall specify the basis for
11 the modification and shall be accompanied by the data or historical pattern upon
12 which the applicant relies. A copy of the deviation filing and data shall be sent
13 simultaneously to such rating organization. Deviation filings shall be subject to
14 the provisions of section 381.095.】

2 [381.105. 1. Any member of or subscriber to a title insurance rating
3 organization may appeal to the director from any action or decision of such rating
4 organization in approving or rejecting any proposed change in or addition to the
5 filings of such rating organization, and the director shall, after a hearing held
6 upon not less than ten days' written notice to the appellant and to such rating
7 organization, issue an order approving the action or decision of such rating
8 organization or directing it to give further consideration to such proposal and to
9 take action or make a decision upon it within thirty days. If such appeal is from
10 the action or decision of the title insurance rating organization in rejecting a
11 proposed addition to its filings, the director may, in the event the director finds
12 that such action or decision was unreasonable, issue an order directing the rating
13 organization to make an addition to its filings, on behalf of its members and
14 subscribers, in a manner consistent with the director's findings, within a
15 reasonable time after the issuance of such order. If the appeal is from the action
16 of the title insurance rating organization with regard to a rate or a proposed
17 change in or addition to its filings relating to the character and extent of coverage,

20 made in accordance with this chapter.

21 2. The failure of a title insurance rating organization to take action or
22 make a decision within thirty days after submission to it of a proposal pursuant
23 to this section shall constitute a rejection of such proposal within the meaning of
24 this section. If such appeal is based upon the failure of the rating organization to
25 make a filing on behalf of such member or subscriber which is based on a system
26 of expense allocation which differs from the system of expense allocation
27 included in a filing made by such rating organization, the director shall, if the
28 director grants the appeal, order the rating organization to make the requested
29 filing for use by the appellant. In deciding such appeal, the director shall apply
30 the standards set forth in section 381.032.]

2 [381.108. 1. The director shall promulgate reasonable rules and
3 statistical plans, reasonably adapted to each of the rating systems on file with the
4 department, which may be modified from time to time, and which shall be used
5 thereafter by each title insurer in the recording and reporting of the composition
6 of its business, its loss and countrywide expense experience and those of its title
7 insurance underwriters in order that the experience of all title insurers may be
8 made available, at least annually, in such form and detail as may be necessary to
9 aid him or her in determining whether rating systems comply with the standards
10 set forth in this chapter. Such rules and plans may also provide for the recording
11 of expense experience items which are specially applicable to this state and are

2 [381.112. For purposes of the premium tax imposed by sections 148.320
3 and 148.340, RSMo, the premium income received by a title insurer shall mean
4 the amount of premium actually remitted to the title insurer and shall exclude any

2 [381.115. 1. A person shall not act in the capacity of a title agency or
3 title agent and a title insurer may not contract with any person to act in the
4 capacity of a title agency or title agent with respect to risks located in this state
5 unless the person is a licensed title agency or title agent in this state.

6 2. An individual employed by a licensed title agency or title agent to
7 whom the agency or agent delegates authority to act on that agency's or agent's

5 as a title agent shall, during each two years, attend courses or programs of
6 instruction or attend seminars equivalent to a minimum of eight hours of
7 instruction. The initial such two-year period shall begin January first of the year
8 next following the effective date of this chapter.

9 2. Subject to approval by the director, the courses or programs of
10 instruction which shall be deemed to meet the director's standards for continuing
11 educational requirements shall include, but not be limited to, the following:

12 (1) An insurance-related course taught by an accredited college or
13 university or qualified instructor who has taught a course of insurance law at such
14 institution;

15 (2) A course or program of instruction or seminar developed or
16 sponsored by any authorized insurer, recognized agents' association or insurance

21 3. A person teaching any approved course of instruction or lecturing at
22 any approved seminar shall qualify for the same number of classroom hours as
23 would be granted to a person taking and successfully completing such course,

25 4. Excess classroom hours accumulated during any two-year period may
26 be carried forward to the two-year period immediately following the two- year
27 period in which the course, program or seminar was held.

28 5. For good cause shown, the director may grant an extension of time
29 during which the educational requirements imposed by this section may be
30 completed, but such extension of time shall not exceed the period of one calendar
31 year. The director may grant an individual waiver of the mandatory continuing
32 education requirement upon a showing by the licensee that it is not feasible for
33 the licensee to satisfy the requirements prior to the renewal date. Waivers may

2 [381.121. 1. The deposit required by section 381.051 and the capital,
surplus and unearned premium reserve of domestic title insurers shall be held in

3 either cash or investments now or hereafter permitted to domestic life insurers
4 with regard to their capital, reserve and surplus for reserve deposit.

5 2. A domestic title insurer may invest in title plants. For purposes of
6 determining the financial condition of such title insurer, title plants will be treated
7 as an asset valued at actual cost to the title insurer, not to exceed fifty percent of
8 the surplus as to policyholders as shown on the most recent annual statement of
9 the title insurer.

10 3. Any investment of a domestic title insurer acquired before September
11 28, 1987, and which under such sections, would be considered ineligible as an
12 investment on that date, shall be disposed of within five years of September 28,
13 1987. The director, upon application and proof that forced sale of any such
14 investment would be contrary to the best interests of the title insurer or its
15 policyholders, may extend the period for disposal of the investment for a
16 reasonable time.]

2 [381.122. The director may during normal business hours examine, audit
3 and inspect any and all books and records maintained by a title agency pursuant
4 to this chapter.]

2 [381.125. 1. Whenever the business to be written constitutes affiliated
3 business, prior to commencing the transaction, the title agency or title agent shall
4 ensure that its customer has been provided with disclosure of the existence of the
5 affiliated business arrangement and a written estimate of the charge or range of
6 charges generally made for the title services provided by the title agency or agent.

7 2. The director may establish rules for use by all title agencies in the
8 recording and reporting of the agency's owners and of the agency's ownership
9 interests in other persons or businesses and of material transactions between the
10 parties.

11 3. The director may require each title agency to file on forms prescribed
12 by the director reports setting forth the names and addresses of those persons, if
13 any, that have a financial interest in the agency and who the agency knows or has
14 reason to believe are producers of title insurance business or associates of
15 producers.

16 4. Nothing in this chapter shall be construed as prohibiting affiliated
17 business arrangements in the provision of title insurance business so long as:

18 (1) The title agency, title agent or party making a referral constituting
19 affiliated business, at or prior to the time of the referral, discloses the
20 arrangement and, in connection with the referral, provides the person being
21 referred with a written estimate of the charge or range of charges likely to be
22 assessed and otherwise complies with the disclosure obligations of this section;

23 (2) The person being referred is not required to use a specified title
insurance agency, agent or insurer; and

(3) The only thing of value that is received by the title agency, title agent or party making the referral, other than payments otherwise permitted, is a return on an ownership interest.

For purposes of this subsection, the terms "required use" and "return on an ownership interest" shall have the meaning accorded to them under the Real Estate Settlement Procedures Act (RESPA), 12 U.S.C. Section 2607, as amended and Regulation X, 24 CFR Section 3500, et seq.

5. Each violation of any provision of this section is a class C violation as that term is defined in section 381.045.]

[381.131. Any person who shall be appointed or who shall act as title insurance agent or agency for any title insurance company within this state, or who shall, as title insurance agent or agency, solicit applications, deliver policies and collect premiums thereon, or who shall receive or collect moneys from any source or on any account whatsoever, as agent or agency, for a title insurance company doing business in this state, shall be held responsible in a trust or fiduciary capacity to the company for any money so collected or received by him for such company.]

[381.141. 1. No title insurer or title agent or agency shall:

(1) Pay, directly or indirectly, to the insured or to any other person any commission, any part of its premiums, fees, or other charges; or any other consideration as inducement or compensation for the referral of title business or for performance of any escrow or other service by the title agent or agency; or

(2) Issue any title insurance policy or perform any service in connection with any transaction in which it has paid or intends to pay any commission, rebate or inducement which it knows to be in violation of this section.

2. Nothing in this section shall be construed as prohibiting reasonable payments, other than for the referral of title insurance business, for services actually rendered to either a title insurer or a title agent or agency in connection with title insurance business.

3. Nothing in sections 381.011 to 381.241 shall prohibit any producer or any associate of a producer from referring title business to any title insurer or title insurance agent or agency of his, her or its choice, and if such producer or associate producer has any financial, franchise, or ownership interest in the title insurer, the title insurance agent or agency, from financial, franchise or ownership interest so long as the purchaser is made aware in writing of the relationship between the producer or associate producer and the title agent or agency.]

[381.151. Nothing in sections 381.011 to 381.241 shall be construed as prohibiting the division of premiums and charges between or among a title insurer and its title agent or agency, two or more title insurers, one or more title

insurers and one or more title agents or agencies or two or more title agents or agencies, provided such division of premiums and charges does not constitute:

(1) An unlawful rebate or inducement under the provisions of sections 381.011 to 381.241; or

(2) Payment of a forwarding fee or finder's fee.]

[381.161. 1. No producer or other person, except the person paying the premium for the title insurance, shall require, directly or indirectly, or through any trustee, director, officer, agent, employee, or affiliate, as a condition, agreement, or understanding to selling or furnishing any other person any loan, or extension thereof, credit, sale, property, contract, lease or service, that such other person shall place, any contract of title insurance of any kind through any particular title agent, agency, or title insurer. No title agent, agency, or title insurer shall knowingly participate in any such prohibited plan or transaction. No person shall fix a price charged for such thing or service, or discount from or rebate upon price, on the condition, agreement, or understanding that any title insurance is to be obtained through a particular agent, agency, or title insurer.

2. Any person who violates the provisions of this section, or any title insurer, title agent, or agency who accepts an order for title insurance knowing that it is in violation of the provision of this section shall, in addition to any other action which may be taken by the director, be subject to a fine in an amount equal to five times the premium for the title insurance.]

[381.171. 1. Premiums shall not be inadequate, excessive or unfairly discriminatory.

2. Premiums are excessive if, in the aggregate, they are likely to produce a long run profit that is unreasonably high in relation to the riskiness of the business or if expenses are unreasonably high in relation to the services rendered.

3. Premiums are inadequate if they are clearly insufficient, together with investment income attributable to them, to sustain projected losses and expenses or if continued use of such premiums will have the effect of substantially lessening competition or the effect of tending to create a monopoly.

4. Premiums are unfairly discriminatory if the premium charged for a policy of any particular face amount of liability is higher than the premium for an indential policy within the same classification where such policy has a like face amount or a higher face amount of liability. Premiums within each premium classification may, in the discretion of the title insurer, to a reasonable degree be less than the expenses incurred and the risks assumed in the case of policies of lower face amount of liability and the excess may be charged against policies of higher face amount of liability without rendering the premiums unfairly discriminatory.

5. Premiums may be grouped by classifications into the various types of title policies and endorsements offered. The classifications may be further

divided to produce premiums for individual risks or services within a classification. Those classifications or further divisions may be established based upon any one or more of the following:

(1) The size of a transaction and its effect upon the continuing solvency of the title insurer using the rate in question if a loss should occur;

(2) Expense elements, including management time that would ordinarily be expended in a typical transaction of a particular size;

(3) The geographic location of a transaction, including variation in risk and expense elements attributable thereto;

(4) The individual experience of the insurer and title insurance agent or agency using the rate in question; and

(5) Any other reasonable considerations which may include but not be limited to builder/developer quantity discounts and multiple policy discounts on an individual parcel of property. Those classifications or further divisions thereof shall apply to all risks and services in the business of title insurance under the same or under substantially the same circumstances or conditions.

6. In making or reviewing premiums due consideration shall be given to past and prospective loss experience, to exposure to loss, to underwriting practice and judgment, to past and prospective expenses including amounts paid to or retained by title agents or agencies, to a reasonable margin for profit and contingencies taking into account the need for a reasonable return on capital committed to the enterprise, and to all other relevant factors both within and outside of this state.

7. The director may promulgate rules or regulations setting forth guidelines for the evaluation of premiums. Such regulations may include consideration of:

(1) Cost of underwriting risks assumed by the insurer;

(2) Amounts paid to or retained by title agents;

(3) Operating expenses of the insurer other than underwriting and claims expense;

(4) Payment of claims and claim related expenses;

(5) Investment income;

(6) Reasonable profit;

(7) Premium taxes; and

(8) Any other factors the director deems relevant.]

[381.181. 1. Every title insurer shall file with the director its premium schedules it proposes to use in any county of this state. Every filing shall set forth its effective date, which shall not be earlier than the thirtieth day following its receipt by the director, and shall indicate the character and extent of the coverages and services contemplated. Filings that the director has not disapproved within thirty days of filing shall be deemed effective.

7 2. No title insurer or title agent or agency may use or collect any premium
8 after September 28, 1987, except in accordance with the premium schedules filed
9 with the director as required by subsections 1 and 2 of this section. The director
10 may provide by regulation for interim use of premium schedules in effect prior

12 3. Every title insurer shall establish basic classifications of coverages to

 [381.201. 1. No title insurer, title agent, or agency shall use any premium
2 in the business of title insurance prior to its effective date nor prior to the filing
3 with respect to such premium having been publicly displayed and made readily
4 available to the public for a period of not less than thirty days in each office of
5 the title insurer, title agent, or agency in the county to which such rates apply, and
6 no premium increase shall apply to title policies which have been contracted for
7 prior to such effective date.

8 2. Premium charges in excess of those set forth in a premium filing which has
9 become effective may be made when such filing includes a statement that such
10 premiums may be made in the event unusual insurance risks are assumed or
11 unusual services performed in the transaction of the business of title insurance,
12 provided that such premiums are reasonably commensurate with the risks
13 assumed for the costs of the services performed.

14 3. Copies of the schedules of premiums which are required to be filed with
15 the director under the provisions of sections 381.011 to 381.241, showing their
16 effective date or dates, shall be kept at all times available to the public and
17 prominently displayed in a public place in each office of a title insurer, title agent,
18 or agency in the county to which such rates apply while such rates are effective.]]

 [381.211. Every title insurer shall file with the director copies of the
2 following forms it proposes to use in this state, including:

- 3 (1) Title insurance policies;
4 (2) Standard form endorsements; and
5 (3) Preliminary reports, commitments, binders, or any other reports
6 issued prior to the issuance of a title insurance policy.]
7

 [381.221. For purposes of the premium tax imposed by sections 148.320
2 and 148.340, RSMo, the premium income received by a title insurer shall be one
3 hundred percent of the amounts paid by or on behalf of the insured as

4 "premiums" within the definition of that term contained in sections 381.011 to
5 381.241.]

2 [381.231. In addition to any other powers granted under sections 381.011
3 to 381.241, the director may adopt rules or regulations to protect the interests of
4 the public including, but not limited to, regulations governing sales practices,
5 escrow, collection, settlement, closing procedures, policy coverage standards,
6 rebates and inducements, controlled business, the approval of agency contracts,
7 unfair trade practices and fraud, statistical plans for data collection, consumer
8 education, any other consumer matters, the business of title insurance, or any
9 regulations otherwise implementing or interpreting the provisions of sections

2 [381.241. 1. The director of insurance or his duly authorized
3 representative may at any time and from time to time, inspect and examine the
4 records, books and accounts of any title insurer, and may require such periodic
5 and special reports from any title insurer, as may be reasonably necessary to
6 enable the director to satisfy himself that such title insurer is complying with the
7 requirements of sections 381.011 to 381.241. No person shall be authorized to
8 inspect and examine the records, books and accounts of any title insurer unless
9 such person has five years experience in the title insurance business. It shall be
10 the duty of the director at least once every four years to make or cause to be made
11 an examination of every title insurer. The reasonable expense of any examination

Section 661, et seq.), as amended, or real estate investment trusts as defined in 26 U.S.C. Section 856, as amended, or institutions constituting the Farm Credit System pursuant to the Farm Credit Act of 1971 (12 U.S.C. Section 2000, et seq.), as amended, or any person which services loans secured by liens or mortgages on real property, which person may or may not maintain a servicing portfolio for such loans; or

(b) The following persons or entities if their principal place of business is in Missouri or a state which is contiguous to Missouri:

a. A mortgage loan company which is subject to licensing, supervision or auditing by the Federal National Mortgage Association, or the Federal Home Loan Mortgage Corporation, or the United States Veterans Administration, or the Government National Mortgage Association, or the United States Department of Housing and Urban Development, or a successor of any of the foregoing agencies or entities, as an approved seller or servicer; or

b. A person or entity acting as a mortgage loan company pursuant to court order;

(5) "Settlement agent", a person, corporation, partnership, or other business organization which accepts funds and documents as fiduciary for the buyer, seller or lender for the purposes of closing a sale of an interest in real estate located within the state of Missouri, and is not a financial institution, or a member in good standing of the Missouri Bar Association, or a person licensed under chapter 339, RSMo.]

[381.410. As used in this section and section 381.412, the following terms mean:

(1) "Cashier's check", a check, however labeled, drawn on the financial institution, which is signed only by an officer or employee of such institution, is a direct obligation of such institution, and is provided to a customer of such institution or acquired from such institution for remittance purposes;

(2) "Certified funds", United States currency, funds conveyed by a cashier's check, certified check, teller's check, as defined in Federal Reserve Regulations CC, or wire transfers, including written advice from a financial institution that collected funds have been credited to the settlement agent's account;

A mortgage loan company which is subject to licensing, supervision or auditing by the Federal National Mortgage Association, or the Federal Home Loan Mortgage Corporation, or the United States Veterans Administration, or the Government National Mortgage Association, or the United States Department of Housing and Urban Development, or a successor of any of the foregoing agencies or entities, as an approved seller or servicer;

(5) "Settlement agent", a person, corporation, partnership, or other business organization which accepts funds and documents as fiduciary for the buyer, seller or lender for the purposes of closing a sale of an interest in real estate located within the state of Missouri, and is not a financial institution, or a member in good standing of the Missouri Bar, or a person licensed under chapter 339, RSMo.]

[381.412. 1. A settlement agent who accepts funds of more than ten thousand dollars, but less than two million dollars, for closing a sale of an interest in real estate shall require a buyer, seller or lender who is not a financial institution to convey such funds to the settlement agent as certified funds. The settlement agent shall record all security instruments for such real estate closing within three business days of such closing after receipt of such certified funds. A check:

(1) Drawn on an escrow account of a licensed real estate broker, as regulated and described in section 339.105, RSMo;

(2) Drawn on an escrow account of a title insurer or title insurance agency licensed to do business in Missouri;

(3) Drawn on an agency of the United States of America, the state of Missouri or any county or municipality of the state of Missouri; or

(4) Drawn on an account by a financial institution;
shall be exempt from the provisions of this section.

2. No title insurer, title insurance agency or title insurance agent, as defined in section 381.031, shall make any payment, disbursement or withdrawal in excess of ten thousand dollars from an escrow account which it maintains as a depository of funds received from the public for the settlement of real estate transactions unless a corresponding deposit of funds was made to the escrow account for the benefit of the payee or payees:

(1) At least ten days prior to such payment, disbursement or withdrawal;

(2) Which consisted of certified funds; or

(3) Consisted of a check made exempt from this section by the provisions of subsection 1 of this section.

3. If the director finds that a settlement agent, title insurer, title insurance agency or title insurance agent has violated any provisions of this section, the director may assess a fine of not more than two thousand dollars for each violation, plus the costs of the investigation. Each separate transaction where certified funds are required shall constitute a separate violation. In determining a fine, the director shall consider the extent to which the violation was a knowing and willful violation, the corrective action taken by the settlement agent to ensure that the violation will not be repeated, and the record of the settlement agent in complying with the provisions of this section.]

[381.412. 1. A settlement agent who accepts funds of more than ten thousand dollars for closing a sale of an interest in real estate shall require a buyer, seller or lender who is not a financial institution to convey such funds to the settlement agent as certified funds. A check:

(1) Drawn on an escrow account of a licensed real estate broker, as regulated and described in section 339.105, RSMo;

(2) Drawn on an escrow account of a title insurer or title insurance agency licensed to do business in Missouri;

(3) Drawn on an agency of the United States of America, the state of Missouri or any county or municipality of the state of Missouri; or

(4) Drawn on an account by a financial institution;

shall be exempt from the provisions of this section.

2. No title insurer, title insurance agency or title insurance agent, as defined in section 381.009, shall make any payment, disbursement or withdrawal
