AN ACT

To amend chapter 173, RSMo, by adding thereto one new section relating to the twenty-first century scholars program.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 173, RSMo, is amended by adding thereto one new section, to be known as section 173.191, to read as follows:

- 173.191. 1. There is hereby established the "Twenty-first Century Scholars Program" to be administered by the department of higher education. The program shall:**
- (1) Reduce the number of students who withdraw from high school before graduation;**
 - (2) Increase the number of students who are prepared to enter the workforce upon graduation;**
 - (3) Increase the number of students entering and graduating from institutions of higher education;**
 - (4) Encourage eligible students to attend institutions of higher education by reducing the financial burden on the eligible students and their families;**
 - (5) Decrease drug and alcohol abuse by encouraging higher education pursuits;**

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

- 12 **(6) Increase individual economic vitality; and**
13 **(7) Improve the overall quality of life for many Missouri residents.**
14 **2. A student who meets the following criteria is eligible for the program:**
15 **(1) Is a resident of Missouri;**
16 **(2) Is a student enrolled in grade eight in a public or private school in Missouri;**
17 **(3) Is eligible for free or reduced lunches under the national school lunch program;**
18 **(4) Agrees in writing, together with the student's custodial parents or guardian,**
19 **that the student will:**
20 **(a) Graduate from a public or private secondary school in Missouri that meets the**
21 **admission criteria of an institution of higher education;**
22 **(b) Not illegally use controlled substances;**
23 **(c) Not commit a crime or infraction of operating a motor vehicle while intoxicated;**
24 **(d) Not be adjudicated as a delinquent, not become a runaway child, or not become**
25 **a truant;**
26 **(e) When the eligible student is a senior in high school, timely apply:**
27 **a. To an institution of higher education for admission; and**
28 **b. For any federal and state student financial assistance available to the eligible**
29 **student to attend an institution of higher education; and**
30 **(5) Achieve a cumulative grade point average upon graduation of at least two point**
31 **zero on a four-point scale, or its equivalent if another grading scale is used, for courses**
32 **taken during grades nine, ten, eleven, and twelve.**
33 **3. (1) There is hereby created in the state treasury the "Twenty-first Century**
34 **Scholars Fund" as a separate fund under the control of the commissioner of higher**
35 **education. The fund shall consist of moneys appropriated and made available to the**
36 **commissioner of higher education for scholarships under this section. The state treasurer**
37 **shall be custodian of the fund and shall disburse moneys from the fund in accordance with**
38 **sections 30.170 and 30.180, RSMo. Upon appropriation, moneys in the fund shall be used**
39 **solely for scholarships for students meeting all of the requirements of this section, including**
40 **meeting the requirements of subdivision (2) of subsection 1 of this section. Scholarships**
41 **awarded under this section shall not exceed the resident tuition rate and mandatory fees**
42 **for the program of enrollment established for public institutions of higher education in this**
43 **state.**
44 **(2) Notwithstanding the provisions of section 33.080, RSMo, to the contrary, any**
45 **moneys remaining in the fund at the end of the biennium shall not revert to the credit of**
46 **the general revenue fund.**

47 **(3) The state treasurer shall invest moneys in the fund in the same manner as other**
48 **funds are invested. Any interest and moneys earned on such investments shall be credited**
49 **to the fund.**

50 **4. (1) Moneys in the fund created in subsection 3 of this section shall be used to**
51 **provide annual tuition scholarship applicants who qualify under this section in an amount**
52 **equal to the lowest of the following amounts:**

53 **(a) If the scholarship applicant attends a state institution of higher education that**
54 **satisfies the requirements of subdivision (3) of this subsection and:**

55 **a. Receives no other financial assistance specifically designated for tuition and**
56 **other regularly assessed fees, a full tuition scholarship to the state institution of higher**
57 **education;**

58 **b. Receives other financial assistance specifically designated for tuition and other**
59 **regularly assessed fees, the balance required to attend the state institution of higher**
60 **education not to exceed the amount described in subparagraph a. of this paragraph;**

61 **(b) If the scholarship applicant attends a private institution of higher education**
62 **that satisfies the requirements of subdivision (3) of this subsection and:**

63 **a. Receives no other financial assistance specifically designated for tuition and**
64 **other regularly assessed fees, an average of the full tuition scholarship amounts of all state**
65 **institutions of higher education;**

66 **b. Receives other financial assistance specifically designated for tuition and other**
67 **regularly assessed fees, the balance required to attend the institution of higher education**
68 **not to exceed the amount described in subparagraph a. of this paragraph;**

69 **(c) If the scholarship applicant attends a postsecondary educational institution**
70 **other than a four-year institution of higher education that satisfies the requirements of**
71 **subdivision (3) of this subsection and:**

72 **a. Receives no other financial assistance specifically designated for tuition and**
73 **other regularly assessed fees, the actual tuition and regularly assessed fees of the**
74 **institution; or**

75 **b. Receives other financial assistance specifically designated for tuition and other**
76 **regularly assessed fees, the balance required to attend the institution not to exceed the**
77 **amount described in subparagraph a. of this paragraph.**

78 **(2) Each tuition scholarship awarded under this section shall be renewable under**
79 **subsection 5 of this section for a total scholarship award that does not exceed the**
80 **equivalent of eight semesters.**

81 **(3) An institution of higher education attended by an applicant described in**
82 **subdivision (1) of this subsection shall satisfy the following requirements:**

83 (a) Be accredited by an agency that is recognized by the Secretary of the United
84 States Department of Education;

85 (b) Operate an organized program of postsecondary education leading to an
86 associate or baccalaureate degree on a campus located in Missouri;

87 (c) Be approved by the commissioner of higher education under rules adopted by
88 the department.

89 **5. (1) To initially qualify for a tuition scholarship under this section, a scholarship**
90 **applicant shall:**

91 (a) Enroll as a full-time student in an institution of higher education that satisfies
92 the requirements of this section;

93 (b) Submit to the commissioner all of the information and evidence required by the
94 commissioner to determine eligibility as a scholarship applicant; and

95 (c) Meet any other minimum criteria established by the commissioner.

96 **(2) To qualify for a tuition scholarship renewal under this section, a scholarship**
97 **recipient shall:**

98 (a) Submit to the commissioner a renewal application;

99 (b) Continue to comply with the requirements set forth in subdivision (1) of this
100 subsection; and

101 (c) Continue to be a student in good standing at the institution of higher education.

102 **6. If an eligible student, scholarship applicant, or scholarship recipient violates an**
103 **agreement entered into under this section, such student, applicant, or recipient is**
104 **disqualified from further consideration as a scholarship recipient under this section.**

105 **7. Each institution of higher education that participates in the program under this**
106 **section shall develop specific mentoring programs for scholarship recipients under this**
107 **section to assist the recipients through particularized academic and social counseling.**

108 **8. The commissioner of higher education may promulgate rules to implement the**
109 **provisions of this section. Any rule or portion of a rule, as that term is defined in section**
110 **536.010, RSMo, that is created under the authority delegated in this section shall become**
111 **effective only if it complies with and is subject to all of the provisions of chapter 536,**
112 **RSMo, and, if applicable, section 536.028, RSMo. This section and chapter 536, RSMo, are**
113 **nonseverable and if any of the powers vested with the general assembly pursuant to**
114 **chapter 536, RSMo, to review, to delay the effective date, or to disapprove and annul a rule**
115 **are subsequently held unconstitutional, then the grant of rulemaking authority and any**
116 **rule proposed or adopted after August 28, 2006, shall be invalid and void.**
