**AN ACT**

To repeal sections 50.565, 192.925, 195.017, 210.482, 217.670, 217.690, 221.040, 311.310, 311.325, 311.326, 409.1-102, 409.2-202, 409.3-304, 409.4-401, 409.4-404, 409.4-408, 409.4-412, 409.5-501, 409.5-508, 409.6-604, 409.6-607, 479.260, 488.5050, 488.5320, 491.170, 545.050, 550.040, 556.036, 561.031, 565.182, 568.070, 569.145, 570.040, 573.037, 577.020, 577.021, 577.023, 577.070, 577.500, 578.250, 578.255, 578.260, 578.265, 578.409, 595.030, 595.209, 610.105, and 650.457, RSMo, and to enact in lieu thereof fifty-nine new sections relating to crime, with penalty provisions.

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

50.565. 1. A county commission may establish by ordinance or order a fund whose  
2 proceeds may be expended only for the purposes provided for in subsection 3 of this section.  
3 The fund shall be designated as a county law enforcement restitution fund and shall be under the  
4 supervision of a board of trustees consisting of two citizens of the county appointed by the  
5 presiding commissioner of the county, two citizens of the county appointed by the sheriff of the  
6 county, and one citizen of the county appointed by the county coroner or medical examiner. The  
7 citizens so appointed shall not be **current or former county elected officials**, current or former  
8 employees of the sheriff's department, the office of the prosecuting attorney for the county, **office**  
9 **of the county commissioners**, or the county treasurer's office. If a county does not have a  
10 coroner or medical examiner, the county treasurer shall appoint one citizen to the board of  
11 trustees.

12 2. Money from the county law enforcement restitution fund shall only be expended upon  
13 the approval of a majority of the members of the county law enforcement restitution fund's board  
14 of trustees and only for the purposes provided for by subsection 3 of this section.

15 3. Money from the county law enforcement restitution fund shall only be expended for  
16 the following purposes:

- 17 (1) Narcotics investigation, prevention, and intervention;  
18 (2) Purchase of law enforcement-related equipment and supplies for the sheriff's office;  
19 (3) Matching funds for federal or state law enforcement grants;  
20 (4) Funding for the reporting of all state and federal crime statistics or information; and  
21 (5) Any **county** law enforcement-related expense, including those of the prosecuting  
22 attorney, approved by the board of trustees for the county law enforcement restitution fund that  
23 is reasonably related to investigation, charging, preparation, trial, and disposition of criminal  
24 cases before the courts of the state of Missouri.

25 4. The county commission may not reduce any law enforcement agency's budget as a  
26 result of funds the law enforcement agency receives from the county law enforcement restitution  
27 fund. The restitution fund is to be used only as a supplement to the law enforcement agency's  
28 funding received from other county, state, or federal funds.

29 5. County law enforcement restitution funds shall be audited as are all other county  
30 funds.

31 6. No court may order the assessment and payment authorized by this section if the plea  
32 of guilty or the finding of guilt is to [the charge of speeding, careless and imprudent driving, any

33 charge of violating a traffic control signal or sign, or] any charge which is a class C misdemeanor  
34 or an infraction, **unless such charge is a moving violation, as defined by section 302.010,**  
35 **RSMo.** No assessment and payment ordered pursuant to this section may exceed three hundred  
36 dollars for any charged offense.

**56.087. 1. The prosecuting or circuit attorney has the power, in his or her**  
2 **discretion, to dismiss a complaint, information, or indictment, or any count or counts**  
3 **thereof, and in order to exercise that power it is not necessary for the prosecutor or circuit**  
4 **attorney to obtain the consent of the court. The dismissal may be made orally by the**  
5 **prosecuting or circuit attorney in open court, or by a written statement of the dismissal**  
6 **signed by the prosecuting or circuit attorney and filed with the clerk of court.**

7 **2. A dismissal filed by the prosecuting or circuit attorney prior to the time double**  
8 **jeopardy has attached is without prejudice. A dismissal filed by the prosecuting or circuit**  
9 **attorney after double jeopardy has attached is with prejudice, unless the criminal**  
10 **defendant has consented to having the case dismissed without prejudice.**

11 **3. A dismissal without prejudice means that the prosecutor or circuit attorney has**  
12 **complete discretion to refile the case, as long as it is refiled within the time specified by the**  
13 **applicable statute of limitations. A dismissal with prejudice means that the prosecutor or**  
14 **circuit attorney cannot refile the case.**

15 **4. For the purposes of this section, double jeopardy attaches in a jury trial when**  
16 **the jury has been impaneled and sworn. It attaches in a court-tried case when the court**  
17 **begins to hear evidence.**

**92.500. 1. The governing body of any city not within a county may impose, by**  
2 **order or ordinance, a sales tax on all retail sales made within the city which are subject to**  
3 **sales tax under chapter 144, RSMo. The tax authorized in this section shall not exceed one-**  
4 **half of one percent, and shall be imposed solely for the purpose of providing revenues for**  
5 **the operation of public safety departments, including police and fire departments, and for**  
6 **compensation, pension programs, and health care for employees and pensioners of the**  
7 **public safety departments. The tax authorized in this section shall be in addition to all**  
8 **other sales taxes imposed by law, and shall be stated separately from all other charges and**  
9 **taxes. The order or ordinance shall not become effective unless the governing body of the**  
10 **city submits to the voters residing within the city at a state general, primary, or special**  
11 **election a proposal to authorize the governing body of the city to impose a tax under this**  
12 **section.**

13 **2. The ballot of submission for the tax authorized in this section shall be in**  
14 **substantially the following form:**

15           Shall ..... (insert the name of the city) impose a sales tax at a rate of ..... (insert rate  
16 of percent) percent, solely for the purpose of providing revenues for the operation of public  
17 safety departments of the city?

20 If you are in favor of the question, place an "X" in the box opposite "YES". If you are

23 If a majority of the votes cast on the question by the qualified voters voting thereon are in  
24 favor of the question, then the tax shall become effective on the first day of the second  
25 calendar quarter immediately following notification to the department of revenue. If a  
26 majority of the votes cast on the question by the qualified voters voting thereon are  
27 opposed to the question, then the tax shall not become effective unless and until the  
28 question is resubmitted under this section to the qualified voters and such question is  
29 approved by a majority of the qualified voters voting on the question.

30           3. All revenue collected under this section by the director of the department of  
31 revenue on behalf of any city, except for one percent for the cost of collection which shall  
32 be deposited in the state's general revenue fund, shall be deposited in a special trust fund,  
33 which is hereby created and shall be known as the "Public Safety Protection Sales Tax  
34 Fund", and shall be used solely for the designated purposes. Moneys in the fund shall not  
35 be deemed to be state funds, and shall not be commingled with any funds of the state. The  
36 director may make refunds from the amounts in the trust fund and credited to the city for  
37 erroneous payments and overpayments made, and may redeem dishonored checks and  
38 drafts deposited to the credit of such city. Any funds in the special trust fund which are  
39 not needed for current expenditures shall be invested in the same manner as other funds  
40 are invested. Any interest and moneys earned on such investments shall be credited to the  
41 fund. The director shall keep accurate records of the amounts in the fund, and such  
42 records shall be open to the inspection of the officers of such city and to the public. Not  
43 later than the tenth day of each month, the director shall distribute all moneys deposited  
44 in the fund during the preceding month to the city. Such funds shall be deposited with the  
45 treasurer of the city, and all expenditures of moneys from the fund shall be by an  
46 appropriation ordinance enacted by the governing body of the city.

47           4. On or after the effective date of the tax, the director of revenue shall be  
48 responsible for the administration, collection, enforcement, and operation of the tax, and  
49 sections 32.085 and 32.087, RSMo, shall apply. In order to permit sellers required to  
50 collect and report the sales tax to collect the amount required to be reported and remitted,

51 but not to change the requirements of reporting or remitting the tax, or to serve as a levy  
52 of the tax, and in order to avoid fractions of pennies, the governing body of the city may  
53 authorize the use of a bracket system similar to that authorized in section 144.285, RSMo,  
54 and notwithstanding the provisions of that section, this new bracket system shall be used  
55 where this tax is imposed and shall apply to all taxable transactions. Beginning with the  
56 effective date of the tax, every retailer in the city shall add the sales tax to the sale price,  
57 and this tax shall be a debt of the purchaser to the retailer until paid, and shall be  
58 recoverable at law in the same manner as the purchase price. For purposes of this section,  
59 all retail sales shall be deemed to be consummated at the place of business of the retailer.

60       5. All applicable provisions in sections 144.010 to 144.525, RSMo, governing the  
61 state sales tax, and section 32.057, RSMo, the uniform confidentiality provision, shall apply  
62 to the collection of the tax, and all exemptions granted to agencies of government,  
63 organizations, and persons under sections 144.010 to 144.525, RSMo, are hereby made  
64 applicable to the imposition and collection of the tax. The same sales tax permit, exemption  
65 certificate, and retail certificate required by sections 144.010 to 144.525, RSMo, for the  
66 administration and collection of the state sales tax shall satisfy the requirements of this  
67 section, and no additional permit or exemption certificate or retail certificate shall be  
68 required; except that, the director of revenue may prescribe a form of exemption certificate  
69 for an exemption from the tax. All discounts allowed the retailer under the state sales tax  
70 for the collection of and for payment of taxes are hereby allowed and made applicable to  
71 the tax. The penalties for violations provided in section 32.057, RSMo, and sections  
72 144.010 to 144.525, RSMo, are hereby made applicable to violations of this section. If any  
73 person is delinquent in the payment of the amount required to be paid under this section,  
74 or in the event a determination has been made against the person for the tax and penalties  
75 under this section, the limitation for bringing suit for the collection of the delinquent tax  
76 and penalties shall be the same as that provided in sections 144.010 to 144.525, RSMo.

77       6. The governing body of any city that has adopted the sales tax authorized in this  
78 section may submit the question of repeal of the tax to the voters on any date available for  
79 elections for the city. The ballot of submission shall be in substantially the following form:

85 If you are in favor of the question, place an "X" in the box opposite "YES". If you are

87 If a majority of the votes cast on the question by the qualified voters voting thereon are in  
88 favor of repeal, that repeal shall become effective on December thirty-first of the calendar  
89 year in which such repeal was approved. If a majority of the votes cast on the question by  
90 the qualified voters voting thereon are opposed to the repeal, then the sales tax authorized  
91 in this section shall remain effective until the question is resubmitted under this section to  
92 the qualified voters and the repeal is approved by a majority of the qualified voters voting  
93 on the question.

94 7. Whenever the governing body of any city that has adopted the sales tax  
95 authorized in this section receives a petition, signed by a number of registered voters of the  
96 city equal to at least two percent of the number of registered voters of the city voting in the  
97 last gubernatorial election, calling for an election to repeal the sales tax imposed under this  
98 section, the governing body shall submit to the voters of the city a proposal to repeal the  
99 tax. If a majority of the votes cast on the question by the qualified voters voting thereon  
100 are in favor of the repeal, the repeal shall become effective on December thirty-first of the  
101 calendar year in which such repeal was approved. If a majority of the votes cast on the  
102 question by the qualified voters voting thereon are opposed to the repeal, then the sales tax  
103 authorized in this section shall remain effective until the question is resubmitted under this  
104 section to the qualified voters and the repeal is approved by a majority of the qualified  
105 voters voting on the question.

106 8. If the tax is repealed or terminated by any means, all funds remaining in the  
107 special trust fund shall continue to be used solely for the designated purposes, and the city  
108 shall notify the director of the department of revenue of the action at least ninety days  
109 before the effective date of the repeal and the director may order retention in the trust  
110 fund, for a period of one year, of two percent of the amount collected after receipt of such  
111 notice to cover possible refunds or overpayment of the tax and to redeem dishonored  
112 checks and drafts deposited to the credit of such accounts. After one year has elapsed after  
113 the effective date of abolition of the tax in such city, the director shall remit the balance in  
114 the account to the city and close the account of that city. The director shall notify each city  
115 of each instance of any amount refunded or any check redeemed from receipts due the city.

192.925. 1. To increase public awareness of the problem of elder abuse and neglect **and**  
2 **financial exploitation of the elderly**, the department of health and senior services shall  
3 implement an education and awareness program. Such program shall have the goal of reducing  
4 the incidences of elder abuse and neglect **and financial exploitation of the elderly**, and may  
5 focus on:

6 (1) The education and awareness of mandatory reporters on their responsibility to report  
7 elder abuse and neglect **and financial exploitation of the elderly**;

8 (2) Targeted education and awareness for the public on the problem, identification and  
9 reporting of elder abuse and neglect **and financial exploitation of the elderly**;

10 (3) Publicizing the elder abuse and neglect hot line telephone number;

11 (4) Education and awareness for law enforcement agencies and prosecutors on the  
12 problem and identification of elder abuse and neglect **and financial exploitation of the elderly**,  
13 and the importance of prosecuting cases pursuant to chapter 565, RSMo; and

14 (5) Publicizing the availability of background checks prior to hiring an individual for  
15 caregiving purposes.

16 2. The department of social services and facilities licensed pursuant to chapters 197 and  
17 198, RSMo, shall cooperate fully with the department of health and senior services in the  
18 distribution of information pursuant to this program.

195.017. 1. The department of health and senior services shall place a substance in  
2 Schedule I if it finds that the substance:

3 (1) Has high potential for abuse; and

4 (2) Has no accepted medical use in treatment in the United States or lacks accepted  
5 safety for use in treatment under medical supervision.

2 the unexpected absence of the child's parents, legal guardian, or custodian, the juvenile court or  
3 children's division:

4           (1) May request that a local or state law enforcement agency or juvenile officer, subject  
5 to any required federal authorization, immediately conduct a name-based criminal history record  
6 check to include full orders of protection and outstanding warrants of each person over the age  
7 of seventeen residing in the home by using the Missouri uniform law enforcement system  
8 (MULES) and the National Crime Information Center to access the Interstate Identification Index  
9 maintained by the Federal Bureau of Investigation; and

10           (2) Shall determine or, in the case of the juvenile court, shall request the division to  
11 determine whether any person over the age of seventeen years residing in the home is listed on  
12 the child abuse and neglect registry.

13

14 For any children less than seventeen years of age residing in the home, the children's division  
15 shall inquire of the person with whom an emergency placement of a child will be made whether  
16 any children less than seventeen years of age residing in the home have ever been certified as an  
17 adult and convicted of or pled guilty or nolo contendere to any crime.

18           2. If a name-based search has been conducted pursuant to subsection 1 of this section,  
19 within fifteen [business] days after the emergency placement of the child in the private home,  
20 and if the private home has not previously been approved as a foster or adoptive home, all  
21 persons over the age of seventeen residing in the home and all children less than seventeen  
22 residing in the home who the division has determined have been certified as an adult for the  
23 commission of a crime[, other than persons within the second degree of consanguinity and  
24 affinity to the child,] shall report to a local law enforcement agency for the purpose of providing  
25 two sets of fingerprints each and accompanying fees, pursuant to section 43.530, RSMo. One  
26 set of fingerprints shall be used by the highway patrol to search the criminal history repository  
27 and the second set shall be forwarded to the Federal Bureau of Investigation for searching the



28 federal criminal history files. Results of the checks will be provided to the juvenile court or  
29 children's division office requesting such information. Any child placed in emergency placement  
30 in a private home shall be removed immediately if any person residing in the home fails to  
31 provide fingerprints after being requested to do so, unless the person refusing to provide  
32 fingerprints ceases to reside in the private home.

33 3. If the placement of a child is denied as a result of a name-based criminal history check  
34 and the denial is contested, all persons over the age of seventeen residing in the home and all  
35 children less than seventeen years of age residing in the home who the division has determined  
36 have been certified as an adult for the commission of a crime shall, within fifteen [business]  
37 days, submit to the juvenile court or the children's division two sets of fingerprints in the same  
38 manner described in subsection 2 of this section, accompanying fees, and written permission  
39 authorizing the juvenile court or the children's division to forward the fingerprints to the state  
40 criminal record repository for submission to the Federal Bureau of Investigation. One set of  
41 fingerprints shall be used by the highway patrol to search the criminal history repository and the  
42 second set shall be forwarded to the Federal Bureau of Investigation for searching the federal  
43 criminal history files.

44 4. Subject to appropriation, the total cost of fingerprinting required by this section may  
45 be paid by the state, including reimbursement of persons incurring fingerprinting costs under this  
46 section.

47 5. For the purposes of this section, "emergency placement" refers to those limited  
48 instances when the juvenile court or children's division is placing a child in the home of private  
49 individuals, including neighbors, friends, or relatives, as a result of a sudden unavailability of  
50 the child's primary caretaker.

**217.439. Upon the victim's request, a photograph shall be taken of the incarcerated  
2 individual prior to release from incarceration and a copy of the photograph shall be  
3 provided to the crime victim.**

217.670. 1. The board shall adopt an official seal of which the courts shall take official  
2 notice.

3 2. Decisions of the board regarding granting of paroles, extensions of a conditional  
4 release date or revocations of a parole or conditional release shall be by a majority vote of the  
5 hearing panel members. The hearing panel shall consist of one member of the board and two  
6 hearing officers appointed by the board. A member of the board may remove the case from the  
7 jurisdiction of the hearing panel and refer it to the full board for a decision. Within thirty days  
8 of entry of the decision of the hearing panel to deny parole or to revoke a parole or conditional  
9 release, the offender may appeal the decision of the hearing panel to the board. The board shall

10 consider the appeal within thirty days of receipt of the appeal. The decision of the board shall  
11 be by majority vote of the board members and shall be final.

12 3. The orders of the board shall not be reviewable except as to compliance with the terms  
13 of sections 217.650 to 217.810 or any rules promulgated pursuant to such section.

14 4. The board shall keep a record of its acts and shall notify each correctional center of  
15 its decisions relating to persons who are or have been confined in such correctional center.

16 5. Notwithstanding any other provision of law, any meeting, record, or vote, of  
17 proceedings involving probation, parole, or pardon, may be a closed meeting, closed record, or  
18 closed vote.

19 **6. Notwithstanding any other provision of law, when the appearance or presence**  
20 **of an offender before the board or a hearing panel is required for the purpose of deciding**  
21 **whether to grant conditional release or parole, extend the date of conditional release,**  
22 **revoke parole or conditional release, or for any other purpose, such appearance or**  
23 **presence may occur by means of a video conference at the discretion of the board. Victims**  
24 **having a right to attend such hearings may testify either at the site where the board is**  
25 **conducting the video conference or at the institution where the offender is located.**

217.690. 1. When in its opinion there is reasonable probability that an offender of a  
2 correctional center can be released without detriment to the community or to himself, the board  
3 may in its discretion release or parole such person except as otherwise prohibited by law. All  
4 paroles shall issue upon order of the board, duly adopted.

5 2. Before ordering the parole of any offender, the board shall have the offender appear  
6 before a hearing panel and shall conduct a personal interview with him, unless waived by the  
7 offender. A parole shall be ordered only for the best interest of society, not as an award of  
8 clemency; it shall not be considered a reduction of sentence or a pardon. An offender shall be  
9 placed on parole only when the board believes that he is able and willing to fulfill the obligations  
10 of a law-abiding citizen. Every offender while on parole shall remain in the legal custody of the  
11 department but shall be subject to the orders of the board.

12 3. The board has discretionary authority to require the payment of a fee, not to exceed  
13 sixty dollars per month, from every offender placed under board supervision on probation,  
14 parole, or conditional release, to waive all or part of any fee, to sanction offenders for willful  
15 nonpayment of fees, and to contract with a private entity for fee collections services. All fees  
16 collected shall be deposited in the inmate fund established in section 217.430. Fees collected  
17 may be used to pay the costs of contracted collections services. The fees collected may otherwise  
18 be used to provide community corrections and intervention services for offenders. Such services  
19 include substance abuse assessment and treatment, mental health assessment and treatment,  
20 electronic monitoring services, residential facilities services, employment placement services,

21 and other offender community corrections or intervention services designated by the board to  
22 assist offenders to successfully complete probation, parole, or conditional release. The board  
23 shall adopt rules not inconsistent with law, in accordance with section 217.040, with respect to  
24 sanctioning offenders and with respect to establishing, waiving, collecting, and using fees.

25 4. The board shall adopt rules not inconsistent with law, in accordance with section  
26 217.040, with respect to the eligibility of offenders for parole, the conduct of parole hearings or  
27 conditions to be imposed upon paroled offenders. Whenever an order for parole is issued it shall  
28 recite the conditions of such parole.

29 5. When considering parole for an offender with consecutive sentences, the minimum  
30 term for eligibility for parole shall be calculated by adding the minimum terms for parole  
31 eligibility for each of the consecutive sentences, except the minimum term for parole eligibility  
32 shall not exceed the minimum term for parole eligibility for an ordinary life sentence.

33 6. Any offender under a sentence for first degree murder who has been denied release  
34 on parole after a parole hearing shall not be eligible for another parole hearing until at least three  
35 years from the month of the parole denial; however, this subsection shall not prevent a release  
36 pursuant to subsection 4 of section 558.011, RSMo.

37 7. Parole hearings shall, at a minimum, contain the following procedures:

38 (1) The victim or person representing the victim who attends a hearing may be  
39 accompanied by one other person;

40 (2) The victim or person representing the victim who attends a hearing shall have the  
41 option of giving testimony in the presence of the inmate or to the hearing panel without the  
42 inmate being present;

43 (3) The victim or person representing the victim may call or write the parole board rather  
44 than attend the hearing;

45 (4) The victim or person representing the victim may have a personal meeting with a  
46 board member at the board's central office;

47 (5) The judge, prosecuting attorney or circuit attorney and a representative of the local  
48 law enforcement agency investigating the crime shall be allowed to attend the hearing or provide  
49 information to the hearing panel in regard to the parole consideration; and

50 (6) The board shall evaluate information listed in the juvenile sex offender registry  
51 pursuant to section 211.425, RSMo, provided the offender is between the ages of seventeen and  
52 twenty-one, as it impacts the safety of the community.

53 8. The board shall notify any person of the results of a parole eligibility hearing if the  
54 person indicates to the board a desire to be notified.

55 9. The board may, at its discretion, require any offender seeking parole to meet certain  
56 conditions during the term of that parole so long as said conditions are not illegal or impossible

57 for the offender to perform. These conditions may include an amount of restitution to the state  
58 for the cost of that offender's incarceration. **These conditions may also include the**  
59 **performance of a designated amount of free work for a public or charitable purpose as**  
60 **determined by the board.**

61 (1) **An offender may refuse parole that is conditioned on the performance of free**  
62 **work. In such cases, the board shall take that fact into account when exercising its**  
63 **discretion to release the offender.**

64 (2) **Any county, city, person, organization, or agency, or any employee of a county,**  
65 **city, organization, or agency charged with the supervision of such free work or who**  
66 **benefits from its performance shall be immune from any suit by the offender or any person**  
67 **deriving a cause of action from him or her if such cause of action arises from such**  
68 **supervision of performance, except for an intentional tort or gross negligence. The services**  
69 **performed by the offender shall not be deemed employment within the meaning of the**  
70 **provisions of chapter 288, RSMo. An offender performing service under this section shall**  
71 **not be deemed an employee within the meaning of the provisions of chapter 287, RSMo.**

72 10. Nothing contained in this section shall be construed to require the release of an  
73 offender on parole nor to reduce the sentence of an offender heretofore committed.

74 11. Beginning January 1, 2001, the board shall not order a parole unless the offender has  
75 obtained a high school diploma or its equivalent, or unless the board is satisfied that the offender,  
76 while committed to the custody of the department, has made an honest good-faith effort to obtain  
77 a high school diploma or its equivalent; provided that the director may waive this requirement  
78 by certifying in writing to the board that the offender has actively participated in mandatory  
79 education programs or is academically unable to obtain a high school diploma or its equivalent.

80 12. Any rule or portion of a rule, as that term is defined in section 536.010, RSMo, that  
81 is created under the authority delegated in this section shall become effective only if it complies  
82 with and is subject to all of the provisions of chapter 536, RSMo, and, if applicable, section  
83 536.028, RSMo. This section and chapter 536, RSMo, are nonseverable and if any of the powers  
84 vested with the general assembly pursuant to chapter 536, RSMo, to review, to delay the  
85 effective date, or to disapprove and annul a rule are subsequently held unconstitutional, then the  
86 grant of rulemaking authority and any rule proposed or adopted after August 28, 2005, shall be  
87 invalid and void.

221.040. It shall be the duty of the sheriff and jailer to receive, from constables and other  
2 officers, all persons who shall be apprehended by such constable or other officers, for offenses  
3 against this state, or who shall be committed to such jail by any competent authority; and if any  
4 sheriff or jailer shall refuse to receive any such person or persons, he shall be adjudged guilty of  
5 a misdemeanor, and on conviction shall be fined in the discretion of the court. **Any sheriff or**

6 **jailer may refuse to accept or incarcerate any prisoner from other officers or constables**  
7 **if the prisoner is deemed medically unfit for confinement.**

311.310. 1. Any licensee under this chapter, or his employee, who shall sell, vend, give  
2 away or otherwise supply any intoxicating liquor, **or any nonintoxicating beer as defined in**  
3 **section 312.010, RSMo**, in any quantity whatsoever to any person under the age of twenty-one  
4 years, or to any person intoxicated or appearing to be in a state of intoxication, or to a habitual  
5 drunkard, and any person whomsoever except his parent or guardian who shall procure for, sell,  
6 give away or otherwise supply intoxicating liquor to any person under the age of twenty-one  
7 years, or to any intoxicated person or any person appearing to be in a state of intoxication, or to  
8 a habitual drunkard, shall be deemed guilty of a misdemeanor, except that this section shall not  
9 apply to the supplying of intoxicating liquor to a person under the age of twenty-one years for  
10 medical purposes only, or to the administering of such intoxicating liquor to any person by a duly  
11 licensed physician. No person shall be denied a license or renewal of a license issued under this  
12 chapter solely due to a conviction for unlawful sale or supply to a minor when serving in the  
13 capacity as an employee of a licensed establishment.

14 2. Any owner, occupant, or other person or legal entity with a lawful right to the  
15 exclusive use and enjoyment of any property who knowingly allows a person under the age of  
16 twenty-one to drink or possess intoxicating liquor or knowingly fails to stop a person under the  
17 age of twenty-one from drinking or possessing intoxicating liquor on such property, unless such  
18 person allowing the person under the age of twenty-one to drink or possess intoxicating liquor  
19 is his or her parent or guardian, is guilty of a class B misdemeanor. Any second or subsequent  
20 violation of this subsection is a class A misdemeanor.

21 3. It shall be a defense to prosecution under this section if:

22 (1) The defendant is a licensed retailer, club, drinking establishment, or caterer or holds  
23 a temporary permit, or an employee thereof;

24 (2) The defendant sold the intoxicating liquor to the minor with reasonable cause to  
25 believe that the minor was twenty-one or more years of age; and

26 (3) To purchase the intoxicating liquor, the person exhibited to the defendant a driver's  
27 license, Missouri nondriver's identification card, or other official or apparently official document,  
28 containing a photograph of the minor and purporting to establish that such minor was twenty-one  
29 years of age and of the legal age for consumption of intoxicating liquor.

311.325. 1. Any person under the age of twenty-one years, who purchases or attempts  
2 to purchase, or has in his or her possession, any intoxicating liquor as defined in section  
3 311.020, **any nonintoxicating beer as defined in section 312.010, RSMo**, or who is visibly  
4 intoxicated as defined in section 577.001, RSMo, or has a detectable blood alcohol content of  
5 more than two-hundredths of one percent or more by weight of alcohol in such person's blood

6 is guilty of a misdemeanor. For purposes of prosecution under this section or any other provision  
7 of this chapter involving an alleged illegal sale or transfer of intoxicating liquor to a person under  
8 twenty-one years of age, a manufacturer-sealed container describing that there is intoxicating  
9 liquor therein need not be opened or the contents therein tested to verify that there is intoxicating  
10 liquor in such container. The alleged violator may allege that there was not intoxicating liquor  
11 in such container, but the burden of proof of such allegation is on such person, as it shall be  
12 presumed that such a sealed container describing that there is intoxicating liquor therein contains  
13 intoxicating liquor.

14 2. For purposes of determining violations of any provision of this chapter, or of any rule  
15 or regulation of the supervisor of alcohol and tobacco control, a manufacturer-sealed container  
16 describing that there is intoxicating liquor therein need not be opened or the contents therein  
17 tested to verify that there is intoxicating liquor in such container. The alleged violator may allege  
18 that there was not intoxicating liquor in such container, but the burden of proof of such allegation  
19 is on such person, as it shall be presumed that such a sealed container describing that there is  
20 intoxicating liquor therein contains intoxicating liquor.

311.326. After a period of not less than one year[, or upon] **after** reaching the age of  
2 twenty-one[, whichever occurs first,] a person who has pleaded guilty to or has been found guilty  
3 of violating section 311.325 for the first time, and who since such conviction has not been  
4 convicted of any other alcohol-related offense, may apply to the court in which he or she was  
5 sentenced for an order to expunge all official records of his or her arrest, plea, trial and  
6 conviction. If the court determines, upon review, that such person has not been convicted of any  
7 other alcohol-related offense at the time of the application for expungement, and the person has  
8 had no other alcohol-related enforcement contacts, as defined in section 302.525, RSMo, the  
9 court shall enter an order of expungement. The effect of such an order shall be to restore such  
10 person to the status he or she occupied prior to such arrest, plea or conviction, as if such event  
11 had never happened. No person as to whom such order has been entered shall be held thereafter  
12 under any provision of any law to be guilty of perjury or otherwise giving a false statement by  
13 reason of his or her failure to recite or acknowledge such arrest, plea, trial, conviction or  
14 expungement in response to any inquiry made of him or her for any purpose whatsoever. A  
15 person shall be entitled to only one expungement pursuant to this section. Nothing contained in  
16 this section shall prevent courts or other state officials from maintaining such records as are  
17 necessary to ensure that an individual receives only one expungement pursuant to this section.

409.1-102. In this act, unless the context otherwise requires:

2 (1) "Agent" means an individual, other than a broker-dealer, who represents a  
3 broker-dealer in effecting or attempting to effect purchases or sales of securities or represents an  
4 issuer in effecting or attempting to effect purchases or sales of the issuer's securities. But a

5 partner, officer, or director of a broker-dealer or issuer, or an individual having a similar status  
6 or performing similar functions is an agent only if the individual otherwise comes within the  
7 term. The term does not include an individual excluded by rule adopted or order issued under  
8 this act.

9 (2) "Commissioner" means the commissioner of securities appointed by the secretary of  
10 state.

11 (3) "Bank" means:

12 (A) A banking institution organized under the laws of the United States;

13 (B) A member bank of the Federal Reserve System;

14 (C) Any other banking institution, whether incorporated or not, doing business under the  
15 laws of a state or of the United States, a substantial portion of the business of which consists of  
16 receiving deposits or exercising fiduciary powers similar to those permitted to be exercised by  
17 national banks under the authority of the Comptroller of the Currency pursuant to Section 1 of  
18 Public Law 87-722 (12 U.S.C. Section 92a), and which is supervised and examined by a state  
19 or federal agency having supervision over banks, and which is not operated for the purpose of  
20 evading this act; and

23 (4) "Broker-dealer" means a person engaged in the business of effecting transactions in

33 (D) An international banking institution; or

34 (E) A person excluded by rule adopted or order issued under this act.

35 (5) "Depository institution" means:

36 (A) A bank; or

37 (B) A savings institution, trust company, credit union, or similar institution that is  
38 organized or chartered under the laws of a state or of the United States, authorized to receive  
39 deposits, and supervised and examined by an official or agency of a state or the United States if  
40 its deposits or share accounts are insured to the maximum amount authorized by statute by the

41 Federal Deposit Insurance Corporation, the National Credit Union Share Insurance Fund, or a  
42 successor authorized by federal law. The term does not include:

43 (I) An insurance company or other organization primarily engaged in the business of  
44 insurance;

47 **defined in section 3(c)(2) of the Federal Deposit Insurance Act (12 U.S.C. 1813(c)(2)), or**

49 (6) "Federal covered investment adviser" means a person registered under the Investment  
50 Advisers Act of 1940.

51 (7) "Federal covered security" means a security that is, or upon completion of a  
52 transaction will be, a covered security under Section 18(b) of the Securities Act of 1933 (15  
53 U.S.C. Section 77r(b)) or rules or regulations adopted pursuant to that provision.

54 (8) "Filing" means the receipt under this act of a record by the commissioner or a  
55 designee of the commissioner.

56 (9) "Fraud", "deceit", and "defraud" are not limited to common law deceit.

57 (10) "Guaranteed" means guaranteed as to payment of all principal and all interest.

58 (11) "Institutional investor" means any of the following, whether acting for itself or for  
59 others in a fiduciary capacity:

60 (A) A depository institution, a trust company organized or chartered under the laws of  
61 this state, or an international banking institution;

62 (B) An insurance company;

63 (C) A separate account of an insurance company;

64 (D) An investment company as defined in the Investment Company Act of 1940;

65 (E) A broker-dealer registered under the Securities Exchange Act of 1934;

66 (F) An employee pension, profit-sharing, or benefit plan if the plan has total assets in  
67 excess of ten million dollars or its investment decisions are made by a named fiduciary, as

90 with total assets in excess of ten million dollars;

91 (K) A private business development company as defined in Section 202(a)(22) of the  
92 Investment Advisers Act of 1940 (15 U.S.C. Section 80b-2(a)(22)) with total assets in excess  
93 of ten million dollars;

94 (L) A federal covered investment adviser acting for its own account;

95 (M) A "qualified institutional buyer" as defined in Rule 144A(a)(1), other than Rule  
96 144A(a)(1)(i)(H), adopted under the Securities Act of 1933 (17 C.F.R. 230.144A);

97 (N) A "major U.S. institutional investor" as defined in Rule 15a-6(b)(4)(i) adopted

99 (O) Any other person, other than an individual, of institutional character with total assets  
100 in excess of ten million dollars not organized for the specific purpose of evading this act; or

101 (P) Any other person specified by rule adopted or order issued under this act.

102 (12) "Insurance company" means a company organized as an insurance company whose  
103 primary business is writing insurance or reinsuring risks underwritten by insurance companies  
104 and which is subject to supervision by the insurance commissioner or a similar official or agency  
105 of a state.

106 (13) "Insured" means insured as to payment of all principal and all interest.

107 (14) "International banking institution" means an international financial institution of  
108 which the United States is a member and whose securities are exempt from registration under  
109 the Securities Act of 1933.

110 (15) "Investment adviser" means a person that, for compensation, engages in the business  
111 of advising others, either directly or through publications or writings, as to the value of securities

125 publication of general and regular circulation;

126 (E) A federal covered investment adviser;

127 (F) A bank, a trust company organized or chartered under the laws of this state, or a  
128 savings institution;

129 (G) Any other person that is excluded by the Investment Advisers Act of 1940 from the  
130 definition of investment adviser; or

131 (H) Any other person excluded by rule adopted or order issued under this act.

132 (16) "Investment adviser representative" means an individual employed by or associated  
133 with an investment adviser or federal covered investment adviser and who makes any  
134 recommendations or otherwise gives investment advice regarding securities, manages accounts  
135 or portfolios of clients, determines which recommendation or advice regarding securities should  
136 be given, provides investment advice or holds herself or himself out as providing investment  
137 advice, receives compensation to solicit, offer, or negotiate for the sale of or for selling  
138 investment advice, or supervises employees who perform any of the foregoing. The term does  
139 not include an individual who:

140 (A) Performs only clerical or ministerial acts;

141 (B) Is an agent whose performance of investment advice is solely incidental to the  
142 individual acting as an agent and who does not receive special compensation for investment

175 (21) "Place of business" of a broker-dealer, an investment adviser, or a federal covered  
176 investment adviser means:

178 investment adviser regularly provides brokerage or investment advice or solicits, meets with, or  
179 otherwise communicates with customers or clients; or

188 underwriting and selling discounts or commissions, amount of proceeds, conversion rates, call  
189 prices, and other matters dependent upon the offering price.

190 (24) "Principal place of business" of a broker-dealer or an investment adviser means the  
191 executive office of the broker-dealer or investment adviser from which the officers, partners, or  
192 managers of the broker-dealer or investment adviser direct, control, and coordinate the activities  
193 of the broker-dealer or investment adviser.

194 (25) "Record", except in the phrases "of record", "official record", and "public record",  
195 means information that is inscribed on a tangible medium or that is stored in an electronic or  
196 other medium and is retrievable in perceivable form.

197 (26) "Sale" includes every contract of sale, contract to sell, or disposition of, a security

79 equivalents, in effect; and a copy of any indenture or other instrument covering the security to  
80 be registered;

81 (15) A signed or conformed copy of an opinion of counsel concerning the legality of the  
82 security being registered, with an English translation if it is in a language other than English,  
83 which states whether the security when sold will be validly issued, fully paid, and nonassessable  
84 and, if a debt security, a binding obligation of the issuer;

85 (16) A signed or conformed copy of a consent of any accountant, engineer, appraiser, or  
86 other person whose profession gives authority for a statement made by the person, if the person  
87 is named as having prepared or certified a report or valuation, other than an official record, that  
88 is public, which is used in connection with the registration statement;

89 (17) A balance sheet of the issuer as of a date within four months before the filing of the  
90 registration statement; a statement of income and [changes in financial position] **a statement of**  
91 **cash flows** for each of the three fiscal years preceding the date of the balance sheet and for any  
92 period between the close of the immediately previous fiscal year and the date of the balance  
93 sheet, or for the period of the issuer's and any predecessor's existence if less than three years; and,  
94 if any part of the proceeds of the offering is to be applied to the purchase of a business, the  
95 financial statements that would be required if that business were the registrant; and

96 (18) Any additional information or records required by rule adopted or order issued  
97 under this act.

98 (c) A registration statement under this section becomes effective thirty days, or any  
99 shorter period provided by rule adopted or order issued under this act, after the date the  
100 registration statement or the last amendment other than a price amendment is filed, if:

101 (1) A stop order is not in effect and a proceeding is not pending under section 409.3-306;

102 (2) The commissioner has not issued an order under section 409.3-306 delaying  
103 effectiveness; and

104 (3) The applicant or registrant has not requested that effectiveness be delayed.

105 (d) The commissioner may delay effectiveness once for not more than ninety days if the  
106 commissioner determines the registration statement is not complete in all material respects and  
107 promptly notifies the applicant or registrant of that determination. The commissioner may also  
108 delay effectiveness for a further period of not more than thirty days if the commissioner  
109 determines that the delay is necessary or appropriate.

110 (e) A rule adopted or order issued under this act may require as a condition of  
111 registration under this section that a prospectus containing a specified part of the information or  
112 record specified in subsection (b) be sent or given to each person to which an offer is made,  
113 before or concurrently, with the earliest of:

114 (1) The first offer made in a record to the person otherwise than by means of a public  
115 advertisement, by or for the account of the issuer or another person on whose behalf the offering

116 is being made or by an underwriter or broker-dealer that is offering part of an unsold allotment  
117 or subscription taken by the person as a participant in the distribution;

118 (2) The confirmation of a sale made by or for the account of the person;

119 (3) Payment pursuant to such a sale; or

120 (4) Delivery of the security pursuant to such a sale.

409.4-401. (a) It is unlawful for a person to transact business in this state as a  
2 broker-dealer unless the person is registered under this act as a broker-dealer or is exempt from  
3 registration as a broker-dealer under subsection (b) or (d).

4 (b) The following persons are exempt from the registration requirement of subsection  
5 (a):

6 (1) A broker-dealer without a place of business in this state if its only transactions  
7 effected in this state are with:

8 (A) The issuer of the securities involved in the transactions;

9 (B) A broker-dealer registered **as a broker-dealer** under this act or not required to be  
10 registered as a broker-dealer under this act;

11 (C) An institutional investor;

12 (D) A nonaffiliated federal covered investment adviser with investments under  
13 management in excess of one hundred million dollars acting for the account of others pursuant  
14 to discretionary authority in a signed record;

15 (E) A bona fide preexisting customer whose principal place of residence is not in this  
16 state and the person is registered as a broker- dealer under the Securities Exchange Act of 1934  
17 or not required to be registered under the Securities Exchange Act of 1934 and is registered  
18 under the securities act of the state in which the customer maintains a principal place of  
19 residence;

20 (F) A bona fide preexisting customer whose principal place of residence is in this state  
21 but was not present in this state when the customer relationship was established, if:

22 (i) The broker-dealer is registered under the Securities Exchange Act of 1934 or not  
23 required to be registered under the Securities Exchange Act of 1934 and is registered under the  
24 securities laws of the state in which the customer relationship was established and where the  
25 customer had maintained a principal place of residence; and

26 (ii) Within forty-five days after the customer's first transaction in this state, the person  
27 files an application for registration as a broker- dealer in this state and a further transaction is not  
28 effected more than seventy-five days after the date on which the application is filed, or, if earlier,  
29 the date on which the commissioner notifies the person that the commissioner has denied the  
30 application for registration or has stayed the pendency of the application for good cause;

31 (G) Not more than three customers in this state during the previous twelve months, in  
32 addition to those customers specified in subparagraphs (A) to (F) and under subparagraph (H),  
33 if the broker-dealer is registered under the Securities Exchange Act of 1934 or not required to  
34 be registered under the Securities Exchange Act of 1934 and is registered under the securities  
35 act of the state in which the broker-dealer has its principal place of business; and

36 (H) Any other person exempted by rule adopted or order issued under this act; and

37 (2) A person that deals solely in United States government securities and is supervised  
38 as a dealer in government securities by the Board of Governors of the Federal Reserve System,  
39 the Comptroller of the Currency, the Federal Deposit Insurance Corporation, or the Office of  
40 Thrift Supervision.

41 (c) It is unlawful for a broker-dealer, or for an issuer engaged in offering, offering to  
42 purchase, purchasing, or selling securities in this state, directly or indirectly, to employ or  
43 associate with an individual to engage in an activity related to securities transactions in this state  
44 if the registration of the individual is suspended or revoked or the individual is barred from  
45 employment or association with a broker-dealer, an issuer, an investment adviser, or a federal  
46 covered investment adviser by an order of the commissioner under this act, the Securities and  
47 Exchange Commission, or a self-regulatory organization. A broker-dealer or issuer does not  
48 violate this subsection if the broker-dealer or issuer did not know and in the exercise of  
49 reasonable care could not have known, of the suspension, revocation, or bar. Upon request from  
50 a broker-dealer or issuer and for good cause, an order under this act may modify or waive, in  
51 whole or in part, the application of the prohibitions of this subsection to the broker-dealer.

52 (d) A rule adopted or order issued under this act may permit:

53 (1) A broker-dealer that is registered in Canada or other foreign jurisdiction and that does  
54 not have a place of business in this state to effect transactions in securities with or for, or attempt  
55 to effect the purchase or sale of any securities by:

56 (A) An individual from Canada or other foreign jurisdiction who is temporarily present  
57 in this state and with whom the broker-dealer had a bona fide customer relationship before the  
58 individual entered the United States;

59 (B) An individual from Canada or other foreign jurisdiction who is present in this state  
60 and whose transactions are in a self-directed tax advantaged retirement plan of which the  
61 individual is the holder or contributor in that foreign jurisdiction; or

62 (C) An individual who is present in this state, with whom the broker- dealer customer  
63 relationship arose while the individual was temporarily or permanently resident in Canada or the  
64 other foreign jurisdiction; and

65 (2) An agent who represents a broker-dealer that is exempt under this subsection to effect  
66 transactions in securities or attempt to effect the purchase or sale of securities in this state as  
67 permitted for a broker- dealer described in paragraph (1).

409.4-404. (a) It is unlawful for an individual to transact business in this state as an  
2 investment adviser representative unless the individual is registered under this act as an  
3 investment adviser representative or is exempt from registration as an investment adviser  
4 **representative** under subsection (b).

5 (b) The following individuals are exempt from the registration requirement of subsection  
6 (a):

7 (1) An individual who is employed by or associated with an investment adviser that is  
8 exempt from registration under section 409.4-403(b) or a federal covered investment adviser that  
9 is excluded from the notice filing requirements of section 409.4-405; and

10 (2) Any other individual exempted by rule adopted or order issued under this act.

11 (c) The registration of an investment adviser representative is not effective while the  
12 investment adviser representative is not employed by or associated with an investment adviser  
13 registered under this act or a federal covered investment adviser that has made or is required to  
14 make a notice filing under section 409.4-405.

15 (d) An individual may transact business as an investment adviser representative for more  
16 than one investment adviser or federal covered investment adviser unless a rule adopted or order  
17 issued under this act prohibits or limits an individual from acting as an investment adviser  
18 representative for more than one investment adviser or federal covered investment adviser.

19 (e) It is unlawful for an individual acting as an investment adviser representative, directly  
20 or indirectly, to conduct business in this state on behalf of an investment adviser or a federal  
21 covered investment adviser if the registration of the individual as an investment adviser  
22 representative is suspended or revoked or the individual is barred from employment or  
23 association with an investment adviser or a federal covered investment adviser by an order under  
24 this act, the Securities and Exchange Commission, or a self-regulatory organization. Upon  
25 request from a federal covered investment adviser and for good cause, the commissioner, by  
26 order issued, may waive, in whole or in part, the application of the requirements of this  
27 subsection to the federal covered investment adviser.

28 (f) An investment adviser registered under this act, a federal covered investment adviser  
29 that has filed a notice under section 409.4-405, or a broker-dealer registered under this act is not  
30 required to employ or associate with an individual as an investment adviser representative if the  
31 only compensation paid to the individual for a referral of investment advisory clients is paid to  
32 an investment adviser registered under this act, a federal covered investment adviser who has



33 filed a notice under section 409.4-405, or a broker-dealer registered under this act with which  
34 the individual is employed or associated as an investment adviser representative.

409.4-408. (a) If an agent registered under this act terminates employment by or  
2 association with a broker-dealer or issuer, or if an investment adviser representative registered  
3 under this act terminates employment by or association with an investment adviser or federal  
4 covered investment adviser, or if either registrant terminates activities that require registration  
5 as an agent or investment adviser representative, the broker-dealer, issuer, investment adviser,  
6 or federal covered investment adviser shall promptly file a notice of termination. If the registrant  
7 learns that the broker-dealer, issuer, investment adviser, or federal covered investment adviser  
8 has not filed the notice, the registrant may do so.

9 (b) If an agent registered under this act terminates employment by or association with  
10 a broker-dealer registered under this act and begins employment by or association with another  
11 broker-dealer registered under this act; or if an investment adviser representative registered under  
12 this act terminates employment by or association with an investment adviser registered under this  
13 act[;] or[, if] a federal covered investment adviser[, who] **that** has filed a notice under section  
14 409.4-405 and begins employment by or association with another investment adviser registered  
15 under this act[;] or [if] a federal covered investment adviser[, who] **that** has filed a notice under  
16 section 409.4-405[, ] ; **then** upon the filing by or on behalf of the registrant, within thirty days  
17 after the termination, of an application for registration that complies with the requirement of  
18 section 409.4-406(a) and payment of the filing fee required under section 409.4-410, the  
19 registration of the agent or investment adviser representative[, ] is:

20 (1) Immediately effective as of the date of the completed filing, if the agent's Central  
21 Registration Depository record or successor record or the investment adviser representative's  
22 Investment Adviser Registration Depository record or successor record does not contain a new  
23 or amended disciplinary disclosure within the previous twelve months; or

24 (2) Temporarily effective as of the date of the completed filing, if the agent's Central  
25 Registration Depository record or successor record or the investment adviser representative's  
26 Investment Adviser Registration Depository record or successor record contains a new or  
27 amended disciplinary disclosure within the preceding twelve months.

28 (c) The commissioner may by order withdraw a temporary registration if there are or  
29 were grounds for discipline as specified in section 409.4- 412 and the commissioner does so  
30 within thirty days after the filing of the application. If the commissioner does not withdraw the  
31 temporary registration within the thirty-day period, registration becomes automatically effective  
32 on the thirty-first day after filing.

33 (d) The commissioner may by order prevent the effectiveness of a transfer of an agent  
34 or investment adviser representative under subsection (b)(1) or (2) based on the public interest  
35 and the protection of investors.

36 (e) If the commissioner determines that a registrant or applicant for registration is no  
37 longer in existence or has ceased to act as a broker-dealer, agent, investment adviser, or  
38 investment adviser representative, or is the subject of an adjudication of incapacity or is subject  
39 to the control of a committee, conservator, or guardian, or cannot reasonably be located, a rule  
40 adopted or order issued under this act may require the registration be canceled or terminated or  
41 the application denied. The commissioner may reinstate a canceled or terminated registration,  
42 with or without hearing, and may make the registration retroactive.

2 409.4-412. (a) If the commissioner finds that the order is in the public interest and  
3 subsection (d) authorizes the action, an order issued under this act may deny an application, or  
4 may condition or limit registration[: (1)] of an applicant to be a broker-dealer, agent, investment  
5 adviser, or investment adviser representative, and [(2)] , if the applicant is a broker-dealer or  
6 investment adviser, of [any] a partner, officer, director, **or** person having a similar status or  
7 performing similar functions, or a person directly or indirectly [controlling] **in control of** the

9 (b) If the commissioner finds that the order is in the public interest and subsection (d)  
10 authorizes the action an order issued under this act may revoke, suspend, condition, or limit the

12 a partner, officer, [or] director, [any] **or** person having a similar status or performing similar  
13 functions, or [any] a person directly or indirectly [controlling] **in control of** the broker-dealer  
14 or investment adviser. However, the commissioner **shall not**:

15 (1) [May not] Institute a revocation or suspension proceeding under this subsection based  
16 on an order issued [by] **under a law of** another state that is reported to the commissioner or a  
17 designee [later] **of the commissioner more** than one year after the date of the order on which  
18 it is based; [and] **or**

19 (2) Under subsection (d)(5)(A) [and] **or** (B), [may not] issue an order on the basis of an  
20 order **issued** under the [state] securities act of another state unless the other order was based on  
21 conduct for which subsection (d) would authorize the action had the conduct occurred in this  
22 state.

23 (c) If the commissioner finds that the order is in the public interest and subsection (d)(1)  
24 to (6), (8), (9), (10), [or] (12) [and] **or** (13) authorizes the action, an order under this act may  
25 censure, impose a bar, or impose a civil penalty in an amount not to exceed a maximum of five  
26 thousand dollars for a single violation or fifty thousand dollars for [several violations] **more than**  
**one violation** on a registrant, and, if the registrant is a broker-dealer or investment adviser, [any]

27 a partner, officer, [or] director, [any] or person having a similar **status or performing similar**  
28 functions, or [any] a person directly or indirectly [controlling] **in control of** the broker-dealer  
29 or investment adviser.

30 (d) A person may be disciplined under subsections (a) to (c) if the person:

31 (1) Has filed an application for registration in this state under this act or the predecessor  
32 act within the previous ten years, which, as of the effective date of registration or as of any date  
33 after filing in the case of an order denying effectiveness, was incomplete in any material respect  
34 or contained a statement that, in light of the circumstances under which it was made, was false  
35 or misleading with respect to a material fact;

36 (2) Willfully violated or willfully failed to comply with this act or the predecessor act  
37 or a rule adopted or order issued under this act or the predecessor act within the previous ten  
38 years;

39 (3) Has been convicted of a felony or within the previous ten years has been convicted  
40 of a misdemeanor involving a security, a commodity future or option contract, or an aspect of  
41 a business involving securities, commodities, investments, franchises, insurance, banking, or  
42 finance;

43 (4) Is enjoined or restrained by a court of competent jurisdiction in an action instituted  
44 by the commissioner under this act or the predecessor act, a state, the Securities and Exchange  
45 Commission, or the United States from engaging in or continuing an act, practice, or course of  
46 business involving an aspect of a business involving securities, commodities, investments,  
47 franchises, insurance, banking, or finance;

48 (5) Is the subject of an order, issued after notice and opportunity for hearing by:

49 (A) The securities, depository institution, insurance, or other financial services regulator  
50 of a state or by the Securities and Exchange Commission or other federal agency denying,  
51 revoking, barring, or suspending registration as a broker-dealer, agent, investment adviser,  
52 federal covered investment adviser, or investment adviser representative;

53 (B) The securities regulator of a state or [by] the Securities and Exchange Commission  
54 against a broker-dealer, agent, investment adviser, investment adviser representative, or federal  
55 covered investment adviser;

56 (C) The Securities and Exchange Commission or [by] a self-regulatory organization  
57 suspending or expelling the registrant from membership in the self-regulatory organization;

58 (D) A court adjudicating a United States Postal Service fraud order;

59 (E) The insurance regulator of a state denying, suspending, or revoking [the] registration  
60 [of] as an insurance agent; or

61 (F) A depository institution regulator suspending or barring [a] the person from the  
62 depository institution business;

63 (6) Is the subject of an adjudication or determination, after notice and opportunity for  
64 hearing, by the Securities and Exchange Commission, the Commodity Futures Trading  
65 Commission; the Federal Trade Commission; a federal depository institution regulator, or a  
66 depository institution, insurance, or other financial services regulator of a state that the person  
67 willfully violated the Securities Act of 1933, the Securities Exchange Act of 1934, the  
68 Investment Advisers Act of 1940, the Investment Company Act of 1940, or the Commodity  
69 Exchange Act, the securities or commodities law of a state, or a federal or state law under which  
70 a business involving investments, franchises, insurance, banking, or finance is regulated;

71 (7) Is insolvent, either because the person's liabilities exceed the person's assets or  
72 because the person cannot meet the person's obligations as they mature, but the commissioner  
73 may not enter an order against an applicant or registrant under this paragraph without a finding  
74 of insolvency as to the applicant or registrant;

75 (8) Refuses to allow or otherwise impedes the commissioner from conducting an audit  
76 or inspection under section 409.4-411(d) or refuses access to a registrant's office to conduct an  
77 audit or inspection under section 409.4-411(d);

78 (9) Has failed to reasonably supervise an agent, investment adviser representative, or  
79 other individual, if the agent, investment adviser representative, or other individual was subject  
80 to the person's supervision and committed a violation of this act or the predecessor act or a rule  
81 adopted or order issued under this act or the predecessor act within the previous ten years;

82 (10) Has not paid the proper filing fee within thirty days after having been notified by  
83 the commissioner of a deficiency, but the commissioner shall vacate an order under this  
84 paragraph when the deficiency is corrected;

85 (11) After notice and opportunity for a hearing, has been found within the previous ten  
86 years:

87 (A) By a court of competent jurisdiction to have willfully violated the laws of a foreign  
88 jurisdiction under which the business of securities, commodities, investment, franchises,  
89 insurance, banking, or finance is regulated;

90 (B) To have been the subject of an order of a securities regulator of a foreign jurisdiction  
91 denying, revoking, or suspending the right to engage in the business of securities as a  
92 broker-dealer, agent, investment adviser, investment adviser representative, or similar person;  
93 or

94 (C) To have been suspended or expelled from membership by or participation in a  
95 securities exchange or securities association operating under the securities laws of a foreign  
96 jurisdiction;

97           (12) Is the subject of a cease and desist order issued by the Securities and Exchange  
98 Commission or issued under the securities, commodities, investment, franchise, banking,  
99 finance, or insurance laws of a state;

100           (13) Has engaged in dishonest or unethical practices in the securities, commodities,  
101 investment, franchise, banking, finance, or insurance business within the previous ten years; or

102           (14) Is not qualified on the basis of factors such as training, experience, and knowledge  
103 of the securities business. However, in the case of an application by an agent for a broker-dealer  
104 that is a member of a self-regulatory organization or by an individual for registration as an  
105 investment adviser representative, a denial order may not be based on this paragraph if the  
106 individual has successfully completed all examinations required by subsection (e). The  
107 commissioner may require an applicant for registration under section 409.4-402 or 409.4-404  
108 who has not been registered in a state within the two years preceding the filing of an application  
109 in this state to successfully complete an examination.

110           (e) A rule adopted or order issued under this act may require that an examination,  
111 including an examination developed or approved by an organization of securities regulators, be  
112 successfully completed by a class of individuals or all individuals. An order issued under this  
113 act may waive, in whole or in part, an examination as to an individual and a rule adopted under  
114 this act may waive, in whole or in part, an examination as to a class of individuals if the  
115 commissioner determines that the examination is not necessary or appropriate in the public  
116 interest and for the protection of investors.

117           (f) The commissioner may suspend or deny an application summarily; restrict, condition,  
118 limit, or suspend a registration; or censure, bar, or impose a civil penalty on a registrant before

124 the order becomes final by operation of law. If a hearing is requested or ordered, the  
125 commissioner, after notice of and opportunity for hearing to each person subject to the order,  
126 may modify or vacate the order or extend the order until final determination.

127           (g) An order issued may not be issued under this section, except under subsection (f),

- 129           (1) Appropriate notice to the applicant or registrant;  
130           (2) Opportunity for hearing; and  
131           (3) Findings of fact and conclusions of law in a record.

(h) A person that controls, directly or indirectly, a person not in compliance with this section may be disciplined by order of the commissioner under subsections (a) to (c) to the same extent as the noncomplying person, unless the controlling person did not know, and in the exercise of reasonable care could not have known, of the existence of conduct that is a ground for discipline under this section.

(i) The commissioner may not institute a proceeding under subsection (a), (b), or (c) based solely on material facts actually known by the commissioner unless an investigation or the proceeding is instituted within one year after the commissioner actually acquires knowledge of the material facts.

(j) Any applicant denied an agent, broker-dealer, investment adviser or investment adviser representative registration by order of the commissioner pursuant to subsection (a) may file a petition with the administrative hearing commission alleging that the commissioner has denied the registration. The administrative hearing commission shall conduct hearings and make findings of fact and conclusions of law. The commissioner shall have the burden of proving a ground for denial pursuant to this act.

(k) If a proceeding is instituted to revoke or suspend a registration of any agent, broker-dealer, investment adviser, or investment adviser representative pursuant to subsection (b), the commissioner shall refer the matter to the administrative hearing commission. The administrative hearing commission shall conduct hearings and make findings of fact and conclusions of law in such cases. The commissioner shall have the burden of proving a ground for suspension or revocation pursuant to this act. The administrative hearing commission shall submit its findings of fact and conclusions of law to the commissioner for final disposition.

(l) Hearing procedures before the commissioner or the administrative hearing commission and judicial review of the decisions and orders of the commissioner and of the administrative hearing commission, and all other procedural matters pursuant to this act shall be governed by the provisions of chapter 536, RSMo. Hearings before the administrative hearing commission shall also be governed by the provisions of chapter 621, RSMo.

409.5-501. It is unlawful for a person, in connection with the offer, sale, or purchase of a security, directly or indirectly:

(1) To employ a device, scheme, or artifice to defraud;

(2) To make an untrue statement of a material fact or to omit to state a material fact necessary in order to make the [statement] **statements** made, in the light of the circumstances under which [it is] **they were** made, not misleading; or

(3) To engage in an act, practice, or course of business that operates or would operate as a fraud or deceit upon another person.

2 409.5-508. (a) A person [that] **commits the crime of criminal securities fraud when**  
3 **such person** willfully violates **section 409.5-501.**

4 (b) **A person commits a criminal securities violation when such person willfully**  
5 **violates any other provision of** this act, or a rule adopted or order issued under this act, except  
6 Section 409.5-504 or the notice filing requirements of section 409.3-302 or 409.4-405, or that  
7 willfully violates section 409.5-505 knowing the statement made to be false or misleading in a  
8 material respect[, upon conviction, shall be fined not more than one million dollars or imprisoned  
9 not more than ten years, or both].

10 (c) **A person convicted of criminal securities fraud or any other criminal violation**  
11 **shall be fined not more than one million dollars or imprisoned not more than ten years, or**  
12 **both, unless the violation was committed against an elderly or disabled person, in which**  
13 **case the person shall be fined not less than fifty thousand dollars and imprisoned not less**  
14 **than five years. For purposes of this section, the following terms mean:**

15 (1) **"Disabled person", a person with a physical or mental impairment that**  
16 **substantially limits one or more of the major life activities of such individual, a record of**  
17 **such impairment, or being regarded as having such an impairment;**

18 (2) **"Elderly person", a person sixty years of age or older.**

19 (d) An individual convicted of violating a rule or order under this act may be fined, but  
20 may not be imprisoned, if the individual did not have knowledge of the rule or order.

21 [(b)] (e) The attorney general or the proper prosecuting attorney with or without a  
22 reference from the commissioner may institute criminal proceedings under this act.

23 [(c)] (f) This act does not limit the power of this state to punish a person for conduct that  
constitutes a crime under other laws of this state.

2 409.6-604. (a) If the commissioner determines that a person has engaged, is engaging,  
3 or is about to engage in an act, practice, or course of business constituting a violation of this act  
4 or a rule adopted or order issued under this act or that a person has materially aided, is materially  
5 aiding, or is about to materially aid an act, practice, or course of business constituting a violation  
6 of this act or a rule adopted or order issued under this act, the commissioner may:

7 (1) Issue an order directing the person to cease and desist from engaging in the act,  
8 practice, or course of business or to take other action necessary or appropriate to comply with  
9 this act;

10 (2) Issue an order denying, suspending, revoking, or conditioning the exemptions for a  
11 broker-dealer under section 409.4-401(b)(1)(D) or (F) or an investment adviser under section  
12 409.4-403(b)(1)(C); or

(3) Issue an order under section 409.2-204.

13 (b) An order under subsection (a) is effective on the date of issuance. Upon issuance of  
14 the order, the commissioner shall promptly serve each person subject to the order with a copy  
15 of the order and a notice that the order has been entered. The order must include a statement  
16 whether the commissioner will seek a civil penalty or costs of the investigation, a statement of  
17 the reasons for the order, and notice that, within fifteen days after receipt of a request in a record  
18 from the person, the matter will be scheduled for a hearing. If a person subject to the order does  
19 not request a hearing and none is ordered by the commissioner within thirty days after the date  
20 of service of the order, the order **which may include a civil penalty or costs of the**

11 RSMo, to a child under the age of fourteen, unless the child's custodial parent or guardian has  
12 consented in writing to the transaction. Criminal negligence as to the age of the child is not an

14 (4) **Being a wholesaler or retailer or any employee of a wholesaler or retailer, such**  
15 **person knowingly sells, rents, or otherwise makes available a video game which is rated M**  
16 **(mature) or AO (adults only) by the entertainment software rating board, (ESRB) or a**

29 **video game which contains graphic depictions of sexual behavior, including depictions of**  
30 **rape or other violent sexual acts, or obscenity, defined as patently offensive depictions or**  
31 **descriptions of sexual conduct, as defined in section 566.010, RSMo, including actual or**  
32 **simulated, normal or perverted acts of human masturbation; deviate sexual intercourse;**  
33 **sexual intercourse; or physical contact with a person's clothed or unclothed genitals, pubic**  
34 **area, buttocks, or the breast of a female in an act of apparent sexual stimulation or**  
35 **gratification or any sadomasochistic abuse or acts including animals or any latent objects**  
36 **in an act of apparent sexual stimulation or gratification, which appeal to the prurient**  
37 **interest, and lack serious literary, artistic, political, or scientific value, or an unrated game**  
38 **which contains the content mentioned in this subsection, to any person under the age of**  
39 **seventeen. It is no defense to a violation under this subsection that the defendant believed**

40 the person to be seventeen years of age or older unless the defendant requested  
41 identification from the person which contained both a photograph and date of birth  
42 purporting to show that the individual was seventeen years of age or older, and examined  
43 such identification before selling, renting, or otherwise making a video game rated M or  
44 AO available to the person.

45 2. Unlawful transactions with a child is a class B misdemeanor **unless committed under**  
46 **subdivision (4) of subsection 1 of this section in which case it is a class A misdemeanor.**

569.145. 1. In addition to the posting of real property as set forth in section 569.140, the  
2 owner or lessee of any real property may post the property by placing identifying purple paint  
3 marks on trees or posts around the area to be posted. Each paint mark shall be a vertical line of  
4 at least eight inches in length and the bottom of the mark shall be no less than three feet nor more  
5 than five feet high. Such paint marks shall be placed no more than one hundred feet apart and  
6 shall be readily visible to any person approaching the property. Property so posted is to be  
7 considered posted for all purposes, and any unauthorized entry upon the property is trespass in

570.040. 1. Every person who has previously pled guilty **to** or been found guilty [on two  
2 separate occasions] of [a] **two** stealing-related [offense] **offenses committed on two separate**  
3 **occasions** where such offenses occurred within ten years of the date of occurrence of the present  
4 offense [and where the person received a sentence of ten days or more on such previous offense]  
5 and who subsequently pleads guilty or is found guilty of a stealing-related offense is guilty of a  
6 class D felony, unless the subsequent plea or guilty verdict is pursuant to paragraph (a) of  
7 subdivision (3) of subsection 3 of section 570.030, in which case the person shall be guilty of  
8 a class B felony, and shall be punished accordingly.

9 2. As used in this section, the term "stealing-related offense" shall include federal and  
10 state violations of criminal statutes against stealing, **robbery** or buying or receiving stolen  
11 property and shall also include municipal ordinances against same if the defendant was either  
12 represented by counsel or knowingly waived counsel in writing and the judge accepting the plea  
13 or making the findings was a licensed attorney at the time of the court proceedings.

14 3. Evidence of prior guilty pleas or findings of guilt shall be heard by the court, out of  
15 the hearing of the jury, prior to the submission of the case to the jury, and the court shall  
16 determine the existence of the prior guilty pleas or findings of guilt.

573.037. 1. A person commits the crime of possession of child pornography if, knowing  
2 of its content and character, such person possesses any obscene material that has a child as one

3 of its participants or portrays what appears to be a child as an observer or participant of sexual  
4 conduct.

5 2. Possession of child pornography is a class [D] C felony unless the person has pleaded  
6 guilty to or has been found guilty of an offense under this section, in which case it is a class [C]  
7 B felony.

2 **575.153. 1. A person commits the crime of disarming a peace officer, as defined in**  
section 590.100, RSMo, or a correctional officer if such person intentionally:

3 (1) Removes a firearm or other deadly weapon from the person of a peace officer  
4 or correctional officer while such officer is acting within the scope of his or her official  
5 duties; or

6 (2) Deprives a peace officer or correctional officer of such officer's use of a firearm  
7 or deadly weapon while the officer is acting within the scope of his or her official duties.

8 2. The provisions of this section shall not apply when:

9 (1) The defendant does not know or could not reasonably have known that the  
10 person he or she disarmed was a peace officer or correctional officer; or

11 (2) The peace officer or correctional officer was engaged in an incident involving

14 3. Disarming a peace officer or correctional officer is a class C felony.

2 **577.020. 1. Sections 577.020 and 577.021 shall be known as the Alan Woods Law.**

3 2. Any person who operates a motor vehicle upon the public highways of this state shall  
4 be deemed to have given consent to, subject to the provisions of sections 577.020 to 577.041,  
5 a chemical test or tests of the person's breath, blood, saliva or urine for the purpose of  
6 determining the alcohol or drug content of the person's blood pursuant to the following  
7 circumstances:

8 (1) If the person is arrested for any offense arising out of acts which the arresting officer  
9 had reasonable grounds to believe were committed while the person was driving a motor vehicle  
10 while in an intoxicated or drugged condition; or

11 (2) If the person is under the age of twenty-one, has been stopped by a law enforcement

15 (3) If the person is under the age of twenty-one, has been stopped by a law enforcement

committed a violation of the traffic laws of the state, or any political subdivision of the state, and

17 such officer has reasonable grounds to believe, after making such stop, that such person has a  
18 blood alcohol content of two-hundredths of one percent or greater;

19 (4) If the person is under the age of twenty-one, has been stopped at a sobriety  
20 checkpoint or roadblock and the law enforcement officer has reasonable grounds to believe that  
21 such person has a blood alcohol content of two-hundredths of one percent or greater;

22 (5) If the person, while operating a motor vehicle, has been involved in a motor vehicle  
23 collision which resulted in a fatality or a readily apparent serious physical injury as defined in

32 The test shall be administered at the direction of the law enforcement officer whenever the  
33 person has been arrested or stopped for any reason.

34 [2.] **3.** The implied consent to submit to the chemical tests listed in subsection [1] **2** of  
35 this section shall be limited to not more than two such tests arising from the same arrest, incident  
36 or charge.

37 [3.] **4.** Chemical analysis of the person's breath, blood, saliva, or urine to be considered  
38 valid pursuant to the provisions of sections 577.020 to 577.041 shall be performed according to  
39 methods approved by the state department of health and senior services by licensed medical  
40 personnel or by a person possessing a valid permit issued by the state department of health and  
41 senior services for this purpose.

42 [4.] **5.** The state department of health and senior services shall approve satisfactory  
43 techniques, devices, equipment, or methods to be considered valid pursuant to the provisions of  
44 sections 577.020 to 577.041 and shall establish standards to ascertain the qualifications and  
45 competence of individuals to conduct analyses and to issue permits which shall be subject to  
46 termination or revocation by the state department of health and senior services.

47 [5.] **6.** The person tested may have a physician, or a qualified technician, chemist,  
48 registered nurse, or other qualified person at the choosing and expense of the person to be tested,  
49 administer a test in addition to any administered at the direction of a law enforcement officer.  
50 The failure or inability to obtain an additional test by a person shall not preclude the admission  
51 of evidence relating to the test taken at the direction of a law enforcement officer.

52 [6.] 7. Upon the request of the person who is tested, full information concerning the test  
53 shall be made available to such person.

54 [7.] 8. Any person given a chemical test of the person's breath pursuant to subsection [1]  
55 2 of this section or a field sobriety test may be videotaped during any such test at the direction  
56 of the law enforcement officer. Any such video recording made during the chemical test  
57 pursuant to this subsection or a field sobriety test shall be admissible as evidence at either any  
58 trial of such person for either a violation of any state law or county or municipal ordinance, or  
59 any license revocation or suspension proceeding pursuant to the provisions of chapter 302,  
60 RSMo.

577.021. 1. Any state, county or municipal law enforcement officer who has the power  
2 of arrest for violations of section 577.010 or 577.012 and who is certified pursuant to chapter  
3 590, RSMo, may, prior to arrest, administer a chemical test to any person suspected of operating  
4 a motor vehicle in violation of section 577.010 or 577.012.

5 **2. Any state, county, or municipal law enforcement officer who has the power of**  
6 **arrest for violations of section 577.010 or 577.012 and who is certified under chapter 590,**  
7 **RSMo, shall make all reasonable efforts to administer a chemical test to any person**  
8 **suspected of driving a motor vehicle involved in a collision which resulted in a fatality or**

10 **3.** A test administered pursuant to this section shall be admissible as evidence of  
11 probable cause to arrest and as exculpatory evidence, but shall not be admissible as evidence of  
12 blood alcohol content. The provisions of section 577.020 shall not apply to a test administered  
13 prior to arrest pursuant to this section.

577.023. 1. For purposes of this section, unless the context clearly indicates otherwise:

2 (1) An "aggravated offender" is a person who:

3 (a) Has pleaded guilty to or has been found guilty of three or more intoxication-related

5 (b) Has pleaded guilty to or has been found guilty of one or more intoxication-related

16 (a) A person who has pleaded guilty to or has been found guilty of four or more  
17 intoxication-related traffic offenses; or

18 (b) A person who has pleaded guilty to or has been found guilty of, on two or more  
19 separate occasions, any combination of the following:

20 **a.** Involuntary manslaughter under subdivision (2) or (3) of subsection 1 of section  
21 565.024, RSMo; murder in the second degree under section 565.021, RSMo, where the

51 (a) A person who has pleaded guilty to or has been found guilty of two or more

54 a. Involuntary manslaughter pursuant to subdivision (2) or (3) of subsection 1 of section

4 public road or state highway or on or in any of the waters in this state or on the banks of any  
5 stream, or on any land or water owned, operated or leased by the state, any board, department,  
6 agency or commission thereof or on any land or water owned, operated or leased by the federal  
7 government or on any private real property owned by another without his **or her** consent.

8 2. Littering is a class A misdemeanor.

9 **3. In addition to any fine or sentence of imprisonment imposed under this section**  
10 **any person who has pled guilty to or been found guilty of littering shall be required to:**

11 (1) **Perform at least ten days involving at least forty hours of community service**  
12 **under the supervision of the court in those jurisdictions which have a recognized program**  
13 **for community service; and**

14 (2) **Pay restitution in the amount of six hundred dollars one-half of which shall be**  
15 **deposited into the county law enforcement restitution fund under section 50.565, RSMo,**  
16 **in the county in which the crime occurred and one half of which shall be deposited into the**  
17 **county school fund under section 166.131, RSMo. If the county in which the crime**  
18 **occurred does not have a county law enforcement restitution fund, the entire restitution**  
19 **amount shall be deposited into the county school fund.**

577.500. 1. A court of competent jurisdiction shall, upon a plea of guilty, conviction or  
2 finding of guilt, or, if the court is a juvenile court, upon a finding of fact that the offense was  
3 committed by a juvenile, enter an order suspending or revoking the driving privileges of any  
4 person determined to have committed one of the following offenses and who, at the time said  
5 offense was committed, was under twenty-one years of age:

6 (1) Any alcohol-related traffic offense in violation of state law or a county or, beginning  
7 July 1, 1992, municipal ordinance, where the defendant was represented by or waived the right  
8 to an attorney in writing;

578.250. No person shall intentionally smell or inhale the fumes of any solvent,  
2 particularly toluol, **amyl nitrite, butyl nitrite, cyclohexyl nitrite, ethyl nitrite, pentyl nitrite,**  
3 **and propyl nitrite and their iso-analogues** or induce any other person to do so, for the purpose  
4 of causing a condition of, or inducing symptoms of, intoxication, elation, euphoria, dizziness,  
5 excitement, irrational behavior, exhilaration, paralysis, stupefaction, or dulling of senses or  
6 nervous system, or for the purpose of, in any manner, changing, distorting, or disturbing the  
7 audio, visual, or mental processes; except that this section shall not apply to the inhalation of any  
8 anesthesia for medical or dental purposes.

578.255. 1. **As used in this section "alcohol beverage vaporizer" means any device**  
2 **which, by means of heat, a vibrating element, or any method, is capable of producing a**  
3 **breathable mixture containing one or more alcoholic beverages to be dispensed for**  
4 **inhalation into the lungs via the nose or mouth or both.**

5         2. No person shall intentionally or willfully induce the symptoms of intoxication, elation,  
6 euphoria, dizziness, excitement, irrational behavior, exhilaration, paralysis, stupefaction, or  
7 dulling of the senses or nervous system, distortion of audio, visual or mental processes by the  
8 use **or abuse** of any [solvent, particularly toluol.] **of the following substances:**

- 9         **(1) Solvents, particularly toluol;**  
10         **(2) Ethyl alcohol;**  
11         **(3) Amyl nitrite and its iso-analogues;**  
12         **(4) Butyl nitrite and its iso-analogues;**  
13         **(5) Cyclohexyl nitrite and its iso-analogues;**  
14         **(6) Ethyl nitrite and its iso-analogues;**  
15         **(7) Pentyl nitrite and its iso-analogues; and**  
16         **(8) Propyl nitrite and its iso-analogues.**

17         3. **This statute shall not apply to substances that have been approved by the United**  
18 **States Food and Drug Administration as therapeutic drug products or are contained in**

19 **approved over-the-counter drug products or administered lawfully pursuant to the order**  
20 **of an authorized medical practitioner.**

21 [2.] **4. No person shall intentionally possess any solvent, particularly toluol, amyl nitrite,**  
22 **butyl nitrite, cyclohexyl nitrite, ethyl nitrite, pentyl nitrite, and propyl nitrite and their iso-**  
23 **analogues** for the purpose of using it in the manner prohibited by section 578.250 and this  
24 section.

25 **5. No person shall possess or use an alcoholic beverage vaporizer.**

578.260. 1. No person shall intentionally possess or buy any solvent, particularly toluol,  
2 **amyl nitrite, butyl nitrite, cyclohexyl nitrite, ethyl nitrite, pentyl nitrite, and propyl nitrite**  
3 **and their iso-analogues** for the purpose of inducing or aiding any other person to violate the  
4 provisions of sections 578.250 and 578.255.

5 2. Any person who violates any provision of sections 578.250 to 578.260 is guilty of a  
6 class B misdemeanor **for the first conviction and a class D felony for any subsequent**  
7 **convictions.**

578.265. 1. No person shall knowingly and intentionally sell or otherwise transfer  
2 possession of any solvent, particularly toluol, **amyl nitrite, butyl nitrite, cyclohexyl nitrite,**  
3 **ethyl nitrite, pentyl nitrite, and propyl nitrite and their iso-analogues** to any person for the  
4 purpose of causing a condition of, or inducing symptoms of, intoxication, elation, euphoria,  
5 dizziness, excitement, irrational behavior, exhilaration, paralysis, stupefaction, or dulling of  
6 senses or nervous system, or for the purpose of, in any manner, changing, distorting, or  
7 disturbing the audio, visual, or mental processes.

8 2. No person who owns or operates any business which receives over fifty percent of its  
9 gross annual income from the sale of alcoholic beverages or beer shall sell or offer for sale  
10 toluol, **amyl nitrite, butyl nitrite, cyclohexyl nitrite, ethyl nitrite, pentyl nitrite, and propyl**  
11 **nitrite and their iso-analogues,** or any toxic glue.

12 3. **No person who owns or operates any business which operates as a venue for live**  
13 **entertainment performance or receives over fifty percent of its gross annual income from**  
14 **the sale of recorded video entertainment shall sell or offer for sale toluol, amyl nitrite, butyl**  
15 **nitrite, cyclohexyl nitrite, ethyl nitrite, pentyl nitrite, propyl nitrite or their iso-analogues.**

16 4. Any person who violates the provisions of subsection 1 or 2 of this section is guilty  
17 of a class C felony.

578.409. 1. Any person who violates section 578.407:

2 (1) Shall be guilty of a misdemeanor for each such violation unless the loss, theft, or  
3 damage to the animal facility exceeds [three] **two** hundred dollars in value;

4 (2) Shall be guilty of a class D felony if the loss, theft, or damage to the animal facility  
5 property exceeds [three] **two** hundred dollars in value but does not exceed [ten] **five** thousand  
6 dollars in value;

7 (3) Shall be guilty of a class C felony if the loss, theft, or damage to the animal facility  
8 property exceeds [ten] **five** thousand dollars in value but does not exceed [one hundred]  
9 **seventy-five** thousand dollars in value;

10 (4) Shall be guilty of a class B felony if the loss, theft, or damage to the animal facility  
11 exceeds [one hundred] **seventy-five** thousand dollars in value.

12 2. Any person who intentionally agrees with another person to violate section 578.407  
13 and commits an act in furtherance of such violation shall be guilty of the same class of violation  
14 as provided in subsection 1 of this section.

15 3. In the determination of the value of the loss, theft, or damage to an animal facility, the  
16 court shall conduct a hearing to determine the reasonable cost of replacement of materials, data,  
17 equipment, animals, and records that were damaged, destroyed, lost, or cannot be returned, as  
18 well as the reasonable cost of lost production funds and repeating experimentation that may have  
19 been disrupted or invalidated as a result of the violation of section 578.407.

20 4. Any persons found guilty of a violation of section 578.407 shall be ordered by the  
21 court to make restitution, jointly and severally, to the owner, operator, or both, of the animal  
22 facility, in the full amount of the reasonable cost as determined under subsection 3 of this  
23 section.

24 5. Any person who has been damaged by a violation of section 578.407 may recover all  
25 actual and consequential damages, punitive damages, and court costs, including reasonable  
26 attorneys' fees, from the person causing such damage.

27 6. Nothing in sections 578.405 to 578.412 shall preclude any animal facility injured in  
28 its business or property by a violation of section 578.407 from seeking appropriate relief under  
29 any other provision of law or remedy including the issuance of an injunction against any person  
30 who violates section 578.407. The owner or operator of the animal facility may petition the court  
31 to permanently enjoin such persons from violating sections 578.405 to 578.412 and the court  
32 shall provide such relief.

**590.035. The POST commission shall make training available to peace officers that  
2 provides instruction on the investigation of crimes involving the use of computers, the  
3 Internet, or both, including but not limited to the crimes of sexual exploitation of a minor,  
4 possession of child pornography, or enticement of a child.**

595.030. 1. No compensation shall be paid unless the claimant has incurred an  
2 out-of-pocket loss of at least fifty dollars or has lost two continuous weeks of earnings or support  
3 from gainful employment. "Out-of-pocket loss" shall mean unreimbursed or unreimbursable

4 expenses or indebtedness reasonably incurred for medical care or other services, including  
5 psychiatric, psychological or counseling expenses, necessary as a result of the crime upon which  
6 the claim is based, except that the amount paid for psychiatric, psychological or counseling  
7 expenses per eligible claim shall not exceed two thousand five hundred dollars.

8         2. No compensation shall be paid unless the division of workers' compensation finds that  
9 a crime was committed, that such crime directly resulted in personal physical injury to, or the  
10 death of, the victim, and that police records show that such crime was promptly reported to the  
11 proper authorities. In no case may compensation be paid if the police records show that such  
12 report was made more than forty-eight hours after the occurrence of such crime, unless the  
13 division of workers' compensation finds that the report to the police was delayed for good cause.  
14 If the victim is under eighteen years of age such report may be made by the victim's parent,  
15 guardian or custodian; by a physician, a nurse, or hospital emergency room personnel; by the  
16 division of family services personnel; or by any other member of the victim's family.

17         3. No compensation shall be paid for medical care if the service provider is not a medical  
18 provider as that term is defined in section 595.027, and the individual providing the medical care  
19 is not licensed by the state of Missouri or the state in which the medical care is provided.

20         4. No compensation shall be paid for psychiatric treatment or other counseling services,  
21 including psychotherapy, unless the service provider is a:

22             (1) Physician licensed pursuant to chapter 334, RSMo, or licensed to practice medicine  
23 in the state in which the service is provided;

24             (2) Psychologist licensed pursuant to chapter 337, RSMo, or licensed to practice  
25 psychology in the state in which the service is provided;

26             (3) Clinical social worker licensed pursuant to chapter 337, RSMo; or

27             (4) Professional counselor licensed pursuant to chapter 337, RSMo.

28         5. Any compensation paid pursuant to sections 595.010 to 595.075 for death or personal  
29 injury shall be in an amount not exceeding out-of-pocket loss, together with loss of earnings or  
30 support from gainful employment, not to exceed [two] **four** hundred dollars per week, resulting  
31 from such injury or death. In the event of death of the victim, an award may be made for  
32 reasonable and necessary expenses actually incurred for preparation and burial not to exceed five  
33 thousand dollars.

34         6. **Compensation shall be paid under sections 595.010 to 595.075 for replacement**  
35 **of clothing, bedding, or other personal items of the victim that are seized by law**  
36 **enforcement as evidence of the crime and shall be in an amount equal to the loss sustained**  
37 **and not to exceed two hundred fifty dollars.**

38         7. Any compensation for loss of earnings or support from gainful employment shall be  
39 in an amount equal to the actual loss sustained not to exceed two hundred dollars per week;

40 provided, however, that no award pursuant to sections 595.010 to 595.075 shall exceed  
41 twenty-five thousand dollars. If two or more persons are entitled to compensation as a result of  
42 the death of a person which is the direct result of a crime or in the case of a sexual assault, the  
43 compensation shall be apportioned by the division of workers' compensation among the  
44 claimants in proportion to their loss.

45 [7.] 8. The method and timing of the payment of any compensation pursuant to sections  
46 595.010 to 595.075 shall be determined by the division.

595.209. 1. The following rights shall automatically be afforded to victims of dangerous  
2 felonies, as defined in section 556.061, RSMo, victims of murder in the first degree, as defined  
3 in section 565.020, RSMo, victims of voluntary manslaughter, as defined in section 565.023,  
4 RSMo, and victims of an attempt to commit one of the preceding crimes, as defined in section  
5 564.011, RSMo; and, upon written request, the following rights shall be afforded to victims of  
6 all other crimes and witnesses of crimes:

7 (1) For victims, the right to be present at all criminal justice proceedings at which the  
8 defendant has such right, including juvenile proceedings where the offense would have been a  
9 felony if committed by an adult, even if the victim is called to testify or may be called to testify  
10 as a witness in the case;

11 (2) For victims, the right to information about the crime, as provided for in subdivision  
12 (5) of this subsection;

13 (3) For victims and witnesses, to be informed, in a timely manner, by the prosecutor's  
14 office of the filing of charges, preliminary hearing dates, trial dates, continuances and the final  
15 disposition of the case. Final disposition information shall be provided within five days;

16 (4) For victims, the right to confer with and to be informed by the prosecutor regarding  
17 bail hearings, guilty pleas, pleas under chapter 552, RSMo, or its successors, hearings, sentencing  
18 and probation revocation hearings and the right to be heard at such hearings, including juvenile  
19 proceedings, unless in the determination of the court the interests of justice require otherwise;

20 (5) The right to be informed by local law enforcement agencies, the appropriate juvenile  
21 authorities or the custodial authority of the following:

22 (a) The status of any case concerning a crime against the victim, including juvenile  
23 offenses;

24 (b) The right to be informed by local law enforcement agencies or the appropriate  
25 juvenile authorities of the availability of victim compensation assistance, assistance in obtaining  
26 documentation of the victim's losses, including, but not limited to and subject to existing law  
27 concerning protected information or closed records, access to copies of complete, unaltered,  
28 unedited investigation reports of motor vehicle, pedestrian, and other similar accidents upon

29 request to the appropriate law enforcement agency by the victim or the victim's representative,  
30 and emergency crisis intervention services available in the community;

31 (c) Any release of such person on bond or for any other reason;

32 (d) Within twenty-four hours, any escape by such person from a municipal detention  
33 facility, county jail, a correctional facility operated by the department of corrections, mental  
34 health facility, or the division of youth services or any agency thereof, and any subsequent  
35 recapture of such person;

36 (6) For victims, the right to be informed by appropriate juvenile authorities of probation  
37 revocation hearings initiated by the juvenile authority and the right to be heard at such hearings  
38 or to offer a written statement, video or audio tape, **counsel or a representative designated by**  
39 **the victim** in lieu of a personal appearance, the right to be informed by the board of probation  
40 and parole of probation revocation hearings initiated by the board and of parole hearings, the  
41 right to be present at each and every phase of parole hearings and the right to be heard at  
42 probation revocation and parole hearings or to offer a written statement, video or audio tape,  
43 **counsel or a representative designated by the victim** in lieu of a personal appearance, and the  
44 right to be informed by the custodial mental health facility or agency thereof of any hearings for  
45 the release of a person committed pursuant to the provisions of chapter 552, RSMo, the right to  
46 be present at such hearings, the right to be heard at such hearings or to offer a written statement,  
47 video or audio tape, **counsel or a representative designated by the victim** in lieu of personal  
48 appearance;

49 (7) For victims and witnesses, upon their written request, the right to be informed by the  
50 appropriate custodial authority, including any municipal detention facility, juvenile detention  
51 facility, county jail, correctional facility operated by the department of corrections, mental health  
52 facility, division of youth services or agency thereof if the offense would have been a felony if  
53 committed by an adult, postconviction or commitment pursuant to the provisions of chapter 552,  
54 RSMo, of the following:

55 (a) The projected date of such person's release from confinement;

56 (b) Any release of such person on bond;

57 (c) Any release of such person on furlough, work release, trial release, electronic  
58 monitoring program, or to a community correctional facility or program or release for any other  
59 reason, in advance of such release;

60 (d) Any scheduled parole or release hearings, including hearings under section 217.362,  
61 RSMo, regarding such person and any changes in the scheduling of such hearings. No such  
62 hearing shall be conducted without thirty days' advance notice;

63 (e) Within twenty-four hours, any escape by such person from a municipal detention  
64 facility, county jail, a correctional facility operated by the department of corrections, mental



65 health facility, or the division of youth services or any agency thereof, and any subsequent  
66 recapture of such person;

67 (f) Any decision by a parole board, by a juvenile releasing authority or by a circuit court  
68 presiding over releases pursuant to the provisions of chapter 552, RSMo, or by a circuit court  
69 presiding over releases under section 217.362, RSMo, to release such person or any decision by  
70 the governor to commute the sentence of such person or pardon such person;

71 (g) Notification within thirty days of the death of such person;

72 (8) For witnesses who have been summoned by the prosecuting attorney and for victims,  
73 to be notified by the prosecuting attorney in a timely manner when a court proceeding will not  
74 go on as scheduled;

75 (9) For victims and witnesses, the right to reasonable protection from the defendant or  
76 any person acting on behalf of the defendant from harm and threats of harm arising out of their  
77 cooperation with law enforcement and prosecution efforts;

78 (10) For victims and witnesses, on charged cases or submitted cases where no charge  
79 decision has yet been made, to be informed by the prosecuting attorney of the status of the case  
80 and of the availability of victim compensation assistance and of financial assistance and  
81 emergency and crisis intervention services available within the community and information  
82 relative to applying for such assistance or services, and of any final decision by the prosecuting  
83 attorney not to file charges;

84 (11) For victims, to be informed by the prosecuting attorney of the right to restitution  
85 which shall be enforceable in the same manner as any other cause of action as otherwise  
86 provided by law;

87 (12) For victims and witnesses, to be informed by the court and the prosecuting attorney  
88 of procedures to be followed in order to apply for and receive any witness fee to which they are  
89 entitled;

90 (13) When a victim's property is no longer needed for evidentiary reasons or needs to be  
91 retained pending an appeal, the prosecuting attorney or any law enforcement agency having  
92 possession of the property shall, upon request of the victim, return such property to the victim  
93 within five working days unless the property is contraband or subject to forfeiture proceedings,  
94 or provide written explanation of the reason why such property shall not be returned;

95 (14) An employer may not discharge or discipline any witness, victim or member of a  
96 victim's immediate family for honoring a subpoena to testify in a criminal proceeding, **attending**  
97 **a criminal proceeding**, or for participating in the preparation of a criminal proceeding, **or**  
98 **require any witness, victim, or member of a victim's immediate family to use vacation time,**  
99 **personal time, or sick leave for honoring a subpoena to testify in a criminal proceeding,**

100 **attending a criminal proceeding, or participating in the preparation of a criminal**  
101 **proceeding;**

102 (15) For victims, to be provided with creditor intercession services by the prosecuting  
103 attorney if the victim is unable, as a result of the crime, temporarily to meet financial obligations;

104 (16) For victims and witnesses, the right to speedy disposition of their cases, and for  
105 victims, the right to speedy appellate review of their cases, provided that nothing in this  
106 subdivision shall prevent the defendant from having sufficient time to prepare such defendant's  
107 defense. The attorney general shall provide victims, upon their written request, case status  
108 information throughout the appellate process of their cases. The provisions of this subdivision  
109 shall apply only to proceedings involving the particular case to which the person is a victim or  
110 witness;

111 (17) For victims and witnesses, to be provided by the court, a secure waiting area during  
112 court proceedings and to receive notification of the date, time and location of any hearing  
113 conducted by the court for reconsideration of any sentence imposed, modification of such  
114 sentence or recall and release of any defendant from incarceration;

115 **(18) For victims, the right to receive upon request a photograph taken of the**  
116 **defendant prior to release from incarceration.**

117 2. The provisions of subsection 1 of this section shall not be construed to imply any  
118 victim who is incarcerated by the department of corrections or any local law enforcement agency  
119 has a right to be released to attend any hearing or that the department of corrections or the local  
120 law enforcement agency has any duty to transport such incarcerated victim to any hearing.

121 3. Those persons entitled to notice of events pursuant to the provisions of subsection 1  
122 of this section shall provide the appropriate person or agency with their current addresses and  
123 telephone numbers or the addresses or telephone numbers at which they wish notification to be

130 5. Victims' rights as established in section 32 of article I of the Missouri Constitution or

132 regardless of the desires of a defendant and no privileges of confidentiality shall exist in favor  
133 of the defendant to exclude victims or prevent their full participation in each and every phase of  
134 parole hearings or probation revocation hearings. The rights of the victims granted in this section  
135 are absolute and the policy of this state is that the victim's rights are paramount to the defendant's

136 rights. The victim has an absolute right to be present at any hearing in which the defendant is  
137 present before a probation and parole hearing officer.

610.105. **1.** If the person arrested is charged but the case is subsequently nolle prossed,  
2 dismissed, or the accused is found not guilty or imposition of sentence is suspended in the court  
3 in which the action is prosecuted, official records pertaining to the case shall thereafter be closed  
4 records when such case is finally terminated except as provided in **subsection 2 of this section**  
5 **and** section 610.120 and except that the court's judgment or order or the final action taken by the  
6 prosecutor in such matters may be accessed. If the accused is found not guilty due to mental  
7 disease or defect pursuant to section 552.030, RSMo, official records pertaining to the case shall  
8 thereafter be closed records upon such findings, except that the disposition may be accessed only  
9 by law enforcement agencies, child-care agencies, facilities as defined in section 198.006, RSMo,  
10 and in-home services provider agencies as defined in section 660.250, RSMo, in the manner

12 **2. If the person arrested is charged with an offense found in chapter 566, RSMo,**  
13 **section 568.045, 568.050, 568.060, 568.065, 568.080, 568.090, or 568.175, RSMo, and an**  
14 **imposition of sentence is suspended in the court in which the action is prosecuted, the**  
15 **official records pertaining to the case shall be made available to the victim for the purpose**  
16 **of using the records in his or her own judicial proceeding, or if the victim is a minor to the**  
17 **victim's parents or guardian, upon request.**

650.457. 1. There is established a "Missouri Medal of Valor Review Board", the  
2 members of which shall be individuals with knowledge or expertise, whether by experience or  
3 training, in the field of public safety, which shall conduct its business in accordance with sections  
4 650.450 to 650.460, and be composed of eleven members, all residents of Missouri, and  
5 appointed in the following manner:

- 6 (1) One member shall be either the director of the department of public safety or a  
7 designee appointed by the director;
- 8 (2) One member shall be a police chief;
- 9 (3) One member shall be a fire chief;
- 10 (4) One member shall be an elected county sheriff;
- 11 (5) One member shall be the director of an ambulance district;
- 12 (6) One member shall be a citizen with experience in law enforcement;
- 13 (7) One member shall be a citizen with experience in corrections;
- 14 (8) One member shall be a citizen with experience in fire fighting;
- 15 (9) One member shall be a citizen with experience in emergency medical services; and
- 16 (10) Two members shall be appointed at the governor's discretion.

17           2. [The term of a board member shall be four years.] **Members of the Missouri medal**  
18 **of valor board shall be appointed by the governor from a list of qualified candidates**  
19 **submitted to the governor by the director of the department of public safety. The**  
20 **appointments would be for a term of four years; except that, of those members first**  
21 **appointed, three members shall be appointed to serve for two years, four members shall**  
22 **be appointed for three years, and four members shall be appointed for four years.**  
23 **Members of the board may serve multiple terms.**

24           3. Any vacancy in the membership of the board shall not affect the powers of the board  
25 and shall be filled in the same manner as the original appointment.

26           4. (1) The chairman of the board shall be elected by the members of the board from  
27 among the members of the board.

28           (2) The board shall conduct its first meeting not later than ninety days after the  
29 appointment of the last member appointed of the initial group of members appointed to the  
30 board. Thereafter, the board shall meet at the call of the chairman of the board. The board shall  
31 meet not less often than once each year and not more than three times a year.

32           (3) A majority of the members shall constitute a quorum to conduct business, but the  
33 board may establish a lesser quorum for conducting hearings scheduled by the board. The board  
34 may establish by majority vote any other rules for the conduct of the board's business, if such  
35 rules are not inconsistent with sections 650.450 to 650.460 or other applicable law.

36           (4) The board shall select candidates as recipients of the medal from among those  
37 applications received by the board. Not more often than once each year, the board shall present  
38 to the governor the name or names of those it recommends as medal recipients. In a given year,  
39 the board shall not be required to select any recipients but may not select more than seven  
40 recipients. The governor may in extraordinary cases increase the number of recipients in a given  
41 year. The board shall set an annual timetable for fulfilling its duties under sections 650.450 to  
42 650.460.

43           (5) The board may secure directly from any department or agency such information as  
44 the board considers necessary to carry out its duties. Upon the request of the board, the head of  
45 such department or agency may furnish such information to the board.

46           (6) The board shall not disclose any information which may compromise an ongoing law  
47 enforcement investigation or is otherwise required by law to be kept confidential.

48           (7) The members of the board shall serve without compensation, except that the  
49 members may be reimbursed for reasonable and necessary expenses arising from board activities  
50 or business. Such expenses shall be paid by the department of public safety from the fund  
51 created pursuant to section 650.460.

**Section 1. The court may require as a condition of probation for a defendant to be**  
2 **vaccinated for hepatitis A and B at any qualified health department or facility, with costs**  
3 **to be paid by the defendant.**

**Section 2. In the event a criminal case is dismissed in a circuit court in this state**  
2 **before the defendant pleads guilty or is found guilty, the circuit judge may assess costs as**  
3 **determined by section 488.012, RSMo, against any defendant if the defendant consents to**  
4 **paying the costs except in those cases where the defendant is found by the judge to be**  
5 **indigent and unable to pay the costs.**

**Section 3. Any person who knowingly enters unlawfully or knowingly remains**  
2 **unlawfully on any real property designated as a licensed hunting preserve by the**  
3 **department of conservation shall be guilty of a class A misdemeanor.**
