### AN ACT

To repeal section 67.993, RSMo, and to enact in lieu thereof one new section relating to senior citizens' services fund tax.

---

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

Section A. Section 67.993, RSMo, is repealed and one new section enacted in lieu thereof, to be known as section 67.993, to read as follows:

67.993. 1. Upon the approval of the tax authorized by section 67.990 by the voters of the county or city not within a county, the tax so approved shall be imposed upon all taxable property within the county or city and the proceeds therefrom shall be deposited in a special fund, to be known as the "Senior Citizens' Services Fund", which is hereby established within the county or city treasury. No moneys in the senior citizens' services fund shall be spent until the board of directors provided for in subsection 2 of this section has been appointed and has taken office.

2. Upon approval of the tax authorized by section 67.990 by the voters of the county or city, the governing body of the county or the mayor of the city shall appoint a board of directors consisting of seven directors, who shall be selected from the county or city at large and shall, as nearly as practicable, represent the various groups to be served by the board. Each director shall be a resident of the county or city. Each director shall be appointed to serve for a term of four years and until his successor is duly appointed and qualified; except that, of the directors first appointed, one director shall be appointed for a term of one year, two directors shall be appointed for a term of two years, two directors shall be appointed for a term of three years, and two

16 directors shall be appointed for a term of four years. Directors may be reappointed. All  
17 vacancies on the board of directors shall be filled for the remainder of the unexpired term by the  
18 governing body of the county or mayor of the city. The directors shall not receive any  
19 compensation for their services, but may be reimbursed for all actual and necessary expenses  
20 incurred in the performance of their official duties from the moneys in the senior citizens'  
21 services fund.

22         3. The administrative control and management of the funds in the senior citizens'  
23 services fund and all programs **and senior centers** to be funded therefrom shall rest solely with  
24 the board of directors appointed under subsection 2 of this section; except that, the budget for  
25 the senior citizens' services fund shall be approved by the governing body of the county or city  
26 prior to making of any payments from the fund in any fiscal year. **Such budget shall contain**  
27 **allocation of funds to senior centers in the county or city where such property taxes are**  
28 **being collected for the purpose of operation and capital needs expenditures.** The board of  
29 directors shall use the funds in the senior citizens' services fund to provide **for operational and**  
30 **capital needs expenditures for senior centers, and** programs which will improve the health,  
31 nutrition, and quality of life of persons who are sixty years of age or older. No funds in the  
32 senior citizens' services fund may be used, directly or indirectly, for any political purpose. In  
33 providing such services, the board of directors may contract with any person to provide services  
34 relating, in whole or in part, to the services which the board itself may provide under this section,  
35 and for such purpose may expend the tax proceeds derived from the tax authorized by section  
36 67.990.

37         4. The board of directors shall elect a chairman, vice chairman, and such other officers  
38 as it deems necessary; shall establish eligibility requirements for the programs it furnishes; and  
39 shall do all other things necessary to carry out the purposes of sections 67.990 to 67.995. A  
40 majority of the board of directors shall constitute a quorum.

41         5. The board of directors, with the approval of the governing body of the county or city,  
42 may accept any gift of property or money for the use and benefit of the persons to be served  
43 through the programs established and funded under sections 67.990 to 67.995, and may sell or  
44 exchange any such property so long as such sale or exchange is in the best interests of the  
45 programs provided under sections 67.990 to 67.995 and the proceeds from such sale or exchange  
46 are used exclusively to fund such programs.
