**AN ACT**

To appropriate money for supplemental purposes for the several departments and offices of state government, and to transfer money among certain funds, from the funds designated for the fiscal period ending June 30, 2007.

---

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

There is appropriated out of the State Treasury, chargeable to the fund and for the agency  
2 and purpose designated, for the period ending June 30, 2007, as follows:

Section 16.005. To the Department of Higher Education

2 Funds are to be transferred out the State Treasury, chargeable to  
3 the General Revenue Fund, to the Student Grant Fund  
4 From General Revenue Fund ..... \$16,666,667

Section 16.010. To the Department of Higher Education

2 For the Charles E. Gallagher Grants Program pursuant to Chapter 173,  
3 RSMo, provided that up to \$133,333 may be used for contracts to  
4 accelerate student application processing  
5 From Student Grant Fund ..... \$16,666,667E

Section 16.015. To the Department of Higher Education

2 Funds are to be transferred out of the State Treasury, chargeable to  
3 the Lottery Proceeds Fund, to the Missouri College Guarantee  
4 Fund  
5 From Lottery Proceeds Fund . . . . . \$8,333,333

Section 16.020. To the Department of Higher Education

2 For the Missouri College Guarantee Program pursuant to Chapter 173,  
3 RSMo, provided that up to \$66,667 may be used for contracts to  
4 accelerate student application processing  
5 From Missouri College Guarantee Fund . . . . . \$8,333,333E

Section 16.025. To the Department of Health and Senior Services

2 For the purpose of funding the Primary Care Resource Initiative Program  
3 (PRIMO) and Area Health Education Centers (AHEC)  
4 From General Revenue Fund . . . . . \$3,400,000

Section 16.030. To the Department of Social Services

2 For the Division of Medical Services  
3 For design, renovation, construction, improvements, and purchase of  
4 equipment for Federally Qualified Health Centers statewide  
5 From General Revenue Fund . . . . . \$60,000,000
