AN ACT

To authorize the conveyance of property owned by the state in Pettis County to the Girl Scouts-Heart of Missouri Council, Inc., with an emergency clause.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section 1. 1. The governor is hereby authorized to remit, release, and forever quit
2 **claim any and all interest in property owned by the state in Pettis County to the Girl Scouts**
3 **- Heart of Missouri Council, Inc. The property to be conveyed is more particularly**
4 **described as follows:**
5 **The North Half of the Northwest Quarter of the Northeast Quarter of**
6 **Section Number Nineteen (19), also that part of the Northeast Quarter of the**
7 **Northeast Quarter of Section Number Nineteen (19) lying North and West**
8 **of the Sedalia and Warsaw Public Road, all in Township Number Forty Five**
9 **(45) North of Range Number Twenty One (21) West of the Fifth Principal**
10 **Meridian, containing twelve and eight tenths acres of land more or less.**

EXPLANATION — Matter enclosed in bold-faced brackets [thus] in the above bill is not enacted and is intended to be omitted from the law. Matter in **bold-face** type in the above bill is proposed language.

11 **2. The commissioner of administration shall set the terms and conditions for the**
12 **sale as the commissioner deems reasonable. Such terms and conditions may include, but**
13 **not be limited to, the number of appraisals required, the time, place, and terms of the sale.**

14 **3. The attorney general shall approve the form of the instrument of conveyance.**

Section A. Because immediate action is necessary to permit the Girl Scouts to obtain
2 financing for improvements on the property to be conveyed, section 1 of this act is deemed
3 necessary for the immediate preservation of the public health, welfare, peace, and safety, and is
4 hereby declared to be an emergency act within the meaning of the constitution, and section 1 of
5 this act shall be in full force and effect upon its passage and approval.
