FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of the State Courts Administrator**, **Office of the Attorney General** and the **Department of Health and Senior Services** each assume the proposal would have no fiscal impact on their respective agencies.

Officials from the **Boone County Recorder of Deeds** states the proposal would have some significant changes. Namely, all forms would have to be thrown away, reprinted and purchased by the counties. In addition, many counties including Boone have computer programs which print the information on the license and there would be a re-programming cost to include the actual date of birth on each license.

Annual cost for Boone County for printing the marriage license is estimated at \$2,000, but Boone County does not have an estimate of what the program changes would be.

Oversight assumes the counties will either have the reprinting cost or the reprogramming cost. The fiscal impact of the reprinting and reprogramming cost for all counties is unknown.
