## FISCAL ANALYSIS

### ASSUMPTION

Officials from the **Department of Elementary and Secondary Education** state this proposal will have no fiscal impact on their agency or on local school districts.

Officials from the **Mexico School District** indicated this proposal has no significant impact on their district.

Officials from the **Fair Grove School District** indicate financial impact could come from having to hire additional staff to allow for the elective courses these students will need in order to complete the required hours of education. Students will still need to complete a certain number of credit hours for graduation.

**Oversight** assumes that acceptable documentation submitted by the transfer student would qualify as a transfer of credit, therefore, additional elective classes would not be necessary.

No direct fiscal impact to small businesses would be expected as a result of this proposal.

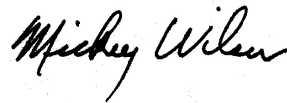
### FISCAL DESCRIPTION
