#### FISCAL ANALYSIS

## **ASSUMPTION**

Officials from the **Office of the State Courts Administrator** assume this proposal would not fiscally impact the courts.

Officials from the **Department of Public Safety - Fire Safety (DFS)** state they currently administer the fireworks licensing program. This proposal prohibits fireworks from being manufactured within 50 feet of any motor vehicle fuel dispensing station, propane dispensing station, compressed natural gas dispensing station, gasoline or propane bulk station. This proposal also defines 'fire department' and mandates fire departments register annually with DFS. Currently, DFS has 898 fire departments registered in Missouri.

DFS assumes the proposal would not fiscally impact their agency.

Officials from the Boone County Fire Protection District, Creve Coeur Fire District, Desoto Rural Fire Protection District, Hawk Point Fire Protection District, Lake Saint Louis Fire District, and Mehlville Fire District did not respond to our request for fiscal impact.
