FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Health and Senior Services** and the **Department of Labor and Industrial Relations** each assume the proposal would not fiscally impact their respective agencies.

Officials from the **Department of Public Safety - Division of Fire Safety (DFS)** state this proposed legislation contains several fire service-related issues. First, it defines "fire department", and specifies the annual reporting requirement for departments to register with DFS. The legislation also further defines a volunteer fire protection association. These clear definitions are needed when departments apply for federal and state assistance, and will assist DFS in maintaining clear and accurate records for Missouri fire departments. The proposal also creates the Volunteer Firefighter Job Protection Act which will protect volunteers from losing their regular job if they are responding to an emergency as a volunteer fire fighter.

Currently, the Division of Fire Safety has 898 fire departments registered in Missouri. We estimate there to be roughly 25,000 fire fighters in the State with approximately 80% of those being volunteers.

DFS assumes no fiscal impact from the proposal.

Officials from the cities of **Fulton, Columbia** and **Kirksville** did not respond to our request for fiscal impact. Officials from the **Boone County Fire District**, the **Lake Saint Louis Fire District** and the **Hawk Point Fire Protection District** also did not respond to our request for fiscal impact.


