#### FISCAL ANALYSIS

#### ASSUMPTION

Officials from the **Department of Public Safety - Alcohol and Tobacco Control (ATC)** assume the proposal would not fiscally impact their agency. ATC stated the revenue generated from the \$300 per resort fee for the ability to stay open from 1:30 a.m. to 3:00 a.m. is deposited into the General Revenue Fund. ATC also stated there was just one such resort license issued in fiscal year 2006.

Officials from **Miller County** assume the proposal would result in an increase in revenues for the county, but uncertain as to the amount.

Officials from the counties of **Camden** and **Morgan** did not respond to our request for fiscal impact.

Without this proposal the General Revenue Fund would receive \$300 less in revenue annually; however, **Oversight** assumes \$300 in revenue to the General Revenue Fund is immaterial, and therefore will not reflect this additional income in the fiscal note.
