### ASSUMPTION

### FISCAL IMPACT - Small Business

This proposal as written would not have a direct fiscal impact to small businesses. If voters would approve the imposition of a transient guest tax in the City of Hollister certain businesses would have fiscal impact related to the collection and administration of the guest tax.

### FISCAL DESCRIPTION

This bill authorizes the City of Hollister to impose, upon voter approval, a transient guest tax of up to 5% per night per sleeping quarters for the promotion of tourism. The bill contains an emergency clause.


This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
