FISCAL ANALYSIS

ASSUMPTION

Officials from the **Coordinating Board for Higher Education** indicated there would be no fiscal impact on their agency.

Officials from the **Office of Secretary of State (SOS)** assume many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact to the SOS office for Administrative Rules is less than \$2,500. The SOS recognizes this is a small amount and does not expect additional funding would be required to meet these costs. However, SOS also recognizes that many such bills may be passed in a given year and that collectively the costs may be in excess of what the SOS can sustain with their core budget. Any additional required funding would be handled through the budget process.

Officials from the **Office of the State Treasurer (STO)** state that their agency ensures the disbursements are made from a lawful appropriation and don't exceed the amount of the appropriation. The proposal, as written, could expand those duties for the "Teach for Missouri Fund". As written, STO would need an FTE (Accounting Specialist I - 339,324 plus 17,762 fringe = 57,086) to monitor these disbursements. (This will be allocated proportionately as a retention of interest earnings on state funds in accordance with Section 30.605 RSMo.)

Officials from the **Department of Elementary and Secondary Education (DES)** state the proposal requires that DES create and maintain a "Teach for Missouri" coordinator position. DES assumes a supervisor position would be able to carry out the requirements of the proposal. (§168.700.5)

For fiscal note purposes only, **Oversight** has calculated the salary based on the salary listing in current DES job opportunity postings.

Officials from the **University of Missouri** and the **University of Central Missouri** state there will be no additional costs to their institutions resulting from this proposal.

Officials from **Missouri State University** state they will be able to handle any additional highly qualified students that might attend their institution as a result of this proposal.

Officials from the Poplar Bluff School District indicated no fiscal impact to their district.

FISCAL DESCRIPTION

168.700.4

The Department of Elementary and Secondary Education shall create and maintain a "Teach for Missouri" coordinator position, the main responsibility of which shall be the identification, recruitment, and selection of potential students.

<u>168.700.9</u>

The general assembly shall appropriate an amount necessary to properly fund this program, not to exceed one million dollars in any fiscal year.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
