Bill Summary: This proposal prohibits foreclosure on a mortgage loan for up to eighteen months for a veteran not on active duty and who has made a good faith claim for disability benefits.

FISCAL DESCRIPTION

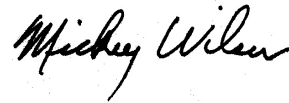
The proposed legislation appears to have no fiscal impact.
