AN ACT

To appropriate money for the expenses, grants, refunds, and distributions of the Department of Mental Health, the Board of Public Buildings, the Department of Health and Senior Services, and the several divisions and programs thereof, the Missouri Health Facilities Review Committee to be expended only as provided in Article IV, Section 28 of the Constitution of Missouri, for the period beginning July 1, 2007 and ending June 30, 2008.

Be it enacted by the General Assembly of the state of Missouri, as follows:

There is appropriated out of the State Treasury, to be expended only as provided in

And further provided 14 that individuals eligible for the Medicaid Personal Care Option 15 must be allowed to choose, from among all the program options, 16 that option which best meets their unmet need as determined by 17 13 CSR 15 9.030(5); and also be allowed to have their Medicaid 18 funds follow them to the extent necessary to meet their unmet 19 needs whichever option they choose. This language does not 20 create any entitlements not established by statute. Upon receipt of 21 a referral for Medicaid funded home and community based care 22 containing a nurse assessment or physician's order, the department 23 shall review the recommendations regarding services and process 24 the referral within 15 business days. When information contained 25 in the referral is sufficient to establish eligibility for Medicaid 26 funded long-term care and determine the level of service need as 27 required pursuant to state and federal regulations, the department 28 shall prior-authorize Home and Community based services and 29 arrange for the provision of services. Medicaid reimbursement for 30 personal care benefits shall be effective the date of the assessment 31 or physician's order. Medicaid reimbursement for Waiver services 32 shall be effective the date the state develops and approves the care 33 plan. At such time the state shall notify the referring entity. The in-34 home provider shall be reimbursed a minimum of one and no more 35 than two authorized nurse visits to make the initial nurse 36 assessment. When information is insufficient or the proposed care 37 plan requires additional evaluation by state staff that is not 38 obtainable from the referring entity, the department shall inform 39 the provider and contact the individual to schedule an in-home 40 assessment to be conducted by the state staff within 30 days 41 42 43
