	Whereas, Chamois, Missouri, is a community located along the Missouri River
2	in northern Osage County which has no means to cross the river except by way of bridges located
3 4	approximately 45 miles to the west and 30 miles to the east; and

5	Whereas, the people who live in Chamois incur increasingly high costs using
6	present routes in order to reach destinations on the north side of the Missouri River for
7	employment, recreation, and business; and

9	Whereas, people who live on the north side of the Missouri River are equally
10	$restricted \ from \ accessing \ destinations \ on \ the \ south \ side \ of \ the \ Missouri \ River, \ respectively; \ and$

12	Whereas, locating a ferryboat on the Missouri River at Chamois would allow
13	residents on both sides to cross the River, reducing travel times and travel costs, provide a safer
14	route, and conserve fuel; and
15	
16	Whereas, locating a ferryboat at Chamois would establish the only reported ferry
17	on the Missouri River and would thereby promote tourism on both sides of the River by
18	attracting more visitors to the area and creating a driving destination for tourists visiting such
19 20	communities as Hermann, Fulton, and Jefferson City; and

21	Whereas, locating a ferryboat at Chamois would likewise give residents on the
22	south side of the River access to the Katy Trail located on the north side of the River; and

24	Whereas, numerous organizations have endorsed the ferryboat at Chamois,
25	including but not limited to the Hermann Area Chamber of Commerce, the Fulton Area Chamber
26	of Commerce, the county commissions for Osage and Callaway counties, the City of Mokane,
27	the City of Chamois, and the Missouri Division of Tourism; and

29	Whereas, the promoters of the ferryboat at Chamois have requested federal and
30	state funding for the project:

32	Now, therefore, be it resolved that the members of the House of
33	Representatives of the Ninety-fourth General Assembly, First Regular Session, the Senate
34	concurring therein, hereby express support for the Chamois ferryboat and urge the Missouri
35	Department of Economic Development and the Missouri Department of Transportation, along
36	with other state agencies and the Missouri Congressional Delegation, to assist in securing
37	moneys for locating and construction of the ferryboat; and

39	Be it further resolved that the Chief Clerk of the Missouri House of
40	Representatives be instructed to prepare properly inscribed copies of this resolution for Governor
41	Matt Blunt, Gregory A. Steinhoff, the Director of the Department of Economic Development,
42	Peter Rahn, the Director of the Missouri Department of Transportation, and each member of the
43	Missouri Congressional Delegation.
