AN ACT

Be it enacted by the General Assembly of the state of Missouri, as follows:

43.010. As used in this chapter, the following terms shall have the meanings indicated:

- 2 (1) ["Commission", the Missouri state highways and transportation commission;
- 3 (2) "Members of the patrol", the superintendent, lieutenant colonel, majors, captains,
- 4 director of radio, lieutenants, sergeants, corporals, and patrolmen of the Missouri state highway
- 5 patrol;
- 6 [(3)] (2) "MULES", Missouri uniform law enforcement system, a
- 7 statewide-computerized communications system provided by the patrol designed to provide
- 8 services, information, and capabilities to the law enforcement and criminal justice community
- 9 in the state of Missouri;
- 10 [(4)] (3) "Patrol", the Missouri state highway patrol;
- 11 [(5)] (4) "Peace officers", sheriffs, police officers and other peace officers of this state;
- 12 [(6)] (5) "Radio personnel", those employees of the patrol engaged in the construction,
- 13 operation, and maintenance of the patrol radio system.

43.030. 1. The superintendent of the Missouri state highway patrol shall be appointed
2 by the governor by and with the advice and consent of the senate. The superintendent shall hold
3 office at the pleasure of the governor. The superintendent shall be a citizen of the United States
4 and a resident taxpaying citizen of this state for a period of three years previous to being
5 appointed as superintendent and shall be at least thirty years of age. **The superintendent shall**
6 **be a current uniformed member of the Missouri state highway patrol.** The superintendent
7 shall maintain an office [and reside] in Jefferson City.

8 2. The superintendent of the Missouri state highway patrol shall:

9 (1) Have command of the patrol and perform all duties imposed on the superintendent
10 and exercise all of the powers and authority conferred upon the superintendent by the provisions
11 of this chapter and the requirements of chapter 650, RSMo;

12 (2) Within available appropriations, establish an equitable pay plan for the members of
13 the highway patrol and radio personnel taking into consideration ranks and length of service.

43.050. 1. The superintendent may appoint not more than twenty-five captains and one
2 director of radio, each of whom shall have the same qualifications as the superintendent, nor
3 more than sixty lieutenants, and such additional force of sergeants, corporals and patrolmen, so
4 that the total number of members of the patrol shall not exceed nine hundred sixty-five officers
5 and patrolmen and such numbers of radio personnel as the superintendent deems necessary.

6 2. In case of a national emergency the superintendent may name additional patrolmen
7 and radio personnel in a number sufficient to replace, temporarily, patrolmen and radio personnel
8 called into military services.

9 3. **The superintendent may enter into an agreement with the Missouri gaming**
10 **commission related to the enforcement of any law, regulation, and conduct background**
11 **investigations related to the laws of this state, and the regulation of licensed gaming**
12 **activities in chapter 313, RSMo. A notice of either party to terminate or modify the**
13 **provisions of such agreement shall be in writing and executed no less than one year from**
14 **the effective date of the termination or modification, unless mutually agreed upon by the**
15 **superintendent and the Missouri gaming commission.** Members of the patrol hired in
16 conjunction with any agreement with the Missouri gaming commission shall not be subject to
17 the personnel cap referenced in subsection 1 of this section. If such agreement is subsequently
18 terminated or modified to reduce the number of personnel used in such agreement, those
19 members affected by such termination or modification shall not be subject to the personnel cap
20 referenced in subsection 1 of this section for a period of [three] **five** years.

21 4. Members of the patrol hired in conjunction with the community-oriented policing
22 services federal grant or members assigned to fulfill the duties established in sections 43.350 to
23 43.380 shall not be subject to the personnel cap referenced in subsection 1 of this section.

24 5. Applicants shall not be discriminated against because of race, creed, color, national
25 origin or sex.

43.090. [The board of public buildings shall provide suitable offices for general
2 headquarters at Jefferson City, Missouri, which shall at all times be open and in charge of the
3 superintendent, or some member of the patrol designated by him.] The superintendent[, with the
4 consent and approval of the commission,] shall employ such clerical force, radio operators, and
5 other subordinates, and shall provide such office equipment, stationery, postage supplies,
6 [telegraph] **communication** and telephone facilities as he **or she** shall deem necessary **for**

7 **general headquarters located at Jefferson City, Missouri**, and shall also provide offices,
8 equipment, stationery, postage, clerical force, and other subordinates for the headquarters of each
9 [district] **troop or division** of the patrol. The state highway patrol [radio network]
10 **communications division** shall be under the control of and at the service of the superintendent
11 for such regular and emergency [bulletins] **communications**, and service as the superintendent
12 may require [from time to time].

43.110. The necessary expenses of the members of the patrol in the performance of their
2 duties shall be paid by the state when such members are away from their places of residence or
3 from the [district] **troop or division** to which they are assigned, subject to the approval of the
4 [commission] **superintendent**. No fee shall be allowed to any person or officer for the arrest
5 and transportation of persons arrested and transported by members of the patrol, and no witness
6 fees shall be granted or allowed members of the patrol in criminal cases. Witness fees for
7 members of the patrol in civil cases, and for testifying in federal court, shall be the same as
8 provided by law, and shall be claimed and collected by members of the patrol, and promptly
9 transmitted to the [division of collection in the department of revenue] **fund from which the**
10 **member or employee's position is funded**.

43.115. Subject to appropriation, any retired employee of the highway patrol
2 **required to perform as a witness in an official court proceeding no less than thirty miles**
3 **from their place of residence shall receive as compensation:**

4 (1) **Upon approval by the superintendent, a per diem of up to one hundred dollars**
5 **for each day of service;**

6 (2) **A mileage reimbursement which shall be equal to the rate prescribed by the**
7 **Internal Revenue Service for allowable expenses for motor vehicle use expressed as an**
8 **amount per mile; and**

9 (3) **A reimbursement of the necessary travel expenses incurred while in the**
10 **performance of their court duties as prescribed in section 43.110.**

43.120. 1. The superintendent shall prescribe rules for instruction and discipline and
2 make all administrative rules and regulations and fix the hours of duty for the members of the
3 patrol. The superintendent shall divide the state into [districts] **troops** and assign members of
4 the patrol to such [districts] **troops** in the manner as deemed proper to carry out the purposes of
5 this chapter. The superintendent may call members of the patrol from one [district] **troop** to
6 another.

7 2. The superintendent shall appoint the lieutenant colonel and five majors from within
8 the membership. Such individuals shall serve at the superintendent's pleasure and shall return
9 to their previously held rank after being relieved of their position duties by the present or
10 incoming superintendent. The superintendent shall classify and rank through promotions the

11 majors, the director of radio, captains, lieutenants, sergeants, corporals, patrolmen, and radio
12 personnel from the next lower grade after not less than one year of service satisfactorily
13 performed therein.

14 3. In case of the absence of the superintendent, or at the time the superintendent
15 designates, the lieutenant colonel shall assume the duties of the superintendent. In the absence
16 of both the superintendent and the lieutenant colonel, a major shall be designated by the
17 superintendent or by the lieutenant colonel. In case of the disability of the superintendent and
18 the lieutenant colonel, the governor may designate a major as acting superintendent and when
19 so designated, the acting superintendent shall have all the powers and duties of the
20 superintendent.

21 4. The superintendent shall collect, compile and keep available for the use of peace
22 officers of the state the information as is deemed necessary for the detection of crime and
23 identification of criminals. **The superintendent shall have the authority to direct members
24 and other employees of the patrol to carry out any public safety duty or service authorized
25 or appropriated by the general assembly.**

26 5. The superintendent is responsible for establishing policy, procedures, and regulations
27 in cooperation with the law enforcement and criminal justice community in protecting the
28 integrity of the MULES system. The superintendent shall be responsible for the administration
29 and enforcement of all MULES policies and regulations consistent with state and federal rules,
30 policy, and law by which the MULES system operates.

31 [6. Within ninety days after the close of each fiscal year, the superintendent shall make
32 to the governor and the commission a report of the activities of the patrol and the cost thereof
33 for the fiscal period.]

43.140. [1.] The members of the patrol, before entering upon the discharge of their
2 duties, shall each take and subscribe an oath to support the constitution and laws of the United
3 States and the state of Missouri and to faithfully demean themselves in office in the form
4 prescribed by section 11, article VII, of the constitution of this state and they shall each faithfully
5 perform the duties of their respective offices and safely keep and account for all moneys and
6 property received by them.

7 [2. The superintendent, major, director of radio, each member assigned to duty in the
8 department of finance and statistics and each member assigned to duty in the department of
9 supplies and equipment shall give bond to be approved by the commission. The bond of the
10 superintendent shall be twenty thousand dollars, and for each other member required to be
11 bonded, ten thousand dollars. The cost of furnishing all such bonds shall be paid by the state.]

43.160. It shall be the duty of the patrol to police the highways constructed and
2 maintained by the [commission] **state**; to regulate the movement of traffic thereon; to enforce

3 thereon the laws of this state relating to the operation and use of vehicles on the highways; to
4 enforce and prevent thereon the violation of the laws relating to the size, weight and speed of
5 commercial motor vehicles and all laws designed to protect and safeguard the highways
6 constructed and maintained by the [commission] **state**. It shall be the duty of the patrol
7 whenever possible to determine persons causing or responsible for the breaking, damaging or
8 destruction of any improved hard surfaced roadway, structure, sign markers, guard rail, or any
9 other appurtenance constructed or maintained by the [commission] **state** and to arrest persons
10 criminally responsible therefor and to bring them before the proper officials for prosecution. It
11 shall be the duty of the patrol to cooperate with such state official as may be designated by law
12 in the collection of all state revenue derived from highway users as an incident to their use or
13 right to use the highways of the state, including all license fees and taxes upon motor vehicles,
14 trailers, and motor vehicle fuels, and upon, with respect to, or on the privilege of the
15 manufacture, receipt, storage, distribution, sale or use thereof (except the sales tax on motor
16 vehicles and trailers, and all property taxes).

43.210. Any person arrested by a member of the patrol shall forthwith be taken by such
2 member before the court or associate circuit judge **or his or her designee** having jurisdiction of
3 the crime whereof such person so arrested is charged there to be dealt with according to law.

43.220. Neither the governor[, the commission,] nor the superintendent shall have any
2 power, right or authority to command, order or direct any member of the patrol to perform any
3 duty or service not authorized by [this chapter] **statute**.

43.530. **1.** For each request requiring the payment of a fee received by the central
2 repository, the requesting entity shall pay a fee of not more than [five] **nine** dollars per request
3 for criminal history record information not based on a fingerprint search [when the requesting
4 entity is required to obtain such information by any provision of state or federal law and pay a
5 fee of not more than fourteen dollars per request for criminal history record information based
6 on a fingerprint search when the requesting entity is required to obtain such information by any
7 provision of state or federal law; provided that, when the requesting entity is not required to
8 obtain such information by law, the requesting entity shall pay a fee of not more than ten dollars
9 per request for criminal history record information not based on a fingerprint search and] . **In**
10 **each year beginning on or after January 1, 2010, the superintendent may increase the fee**
11 **paid by requesting entities by an amount not to exceed one dollar per year, however, under**
12 **no circumstance shall the fee paid by requesting entities exceed fifteen dollars per request.**

2. For each request requiring the payment of a fee received by the central
14 **repository, the requesting entity shall** pay a fee of not more than twenty dollars per request for
15 criminal history record information based on a fingerprint search[. Each such] , **unless the**

16 **request is required under the provisions of section 210.487, RSMo, or section 571.101,**
17 **RSMo, in which case, the fee shall be fourteen dollars.**

18 **3. A request made under subsections 1 and 2 of this section** shall be limited to check
19 and search on one individual. Each request shall be accompanied by a check, warrant, voucher,
20 money order, or electronic payment payable to the state of Missouri-criminal record system or
21 payment shall be made in a manner approved by the highway patrol. The highway patrol may
22 establish procedures for receiving requests for criminal history record information for
23 classification and search for fingerprints, from courts and other entities, and for the payment of
24 such requests. There is hereby established by the treasurer of the state of Missouri a fund to be
25 entitled as the "Criminal Record System Fund". Notwithstanding the provisions of section
26 33.080, RSMo, to the contrary, if the moneys collected and deposited into this fund are not
27 totally expended annually for the purposes set forth in sections 43.500 to 43.543, the unexpended
28 moneys in such fund shall remain in the fund and the balance shall be kept in the fund to
29 accumulate from year to year.

43.546. 1. Any state agency, board, or commission may require the fingerprinting
2 **of applicants in specified occupations or appointments within the state agency, board, or**
3 **commission for the purpose of positive identification and receiving criminal history record**
4 **information when determining an applicant's ability or fitness to serve in such occupation**
5 **or appointment.**

6 **2. In order to facilitate the criminal background check under subsection 1 of this**
7 **section on any person employed or appointed by a state agency, board, or commission, and**
8 **in accordance with section 43.543, the applicant or employee shall submit a set of**
9 **fingerprints collected under the standards determined by the Missouri highway patrol.**
10 **The fingerprints and accompanying fees, unless otherwise arranged, shall be forwarded**
11 **to the highway patrol to be used to search the state criminal history repository and the**
12 **fingerprints shall be forwarded to the Federal Bureau of Investigation for a national**
13 **criminal background check. Notwithstanding the provisions of section 610.120, RSMo, all**
14 **records related to any criminal history information discovered shall be accessible and**
15 **available to the state agency making the request.**

43.547. 1. The Missouri state highway patrol, at the direction of the governor, shall
2 **conduct name or fingerprint background investigations of gubernatorial appointees. The**
3 **governor's directive shall state whether the background investigation shall be a name**
4 **background investigation or a fingerprint background investigation. In addition, the**
5 **patrol may, at the governor's direction, conduct other appropriate investigations to**
6 **determine if an applicant or appointee is in compliance with section 105.262, RSMo, and**
7 **other necessary inquiries to determine the person's suitability for positions of public trust.**

8 **2. In order to facilitate the fingerprint background investigation under subsection**
9 **1 of this section, and in accordance with the provisions of section 43.543, the appointee**
10 **shall submit a set of fingerprints collected under the standards determined by the Missouri**
11 **highway patrol. The fingerprints and accompanying fees, unless otherwise arranged, shall**
12 **be forwarded to the highway patrol to be used to search the state criminal history**
13 **repository and the fingerprints shall be forwarded to the Federal Bureau of Investigation**
14 **for a national criminal background check. Any background investigation conducted at the**
15 **direction of the governor under subsection 1 of this section may include criminal history**
16 **record information and other source information obtained by the highway patrol.**

2 50.565. 1. A county commission may establish by ordinance or order a fund whose
3 proceeds may be expended only for the purposes provided for in subsection 3 of this section.
4 The fund shall be designated as a county law enforcement restitution fund and shall be under the
5 supervision of a board of trustees consisting of two citizens of the county appointed by the
6 presiding commissioner of the county, two citizens of the county appointed by the sheriff of the
7 county, and one citizen of the county appointed by the county coroner or medical examiner. The
8 citizens so appointed shall not be **current or former county elected officials**, current or former
9 employees of the sheriff's department, the office of the prosecuting attorney for the county, **office**
10 **of the county commissioners**, or the county treasurer's office. If a county does not have a
11 coroner or medical examiner, the county treasurer shall appoint one citizen to the board of
12 trustees.

13 2. Money from the county law enforcement restitution fund shall only be expended upon
14 the approval of a majority of the members of the county law enforcement restitution fund's board
15 of trustees and only for the purposes provided for by subsection 3 of this section.

16 3. Money from the county law enforcement restitution fund shall only be expended for
17 the following purposes:

- 18 (1) Narcotics investigation, prevention, and intervention;
- 19 (2) Purchase of law enforcement-related equipment and supplies for the sheriff's office;
- 20 (3) Matching funds for federal or state law enforcement grants;
- 21 (4) Funding for the reporting of all state and federal crime statistics or information; and
- 22 (5) Any **county** law enforcement-related expense, including those **expenses** of the
23 prosecuting attorney, approved by the board of trustees for the county law enforcement
24 restitution fund that is reasonably related to investigation, charging, preparation, trial, and
25 disposition of criminal cases before the courts of the state of Missouri.

26 4. The county commission may not reduce any law enforcement agency's budget as a
result of funds the law enforcement agency receives from the county law enforcement restitution

27 fund. The restitution fund is to be used only as a supplement to the law enforcement agency's
28 funding received from other county, state, or federal funds.

29 5. County law enforcement restitution funds shall be audited as are all other county
30 funds.

31 6. No court may order the assessment and payment authorized by this section if the plea
32 of guilty or the finding of guilt is to [the charge of speeding, careless and imprudent driving, any
33 charge of violating a traffic control signal or sign, or] any charge which is a class C misdemeanor
34 or an infraction, **unless such charge is a moving violation, as defined by section 302.010,**
35 **RSMo.** No assessment and payment ordered pursuant to this section may exceed three hundred
36 dollars for any charged offense.

84.160. 1. As of August 28, 2006, the board of police commissioners shall have the
2 authority to compute and establish the annual salary of each member of the police force without
3 receiving prior authorization from the general assembly.

4 2. Each officer of police and patrolman whose regular assignment requires nonuniformed
5 attire may receive, in addition to his or her salary, an allowance not to exceed three hundred sixty
6 dollars per annum payable biweekly. Notwithstanding the provisions of subsection 1 of this
7 section to the contrary, no additional compensation or compensatory time off for overtime, court
8 time, or standby court time shall be paid or allowed to any officer of the rank of [sergeant]
9 **lieutenant** or above. Notwithstanding any other provision of law to the contrary, nothing in this
10 section shall prohibit the payment of additional compensation pursuant to this subsection to
11 officers of the ranks of [sergeants] **lieutenants** and above, provided that funding for such
12 compensation shall not:

13 (1) Be paid from the general funds of either the city or the board of police commissioners
14 of the city; or

15 (2) Be violative of any federal law or other state law.

16 3. It is the duty of the municipal assembly or common council of the cities to make the
17 necessary appropriation for the expenses of the maintenance of the police force in the manner
18 herein and hereafter provided; provided, that in no event shall such municipal assembly or
19 common council be required to appropriate for such purposes (including, but not limited to, costs
20 of funding pensions or retirement plans) for any fiscal year a sum in excess of any limitation
21 imposed by article X, section 21, Missouri Constitution; and provided further, that such
22 municipal assembly or common council may appropriate a sum in excess of such limitation for
23 any fiscal year by an appropriations ordinance enacted in conformity with the provisions of the
24 charter of such cities.

25 4. Notwithstanding the provisions of subsection 1 of this section to the contrary, the
26 board of police commissioners shall pay additional compensation for all hours of service

27 rendered by probationary patrolmen [and], patrolmen, **and sergeants** in excess of the established
28 regular working period, and the rate of compensation shall be one and one-half times the regular
29 hourly rate of pay to which each member shall normally be entitled; except that, the court time
30 and court standby time shall be paid at the regular hourly rate of pay to which each member shall
31 normally be entitled. No credit shall be given or deductions made from payments for overtime
32 for the purpose of retirement benefits.

33 5. Notwithstanding the provisions of subsection 1 of this section to the contrary,
34 probationary patrolmen [and], patrolmen, **and sergeants** shall receive additional compensation
35 for authorized overtime, court time and court standby time whenever the total accumulated time
36 exceeds forty hours. The accumulated forty hours shall be taken as compensatory time off at the
37 officer's discretion with the approval of his supervisor.

38 6. The allowance of compensation or compensatory time off for court standby time shall
39 be computed at the rate of one-third of one hour for each hour spent on court standby time.

40 7. The board of police commissioners may effect programs to provide additional
41 compensation to its employees for successful completion of academic work at an accredited
42 college or university, in amounts not to exceed ten percent of their yearly salaries or for field
43 training officer and lead officer responsibilities in amounts not to exceed three percent of their
44 yearly salaries for field training officer responsibilities and an additional three percent of their
45 yearly salaries for lead officer responsibilities. The board may designate up to one hundred fifty
46 employees as field training officers and up to fifty employees as lead officers.

47 8. The board of police commissioners:

48 (1) Shall provide or contract for life insurance coverage and for insurance benefits
49 providing health, medical and disability coverage for officers and employees of the department;

50 (2) Shall provide or contract for insurance coverage providing salary continuation
51 coverage for officers and employees of the police department;

52 (3) Shall provide health, medical, and life insurance coverage for retired officers and
53 employees of the police department. Health, medical and life insurance coverage shall be made
54 available for purchase to the spouses or dependents of deceased retired officers and employees
55 of the police department who receive pension benefits pursuant to sections 86.200 to 86.364,
56 RSMo, at the rate that such dependent's or spouse's coverage would cost under the appropriate
57 plan if the deceased were living;

58 (4) May pay an additional shift differential compensation to members of the police force
59 for evening and night tour of duty in an amount not to exceed ten percent of the officer's base
60 hourly rate.

61 9. Notwithstanding the provisions of subsection 1 of this section to the contrary, the
62 board of police commissioners shall pay additional compensation to members of the police force

63 up to and including the rank of [police officer] **sergeant** for any full hour worked between the
64 hours of 11:00 p.m. and 7:00 a.m., in amounts equal to five percent of the officer's base hourly
65 pay.

66 10. The board of police commissioners, from time to time and in its discretion, may pay
67 additional compensation to police officers, sergeants and lieutenants by paying commissioned
68 officers in the aforesaid ranks for accumulated, unused vacation time. Any such payments shall
69 be made in increments of not less than forty hours, and at rates equivalent to the base
70 straight-time rates being earned by said officers at the time of payment; except that, no such
71 officer shall be required to accept payment for accumulated unused vacation time.

174.700. The board of regents or board of governors of any state college or university
2 may appoint and employ as many college or university police officers as it may deem necessary
3 to **enforce regulations established under section 174.709 and general motor vehicle laws of**
4 **this state in accordance with section 174.712**, protect persons, property, and to preserve peace
5 and good order only in the public buildings, properties, grounds, and other facilities and locations
6 over which it has charge or control.

174.703. **1.** The college or university police officers, before they enter upon their duties,
2 shall take and subscribe an oath of office before some officer authorized to administer oaths, to
3 faithfully and impartially discharge the duties thereof, which oath shall be filed in the office of
4 the board, and the secretary of the board shall give each college police officer so appointed and
5 qualified a certificate of appointment, under the seal of the board, which certificate shall
6 empower him or her with the same authority to maintain order, preserve peace and make arrests
7 as is now held by peace officers.

8 **2. The college or university police officers shall have the authority to enforce the**
9 **regulations established in section 174.709 and general motor vehicle laws in accordance**
10 **with section 174.712 on the campus as proscribed in chapter 304, RSMo.** The college or
11 university police officer may in addition expel from the public buildings, campuses, and grounds,
12 persons violating the rules and regulations that may be prescribed by the board or others under
13 the authority of the board.

14 **3.** Such officer or employee of the state college or university as may be designated by
15 the board shall have immediate charge, control and supervision of police officers appointed by
16 authority of this section. Such college or university police officers shall have satisfactorily
17 completed before appointment a training course for police officers as prescribed by chapter 590,
18 RSMo, for state peace officers or, by virtue of previous experience or training, have met the
19 requirements of chapter 590, RSMo, **and have been certified under that chapter.**

174.706. Nothing in sections 174.700 to 174.706 shall be construed as denying the board
2 the right to appoint guards or watchmen who shall not be given the authority and powers
3 authorized by sections 174.700 to [174.706] **174.712**.

**174.709. 1. For the purpose of promoting public safety, health, and general welfare
2 and to protect life and property, the board of regents or board of governors of any state
3 college or university may establish regulations to control vehicular traffic, including speed
4 regulations, on any thoroughfare owned or maintained by the state college or university
5 and located within any of its campuses. Such regulations shall be consistent with the
6 provisions of the general motor vehicle laws of this state. Upon adoption of such
7 regulations, the state college or university shall have the authority to place official traffic
8 control devices, as defined in section 300.010, RSMo, on campus property.**

9 **2. The regulations established by the board of regents or board of governors of any
10 state college or university under subsection 1 of this section shall be codified, printed, and
11 distributed for public use. Adequate signs displaying the speed limit shall be posted along
12 such thoroughfares.**

13 **3. Violations of any regulation established under this section shall have the same
14 effect as a violation of municipal ordinances adopted under section 304.120, RSMo, with
15 penalty provisions as provided in section 304.570, RSMo. Points assessed against any
16 person under section 302.302, RSMo, for a violation of this section shall be the same as
17 provided for a violation of a county or municipal ordinance.**

18 **4. The provisions of this section shall apply only to moving violations.**

**174.712. All motor vehicles operated upon any thoroughfare owned or maintained
2 by the state college or university and located within any of its campuses shall be subject to
3 the provisions of the general motor vehicle laws of this state, including chapters 301, 302,
4 303, 304, 307, and 577, RSMo. Violations shall have the same effect as though such had
5 occurred on public roads, streets, or highways of this state.**

192.925. 1. To increase public awareness of the problem of elder abuse and neglect **and
2 financial exploitation of the elderly**, the department of health and senior services shall
3 implement an education and awareness program. Such program shall have the goal of reducing
4 the incidences of elder abuse and neglect **and financial exploitation of the elderly**, and may
5 focus on:

6 (1) The education and awareness of mandatory reporters on their responsibility to report
7 elder abuse and neglect **and financial exploitation of the elderly**;

8 (2) Targeted education and awareness for the public on the problem, identification and
9 reporting of elder abuse and neglect **and financial exploitation of the elderly**;

10 (3) Publicizing the elder abuse and neglect hot line telephone number;

11 (4) Education and awareness for law enforcement agencies and prosecutors on the
12 problem and identification of elder abuse and neglect **and financial exploitation of the elderly**,
13 and the importance of prosecuting cases pursuant to chapter 565, RSMo; and

14 (5) Publicizing the availability of background checks prior to hiring an individual for
15 caregiving purposes.

16 2. The department of social services and facilities licensed pursuant to chapters 197 and
17 198, RSMo, shall cooperate fully with the department of health and senior services in the
18 distribution of information pursuant to this program.

195.010. The following words and phrases as used in sections 195.005 to 195.425,
2 unless the context otherwise requires, mean:

3 (1) "Addict", a person who habitually uses one or more controlled substances to such an
4 extent as to create a tolerance for such drugs, and who does not have a medical need for such
5 drugs, or who is so far addicted to the use of such drugs as to have lost the power of self-control
6 with reference to his addiction;

7 (2) "Administer", to apply a controlled substance, whether by injection, inhalation,
8 ingestion, or any other means, directly to the body of a patient or research subject by:

9 (a) A practitioner (or, in his presence, by his authorized agent); or

10 (b) The patient or research subject at the direction and in the presence of the practitioner;

11 (3) "Agent", an authorized person who acts on behalf of or at the direction of a
12 manufacturer, distributor, or dispenser. The term does not include a common or contract carrier,
13 public warehouseman, or employee of the carrier or warehouseman while acting in the usual and
14 lawful course of the carrier's or warehouseman's business;

15 (4) "Attorney for the state", any prosecuting attorney, circuit attorney, or attorney general
16 authorized to investigate, commence and prosecute an action under sections 195.005 to 195.425;

17 (5) "Controlled substance", a drug, substance, or immediate precursor in Schedules I
18 through V listed in sections 195.005 to 195.425;

19 (6) "Controlled substance analogue", a substance the chemical structure of which is
20 substantially similar to the chemical structure of a controlled substance in Schedule I or II and:

21 (a) Which has a stimulant, depressant, or hallucinogenic effect on the central nervous
22 system substantially similar to the stimulant, depressant, or hallucinogenic effect on the central
23 nervous system of a controlled substance included in Schedule I or II; or

24 (b) With respect to a particular individual, which that individual represents or intends
25 to have a stimulant, depressant, or hallucinogenic effect on the central nervous system
26 substantially similar to the stimulant, depressant, or hallucinogenic effect on the central nervous
27 system of a controlled substance included in Schedule I or II. The term does not include a
28 controlled substance; any substance for which there is an approved new drug application; any

29 substance for which an exemption is in effect for investigational use, for a particular person,
30 under Section 505 of the federal Food, Drug and Cosmetic Act (21 U.S.C. 355) to the extent
31 conduct with respect to the substance is pursuant to the exemption; or any substance to the extent
32 not intended for human consumption before such an exemption takes effect with respect to the
33 substance;

34 (7) "Counterfeit substance", a controlled substance which, or the container or labeling
35 of which, without authorization, bears the trademark, trade name, or other identifying mark,
36 imprint, number or device, or any likeness thereof, of a manufacturer, distributor, or dispenser
37 other than the person who in fact manufactured, distributed, or dispensed the substance;

38 (8) "Deliver" or "delivery", the actual, constructive, or attempted transfer from one
39 person to another of drug paraphernalia or of a controlled substance, or an imitation controlled
40 substance, whether or not there is an agency relationship, and includes a sale;

41 (9) "Dentist", a person authorized by law to practice dentistry in this state;

42 (10) "Depressant or stimulant substance":

43 (a) A drug containing any quantity of barbituric acid or any of the salts of barbituric acid
44 or any derivative of barbituric acid which has been designated by the United States Secretary of
45 Health and Human Services as habit forming under 21 U.S.C. 352(d);

46 (b) A drug containing any quantity of:

47 a. Amphetamine or any of its isomers;

48 b. Any salt of amphetamine or any salt of an isomer of amphetamine; or

49 c. Any substance the United States Attorney General, after investigation, has found to
50 be, and by regulation designated as, habit forming because of its stimulant effect on the central
51 nervous system;

52 (c) Lysergic acid diethylamide; or

53 (d) Any drug containing any quantity of a substance that the United States Attorney
54 General, after investigation, has found to have, and by regulation designated as having, a
55 potential for abuse because of its depressant or stimulant effect on the central nervous system or
56 its hallucinogenic effect;

57 (11) "Dispense", to deliver a narcotic or controlled dangerous drug to an ultimate user
58 or research subject by or pursuant to the lawful order of a practitioner including the prescribing,
59 administering, packaging, labeling, or compounding necessary to prepare the substance for such
60 delivery. "Dispenser" means a practitioner who dispenses;

61 (12) "Distribute", to deliver other than by administering or dispensing a controlled
62 substance;

63 (13) "Distributor", a person who distributes;

64 (14) "Drug":

65 (a) Substances recognized as drugs in the official United States Pharmacopoeia, Official
66 Homeopathic Pharmacopoeia of the United States, or Official National Formulary, or any
67 supplement to any of them;

68 (b) Substances intended for use in the diagnosis, cure, mitigation, treatment or
69 prevention of disease in humans or animals;

70 (c) Substances, other than food, intended to affect the structure or any function of the
71 body of humans or animals; and

72 (d) Substances intended for use as a component of any article specified in this
73 subdivision. It does not include devices or their components, parts or accessories;

74 (15) "Drug-dependent person", a person who is using a controlled substance and who
75 is in a state of psychic or physical dependence, or both, arising from the use of such substance
76 on a continuous basis. Drug dependence is characterized by behavioral and other responses
77 which include a strong compulsion to take the substance on a continuous basis in order to
78 experience its psychic effects or to avoid the discomfort caused by its absence;

79 (16) "Drug enforcement agency", the Drug Enforcement Administration in the United
80 States Department of Justice, or its successor agency;

81 (17) "Drug paraphernalia", all equipment, products, substances and materials of any kind
82 which are used, intended for use, or designed for use, in planting, propagating, cultivating,
83 growing, harvesting, manufacturing, compounding, converting, producing, processing, preparing,
84 storing, containing, concealing, injecting, ingesting, inhaling, or otherwise introducing into the
85 human body a controlled substance or an imitation controlled substance in violation of sections
86 195.005 to 195.425. It includes, but is not limited to:

87 (a) Kits used, intended for use, or designed for use in planting, propagating, cultivating,
88 growing or harvesting of any species of plant which is a controlled substance or from which a
89 controlled substance can be derived;

90 (b) Kits used, intended for use, or designed for use in manufacturing, compounding,
91 converting, producing, processing, or preparing controlled substances or imitation controlled
92 substances;

93 (c) Isomerization devices used, intended for use, or designed for use in increasing the
94 potency of any species of plant which is a controlled substance or an imitation controlled
95 substance;

96 (d) Testing equipment used, intended for use, or designed for use in identifying, or in
97 analyzing the strength, effectiveness or purity of controlled substances or imitation controlled
98 substances;

99 (e) Scales and balances used, intended for use, or designed for use in weighing or
100 measuring controlled substances or imitation controlled substances;

- 101 (f) Dilutents and adulterants, such as quinine hydrochloride, mannitol, mannite, dextrose
102 and lactose, used, intended for use, or designed for use in cutting controlled substances or
103 imitation controlled substances;
- 104 (g) Separation gins and sifters used, intended for use, or designed for use in removing
105 twigs and seeds from, or in otherwise cleaning or refining, marijuana;
- 106 (h) Blenders, bowls, containers, spoons and mixing devices used, intended for use, or
107 designed for use in compounding controlled substances or imitation controlled substances;
- 108 (i) Capsules, balloons, envelopes and other containers used, intended for use, or designed
109 for use in packaging small quantities of controlled substances or imitation controlled substances;
- 110 (j) Containers and other objects used, intended for use, or designed for use in storing or
111 concealing controlled substances or imitation controlled substances;
- 112 (k) Hypodermic syringes, needles and other objects used, intended for use, or designed
113 for use in parenterally injecting controlled substances or imitation controlled substances into the
114 human body;
- 115 (l) Objects used, intended for use, or designed for use in ingesting, inhaling, or otherwise
116 introducing marijuana, cocaine, hashish, or hashish oil into the human body, such as:
- 117 a. Metal, wooden, acrylic, glass, stone, plastic, or ceramic pipes with or without screens,
118 permanent screens, hashish heads, or punctured metal bowls;
- 119 b. Water pipes;
- 120 c. Carburetion tubes and devices;
- 121 d. Smoking and carburetion masks;
- 122 e. Roach clips meaning objects used to hold burning material, such as a marijuana
123 cigarette, that has become too small or too short to be held in the hand;
- 124 f. Miniature cocaine spoons and cocaine vials;
- 125 g. Chamber pipes;
- 126 h. Carburetor pipes;
- 127 i. Electric pipes;
- 128 j. Air-driven pipes;
- 129 k. Chillums;
- 130 l. Bongs;
- 131 m. Ice pipes or chillers;
- 132 (m) Substances used, intended for use, or designed for use in the manufacture of a
133 controlled substance;
- 134

135 In determining whether an object, product, substance or material is drug paraphernalia, a court
136 or other authority should consider, in addition to all other logically relevant factors, the
137 following:

138 (a) Statements by an owner or by anyone in control of the object concerning its use;

139 (b) Prior convictions, if any, of an owner, or of anyone in control of the object, under any
140 state or federal law relating to any controlled substance or imitation controlled substance;

141 (c) The proximity of the object, in time and space, to a direct violation of sections
142 195.005 to 195.425;

143 (d) The proximity of the object to controlled substances or imitation controlled
144 substances;

145 (e) The existence of any residue of controlled substances or imitation controlled
146 substances on the object;

147 (f) Direct or circumstantial evidence of the intent of an owner, or of anyone in control
148 of the object, to deliver it to persons who he knows, or should reasonably know, intend to use
149 the object to facilitate a violation of sections 195.005 to 195.425; the innocence of an owner, or
150 of anyone in control of the object, as to direct violation of sections 195.005 to 195.425 shall not
151 prevent a finding that the object is intended for use, or designed for use as drug paraphernalia;

152 (g) Instructions, oral or written, provided with the object concerning its use;

153 (h) Descriptive materials accompanying the object which explain or depict its use;

154 (i) National or local advertising concerning its use;

155 (j) The manner in which the object is displayed for sale;

156 (k) Whether the owner, or anyone in control of the object, is a legitimate supplier of like
157 or related items to the community, such as a licensed distributor or dealer of tobacco products;

158 (l) Direct or circumstantial evidence of the ratio of sales of the object to the total sales
159 of the business enterprise;

160 (m) The existence and scope of legitimate uses for the object in the community;

161 (n) Expert testimony concerning its use;

162 (o) The quantity, form or packaging of the product, substance or material in relation to
163 the quantity, form or packaging associated with any legitimate use for the product, substance or
164 material;

165 (18) "Federal narcotic laws", the laws of the United States relating to controlled
166 substances;

167 (19) "Hospital", a place devoted primarily to the maintenance and operation of facilities
168 for the diagnosis, treatment or care, for not less than twenty-four hours in any week, of three or
169 more nonrelated individuals suffering from illness, disease, injury, deformity or other abnormal
170 physical conditions; or a place devoted primarily to provide, for not less than twenty-four

171 consecutive hours in any week, medical or nursing care for three or more nonrelated individuals.
172 The term "hospital" does not include convalescent, nursing, shelter or boarding homes as defined
173 in chapter 198, RSMo;

174 (20) "Immediate precursor", a substance which:

175 (a) The state department of health and senior services has found to be and by rule
176 designates as being the principal compound commonly used or produced primarily for use in the
177 manufacture of a controlled substance;

178 (b) Is an immediate chemical intermediary used or likely to be used in the manufacture
179 of a controlled substance; and

180 (c) The control of which is necessary to prevent, curtail or limit the manufacture of the
181 controlled substance;

182 (21) "Imitation controlled substance", a substance that is not a controlled substance,
183 which by dosage unit appearance (including color, shape, size and markings), or by
184 representations made, would lead a reasonable person to believe that the substance is a controlled
185 substance. In determining whether the substance is an "imitation controlled substance" the court
186 or authority concerned should consider, in addition to all other logically relevant factors, the
187 following:

188 (a) Whether the substance was approved by the federal Food and Drug Administration
189 for over-the-counter (nonprescription or nonlegend) sales and was sold in the federal Food and
190 Drug Administration approved package, with the federal Food and Drug Administration
191 approved labeling information;

192 (b) Statements made by an owner or by anyone else in control of the substance
193 concerning the nature of the substance, or its use or effect;

194 (c) Whether the substance is packaged in a manner normally used for illicit controlled
195 substances;

196 (d) Prior convictions, if any, of an owner, or anyone in control of the object, under state
197 or federal law related to controlled substances or fraud;

198 (e) The proximity of the substances to controlled substances;

199 (f) Whether the consideration tendered in exchange for the noncontrolled substance
200 substantially exceeds the reasonable value of the substance considering the actual chemical
201 composition of the substance and, where applicable, the price at which over-the-counter
202 substances of like chemical composition sell. An imitation controlled substance does not include
203 a placebo or registered investigational drug either of which was manufactured, distributed,
204 possessed or delivered in the ordinary course of professional practice or research;

205 (22) "Laboratory", a laboratory approved by the department of health and senior services
206 as proper to be entrusted with the custody of controlled substances but does not include a
207 pharmacist who compounds controlled substances to be sold or dispensed on prescriptions;

208 (23) "Manufacture", the production, preparation, propagation, compounding or
209 processing of drug paraphernalia or of a controlled substance, or an imitation controlled
210 substance, either directly or by extraction from substances of natural origin, or independently by
211 means of chemical synthesis, or by a combination of extraction and chemical synthesis, and
212 includes any packaging or repackaging of the substance or labeling or relabeling of its container.
213 This term does not include the preparation or compounding of a controlled substance or an
214 imitation controlled substance or the preparation, compounding, packaging or labeling of a
215 narcotic or dangerous drug:

216 (a) By a practitioner as an incident to his administering or dispensing of a controlled
217 substance or an imitation controlled substance in the course of his professional practice, or

218 (b) By a practitioner or his authorized agent under his supervision, for the purpose of,
219 or as an incident to, research, teaching or chemical analysis and not for sale;

220 (24) "Marijuana", all parts of the plant genus Cannabis in any species or form thereof,
221 including, but not limited to Cannabis Sativa L., Cannabis Indica, Cannabis Americana,
222 Cannabis Ruderalis, and Cannabis Gigantea, whether growing or not, the seeds thereof, the resin
223 extracted from any part of the plant; and every compound, manufacture, salt, derivative, mixture,
224 or preparation of the plant, its seeds or resin. It does not include the mature stalks of the plant,
225 fiber produced from the stalks, oil or cake made from the seeds of the plant, any other compound,
226 manufacture, salt, derivative, mixture or preparation of the mature stalks (except the resin
227 extracted therefrom), fiber, oil or cake, or the sterilized seed of the plant which is incapable of
228 germination;

229 (25) "Methamphetamine precursor drug", any drug containing ephedrine,
230 pseudoephedrine, phenylpropanolamine, or any of their salts, optical isomers, or salts of optical
231 isomers;

232 (26) **"Mobile retail vendor", a person or entity that makes sales at retail from a**
233 **stand that is intended to be temporary, or is capable of being moved from one location to**
234 **another, whether the stand is located within or on the premises of a fixed facility, such as**
235 **a kiosk at a shopping center or an airport, or whether the stand is located on unimproved**
236 **real estate, such as a lot or field leased for retail purposes;**

237 (27) "Narcotic drug", any of the following, whether produced directly or indirectly by
238 extraction from substances of vegetable origin, or independently by means of chemical synthesis,
239 or by a combination of extraction and chemical analysis:

240 (a) Opium, opiate, and any derivative, of opium or opiate, including their isomers, esters,
241 ethers, salts, and salts of isomers, esters, and ethers, whenever the existence of the isomers,
242 esters, ethers, and salts is possible within the specific chemical designation. The term does not
243 include the isoquinoline alkaloids of opium;

244 (b) Coca leaves, but not including extracts of coca leaves from which cocaine, ecgonine,
245 and derivatives of ecgonine or their salts have been removed;

246 (c) Cocaine or any salt, isomer, or salt of isomer thereof;

247 (d) Ecgonine, or any derivative, salt, isomer, or salt of isomer thereof;

248 (e) Any compound, mixture, or preparation containing any quantity of any substance
249 referred to in paragraphs (a) to (d) of this subdivision;

250 [(27)] **(28)** "Official written order", an order written on a form provided for that purpose
251 by the United States Commissioner of Narcotics, under any laws of the United States making
252 provision therefor, if such order forms are authorized and required by federal law, and if no such
253 order form is provided, then on an official form provided for that purpose by the department of
254 health and senior services;

255 [(28)] **(29)** "Opiate", any substance having an addiction-forming or addiction-sustaining
256 liability similar to morphine or being capable of conversion into a drug having addiction-forming
257 or addiction-sustaining liability. The term includes its racemic and levorotatory forms. It does
258 not include, unless specifically controlled under section 195.017, the dextrorotatory isomer of
259 3-methoxy-n-methyl-morphinan and its salts (dextromethorphan);

260 [(29)] **(30)** "Opium poppy", the plant of the species *Papaver somniferum* L., except its
261 seeds;

262 [(30)] **(31)** "Over-the-counter sale", a retail sale licensed pursuant to chapter 144, RSMo,
263 of a drug other than a controlled substance;

264 [(31)] **(32)** "Person", an individual, corporation, government or governmental
265 subdivision or agency, business trust, estate, trust, partnership, joint venture, association, or any
266 other legal or commercial entity;

267 [(32)] **(33)** "Pharmacist", a licensed pharmacist as defined by the laws of this state, and
268 where the context so requires, the owner of a store or other place of business where controlled
269 substances are compounded or dispensed by a licensed pharmacist; but nothing in sections
270 195.005 to 195.425 shall be construed as conferring on a person who is not registered nor
271 licensed as a pharmacist any authority, right or privilege that is not granted to him by the
272 pharmacy laws of this state;

273 [(33)] **(34)** "Poppy straw", all parts, except the seeds, of the opium poppy, after mowing;

274 [(34)] **(35)** "Possessed" or "possessing a controlled substance", a person, with the
275 knowledge of the presence and nature of a substance, has actual or constructive possession of

276 the substance. A person has actual possession if he has the substance on his person or within
277 easy reach and convenient control. A person who, although not in actual possession, has the
278 power and the intention at a given time to exercise dominion or control over the substance either
279 directly or through another person or persons is in constructive possession of it. Possession may
280 also be sole or joint. If one person alone has possession of a substance possession is sole. If two
281 or more persons share possession of a substance, possession is joint;

282 [(35)] (36) "Practitioner", a physician, dentist, optometrist, podiatrist, veterinarian,
283 scientific investigator, pharmacy, hospital or other person licensed, registered or otherwise
284 permitted by this state to distribute, dispense, conduct research with respect to or administer or
285 to use in teaching or chemical analysis, a controlled substance in the course of professional
286 practice or research in this state, or a pharmacy, hospital or other institution licensed, registered,
287 or otherwise permitted to distribute, dispense, conduct research with respect to or administer a
288 controlled substance in the course of professional practice or research;

289 [(36)] (37) "Production", includes the manufacture, planting, cultivation, growing, or
290 harvesting of drug paraphernalia or of a controlled substance or an imitation controlled
291 substance;

292 [(37)] (38) "Registry number", the number assigned to each person registered under the
293 federal controlled substances laws;

294 [(38)] (39) **"Restricted natural substance", all parts of the plant datura**
295 **stramonium, also known as jimson weed, whether growing or not, the seeds thereof, any**
296 **extract from any part of such plant, and every compound, manufacture, salt derivative,**

442 195.320 if the compound, mixture, or preparation contains one or more active medicinal
443 ingredients not having a stimulant or depressant effect on the central nervous system, and if the

445 vitiate the potential for abuse of the substances which have a stimulant or depressant effect on
446 the central nervous system.

447 7. The department of health and senior services shall place a substance in Schedule IV
448 if it finds that:

- 549 is the only active medicinal ingredient;
- 550 (7) The department of health and senior services may except by rule any compound,

- 552 subsection from the application of all or any part of sections 195.010 to 195.320 if the
- 553 compound, mixture, or preparation contains one or more active medicinal ingredients not having
- 554 a depressant effect on the central nervous system, and if the admixtures are included therein in
- 555 combinations, quantity, proportion, or concentration that vitiate the potential for abuse of the
- 556 substances which have a depressant effect on the central nervous system.
- 557 9. The department of health and senior services shall place a substance in Schedule V
- 558 if it finds that:
- 559 (1) The substance has low potential for abuse relative to the controlled substances listed
- 560 in Schedule IV;
- 561 (2) The substance has currently accepted medical use in treatment in the United States;
- 562 and
- 563 (3) The substance has limited physical dependence or psychological dependence liability
- 564 relative to the controlled substances listed in Schedule IV.
- 565 10. The controlled substances listed in this subsection are included in Schedule V:
- 566 (1) Any compound, mixture or preparation containing any of the following narcotic
- 567 drugs or their salts calculated as the free anhydrous base or alkaloid, in limited quantities as set
- 568 forth below, which also contains one or more nonnarcotic active medicinal ingredients in
- 569 sufficient proportion to confer upon the compound, mixture or preparation valuable medicinal
- 570 qualities other than those possessed by the narcotic drug alone:
- 571 (a) Not more than two and five-tenths milligrams of diphenoxylate and not less than
- 572 twenty-five micrograms of atropine sulfate per dosage unit;
- 573 (b) Not more than one hundred milligrams of opium per one hundred milliliters or per

588 11. If any compound, mixture, or preparation as specified in subdivision (3) of
589 subsection 10 of this section is dispensed, sold, or distributed in a pharmacy without a
590 prescription:

591 (1) All packages of any compound, mixture, or preparation containing any detectable
592 quantity of pseudoephedrine, its salts or optical isomers, or salts of optical isomers or ephedrine,
593 its salts or optical isomers, or salts of optical isomers, shall be offered for sale only from behind
594 a pharmacy counter where the public is not permitted, and only by a registered pharmacist or
595 registered pharmacy technician; and

596 (2) Any person purchasing, receiving or otherwise acquiring any compound, mixture,
597 or preparation containing any detectable quantity of pseudoephedrine, its salts or optical isomers,
598 or salts of optical isomers or ephedrine, its salts or optical isomers, or salts of optical isomers
599 shall be at least eighteen years of age; and

600 (3) The pharmacist or registered pharmacy technician shall require any person
601 purchasing, receiving or otherwise acquiring such compound, mixture, or preparation, who is not
602 known to the pharmacist or registered pharmacy technician, to furnish suitable photo
603 identification [showing] **that is issued by a state or the federal government or a document**
604 **that, with respect to identification, is considered acceptable, and which shows** the date of
605 birth of the person.

606 12. Within ninety days of the enactment of this section, pharmacists and registered
607 pharmacy technicians shall implement and maintain a written or electronic log of each
608 transaction. Such log shall include the following information:

609 (1) The name [and] , address, **and signature** of the purchaser;

610 (2) The **name of the product and the** amount of the compound, mixture, or preparation
611 purchased;

612 (3) The date **and time** of each purchase; and

613 (4) The name or initials of the pharmacist or registered pharmacy technician who
614 dispensed the compound, mixture, or preparation to the purchaser.

616 **fully funded and operational, then pharmacists and registered pharmacy technicians shall**

621 [14.] **15.** Within thirty days of the enactment of this section, all persons who dispense
622 or offer for sale pseudoephedrine and ephedrine products in a pharmacy shall ensure that all such
623 products are located only behind a pharmacy counter where the public is not permitted.

624 [15.] **16.** Within thirty days of the enactment of this section, any business entity which
625 sells ephedrine or pseudoephedrine products in the course of legitimate business which is in the
626 possession of pseudoephedrine and ephedrine products, and which does not have a state and
627 federal controlled substances registration, shall return these products to a manufacturer or
628 distributor or transfer them to an authorized controlled substances registrant.

629 [16.] **17.** Any person who knowingly or recklessly violates the provisions of subsections
630 11 to 15 of this section is guilty of a class A misdemeanor.

631 [17.] **18.** The scheduling of substances specified in subdivision (3) of subsection 10 of
632 this section and subsections 11, 12, [14, and] 15, **and 16** of this section shall not apply to any
633 compounds, mixtures, or preparations that are in liquid or liquid-filled gel capsule form or to any
634 compound, mixture, or preparation specified in subdivision (3) of subsection 10 of this section
635 which must be dispensed, sold, or distributed in a pharmacy pursuant to a prescription.

636 [18.] **19.** The manufacturer of a drug product or another interested party may apply with
637 the department of health and senior services for an exemption from this section. The department
638 of health and senior services may grant an exemption by rule from this section if the department
639 finds the drug product is not used in the illegal manufacture of methamphetamine or other
640 controlled or dangerous substances. The department of health and senior services shall rely on
641 reports from law enforcement and law enforcement evidentiary laboratories in determining if the
642 proposed product can be used to manufacture illicit controlled substances.

643 [19.] **20.** The department of health and senior services shall revise and republish the
644 schedules annually.

645 [20.] **21.** The department of health and senior services shall promulgate rules under
646 chapter 536, RSMo, regarding the security and storage of Schedule V controlled substances, as
647 described in subdivision (3) of subsection 10 of this section, for distributors as registered by the
648 department of health and senior services.

195.378. 1. Sections 195.378 to 195.399 shall be known and may be cited as the
2 **"Drug Monitoring Act".**

3 **2. Notwithstanding the provisions of section 195.010, as used in sections 195.378 to**
4 **195.399, the following terms mean:**

5 (1) **"Controlled substance", as defined in section 195.010;**

6 (2) **"Department", the department of health and senior services;**

7 (3) **"Dispenser", a person who delivers a schedule II, III, IV, or V controlled**
8 **substance to the ultimate user, but does not include:**

9 (a) **A hospital as defined in section 197.020, RSMo, that distributes such substances**
10 **for the purpose of inpatient hospital care or dispenses prescriptions for controlled**
11 **substances at the time of discharge from such facility;**

12 (b) **A practitioner or other authorized person who administers such a substance;**

13 **or**

14 (c) **A wholesale distributor of a schedule II, III, IV, or V controlled substance;**

15 (4) **"Patient", a person or animal who is the ultimate user of a drug for whom a**
16 **prescription is issued or for whom a drug is dispensed;**

17 (5) **"Schedule II, III, IV, or V controlled substance", a controlled substance that**
18 **is listed in schedule II, III, IV, or V of the schedules provided under this chapter or the**
19 **Federal Controlled Substances Act, 21 U.S.C. Section 812.**

195.381. 1. Subject to appropriations, the department of health and senior services
2 **shall establish and maintain a program for the monitoring of prescribing and dispensing**
3 **of all schedule II, III, IV, and V controlled substances by all professionals licensed to**
4 **prescribe or dispense such substances in this state.**

5 **2. Each dispenser shall submit to the department by electronic means information**
6 **regarding each dispensing of a drug included in subsection 1 of this section. Information**
7 **shall be transmitted in the format established by the ASAP Telecommunication Format for**
8 **Controlled Substances, as published by the American Society of Automation in Pharmacy.**
9 **The information required by the department to be submitted for each dispensing may**
10 **include, but not be limited to:**

11 (1) **The dispenser's United States Drug Enforcement Administration registration**

- 18 **(7) The quantity dispensed;**
- 19 **(8) Any identification issued by a state or federal government to the patient, or any**
- 20 **other acceptable identification as defined by the department by rule;**
- 21 **(9) The patient's name, address, and date of birth;**
- 22 **(10) The prescriber's United States Drug Enforcement Administration registration**
- 23 **number, if applicable;**
- 24 **(11) The date the prescription is issued by the prescriber, if applicable; and**
- 25 **(12) The source of payment for the drug by indicating either cash, credit, debit,**
- 26 **check, Medicaid, or third party.**
- 27 **3. Each dispenser shall submit the information in accordance with transmission**
- 28 **methods and frequency established by the department; except that, each dispenser shall**
- 29 **report at least every thirty days between the first and fifteenth of the month following the**
- 30 **month the drug was dispensed.**
- 31 **4. The department may issue a waiver to a dispenser that is unable to submit**
- 32 **dispensing information by electronic means. Such waiver may permit the dispenser to**
- 33 **submit dispensing information by paper form or other means, provided all information**
- 34 **required in subsection 2 of this section is submitted in such alternative format.**
- 35 **5. Notwithstanding any other state law or provision, the electronic reporting of**
- 36 **sales of any product containing any detectable amount of ephedrine or pseudoephedrine**
- 37 **which may be sold under federal law or regulations without a prescription shall be subject**
- 38 **to appropriations and pursuant to regulations promulgated by the department.**
- 195.384. 1. Controlled substance dispensing information submitted to the**
- 2 **department shall be confidential and not subject to public disclosure under chapter 610,**
- 3 **RSMo, except as provided in subsections 3 to 5 of this section.**
- 4 **2. The department shall maintain procedures to ensure that the privacy and**
- 5 **confidentiality of patients and patient information collected, recorded, transmitted, and**
- 6 **maintained is not disclosed to persons except as provided in subsections 3 to 5 of this**
- 7 **section.**
- 8 **3. The department shall review the dispensing information and, if there is**
- 9 **reasonable cause to believe a violation of law or breach of professional standards may have**
- 10 **occurred, the department shall notify the appropriate law enforcement or professional**

11 **licensing, certification, or regulatory agency or entity, and provide dispensing information**
12 **required for an investigation.**

13 **4. The department may provide data in the drug monitoring program to the**
14 **following persons:**

17 **(2) An individual who requests his or her own drug monitoring information in**
18 **accordance with state law;**

19 **(3) The state board of pharmacy;**

20 **(4) Any state board charged with regulating a professional that has the authority**
21 **to prescribe controlled substances that requests data related to a specific professional**
22 **under the authority of that board;**

23 **(5) Local, state, and federal law enforcement or prosecutorial officials engaged in**
24 **the administration, investigation, or enforcement of the laws governing licit drugs;**

25 **(6) The department of social services regarding Medicaid program recipients;**

26 **(7) A judge or other judicial authority under a court order;**

27 **(8) Personnel of the department of health and senior services for the administration**
28 **and enforcement of sections 195.378 to 195.399;**

29 **(9) The department of mental health regarding department program recipients**
30 **receiving medication or medication-related services; and**

31 **(10) Substance abuse treatment programs regarding persons receiving evaluation**
32 **or treatment.**

33 **5. The department may provide data to public or private entities for statistical,**
34 **research, or educational purposes after removing information that could be used to identify**
35 **individual patients or persons who received prescriptions from dispensers.**

36 **6. Nothing in sections 195.378 to 195.399 shall require or obligate a dispenser or**
37 **prescriber to access or check the information in the drug monitoring program prior to**
38 **dispensing, prescribing, or administering medications or as part of their professional**
39 **practice. Dispensers and prescribers shall not be liable to any person for any claim of**
40 **damages as a result of accessing or failing to access the information in the drug monitoring**
41 **program and no lawsuit may be predicated thereon. Nothing in this subsection shall be**
42 **construed to relieve a dispenser or prescriber from any duty to monitor and report the**
43 **sales of certain products under sections 195.017, 195.417, and 195.378 to 195.399.**

195.387. The department is authorized to contract with any other agency of this
2 **state or with a private vendor, as necessary, to ensure the effective operation of the drug**
3 **monitoring program. Any contractor shall comply with the provisions regarding**

4 confidentiality of drug information in section 195.384. Any contractor who knowingly
5 discloses drug monitoring information other than as provided in sections 195.378 to
6 195.399 or who uses such information in a manner and for a purpose in violation of
7 sections 195.378 to 195.399 is guilty of a class A misdemeanor.

195.390. The department shall promulgate rules setting forth the procedures and
2 methods of implementing sections 195.378 to 195.399 which shall be consistent with federal
3 regulations, if applicable. Any rule or portion of a rule, as that term is defined in section
4 536.010, RSMo, that is created under the authority delegated in this section shall become
5 effective only if it complies with and is subject to all of the provisions of chapter 536,
6 RSMo, and, if applicable, section 536.028, RSMo. This section and chapter 536, RSMo, are
7 nonseverable and if any of the powers vested with the general assembly pursuant to
8 chapter 536, RSMo, to review, to delay the effective date, or to disapprove and annul a rule
9 are subsequently held unconstitutional, then the grant of rulemaking authority and any
10 rule proposed or adopted after August 28, 2007, shall be invalid and void.

195.393. 1. A dispenser who knowingly fails to submit drug monitoring
2 information to the department as required in sections 195.378 to 195.399 or knowingly
3 submits the incorrect prescription information is guilty of a class A misdemeanor.

4 2. A person authorized to have drug monitoring information under sections 195.378
5 to 195.399 who knowingly discloses such information in violation of sections 195.378 to
6 195.399 or who uses such information in a manner and for a purpose in violation of
7 sections 195.378 to 195.399 is guilty of a class A misdemeanor.

195.396. 1. The department shall implement the following education courses:
2 (1) An orientation course during the implementation phase of the drug monitoring
3 program established in section 195.381;
4 (2) A course for persons who are authorized to access the drug monitoring
5 information but who did not participate in the orientation course;
6 (3) A course for persons who are authorized to access the drug monitoring
7 information but who have violated laws or breached occupational standards involving
8 dispensing, prescribing, and use of substances monitored by the drug monitoring program
9 established in section 195.381;
10 When appropriate, the department shall develop the content of the education courses
11 described in subdivisions (1) to (3) of this subsection.

12 2. The department shall, when appropriate:

13 (1) Work with associations for impaired professionals to ensure intervention,
14 treatment, and ongoing monitoring and followup; and

15 (2) Encourage individual patients who are identified and who have become
16 addicted to substances monitored by the drug monitoring program established in section
17 **195.381** to receive addiction treatment. The department of health and senior services shall
18 consult and coordinate with the department of mental health in developing and
19 implementing patient intervention and referrals.

195.399. Pursuant to section 23.253, RSMo, of the Missouri sunset act:

2 (1) The provisions of the new program authorized under sections **195.378** to
3 **195.399** shall automatically sunset six years after the effective date of sections **195.378** to
4 **195.399** unless reauthorized by an act of the general assembly; and

5 (2) If such program is reauthorized, the program authorized under sections **195.378**
6 to **195.399** shall automatically sunset six years after the effective date of the reauthorization
7 of sections **195.378** to **195.399**; and

 195.417. 1. The limits specified in [subsection 2 of] this section shall not apply to any
2 quantity of such product, mixture, or preparation **which must be dispensed, sold, or distributed**
3 **in a pharmacy** pursuant to a valid prescription or to any purchase by an individual of a single
4 sales package if that package contains not more than sixty milligrams of pseudoephedrine

46 detectable quantity of ephedrine or pseudoephedrine, or any of their salts or optical isomers, or
47 salts of optical isomers, [except those that are excluded from Schedule V in subsection 17 or 18
48 of section 195.017, shall be offered for sale only from behind a pharmacy counter where the
49 public is not permitted, and only by a registered pharmacist or registered pharmacy technician
50 under section 195.017] shall place the products such that customers do not have direct
51 access to the products before a sale is made. This placement of product shall be either
52 behind the counter or in a locked cabinet that is located in an area of the facility involved
53 to which customers do not have direct access.

54 [4.] 6. The person selling such compound, mixture, or preparation shall require any
55 person purchasing, receiving, or otherwise acquiring such compound, mixture, or
56 preparation to furnish suitable photo identification showing the date of birth of the person.

57 **7. The person selling such compound, mixture, or preparation shall maintain a**
58 **written or electronic log of each transaction. Such log shall include the following**
59 **information:**

60 **(1) The name, address, and signature of the purchaser;**

79 **9.** All logs, records, documents, and electronic information maintained for the dispensing
80 of these products shall be open for inspection and copying by municipal, county, and state or

**195.550. 1. It is unlawful for any person to possess or have under his or her control
2 a restricted natural substance except as provided in subsection 2 of this section.**

3 **2. It is not a violation of subsection 1 of this section for any person to own, possess,
4 manage, or otherwise have control over land on which a restricted natural substance
5 naturally grows unless such person knowingly plants or cultivates such restricted natural
6 substance, or harvests such a substance for the purpose of any person drinking, inhaling
7 or otherwise ingesting such restricted natural substance, or unless such person knowingly
8 allows or authorizes another person to plant or cultivate such restricted natural substance,
9 or to harvest such a substance on his or her land for the purpose of anyone drinking,

**195.552. 1. It is unlawful for any person to distribute, deliver, manufacture,
2 produce, cultivate or attempt to distribute, deliver, manufacture, produce, or cultivate a
3 restricted natural substance as defined in section 195.010, or to possess with intent to
4 distribute, deliver, manufacture, produce, or cultivate a restricted natural substance.**

5 **2. For a first offense, any person who violates or attempts to violate this section
6 with respect to any restricted natural substance is guilty of a felony for which the**

7 **authorized term of imprisonment is life imprisonment or a term of years not less than four**
8 **years. For a second or subsequent offense any person who violates or attempts to violate**
9 **this section with respect to any restricted natural substance is guilty of a felony for which**
10 **the authorized term of imprisonment is life imprisonment or a term of years not less than**
11 **ten years.**

210.1012. 1. There is hereby created a statewide program called the "Amber Alert
2 System" referred to in this section as the "system" to aid in the identification and location of
3 abducted [persons] **children.**

4 2. For the purposes of this section, "abducted [person] **child**" means a [person] **child**
5 whose whereabouts are unknown and who is:

6 (1) Reasonably believed to be the victim of the crime of **child** kidnapping as defined by
7 section [565.110] **565.115**, RSMo, as determined by local law enforcement; **or**

8 (2) **Less than eighteen years of age and at least fourteen years of age, and who, if**
9 **under fourteen years of age, would otherwise be reasonably believed to be a victim of child**
10 **kidnapping as defined in section 565.115, RSMo, as determined by local law enforcement.**

11 3. The department of public safety shall develop regions to provide the system. The
12 department of public safety shall coordinate local law enforcement agencies and public
13 commercial television and radio broadcasters to provide an effective system. In the event that
14 a local law enforcement agency opts not to set up a system and an abduction occurs within the
15 jurisdiction, it shall notify the department of public safety who will notify local media in the
16 region.

17 4. The Amber alert system shall include all state agencies capable of providing urgent
18 and timely information to the public together with broadcasters and other private entities that
19 volunteer to participate in the dissemination of urgent public information. At a minimum, the
20 Amber alert system shall include the department of public safety, highway patrol, department of
21 transportation, department of health and senior services, and Missouri lottery.

22 5. The department of public safety shall have the authority to notify other regions upon
23 verification that the criteria established by the oversight committee has been met.

24 6. Participation in an Amber alert system is entirely at the option of local law
25 enforcement agencies and federally licensed radio and television broadcasters.

26 7. Any person who knowingly makes a false report that triggers an alert pursuant to this
27 section is guilty of a class A misdemeanor.

217.439. Upon the victim's request, a photograph shall be taken of the incarcerated
2 **individual prior to release from incarceration and a copy of the photograph shall be**
3 **provided to the crime victim.**

217.670. 1. The board shall adopt an official seal of which the courts shall take official
2 notice.

3 2. Decisions of the board regarding granting of paroles, extensions of a conditional
4 release date or revocations of a parole or conditional release shall be by a majority vote of the
5 hearing panel members. The hearing panel shall consist of one member of the board and two
6 hearing officers appointed by the board. A member of the board may remove the case from the
7 jurisdiction of the hearing panel and refer it to the full board for a decision. Within thirty days
8 of entry of the decision of the hearing panel to deny parole or to revoke a parole or conditional
9 release, the offender may appeal the decision of the hearing panel to the board. The board shall
10 consider the appeal within thirty days of receipt of the appeal. The decision of the board shall
11 be by majority vote of the board members and shall be final.

12 3. The orders of the board shall not be reviewable except as to compliance with the terms

21 **the purpose of deciding whether to grant conditional release or parole, extending the date**
22 **of conditional release, revoking parole or conditional release, or for any other purpose,**
23 **such appearance or presence may occur by means of a video conference at the discretion**
24 **of the board. Victims having a right to attend such hearings may testify either at the site**
25 **where the board is conducting the video conference or at the institution where the offender**
26 **is located.**

221.040. 1. It shall be the duty of the sheriff and jailer to receive, from constables and
2 other officers, all persons who shall be apprehended by such constable or other officers, for
3 offenses against this state, or who shall be committed to such jail by any competent authority;
4 and if any sheriff or jailer shall refuse to receive any such person or persons, he **or she** shall be
5 adjudged guilty of a misdemeanor, and on conviction shall be fined in the discretion of the court.

19 **4. The prisoner shall be kept under guard by the arresting officer or other law**
20 **enforcement officer while examination and treatment under subsection 2 of this section are**
21 **being performed.**

 287.067. 1. In this chapter the term "occupational disease" is hereby defined to mean,
2 unless a different meaning is clearly indicated by the context, an identifiable disease arising with
3 or without human fault out of and in the course of the employment. Ordinary diseases of life to
4 which the general public is exposed outside of the employment shall not be compensable, except
5 where the diseases follow as an incident of an occupational disease as defined in this section.
6 The disease need not to have been foreseen or expected but after its contraction it must appear
7 to have had its origin in a risk connected with the employment and to have flowed from that
8 source as a rational consequence.

9 2. An injury by occupational disease is compensable only if the occupational exposure
10 was the prevailing factor in causing both the resulting medical condition and disability. The

15 3. An injury due to repetitive motion is recognized as an occupational disease for
16 purposes of this chapter. An occupational disease due to repetitive motion is compensable only
17 if the occupational exposure was the prevailing factor in causing both the resulting medical
18 condition and disability. The "prevailing factor" is defined to be the primary factor, in relation
19 to any other factor, causing both the resulting medical condition and disability. Ordinary,
20 gradual deterioration, or progressive degeneration of the body caused by aging or by the normal
21 activities of day-to-day living shall not be compensable.

22 4. "Loss of hearing due to industrial noise" is recognized as an occupational disease for
23 purposes of this chapter and is hereby defined to be a loss of hearing in one or both ears due to
24 prolonged exposure to harmful noise in employment. "Harmful noise" means sound capable of
25 producing occupational deafness.

26 5. "Radiation disability" is recognized as an occupational disease for purposes of this
27 chapter and is hereby defined to be that disability due to radioactive properties or substances or
28 to Roentgen rays (X-rays) or exposure to ionizing radiation caused by any process involving the
29 use of or direct contact with radium or radioactive properties or substances or the use of or direct
30 exposure to Roentgen rays (X-rays) or ionizing radiation.

31 6. Disease of the lungs or respiratory tract, hypotension, hypertension, or disease of the
32 heart or cardiovascular system, including carcinoma, may be recognized as occupational diseases
33 for the purposes of this chapter and are defined to be disability due to exposure to smoke, gases,
34 carcinogens, inadequate oxygen, of paid firefighters of a paid fire department or paid police
35 officers of a paid police department certified under chapter 590, RSMo, if a direct causal
36 relationship is established, or psychological stress of firefighters of a paid fire department **or**
37 **paid police officers of a paid police department certified under chapter 590, RSMo**, if a
38 direct causal relationship is established.

39 7. Any employee who is exposed to and contracts any contagious or communicable
40 disease arising out of and in the course of his or her employment shall be eligible for benefits
41 under this chapter as an occupational disease.

42 8. With regard to occupational disease due to repetitive motion, if the exposure to the
43 repetitive motion which is found to be the cause of the injury is for a period of less than three
44 months and the evidence demonstrates that the exposure to the repetitive motion with the
45 immediate prior employer was the prevailing factor in causing the injury, the prior employer
46 shall be liable for such occupational disease.

 302.060. The director shall not issue any license and shall immediately deny any driving
2 privilege:

3 (1) To any person who is under the age of eighteen years, if such person operates a motor
4 vehicle in the transportation of persons or property as classified in section 302.015;

5 (2) To any person who is under the age of sixteen years, except as hereinafter provided;

6 (3) To any person whose license has been suspended, during such suspension, or to any

29 and that the petitioner's habits and conduct show such petitioner to no longer pose a threat to the
30 public safety of this state, the court may order the director to issue a license to the petitioner if
31 the petitioner is otherwise qualified pursuant to the provisions of sections 302.010 to 302.540.
32 No person may obtain a license pursuant to the provisions of this subdivision through court
33 action more than one time;

34 (10) To any person who has been convicted twice within a five-year period of violating
35 state law, or a county or municipal ordinance where the defendant was represented by or waived
36 the right to an attorney in writing, of driving while intoxicated **or any other intoxication-**
37 **related traffic offense as defined in subdivision (1) of subsection 1 of section 577.023,**
38 **RSMo**, or who has been convicted of the crime of involuntary manslaughter while operating a
39 motor vehicle in an intoxicated condition. The director shall not issue a license to such person
40 for five years from the date such person was convicted **or pled guilty** for involuntary
41 manslaughter while operating a motor vehicle in an intoxicated condition or for driving while
42 intoxicated **or any other intoxication-related traffic offense as defined in subdivision (1) of**
43 **subsection 1 of section 577.023, RSMo**, for the second time. [Any person who has been denied
44 a license for two convictions of driving while intoxicated prior to July 27, 1989, shall have the
45 person's license issued, upon application, unless the two convictions occurred within a five-year
46 period, in which case, no license shall be issued to the person for five years from the date of the
47 second conviction];

48 (11) To any person who is otherwise disqualified pursuant to the provisions of sections
49 302.010 to 302.780, chapter 303, RSMo, or section 544.046, RSMo;

50 (12) To any person who is under the age of eighteen years, if such person's parents or
51 legal guardians file a certified document with the department of revenue stating that the director
52 shall not issue such person a driver's license. Each document filed by the person's parents or
53 legal guardians shall be made upon a form furnished by the director and shall include identifying
54 information of the person for whom the parents or legal guardians are denying the driver's
55 license. The document shall also contain identifying information of the person's parents or legal
56 guardians. The document shall be certified by the parents or legal guardians to be true and
57 correct. This provision shall not apply to any person who is legally emancipated. The parents
58 or legal guardians may later file an additional document with the department of revenue which
59 reinstates the person's ability to receive a driver's license.

302.311. In the event an application for a license is denied or withheld, or in the event
2 that a license is suspended or revoked by the director, the applicant or licensee so aggrieved may
3 appeal to the circuit court of the county of his residence in the manner provided by chapter 536,
4 RSMo, for the review of administrative decisions at any time within thirty days after notice that
5 a license is denied or withheld or that a license is suspended or revoked. Upon such appeal the
6 cause shall be heard de novo and the circuit court may order the director to grant such license,

5 substances. In this event, the officer shall make a sworn report to the director that he requested
6 a test pursuant to section 302.745 and that the person refused to submit to such testing.

7 2. A person requested to submit to a test as provided by section 302.745 shall be warned
8 by the law enforcement officer requesting the test that a refusal to submit to the test will result
9 in that person being immediately placed out of service for a period of twenty-four hours and

22 the hearing on behalf of the officer. At the hearing the judge shall determine only:

23 (1) Whether or not the law enforcement officer had reasonable grounds to believe that

28 6. Requests for review as herein provided shall go to the head of the docket of the court

304.022. 1. Upon the immediate approach of an emergency vehicle giving audible signal
2 by siren or while having at least one lighted lamp exhibiting red light visible under normal
3 atmospheric conditions from a distance of five hundred feet to the front of such vehicle or a
4 flashing blue light authorized by section 307.175, RSMo, the driver of every other vehicle shall
5 yield the right-of-way and shall immediately drive to a position parallel to, and as far as possible
6 to the right of, the traveled portion of the highway and thereupon stop and remain in such
7 position until such emergency vehicle has passed, except when otherwise directed by a police
8 or traffic officer.

9 2. Upon approaching a stationary emergency vehicle displaying lighted red or red and
10 blue lights, the driver of every motor vehicle shall:

11 (1) Proceed with caution and yield the right-of-way, if possible with due regard to safety
12 and traffic conditions, by making a lane change into a lane not adjacent to that of the stationary
13 vehicle, if on a roadway having at least four lanes with not less than two lanes proceeding in the
14 same direction as the approaching vehicle; or

15 (2) Proceed with due caution and reduce the speed of the vehicle, maintaining a safe
16 speed for road conditions, if changing lanes would be unsafe or impossible.

17 3. The motorman of every streetcar shall immediately stop such car clear of any
18 intersection and keep it in such position until the emergency vehicle has passed, except as
19 otherwise directed by a police or traffic officer.

23 enforcement personnel of the state highways and transportation commission, police or fire
24 department, sheriff, constable or deputy sheriff, federal law enforcement officer authorized to
25 carry firearms and to make arrests for violations of the laws of the United States, traffic officer
26 or coroner or by a privately owned emergency vehicle company;

27 (2) A vehicle operated as an ambulance or operated commercially for the purpose of
28 transporting emergency medical supplies or organs;

29 (3) Any vehicle qualifying as an emergency vehicle pursuant to section 307.175, RSMo;

30 (4) Any wrecker, or tow truck or a vehicle owned and operated by a public utility or
31 public service corporation while performing emergency service;

32 (5) Any vehicle transporting equipment designed to extricate human beings from the
33 wreckage of a motor vehicle;

34 (6) Any vehicle designated to perform emergency functions for a civil defense or
35 emergency management agency established pursuant to the provisions of chapter 44, RSMo;

36 (7) Any vehicle operated by an authorized employee of the department of corrections
37 who, as part of the employee's official duties, is responding to a riot, disturbance, hostage
38 incident, escape or other critical situation where there is the threat of serious physical injury or
39 death, responding to mutual aid call from another criminal justice agency, or in accompanying
40 an ambulance which is transporting an offender to a medical facility;

41 (8) Any vehicle designated to perform hazardous substance emergency functions
42 established pursuant to the provisions of sections 260.500 to 260.550, RSMo.

43 5. (1) The driver of any vehicle referred to in subsection 4 of this section shall not sound
44 the siren thereon or have the front red lights or blue lights on except when such vehicle is
45 responding to an emergency call or when in pursuit of an actual or suspected law violator, or
46 when responding to, but not upon returning from, a fire.

47 (2) The driver of an emergency vehicle may:

48 (a) Park or stand irrespective of the provisions of sections 304.014 to 304.025;

49 (b) Proceed past a red or stop signal or stop sign, but only after slowing down as may be
50 necessary for safe operation;

51 (c) Exceed the prima facie speed limit so long as the driver does not endanger life or
52 property;

53 (d) Disregard regulations governing direction of movement or turning in specified
54 directions.

55 (3) The exemptions granted to an emergency vehicle pursuant to subdivision (2) of this
56 subsection shall apply only when the driver of any such vehicle while in motion sounds audible

57 signal by bell, siren, or exhaust whistle as may be reasonably necessary, and when the vehicle
58 is equipped with at least one lighted lamp displaying a red light or blue light visible under normal
59 atmospheric conditions from a distance of five hundred feet to the front of such vehicle.

60 6. No person shall purchase an emergency light as described in this section without
61 furnishing the seller of such light an affidavit stating that the light will be used exclusively for
62 emergency vehicle purposes.

63 7. Violation of this section shall be deemed a class A misdemeanor.

304.070. 1. Any person who violates any of the provisions of subsections 1, 3, and 6 of
2 section 304.050 is guilty of a class A misdemeanor. In addition, beginning July 1, 2005, the
3 court may suspend the driver's license of any person who violates the provision of subsection 1
4 of section 304.050. If ordered by the court, the director shall suspend the driver's license for
5 [ninety] **one hundred twenty** days for a first offense of subsection 1 of section 304.050, and one
6 hundred [twenty] **eighty** days for a second or subsequent offense of subsection 1 of section
7 304.050. Any person who violates subsection 1 of section 304.050 where such violation results
8 in the injury of any child shall be guilty of a class D felony. Any person who violates subsection
9 1 of section 304.050 where such violation causes the death of any child shall be guilty of a class
10 C felony.

11 2. Any appeal of a suspension imposed under subsection 1 of this section shall be a
12 direct appeal of the court order and subject to review by the presiding judge of the circuit court
13 or another judge within the circuit other than the judge who issued the original order to suspend
14 the driver's license. The director of revenue's entry of the court-ordered suspension on the
15 driving record is not a decision subject to review pursuant to section 302.311, RSMo. Any
16 suspension of the driver's license ordered by the court under this section shall be in addition to
17 any other suspension that may occur as a result of the conviction pursuant to other provisions of
18 law.

304.230. 1. It shall be the duty of the sheriff of each county or city to see that the
2 provisions of sections 304.170 to 304.230 are enforced, and any peace officer or police officer
3 of any county or city or any highway patrol officer shall have the power to arrest on sight or upon
4 a warrant any person found violating or having violated the provisions of such sections.

5 2. The sheriff or any peace officer or any highway patrol officer is hereby given the
6 power to stop any such conveyance or vehicle as above described upon the public highway for
7 the purpose of determining whether such vehicle is loaded in excess of the provisions of sections
8 304.170 to 304.230, and if he or she finds such vehicle loaded in violation of the provisions
9 thereof he or she shall have a right at that time and place to cause the excess load to be removed
10 from such vehicle; and provided further, that any regularly employed maintenance man of the
11 department of transportation shall have the right and authority in any part of this state to stop any

12 such conveyance or vehicle upon the public highway for the purpose of determining whether
13 such vehicle is loaded in excess of the provisions of sections 304.170 to 304.230, and if he or
14 she finds such vehicle loaded in violation of the provisions thereof, he or she shall have the right
15 at that time and place to cause the excess load to be removed from such vehicle. When only an
16 axle or a tandem axle group of a vehicle is overloaded, the operator shall be permitted to shift
17 the load, if this will not overload some other axle or axles, without being charged with a
18 violation; provided, however, the privilege of shifting the weight without being charged with a
19 violation shall not extend to or include vehicles while traveling on the federal interstate system
20 of highways. When only an axle or tandem axle group of the vehicle traveling on the federal
21 interstate system of highways is overloaded and a court authorized to enforce the provisions of
22 sections 304.170 to 304.230 finds that the overloading was due to the inadvertent shifting of the
23 load changing axle weights in transit through no fault of the operator of the vehicle and that the
24 load thereafter had been shifted so that no axle had been overloaded, then the court may find that
25 no violation has been committed. The operator of any vehicle shall be permitted to back up and
26 reweigh, or to turn around and weigh from the opposite direction. Any operator whose vehicle
27 is weighed and found to be within five percent of any legal limit may request and receive a
28 weight ticket, memorandum or statement showing the weight or weights on each axle or any
29 combinations of axles. Once a vehicle is found to be within the limits of section 304.180 after
30 having been weighed on any state scale and there is no evidence that any cargo or fuel has been
31 added, no violation shall occur, but a presumption shall exist that cargo or fuel has been added
32 if upon reweighing on another state scale the total gross weight exceeds the applicable limits of
33 section 304.180 or 304.190. The highways and transportation commission of this state may
34 deputize and appoint any number of their regularly employed maintenance men to enforce the
35 provisions of such sections, and the maintenance men delegated and appointed in this section
36 shall report to the proper officers any violations of sections 304.170 to 304.230 for prosecution
37 by such proper officers.

38 3. The superintendent of the Missouri state highway patrol may assign qualified persons
39 who are not highway patrol officers to supervise or operate permanent or portable weigh stations
40 used in the enforcement of commercial vehicle laws. These persons shall be designated as
41 commercial vehicle inspectors and have limited police powers:

42 (1) To issue uniform traffic tickets at a permanent or portable weigh station for violations
43 of rules and regulations of the division of motor carrier [and railroad safety of the department of
44 economic development] **services of the highways and transportation commission** and
45 department of public safety, and laws, rules, and regulations pertaining to commercial motor
46 vehicles and trailers and related to size, weight, fuel tax, registration, equipment, driver

47 requirements, transportation of hazardous materials and operators' or chauffeurs' licenses, and
48 the provisions of sections 303.024 and 303.025, RSMo;

49 (2) To require the operator of any commercial vehicle to stop and submit to a vehicle and
50 driver inspection to determine compliance with commercial vehicle laws, rules, and regulations,
51 the provisions of sections 303.024 and 303.025, RSMo, and to submit to a cargo inspection when
52 reasonable grounds exist to cause belief that a vehicle is transporting hazardous materials as
53 defined by Title 49 of the Code of Federal Regulations;

54 (3) To make arrests for violation of subdivisions (1) and (2) of this subsection.
55 Commercial vehicle enforcement officers shall not have the authority to exercise the powers
56 granted in subdivisions (1), (2) and (3) of this subsection until they have successfully completed
57 training approved by the superintendent of the Missouri state highway patrol. Commercial
58 vehicle enforcement officers shall have the right as peace officers to bear arms.

59 4. The superintendent of the Missouri state highway patrol may appoint qualified
60 persons, who are not members of the highway patrol, designated as commercial vehicle
61 enforcement officers, with the powers:

62 (1) To issue uniform traffic tickets for violations of laws, rules and regulations pertaining
63 to commercial vehicles, trailers, special mobile equipment and drivers of such vehicles, and the
64 provisions of sections 303.024 and 303.025, RSMo;

65 (2) To require the operator of any commercial vehicle to stop and submit to a vehicle and
66 driver inspection to determine compliance with commercial vehicle laws, rules, and regulations,
67 compliance with the provisions of sections 303.024 and 303.025, RSMo, and to submit to a
68 cargo inspection when reasonable grounds exist to cause belief that a vehicle is transporting
69 hazardous materials as defined by Title 49 of the Code of Federal Regulations;

70 (3) To make arrests upon warrants and for violations of subdivisions (1) and (2) of this
71 subsection. Commercial vehicle enforcement officers shall not have the authority to exercise the
72 powers granted in subdivisions (1), (2) and (3) of this subsection until they have successfully
73 completed training approved by the superintendent of the Missouri state highway patrol.
74 Commercial vehicle enforcement officers shall have the right as peace officers to bear arms.

75 5. Any additional employees needed for the implementation of this section shall be hired
76 in conformity with the provisions of the federal fair employment and antidiscrimination acts.

77 6. Any part of this section which shall be construed to be in conflict with the axle or
78 tandem axle load limits permitted by the Federal-Aid Highway Act, Section 127 of Title 23 of
79 the United States Code (Public Law 85-767, 85th Congress) shall be null, void and of no effect.

306.111. 1. A person commits the crime of negligent operation of a vessel if when
2 operating a vessel on the [Mississippi River, Missouri River or the lakes] **waters** of this state
3 [he] **such person** acts with criminal negligence, as defined in subsection 5 of section 562.016,

4 RSMo, to cause physical injury to any other person or damage to the property of any other
5 person. A person convicted of negligent operation of a vessel is guilty of a class B misdemeanor
6 upon conviction for the first violation, guilty of a class A misdemeanor upon conviction for the
7 second violation, and guilty of a class D felony for conviction for the third and subsequent
8 violations.

9 2. A person commits the crime of operating a vessel while intoxicated if [he] **such**
10 **person** operates a vessel on the [Mississippi River, Missouri River or the lakes] **waters** of this
11 state while in an intoxicated condition. A person convicted of operating a vessel while
12 intoxicated is guilty of a class B misdemeanor upon conviction for the first violation, guilty of
13 a class A misdemeanor upon conviction for the second violation, and guilty of a class D felony
14 for conviction for the third and subsequent violations.

15 3. A person commits the crime of involuntary manslaughter with a vessel if, while in an
16 intoxicated condition, [he] **such person** operates any vessel on the [Mississippi River, Missouri
17 River or the lakes] **waters** of this state and, when so operating, acts with criminal negligence to
18 cause the death of any person. Involuntary manslaughter with a vessel is a class C felony.

19 4. A person commits the crime of assault with a vessel in the second degree if, while in
20 an intoxicated condition, [he] **such person** operates any vessel on the [Mississippi River,
21 Missouri River or the lakes] **waters** of this state and, when so operating, acts with criminal
22 negligence to cause physical injury to any other person. Assault with a vessel in the second
23 degree is a class D felony.

24 5. For purposes of this section, a person is in an intoxicated condition when [he] **such**
25 **person** is under the influence of alcohol, a controlled substance or drug, or any combination
26 thereof.

306.112. 1. A person commits the crime of operating a vessel with excessive blood
2 alcohol content if such person operates a vessel on the [Mississippi River, Missouri River or the
3 lakes] **waters** of this state with [ten-hundredths] **eight-hundredths** of one percent or more by
4 weight of alcohol in such person's blood.

5 2. As used in this section, percent by weight of alcohol in the blood shall be based upon
6 grams of alcohol per one hundred milliliters of blood and may be shown by chemical analysis
7 of the person's blood, breath, urine, or saliva.

8 3. Any person convicted of operating a vessel with excessive blood alcohol content is:
9 **(1) Guilty of a class B misdemeanor upon conviction for the first violation[.];**
10 **(2) Guilty of a class A misdemeanor upon conviction for the second violation[.], within**
11 **ten years of a first offense and such person shall be placed on probation by the court for**
12 **a period of two years; and**

13 (3) Guilty of a class D felony for conviction for the third and subsequent violations
14 **within twenty years of two prior offenses and such person shall be placed on probation by**
15 **the court for a period of three years. In addition to the requirements set forth in section**
16 **306.128, such person shall be prohibited from operating a vessel for a period of five years**
17 **from the date of conviction.**

 306.114. 1. No person convicted of or pleading guilty to a violation of section 306.111
2 or 306.112 shall be granted a suspended imposition of sentence, unless such person is placed on
3 probation for a minimum of two years and a record of the conviction or plea of guilty is entered
4 into the records of the Missouri uniform law enforcement system maintained by the Missouri
5 state highway patrol.

6 2. Chemical tests of a person's blood, breath, urine, or saliva to be considered valid under
7 the provisions of sections 306.111 to 306.119 shall be performed according to methods and
8 devices approved by the [department of health and senior services] **highways and**
9 **transportation commission** by licensed medical personnel or by a person possessing a valid
10 permit issued by the [department of health and senior services] **highways and transportation**
11 **commission** for this purpose. In addition, any state, county, or municipal law enforcement
12 officer who is certified pursuant to chapter 590, RSMo, may, prior to arrest, administer a portable
13 chemical test to any person suspected of operating any vessel in violation of section 306.111 or
14 306.112. A portable chemical test shall be admissible as evidence of probable cause to arrest and
15 as exculpatory evidence, but shall not be admissible as evidence of blood alcohol content. The
16 provisions of section 306.116 shall not apply to a test administered prior to arrest pursuant to this
17 section.

18 3. The [department of health and senior services] **highways and transportation**
19 **commission** shall approve satisfactory techniques, devices, equipment, or methods to conduct
20 tests required by sections 306.111 to 306.119, and shall establish standards as to the
21 qualifications and competence of individuals to conduct analyses and to issue permits which
22 shall be subject to termination, suspension or revocation by the [department of health and senior
23 services] **highways and transportation commission.**

24 4. A licensed physician, registered nurse, or trained medical technician, acting at the
25 request and direction of a law enforcement officer, shall withdraw blood for the purpose of
26 determining the alcohol content of the blood, unless the medical personnel, in the exercise of
27 good faith medical judgment, believes such procedure would endanger the life or health of the
28 person in custody. Blood may be withdrawn only by such medical personnel, but such restriction
29 shall not apply to the taking of a breath test or a urine or saliva specimen. In withdrawing blood
30 for the purpose of determining the alcohol content in the blood, only a previously unused and
31 sterile needle and sterile vessel shall be used and the withdrawal shall otherwise be in strict

32 accord with accepted medical practices. A nonalcoholic antiseptic shall be used for cleansing
33 the skin prior to a venapuncture. Upon the request of the person who is tested, full information
34 concerning the test taken at the direction of the law enforcement officer shall be made available
35 to such person.

36 5. No person who administers any test pursuant to the provisions of sections 306.111 to
37 306.119 upon the request of a law enforcement officer, no hospital in or with which such person
38 is employed or is otherwise associated or in which such test is administered, and no other person,
39 firm, or corporation by whom or with which such person is employed or is in any way associated
40 shall be civilly liable for damages to the person tested, except for negligence in administering
41 of the test or for willful and wanton acts or omissions.

42 6. Any person who is dead, unconscious or who is otherwise in a condition rendering
43 such person incapable of refusing to take a test as provided in sections 306.111 to 306.119 shall
44 be deemed not to have withdrawn the consent provided by section 306.116 and the test or tests
45 may be administered.

306.116. 1. Any person who operates a vessel upon the [Mississippi River, Missouri
2 River or the lakes] **waters** of this state shall be deemed to have given consent to, subject to the
3 provisions of sections 306.111 to 306.119, a chemical test or tests of such person's breath, blood,
4 urine, or saliva for the purpose of determining the alcohol or drug content of such person's blood
5 if arrested for any offense arising out of acts which the arresting law enforcement officer had
6 reasonable grounds to believe were committed while the person was operating a vessel upon the
7 [Mississippi River, Missouri River or lakes] **waters** of this state in violation of section 306.111
8 or 306.112. The test shall be administered at the direction of the arresting law enforcement
9 officer whenever the person has been arrested for the offense.

10 2. The implied consent to submit to the chemical tests listed in subsection 1 of this
11 section shall be limited to not more than two such tests arising from the same arrest, incident,
12 or charge.

13 3. The person tested may have a physician, or a qualified technician, chemist, registered
14 nurse, or other qualified person of such person's choosing and at such person's expense
15 administer a test in addition to any administered at the direction of a law enforcement officer.
16 The failure or inability to obtain an additional test by a person shall not preclude the admission
17 of evidence relating to the test taken at the direction of a law enforcement officer.

18 4. Upon the request of the person who is tested, full information concerning the test shall
19 be made available to such person.

306.117. 1. Upon the trial of any person for violation of any of the provisions of section
2 306.111 or 306.112 the amount of alcohol or drugs in the person's blood at the time of the act
3 alleged as shown by any chemical analysis of the person's blood, breath, urine, or saliva is

4 admissible in evidence and the provisions of subdivision (5) of section 491.060, RSMo, shall not
5 prevent the admissibility or introduction of such evidence if otherwise admissible. Evidence of
6 alcohol in a person's blood shall be given the following effect:

7 (1) If there was five-hundredths of one percent or less by weight of alcohol in such
8 person's blood, it shall be presumed that the person was not intoxicated at the time the specimen
9 was obtained;

10 (2) If there was in excess of five-hundredths of one percent but less than
11 [ten-hundredths] **eight-hundredths** of one percent by weight of alcohol in such person's blood,
12 the fact shall not give rise to any presumption that the person was or was not intoxicated, but the
13 fact may be considered with other competent evidence in determining whether the person was
14 intoxicated;

15 (3) If there was [ten-hundredths] **eight-hundredths** of one percent or more by weight
16 of alcohol in the person's blood, this shall be prima facie evidence that the person was
17 intoxicated at the time the specimen was taken.

18 2. Percent by weight of alcohol in the blood shall be based upon grams of alcohol per
19 one hundred milliliters of blood.

20 3. A chemical analysis of a person's breath, blood, urine, or saliva, in order to give rise
21 to the presumption or to have the effect provided for in subsection 1 of this section, shall have
22 been performed as provided in sections 306.111 to 306.119 and in accordance with methods and
23 standards approved by the [department of health and senior services] **highways and**
24 **transportation commission.**

25 4. The provisions of this section shall not be construed as limiting the introduction of
26 any other competent evidence bearing upon the question whether the person was intoxicated or
27 under the influence of a controlled substance, or drug, or a combination of either or both with
28 or without alcohol.

311.310. 1. Any licensee under this chapter, or his employee, who shall sell, vend, give
2 away or otherwise supply any intoxicating liquor, **or any nonintoxicating beer as defined in**
3 **section 312.010, RSMo**, in any quantity whatsoever to any person under the age of twenty-one
4 years, or to any person intoxicated or appearing to be in a state of intoxication, or to a habitual
5 drunkard, and any person whomsoever except his parent or guardian who shall procure for, sell,
6 give away or otherwise supply intoxicating liquor to any person under the age of twenty-one
7 years, or to any intoxicated person or any person appearing to be in a state of intoxication, or to
8 a habitual drunkard, shall be deemed guilty of a misdemeanor, except that this section shall not
9 apply to the supplying of intoxicating liquor to a person under the age of twenty-one years for
10 medical purposes only, or to the administering of such intoxicating liquor to any person by a duly
11 licensed physician. No person shall be denied a license or renewal of a license issued under this

12 chapter solely due to a conviction for unlawful sale or supply to a minor when serving in the
13 capacity as an employee of a licensed establishment.

14 2. Any owner, occupant, or other person or legal entity with a lawful right to the
15 exclusive use and enjoyment of any property who knowingly allows a person under the age of
16 twenty-one to drink or possess intoxicating liquor or knowingly fails to stop a person under the
17 age of twenty-one from drinking or possessing intoxicating liquor on such property, unless such
18 person allowing the person under the age of twenty-one to drink or possess intoxicating liquor
19 is his or her parent or guardian, is guilty of a class B misdemeanor. Any second or subsequent
20 violation of this subsection is a class A misdemeanor.

21 3. It shall be a defense to prosecution under this section if:

22 (1) The defendant is a licensed retailer, club, drinking establishment, or caterer or holds
23 a temporary permit, or an employee thereof;

24 (2) The defendant sold the intoxicating liquor to the minor with reasonable cause to
25 believe that the minor was twenty-one or more years of age; and

26 (3) To purchase the intoxicating liquor, the person exhibited to the defendant a driver's
27 license, Missouri nondriver's identification card, or other official or apparently official document,
28 containing a photograph of the minor and purporting to establish that such minor was twenty-one
29 years of age and of the legal age for consumption of intoxicating liquor.

311.325. 1. Any person under the age of twenty-one years, who purchases or attempts
2 to purchase, or has in his or her possession, any intoxicating liquor as defined in section 311.020
3 **or any nonintoxicating beer as defined in section 312.010, RSMo**, or who is visibly
4 intoxicated as defined in section 577.001, RSMo, or has a detectable blood alcohol content of
5 more than two-hundredths of one percent or more by weight of alcohol in such person's blood
6 is guilty of a misdemeanor. For purposes of prosecution under this section or any other provision
7 of this chapter involving an alleged illegal sale or transfer of intoxicating liquor to a person under
8 twenty-one years of age, a manufacturer-sealed container describing that there is intoxicating
9 liquor therein need not be opened or the contents therein tested to verify that there is intoxicating
10 liquor in such container. The alleged violator may allege that there was not intoxicating liquor
11 in such container, but the burden of proof of such allegation is on such person, as it shall be
12 presumed that such a sealed container describing that there is intoxicating liquor therein contains
13 intoxicating liquor.

14 2. For purposes of determining violations of any provision of this chapter, or of any rule
15 or regulation of the supervisor of alcohol and tobacco control, a manufacturer-sealed container
16 describing that there is intoxicating liquor therein need not be opened or the contents therein
17 tested to verify that there is intoxicating liquor in such container. The alleged violator may allege
18 that there was not intoxicating liquor in such container, but the burden of proof of such allegation

19 is on such person, as it shall be presumed that such a sealed container describing that there is
20 intoxicating liquor therein contains intoxicating liquor.

21 3. The provisions of this section shall not apply to a student who:

22 (1) Is eighteen years of age or older;

23 (2) Is enrolled in an accredited college or university and is a student in a culinary course;

24 (3) Is required to taste, but not consume or imbibe, any beer, ale, porter, wine, or other
25 similar malt or fermented beverage as part of the required curriculum; and

26 (4) Tastes a beverage under subdivision (3) of this subsection only for instructional
27 purposes during classes that are part of the curriculum of the accredited college or university.

28

29 The beverage must at all times remain in the possession and control of an authorized instructor
30 of the college or university, who must be twenty-one years of age or older. Nothing in this
31 subsection may be construed to allow a student under the age of twenty-one to receive any beer,
32 ale, porter, wine, or other similar malt or fermented beverage unless the beverage is delivered
33 as part of the student's required curriculum and the beverage is used only for instructional
34 purposes during classes conducted as part of the curriculum.

311.326. After a period of not less than one year[, or upon] **after** reaching the age of
2 twenty-one[, whichever occurs first,] a person who has pleaded guilty to or has been found guilty
3 of violating section 311.325 for the first time, and who since such conviction has not been
4 convicted of any other alcohol-related offense, may apply to the court in which he or she was
5 sentenced for an order to expunge all official records of his or her arrest, plea, trial and
6 conviction. If the court determines, upon review, that such person has not been convicted of any
7 other alcohol-related offense at the time of the application for expungement, and the person has
8 had no other alcohol-related enforcement contacts, as defined in section 302.525, RSMo, the
9 court shall enter an order of expungement. The effect of such an order shall be to restore such
10 person to the status he or she occupied prior to such arrest, plea or conviction, as if such event
11 had never happened. No person as to whom such order has been entered shall be held thereafter
12 under any provision of any law to be guilty of perjury or otherwise giving a false statement by
13 reason of his or her failure to recite or acknowledge such arrest, plea, trial, conviction or
14 expungement in response to any inquiry made of him or her for any purpose whatsoever. A
15 person shall be entitled to only one expungement pursuant to this section. Nothing contained in
16 this section shall prevent courts or other state officials from maintaining such records as are

4 aiding, or is about to materially aid an act, practice, or course of business constituting a violation
5 of this act or a rule adopted or order issued under this act, the commissioner may:

544.157. 1. Any law enforcement officer certified pursuant to chapter 590, RSMo, of
2 any political subdivision of this state, any authorized agent of the department of conservation,
3 any commissioned member of the Missouri capitol police, any commissioned member of the
4 Missouri state park rangers, **any college or university police officer**, and any authorized agent
5 of the Missouri state water patrol in fresh pursuit of a person who is reasonably believed by such
6 officer to have committed a felony in this state or who has committed, or attempted to commit,
7 in the presence of such officer or agent, any criminal offense or violation of a municipal or
8 county ordinance, or for whom such officer holds a warrant of arrest for a criminal offense, shall

9 have the authority to arrest and hold in custody such person anywhere in this state. Fresh pursuit
10 may only be initiated from within the pursuing peace officer's, conservation agent's, capitol
11 police officer's, state park ranger's, **college or university police officer's**, or water patrol
12 officer's jurisdiction and shall be terminated once the pursuing peace officer is outside of such
13 officer's jurisdiction and has lost contact with the person being pursued. If the offense is a traffic
14 violation, the uniform traffic ticket shall be used as if the violator had been apprehended in the
15 municipality or county in which the offense occurred.

16 2. If such an arrest is made in obedience to a warrant, the disposition of the prisoner shall
17 be made as in other cases of arrest under a warrant; if the violator is served with a uniform traffic
18 ticket, the violator shall be directed to appear before a court having jurisdiction to try the offense;
19 if the arrest is without a warrant, the prisoner shall be taken forthwith before a judge of a court
20 with original criminal jurisdiction in the county wherein such arrest was made or before a

4 August 28, 2006, or the offender has pleaded guilty to or has been found guilty of an offense
5 under section 566.067, 566.083, 566.100, 566.151, 566.212, 566.213, 568.020, 568.080, or
6 568.090, RSMo, based on an act committed on or after August 28, 2006, against a victim who
7 was less than fourteen years old and the offender is a prior sex offender as defined in subsection
8 2 of this section, the court shall order that the offender be supervised by the board of probation
9 and parole for the duration of his or her natural life.

10 2. For the purpose of this section, a prior sex offender is a person who has previously
11 pleaded guilty to or has been found guilty of an offense contained in chapter 566, RSMo, or

12 violating section 568.020, RSMo, when the person had sexual intercourse or deviate sexual
13 intercourse with the victim, or of violating subdivision (2) of subsection 1 of section 568.045,
14 RSMo.

15 3. When probation for the duration of the offender's natural life has been ordered, a
16 mandatory condition of such probation is that the offender be electronically monitored.
17 Electronic monitoring shall be based on a global positioning system or other technology that
18 identifies and records the offender's location at all times.

19 4. In appropriate cases as determined by a risk assessment, the court may terminate the
20 probation of an offender who is being supervised under this section when the offender is
21 sixty-five years of age or older.

561.031. 1. In the following proceedings, the provisions of section 544.250, 544.270,

6 appearance may be made by means of two-way audio-visual communication, including but not

8 audio-visual communication facilities provide two-way audio-visual communication between
9 the court and the place of custody or confinement [and that a full record of such proceedings be
10 made by split-screen imaging and recording of the proceedings in the courtroom and the place
11 of confinement or custody in addition to such other record as may be required]:

12 (1) First appearance before an associate circuit judge on a criminal complaint;

13 (2) Waiver of preliminary hearing;

14 (3) Arraignment on an information or indictment where a plea of not guilty is entered;

4 (2) While in an intoxicated condition operates a motor vehicle in this state and, when so
5 operating, acts with criminal negligence to cause the death of any person; or

6 (3) While in an intoxicated condition operates a motor vehicle in this state, and, when
7 so operating, acts with criminal negligence to:

8 (a) Cause the death of any person not a passenger in the vehicle operated by the
9 defendant, including the death of an individual that results from the defendant's vehicle leaving
10 a highway, as defined by section 301.010, RSMo, or the highway's right-of-way; or

11 (b) Cause the death of two or more persons; or

12 (c) Cause the death of any person while he or she has a blood alcohol content of at least
13 eighteen-hundredths of one percent by weight of alcohol in such person's blood; or

14 (4) Operates a motor vehicle in violation of subsection 2 of section 304.022, RSMo, and
15 when so operating, acts with criminal negligence to cause the death of any person authorized to
16 operate an emergency vehicle, as defined in section 304.022, RSMo, while such person is in the
17 performance of official duties; or

18 **(5) Unlawfully distributes or delivers any controlled substance to any person and**

6 of section 565.050] or assault in the second degree [pursuant to the provisions of section
7 565.060,] if the victim of the assault was a family or household member;

8 (c) **The commission of a crime in another state, or any federal offense, or any**
9 **military offense which, if committed in this state, would be a violation of any offense listed**
10 **in paragraph (a) or (b) of this subdivision;**

11 (2) "Family" or "household member", spouses, former spouses, adults related by blood
12 or marriage, adults who are presently residing together or have resided together in the past and
13 adults who have a child in common regardless of whether they have been married or have resided

50 (4) A "persistent offender" is one of the following:

51 (a) A person who has pleaded guilty to or has been found guilty of two or more
52 intoxication-related traffic offenses;

53 (b) A person who has pleaded guilty to or has been found guilty of:

54 **a.** Involuntary manslaughter pursuant to subdivision (2) or (3) of subsection 1 of section
55 565.024, RSMo, assault in the second degree pursuant to subdivision (4) of subsection 1 of
56 section 565.060, RSMo, assault of a law enforcement officer in the second degree pursuant to
57 subdivision (4) of subsection 1 of section 565.082, RSMo; [and] **or**

58 **b. Any offense committed in another state, or any federal offense, or any military**
59 **offense which, if committed in this state, would be a violation of any offense listed in**
60 **subparagraph a. of paragraph (b) of this subdivision; and**

61 (5) A "prior offender" is a person who has pleaded guilty to or has been found guilty of
62 one intoxication-related traffic offense, where such prior offense occurred within five years of
63 the occurrence of the intoxication-related traffic offense for which the person is charged.

64 2. Any person who pleads guilty to or is found guilty of a violation of section 577.010
65 or 577.012 who is alleged and proved to be a prior offender shall be guilty of a class A
66 misdemeanor.

67 3. Any person who pleads guilty to or is found guilty of a violation of section 577.010
68 or 577.012 who is alleged and proved to be a persistent offender shall be guilty of a class D
69 felony.

70 4. Any person who pleads guilty to or is found guilty of a violation of section 577.010
71 or section 577.012 who is alleged and proved to be an aggravated offender shall be guilty of a
72 class C felony.

73 5. Any person who pleads guilty to or is found guilty of a violation of section 577.010
74 or section 577.012 who is alleged and proved to be a chronic offender shall be guilty of a class
75 B felony.

76 6. No state, county, or municipal court shall suspend the imposition of sentence as to a
77 prior offender, persistent offender, aggravated offender, or chronic offender under this section
78 nor sentence such person to pay a fine in lieu of a term of imprisonment, section 557.011, RSMo,
79 to the contrary notwithstanding. No prior offender shall be eligible for parole or probation until
80 he or she has served a minimum of five days imprisonment, unless as a condition of such parole
81 or probation such person performs at least thirty days of community service under the
82 supervision of the court in those jurisdictions which have a recognized program for community
83 service. No persistent offender shall be eligible for parole or probation until he or she has served
84 a minimum of ten days imprisonment, unless as a condition of such parole or probation such
85 person performs at least sixty days of community service under the supervision of the court. No
86 aggravated offender shall be eligible for parole or probation until he or she has served a
87 minimum of sixty days imprisonment. No chronic offender shall be eligible for parole or
88 probation until he or she has served a minimum of two years imprisonment.

89 7. The state, county, or municipal court shall find the defendant to be a prior offender,
90 persistent offender, aggravated offender, or chronic offender if:

91 (1) The indictment or information, original or amended, or the information in lieu of an
92 indictment pleads all essential facts warranting a finding that the defendant is a prior offender
93 or persistent offender; and

94 (2) Evidence is introduced that establishes sufficient facts pleaded to warrant a finding
95 beyond a reasonable doubt the defendant is a prior offender, persistent offender, aggravated
96 offender, or chronic offender; and

97 (3) The court makes findings of fact that warrant a finding beyond a reasonable doubt
98 by the court that the defendant is a prior offender, persistent offender, aggravated offender, or
99 chronic offender.

100 8. In a jury trial, the facts shall be pleaded, established and found prior to submission to
101 the jury outside of its hearing.

102 9. In a trial without a jury or upon a plea of guilty, the court may defer the proof in
103 findings of such facts to a later time, but prior to sentencing.

104 10. The defendant shall be accorded full rights of confrontation and cross-examination,
105 with the opportunity to present evidence, at such hearings.

106 11. The defendant may waive proof of the facts alleged.

107 12. Nothing in this section shall prevent the use of presentence investigations or
108 commitments.

109 13. At the sentencing hearing both the state, county, or municipality and the defendant
110 shall be permitted to present additional information bearing on the issue of sentence.

111 14. The pleas or findings of guilty shall be prior to the date of commission of the present
112 offense.

113 15. The court shall not instruct the jury as to the range of punishment or allow the jury,
114 upon a finding of guilty, to assess and declare the punishment as part of its verdict in cases of
115 prior offenders, persistent offenders, aggravated offenders, or chronic offenders.

116 16. Evidence of prior convictions shall be heard and determined by the trial court out of
117 the hearing of the jury prior to the submission of the case to the jury, and shall include but not
118 be limited to evidence of convictions received by a search of the records of the Missouri uniform
119 law enforcement system maintained by the Missouri state highway patrol. After hearing the
120 evidence, the court shall enter its findings thereon. A conviction of a violation of a municipal
121 or county ordinance in a county or municipal court for [driving while intoxicated] **any**
122 **intoxication-related traffic offense** or a conviction or a plea of guilty or a finding of guilty
123 followed by a suspended imposition of sentence, suspended execution of sentence, probation or
124 parole or any combination thereof in a state court shall be treated as a prior conviction.

577.026. 1. Chemical tests of the person's breath, blood, saliva, or urine to be considered
2 valid under the provisions of sections 577.020 to 577.041, shall be performed according to
3 methods and devices approved by the [state department of health and senior services] **highways**
4 **and transportation commission** by licensed medical personnel or by a person possessing a valid
5 permit issued by the [state department of health and senior services] **highways and**
6 **transportation commission** for this purpose.

7 2. The [state department of health and senior services] **highways and transportation**
8 **commission** shall approve satisfactory techniques, devices, equipment, or methods to conduct
9 tests required by sections 577.020 to 577.041, and shall establish standards as to the
10 qualifications and competence of individuals to conduct analyses and to issue permits which
11 shall be subject to termination or revocation by the [state department of health and senior
12 services] **highways and transportation commission**.

13 3. **All the powers, duties, and functions described in this section, and all powers,**
14 **duties, and functions under sections 306.114 and 306.117, RSMo, and sections 577.020 and**
15 **577.037, relating to the approval and licensing of personnel, methods, techniques, devices,**
16 **and equipment for the testing of blood alcohol content, including all administrative rules**
17 **and orders, are hereby transferred from the department of health and senior services to**

18 the department of transportation, which is in the charge of the highways and
19 transportation commission, by type I transfer, as defined in the Omnibus State
20 Reorganization Act of 1974, and the department of health and senior services and its
21 employees, officers, and agents shall no longer be responsible for those powers, duties, and
22 functions.

23 **4. All budget authority to fund the personal services and equipment and expenses**
24 **to carry out the powers, duties, and functions under this section and sections 306.114 and**
25 **306.117, RSMo, and sections 577.020 and 577.037, relating to the approval and licensing**
26 **of personnel, methods, and devices for testing of blood alcohol content shall be transferred**
27 **from the department of health and senior services to the department of transportation and**
28 **all appropriations to fund the powers, duties, and functions transferred under this section**
29 **shall be paid from the general revenue fund.**

30 **5. All credentials, permits, and licenses issued prior to the effective date of this**
31 **transfer by the department of health and senior services under this section and sections**
32 **306.114 and 306.117, RSMo, and sections 577.020 and 577.037, shall remain in force or**
33 **expire as provided by law. In addition, the highways and transportation commission shall**
34 **have the authority to suspend, cancel, or revoke such credentials, permits, and licenses**
35 **after the effective date of this act.**

36 **6. The commission may promulgate administrative rules to administer the powers,**
37 **duties, and functions relating to the approval and licensing of personnel, methods, and**
38 **devices for testing of blood alcohol content. Any rule or portion of a rule, as that term is**
39 **defined in section 536.010, RSMo, that is created under the authority delegated in this**
40 **section shall become effective only if it complies with and is subject to all of the provisions**
41 **of chapter 536, RSMo, and, if applicable, section 536.028, RSMo. This section and chapter**
42 **536, RSMo, are nonseverable and if any of the powers vested with the general assembly**
43 **pursuant to chapter 536, RSMo, to review, to delay the effective date, or to disapprove and**
44 **annul a rule are subsequently held unconstitutional, then the grant of rulemaking**
45 **authority and any rule proposed or adopted after August 28, 2007, shall be invalid and**
46 **void.**

47 **7. Notwithstanding any provision of law to the contrary, on and after the effective**
48 **date of this section, all bonds, certificates of deposit, letters of credit, drafts, checks, or**
49 **other financial instruments payable to the department of health and senior services or any**
50 **other employee, official, or agent whose powers, duties, or functions are transferred under**
51 **this section shall be payable instead to the highways and transportation commission to be**
52 **deposited to the credit of the general revenue fund.**

577.037. 1. Upon the trial of any person for violation of any of the provisions of section 2 565.024, RSMo, or section 565.060, RSMo, or section 577.010 or 577.012, or upon the trial of 3 any criminal action or violations of county or municipal ordinances or in any license suspension 4 or revocation proceeding pursuant to the provisions of chapter 302, RSMo, arising out of acts 5 alleged to have been committed by any person while driving a motor vehicle while in an 6 intoxicated condition, the amount of alcohol in the person's blood at the time of the act alleged 7 as shown by any chemical analysis of the person's blood, breath, saliva or urine is admissible in 8 evidence and the provisions of subdivision (5) of section 491.060, RSMo, shall not prevent the 9 admissibility or introduction of such evidence if otherwise admissible. If there was 10 eight-hundredths of one percent or more by weight of alcohol in the person's blood, this shall be 11 prima facie evidence that the person was intoxicated at the time the specimen was taken.

12 2. Percent by weight of alcohol in the blood shall be based upon grams of alcohol per 13 one hundred milliliters of blood or grams of alcohol per two hundred ten liters of breath.

14 3. The foregoing provisions of this section shall not be construed as limiting the 15 introduction of any other competent evidence bearing upon the question whether the person was 16 intoxicated.

17 4. A chemical analysis of a person's breath, blood, saliva or urine, in order to give rise 18 to the presumption or to have the effect provided for in subsection 1 of this section, shall have 19 been performed as provided in sections 577.020 to 577.041 and in accordance with methods and 20 standards approved by the [state department of health and senior services] **highways and** 21 **transportation commission**.

22 5. Any charge alleging a violation of section 577.010 or 577.012 or any county or 23 municipal ordinance prohibiting driving while intoxicated or driving under the influence of 24 alcohol shall be dismissed with prejudice if a chemical analysis of the defendant's breath, blood, 25 saliva, or urine performed in accordance with sections 577.020 to 577.041 and rules promulgated 26 thereunder by the [state department of health and senior services] **highways and transportation** 27 **commission** demonstrate that there was less than eight-hundredths of one percent of alcohol in 28 the defendant's blood unless one or more of the following considerations cause the court to find 29 a dismissal unwarranted:

30 (1) There is evidence that the chemical analysis is unreliable as evidence of the 31 defendant's intoxication at the time of the alleged violation due to the lapse of time between the 32 alleged violation and the obtaining of the specimen;

33 (2) There is evidence that the defendant was under the influence of a controlled 34 substance, or drug, or a combination of either or both with or without alcohol; or

35 (3) There is substantial evidence of intoxication from physical observations of witnesses 36 or admissions of the defendant.

577.041. 1. If a person under arrest, or who has been stopped pursuant to subdivision 2 (2) or (3) of subsection 1 of section 577.020, refuses upon the request of the officer to submit to 3 any test allowed pursuant to section 577.020, then none shall be given and evidence of the refusal 4 shall be admissible in a proceeding pursuant to section 565.024, 565.060, or 565.082, RSMo, or 5 section 577.010 or 577.012. The request of the officer shall include the reasons of the officer 6 for requesting the person to submit to a test and also shall inform the person that evidence of 7 refusal to take the test may be used against such person and that the person's license shall be 8 immediately revoked upon refusal to take the test. If a person when requested to submit to any 9 test allowed pursuant to section 577.020 requests to speak to an attorney, the person shall be 10 granted twenty minutes in which to attempt to contact an attorney. If upon the completion of the 11 twenty-minute period the person continues to refuse to submit to any test, it shall be deemed a 12 refusal. In this event, the officer shall, on behalf of the director of revenue, serve the notice of 13 license revocation personally upon the person and shall take possession of any license to operate 14 a motor vehicle issued by this state which is held by that person. The officer shall issue a 15 temporary permit, on behalf of the director of revenue, which is valid for fifteen days and shall 16 also give the person a notice of such person's right to file a petition for review to contest the 17 license revocation.

18 2. The officer shall make a certified report under penalties of perjury for making a false 19 statement to a public official. The report shall be forwarded to the director of revenue and shall 20 include the following:

21 (1) That the officer has:

22 (a) Reasonable grounds to believe that the arrested person was driving a motor vehicle 23 while in an intoxicated or drugged condition; or

24 (b) Reasonable grounds to believe that the person stopped, being under the age of 25 twenty-one years, was driving a motor vehicle with a blood alcohol content of two-hundredths 26 of one percent or more by weight; or

27 (c) Reasonable grounds to believe that the person stopped, being under the age of 28 twenty-one years, was committing a violation of the traffic laws of the state, or political 29 subdivision of the state, and such officer has reasonable grounds to believe, after making such 30 stop, that the person had a blood alcohol content of two-hundredths of one percent or greater;

31 (2) That the person refused to submit to a chemical test;

32 (3) Whether the officer secured the license to operate a motor vehicle of the person;

33 (4) Whether the officer issued a fifteen-day temporary permit;

34 (5) Copies of the notice of revocation, the fifteen-day temporary permit and the notice 35 of the right to file a petition for review, which notices and permit may be combined in one 36 document; and

37 (6) Any license to operate a motor vehicle which the officer has taken into possession.

38 3. Upon receipt of the officer's report, the director shall revoke the license of the person
39 refusing to take the test for a period of one year; or if the person is a nonresident, such person's
40 operating permit or privilege shall be revoked for one year; or if the person is a resident without
41 a license or permit to operate a motor vehicle in this state, an order shall be issued denying the
42 person the issuance of a license or permit for a period of one year.

43 4. If a person's license has been revoked because of the person's refusal to submit to a
44 chemical test, such person may petition for a hearing before a circuit or associate circuit court
45 in the county in which the arrest or stop occurred. The person may request such court to issue
46 an order staying the revocation until such time as the petition for review can be heard. If the
47 court, in its discretion, grants such stay, it shall enter the order upon a form prescribed by the
48 director of revenue and shall send a copy of such order to the director. Such order shall serve
49 as proof of the privilege to operate a motor vehicle in this state and the director shall maintain
50 possession of the person's license to operate a motor vehicle until termination of any revocation
51 pursuant to this section. Upon the person's request the clerk of the court shall notify the
52 [prosecuting attorney of the county and the prosecutor shall appear at the hearing on behalf of
53 the] director of revenue. At the hearing the court shall determine only:

54 (1) Whether or not the person was arrested or stopped;

55 (2) Whether or not the officer had:

56 (a) Reasonable grounds to believe that the person was driving a motor vehicle while in
57 an intoxicated or drugged condition; or

58 (b) Reasonable grounds to believe that the person stopped, being under the age of
59 twenty-one years, was driving a motor vehicle with a blood alcohol content of two-hundredths
60 of one percent or more by weight; or

61 (c) Reasonable grounds to believe that the person stopped, being under the age of
62 twenty-one years, was committing a violation of the traffic laws of the state, or political
63 subdivision of the state, and such officer had reasonable grounds to believe, after making such
64 stop, that the person had a blood alcohol content of two-hundredths of one percent or greater; and

65 (3) Whether or not the person refused to submit to the test.

66 5. If the court determines any issue not to be in the affirmative, the court shall order the
67 director to reinstate the license or permit to drive.

68 6. Requests for review as provided in this section shall go to the head of the docket of
69 the court wherein filed.

70 7. No person who has had a license to operate a motor vehicle suspended or revoked
71 pursuant to the provisions of this section shall have that license reinstated until such person has
72 participated in and successfully completed a substance abuse traffic offender program defined

73 in section 577.001, or a program determined to be comparable by the department of mental
74 health or the court. Assignment recommendations, based upon the needs assessment as
75 described in subdivision (22) of section 302.010, RSMo, shall be delivered in writing to the
76 person with written notice that the person is entitled to have such assignment recommendations
77 reviewed by the court if the person objects to the recommendations. The person may file a
78 motion in the associate division of the circuit court of the county in which such assignment was
79 given, on a printed form provided by the state courts administrator, to have the court hear and
80 determine such motion pursuant to the provisions of chapter 517, RSMo. The motion shall name
81 the person or entity making the needs assessment as the respondent and a copy of the motion
82 shall be served upon the respondent in any manner allowed by law. Upon hearing the motion,
83 the court may modify or waive any assignment recommendation that the court determines to be
84 unwarranted based upon a review of the needs assessment, the person's driving record, the
85 circumstances surrounding the offense, and the likelihood of the person committing a like
86 offense in the future, except that the court may modify but may not waive the assignment to an
87 education or rehabilitation program of a person determined to be a prior or persistent offender
88 as defined in section 577.023, or of a person determined to have operated a motor vehicle with
89 fifteen-hundredths of one percent or more by weight in such person's blood. Compliance with
90 the court determination of the motion shall satisfy the provisions of this section for the purpose
91 of reinstating such person's license to operate a motor vehicle. The respondent's personal
92 appearance at any hearing conducted pursuant to this subsection shall not be necessary unless
93 directed by the court.

94 8. The fees for the substance abuse traffic offender program, or a portion thereof to be
95 determined by the division of alcohol and drug abuse of the department of mental health, shall
96 be paid by the person enrolled in the program. Any person who is enrolled in the program shall
97 pay, in addition to any fee charged for the program, a supplemental fee to be determined by the
98 department of mental health for the purposes of funding the substance abuse traffic offender
99 program defined in section 302.010, RSMo, and section 577.001. The administrator of the
100 program shall remit to the division of alcohol and drug abuse of the department of mental health

108 9. Any administrator who fails to remit to the division of alcohol and drug abuse of the
109 department of mental health the supplemental fees and interest for all persons enrolled in the
110 program pursuant to this section shall be subject to a penalty equal to the amount of interest
111 accrued on the supplemental fees due the division pursuant to this section. If the supplemental
112 fees, interest, and penalties are not remitted to the division of alcohol and drug abuse of the
113 department of mental health within six months of the due date, the attorney general of the state
114 of Missouri shall initiate appropriate action of the collection of said fees and interest accrued.
115 The court shall assess attorney fees and court costs against any delinquent program.

 577.208. 1. Chemical tests of the person's breath, blood, or urine to be considered valid
2 shall be performed according to methods and devices approved by the [state department of health
3 and senior services] **highways and transportation commission** and shall be performed by
4 licensed medical personnel or by a person possessing a valid permit issued by the [state
5 department of health and senior services] **highways and transportation commission** for this
6 purpose. A blood test shall not be performed if the medical personnel, in good faith medical
7 judgment, believe such procedure would endanger the health of the person in custody.

8 2. Upon request of the person tested, full information concerning the test shall be made
9 available to him.

10 3. No person administering a chemical test under this section and sections 577.206,
11 577.211 and 577.214, or any other person, firm or corporation with whom he is associated, shall
12 be civilly liable for damages to the person tested except for negligence or by willful or wanton
13 act or omission.

 577.500. 1. A court of competent jurisdiction shall, upon a plea of guilty, conviction or
2 finding of guilt, or, if the court is a juvenile court, upon a finding of fact that the offense was
3 committed by a juvenile, enter an order suspending or revoking the driving privileges of any
4 person determined to have committed one of the following offenses and who, at the time said
5 offense was committed, was under twenty-one years of age:

6 (1) Any alcohol-related traffic offense in violation of state law or a county or, beginning
7 July 1, 1992, municipal ordinance, where the defendant was represented by or waived the right
8 to an attorney in writing;

9 (2) Any offense in violation of state law or, beginning July 1, 1992, a county or
10 municipal ordinance, where the defendant was represented by or waived the right to an attorney
11 in writing, involving the possession or use of alcohol, committed while operating a motor
12 vehicle;

13 (3) Any offense involving the possession or use of a controlled substance **or the**
14 **unlawful use or possession of drug paraphernalia** as defined in chapter 195, RSMo, in

15 violation of the state law or, beginning July 1, 1992, a county or municipal ordinance, where the
16 defendant was represented by or waived the right to an attorney in writing;

17 (4) Any offense involving the alteration, modification or misrepresentation of a license
18 to operate a motor vehicle in violation of section 311.328, RSMo;

19 (5) Any offense in violation of state law or, beginning July 1, 1992, a county or
20 municipal ordinance, where the defendant was represented by or waived the right to an attorney
21 in writing, involving the possession or use of alcohol for a second time; except that a
22 determination of guilt or its equivalent shall have been made for the first offense and both
23 offenses shall have been committed by the person when the person was under eighteen years of
24 age.

25 2. A court of competent jurisdiction [shall] **may**, upon a plea of guilty or nolo
26 contendere, conviction or finding of guilt, or, if the court is a juvenile court, upon a finding of
27 fact [that] **involving the possession or use of alcohol for a second time, and** the offense was
28 committed by a juvenile, enter an order suspending or revoking the driving privileges of any
29 person determined to have committed a crime or violation of section 311.325, RSMo, **or,**
30 **beginning July 1, 1992, a county or municipal ordinance, where the defendant was**
31 **represented by or waived the right to an attorney in writing;** and who, at the time said crime
32 or violation was committed, was more than fifteen years of age and under twenty-one years of

34 3. The court shall require the surrender to it of any license to operate a motor vehicle,
35 temporary instruction permit, intermediate driver's license or any other driving privilege then
36 held by any person against whom a court has entered an order suspending or revoking driving
37 privileges under subsections 1 and 2 of this section.

38 4. The court, if other than a juvenile court, shall forward to the director of revenue the
39 order of suspension or revocation of driving privileges and any licenses, temporary instruction
40 permits, intermediate driver's licenses, or any other driving privilege acquired under subsection
41 3 of this section.

42 5. (1) The court, if a juvenile court, shall forward to the director of revenue the order
43 of suspension or revocation of driving privileges and any licenses, temporary instruction permits,
44 intermediate driver's licenses, or any other driving privilege acquired under subsection 3 of this
45 section for any person sixteen years of age or older, the provision of chapter 211, RSMo, to the

47 (2) The court, if a juvenile court, shall hold the order of suspension or revocation of

 577.505. A court of competent jurisdiction shall enter an order revoking the driving

4 **drug paraphernalia**, as defined in chapter 195, RSMo, while operating a motor vehicle and
5 who, at the time said offense was committed, was twenty-one years of age or older when the
6 person pleads guilty, or is convicted or found guilty of such offense by the court. The court shall
7 require the surrender to it of all operator's and chauffeur's licenses then held by such person. The
8 court shall forward to the director of revenue the order of revocation of driving privileges and
9 any licenses surrendered.

 578.250. No person shall intentionally smell or inhale the fumes of any solvent,
2 particularly toluol, **amyl nitrite, butyl nitrite, cyclohexyl nitrite, ethyl nitrite, pentyl nitrite,**
3 **and propyl nitrite and their iso-analogues** or induce any other person to do so, for the purpose
4 of causing a condition of, or inducing symptoms of, intoxication, elation, euphoria, dizziness,
5 excitement, irrational behavior, exhilaration, paralysis, stupefaction, or dulling of senses or
6 nervous system, or for the purpose of, in any manner, changing, distorting, or disturbing the

4 **inhalation into the lungs via the nose or mouth or both.**

 2. No person shall intentionally or willfully induce the symptoms of intoxication, elation,
6 euphoria, dizziness, excitement, irrational behavior, exhilaration, paralysis, stupefaction, or
7 dulling of the senses or nervous system, distortion of audio, visual or mental processes by the
8 use **or abuse** of any [solvent, particularly toluol.] **of the following substances:**

- 9 **(1) Solvents, particularly toluol; or**
10 **(2) Ethyl alcohol.**

11 **3. This section shall not apply to substances that have been approved by the United**
12 **States Food and Drug Administration as therapeutic drug products or are contained in**
13 **approved over-the-counter drug products or administered lawfully pursuant to the order**
14 **of an authorized medical practitioner.**

15 [2.] **4. No person shall intentionally possess any solvent, particularly toluol, amyl nitrite,**
16 **butyl nitrite, cyclohexyl nitrite, ethyl nitrite, pentyl nitrite, and propyl nitrite and their iso-**
17 **analogues for the purpose of using it in the manner prohibited by section 578.250 and this**
18 **section.**

19 **5. No person shall possess or use an alcoholic beverage vaporizer.**

20 **6. Nothing in this section shall be construed to prohibit the legal consumption of**
21 **intoxicating liquor, as defined by section 311.020, RSMo, or nonintoxicating beer, as**
22 **defined by section 312.010, RSMo.**

 578.260. 1. No person shall intentionally possess or buy any solvent, particularly toluol,
2 **amyl nitrite, butyl nitrite, cyclohexyl nitrite, ethyl nitrite, pentyl nitrite, and propyl nitrite**
3 **and their iso-analogues** for the purpose of inducing or aiding any other person to violate the
4 provisions of sections 578.250 and 578.255.

5 2. Any person who violates any provision of sections 578.250 to 578.260 is guilty of a
6 class B misdemeanor **for the first violation and a class D felony for any subsequent**
7 **violations.**

 578.265. 1. No person shall knowingly and intentionally sell or otherwise transfer
2 possession of any solvent, particularly toluol, **amyl nitrite, butyl nitrite, cyclohexyl nitrite,**
3 **ethyl nitrite, pentyl nitrite, and propyl nitrite and their iso-analogues** to any person for the
4 purpose of causing a condition of, or inducing symptoms of, intoxication, elation, euphoria,
5 dizziness, excitement, irrational behavior, exhilaration, paralysis, stupefaction, or dulling of
6 senses or nervous system, or for the purpose of, in any manner, changing, distorting, or
7 disturbing the audio, visual, or mental processes.

8 2. No person who owns or operates any business which receives over fifty percent of its
9 gross annual income from the sale of alcoholic beverages or beer shall sell or offer for sale
10 toluol, **amyl nitrite, butyl nitrite, cyclohexyl nitrite, ethyl nitrite, pentyl nitrite, and propyl**
11 **nitrite and their iso-analogues,** or any toxic glue.

12 3. **No person who owns or operates any business which operates as a venue for live**
13 **entertainment performance or receives over fifty percent of its gross annual income from**
14 **the sale of recorded video entertainment shall sell or offer for sale toluol, amyl nitrite, butyl**
15 **nitrite, cyclohexyl nitrite, ethyl nitrite, pentyl nitrite, propyl nitrite or their iso-analogues.**

16 4. Any person who violates the provisions of subsection 1 or 2 of this section is guilty
17 of a class C felony.

1 **589.395. 1. No person shall own or operate a facility for the primary purpose of**
2 **providing sex offender treatment and living quarters, including temporary residence, for**
3 **more than one sex offender who is required to register under sections 589.400 to 589.425.**

4 **2. This section shall not apply to any person who owns or operates a facility**
5 **through a contract with a public governmental body, or to any facility owned by a public**

5 **under the following application and certification procedures:**

32 **reapplication form to a program participant at least four weeks prior to the expiration of**

34 **(4) The secretary shall forward first-class mail, legal documents, and certified mail**

36 **2. A person commits a class D felony if:**

589.666. Certification of a program participant may be cancelled by the secretary
2 if one or more of the following conditions apply:

3 (1) If the program participant obtains a name change, unless the program
4 participant provides the secretary with documentation of a legal name change within ten
5 business days of the name change;

6 (2) If there is a change in the mailing address from the person listed on the
7 application, unless the program participant provides the secretary with notice of the
8 change in such manner as the secretary provides by rule; or

9 (3) The applicant or program participant violates subsection 2 of section 589.663.

589.669. Upon demonstration of a program participant's certification in the
2 program, state and local agencies and the courts shall accept the designated address as a

6 of the program participant's address or mailing address, such that it is unable to fulfill its
7 statutory duties and obligations without the address; and

8 (2) The program participant's address or mailing address shall be used only for

589.672. If the secretary deems it appropriate, the secretary may make a program
2 participant's address or mailing address available for inspection or copying, under the
3 following circumstances:

4 (1) If requested of the secretary by a law enforcement agency in the manner
5 provided for by rule; or

6 (2) Upon request to the secretary by a director of a state agency or the director's
7 designee in the manner provided for by rule and upon a showing of a bona fide statutory

589.675. If the secretary deems it appropriate, the secretary shall make a program

6 address and mailing address and the reasons stated for the disclosure; or

589.678. A program participant's application and supporting materials are not a
2 public record and shall be kept confidential by the secretary.

589.681. The secretary shall promulgate rules to establish and administer the
2 address confidentiality program. Any rule or portion of a rule, as that term is defined in
3 section 536.010, RSMo, that is created under the authority delegated in sections 589.660
4 to 589.681 shall become effective only if it complies with and is subject to all of the
5 provisions of chapter 536, RSMo, and, if applicable, section 536.028, RSMo. This section
6 and chapter 536, RSMo, are nonseverable and if any of the powers vested with the general
7 assembly pursuant to chapter 536, RSMo, to review, to delay the effective date, or to
8 disapprove and annul a rule are subsequently held unconstitutional, then the grant of

589.683. Pursuant to section 23.253, RSMo, of the Missouri Sunset Act:

2 (1) Any new program authorized under sections 589.660 to 589.681 shall
3 automatically sunset six years after the effective date of sections 589.660 to 589.681 unless
4 reauthorized by an act of the general assembly; and

5 (2) If such program is reauthorized, the program authorized under sections 589.660
6 to 589.681 shall automatically sunset twelve years after the effective date of the
7 reauthorization of sections 589.660 to 589.681; and

8 (3) Sections 589.660 to 589.681 shall terminate on September first of the calendar
9 year immediately following the calendar year in which a program authorized under

590.035. The POST commission shall make training available to peace officers that
2 provides instruction on the investigation of crimes involving the use of computers, the
3 Internet, or both, including but not limited to the crimes of sexual exploitation of a minor,
4 possession of child pornography, or enticement of a child.

590.050. 1. The POST commission shall establish requirements for the continuing
2 education of all peace officers. Peace officers who make traffic stops shall be required to receive
3 [annual training] **three hours of training within the law enforcement continuing education**
4 **three-year reporting period** concerning the prohibition against racial profiling and such
5 training shall promote understanding and respect for racial and cultural differences and the use
6 of effective, noncombative methods for carrying out law enforcement duties in a racially and
7 culturally diverse environment. **The director of the department of public safety may waive**
8 **any and all continuing education requirements, including training concerning the**

20 commission serving a full term of three years may be reappointed to the POST commission until
21 at least one year after the expiration of his most recent term.

22 2. Three of the original members of the POST commission shall be appointed for terms

3 term is defined in section 536.010, RSMo, that is created under the authority delegated in this
4 section shall become effective only if it complies with and is subject to all of the provisions of
5 chapter 536, RSMo, and, if applicable, section 536.028, RSMo. This section and chapter 536,
6 RSMo, are nonseverable and if any of the powers vested with the general assembly pursuant to
7 chapter 536, RSMo, to review, to delay the effective date or to disapprove and annul a rule are
8 subsequently held unconstitutional, then the grant of rulemaking authority and any rule proposed
9 or adopted after August 28, 2001, shall be invalid and void.

595.030. 1. No compensation shall be paid unless the claimant has incurred an
2 out-of-pocket loss of at least fifty dollars or has lost two continuous weeks of earnings or support
3 from gainful employment. "Out-of-pocket loss" shall mean unreimbursed or unreimbursable
4 expenses or indebtedness reasonably incurred for medical care or other services, including
5 psychiatric, psychological or counseling expenses, necessary as a result of the crime upon which
6 the claim is based, except that the amount paid for psychiatric, psychological or counseling
7 expenses per eligible claim shall not exceed two thousand five hundred dollars.

8 2. No compensation shall be paid unless the division of workers' compensation finds that
9 a crime was committed, that such crime directly resulted in personal physical injury to, or the

10 death of, the victim, and that police records show that such crime was promptly reported to the
11 proper authorities. In no case may compensation be paid if the police records show that such
12 report was made more than forty-eight hours after the occurrence of such crime, unless the
13 division of workers' compensation finds that the report to the police was delayed for good cause.
14 If the victim is under eighteen years of age such report may be made by the victim's parent,
15 guardian or custodian; by a physician, a nurse, or hospital emergency room personnel; by the
16 division of family services personnel; or by any other member of the victim's family.

17 3. No compensation shall be paid for medical care if the service provider is not a medical
18 provider as that term is defined in section 595.027, and the individual providing the medical care
19 is not licensed by the state of Missouri or the state in which the medical care is provided.

20 4. No compensation shall be paid for psychiatric treatment or other counseling services,
21 including psychotherapy, unless the service provider is a:

22 (1) Physician licensed pursuant to chapter 334, RSMo, or licensed to practice medicine
23 in the state in which the service is provided;

24 (2) Psychologist licensed pursuant to chapter 337, RSMo, or licensed to practice
25 psychology in the state in which the service is provided;

26 (3) Clinical social worker licensed pursuant to chapter 337, RSMo; or

27 (4) Professional counselor licensed pursuant to chapter 337, RSMo.

28 5. Any compensation paid pursuant to sections 595.010 to 595.075 for death or personal
29 injury shall be in an amount not exceeding out-of-pocket loss, together with loss of earnings or
30 support from gainful employment, not to exceed [two] **four** hundred dollars per week, resulting
31 from such injury or death. In the event of death of the victim, an award may be made for
32 reasonable and necessary expenses actually incurred for preparation and burial not to exceed five
33 thousand dollars.

34 6. **Compensation shall be paid under sections 595.010 to 595.075 for replacement**
35 **of clothing, bedding, or other personal items of the victim that are seized by law**
36 **enforcement as evidence of the crime and shall be in an amount equal to the loss sustained**
37 **and not to exceed two hundred fifty dollars.**

38 7. Any compensation for loss of earnings or support from gainful employment shall be
39 in an amount equal to the actual loss sustained not to exceed two hundred dollars per week;
40 provided, however, that no award pursuant to sections 595.010 to 595.075 shall exceed
41 twenty-five thousand dollars. If two or more persons are entitled to compensation as a result of
42 the death of a person which is the direct result of a crime or in the case of a sexual assault, the

45 [7.] 8. The method and timing of the payment of any compensation pursuant to sections
46 595.010 to 595.075 shall be determined by the division.

595.209. 1. The following rights shall automatically be afforded to victims of dangerous
2 felonies, as defined in section 556.061, RSMo, victims of murder in the first degree, as defined
3 in section 565.020, RSMo, victims of voluntary manslaughter, as defined in section 565.023,
4 RSMo, and victims of an attempt to commit one of the preceding crimes, as defined in section
5 564.011, RSMo; and, upon written request, the following rights shall be afforded to victims of
6 all other crimes and witnesses of crimes:

7 (1) For victims, the right to be present at all criminal justice proceedings at which the
8 defendant has such right, including juvenile proceedings where the offense would have been a
9 felony if committed by an adult, even if the victim is called to testify or may be called to testify
10 as a witness in the case;

11 (2) For victims, the right to information about the crime, as provided for in subdivision
12 (5) of this subsection;

13 (3) For victims and witnesses, to be informed, in a timely manner, by the prosecutor's
14 office of the filing of charges, preliminary hearing dates, trial dates, continuances and the final
15 disposition of the case. Final disposition information shall be provided within five days;

16 (4) For victims, the right to confer with and to be informed by the prosecutor regarding
17 bail hearings, guilty pleas, pleas under chapter 552, RSMo, or its successors, hearings, sentencing
18 and probation revocation hearings and the right to be heard at such hearings, including juvenile
19 proceedings, unless in the determination of the court the interests of justice require otherwise;

20 (5) The right to be informed by local law enforcement agencies, the appropriate juvenile
21 authorities or the custodial authority of the following:

22 (a) The status of any case concerning a crime against the victim, including juvenile
23 offenses;

24 (b) The right to be informed by local law enforcement agencies or the appropriate
25 juvenile authorities of the availability of victim compensation assistance, assistance in obtaining
26 documentation of the victim's losses, including, but not limited to and subject to existing law
27 concerning protected information or closed records, access to copies of complete, unaltered,
28 unedited investigation reports of motor vehicle, pedestrian, and other similar accidents upon
29 request to the appropriate law enforcement agency by the victim or the victim's representative,
30 and emergency crisis intervention services available in the community;

31 (c) Any release of such person on bond or for any other reason;

32 (d) Within twenty-four hours, any escape by such person from a municipal detention
33 facility, county jail, a correctional facility operated by the department of corrections, mental

34 health facility, or the division of youth services or any agency thereof, and any subsequent
35 recapture of such person;

36 (6) For victims, the right to be informed by appropriate juvenile authorities of probation
37 revocation hearings initiated by the juvenile authority and the right to be heard at such hearings
38 or to offer a written statement, video or audio tape, **counsel or a representative designated by**
39 **the victim** in lieu of a personal appearance, the right to be informed by the board of probation
40 and parole of probation revocation hearings initiated by the board and of parole hearings, the
41 right to be present at each and every phase of parole hearings and the right to be heard at
42 probation revocation and parole hearings or to offer a written statement, video or audio tape,
43 **counsel or a representative designated by the victim** in lieu of a personal appearance, and the
44 right to be informed by the custodial mental health facility or agency thereof of any hearings for
45 the release of a person committed pursuant to the provisions of chapter 552, RSMo, the right to
46 be present at such hearings, the right to be heard at such hearings or to offer a written statement,
47 video or audio tape, **counsel or a representative designated by the victim** in lieu of personal
48 appearance;

49 (7) For victims and witnesses, upon their written request, the right to be informed by the
50 appropriate custodial authority, including any municipal detention facility, juvenile detention
51 facility, county jail, correctional facility operated by the department of corrections, mental health
52 facility, division of youth services or agency thereof if the offense would have been a felony if
53 committed by an adult, postconviction or commitment pursuant to the provisions of chapter 552,
54 RSMo, of the following:

55 (a) The projected date of such person's release from confinement;

56 (b) Any release of such person on bond;

57 (c) Any release of such person on furlough, work release, trial release, electronic
58 monitoring program, or to a community correctional facility or program or release for any other
59 reason, in advance of such release;

60 (d) Any scheduled parole or release hearings, including hearings under section 217.362,
61 RSMo, regarding such person and any changes in the scheduling of such hearings. No such
62 hearing shall be conducted without thirty days' advance notice;

63 (e) Within twenty-four hours, any escape by such person from a municipal detention
64 facility, county jail, a correctional facility operated by the department of corrections, mental
65 health facility, or the division of youth services or any agency thereof, and any subsequent
66 recapture of such person;

67 (f) Any decision by a parole board, by a juvenile releasing authority or by a circuit court
68 presiding over releases pursuant to the provisions of chapter 552, RSMo, or by a circuit court

69 presiding over releases under section 217.362, RSMo, to release such person or any decision by
70 the governor to commute the sentence of such person or pardon such person;

71 (g) Notification within thirty days of the death of such person;

72 (8) For witnesses who have been summoned by the prosecuting attorney and for victims,
73 to be notified by the prosecuting attorney in a timely manner when a court proceeding will not
74 go on as scheduled;

75 (9) For victims and witnesses, the right to reasonable protection from the defendant or
76 any person acting on behalf of the defendant from harm and threats of harm arising out of their
77 cooperation with law enforcement and prosecution efforts;

78 (10) For victims and witnesses, on charged cases or submitted cases where no charge
79 decision has yet been made, to be informed by the prosecuting attorney of the status of the case
80 and of the availability of victim compensation assistance and of financial assistance and
81 emergency and crisis intervention services available within the community and information
82 relative to applying for such assistance or services, and of any final decision by the prosecuting
83 attorney not to file charges;

84 (11) For victims, to be informed by the prosecuting attorney of the right to restitution
85 which shall be enforceable in the same manner as any other cause of action as otherwise
86 provided by law;

87 (12) For victims and witnesses, to be informed by the court and the prosecuting attorney
88 of procedures to be followed in order to apply for and receive any witness fee to which they are
89 entitled;

90 (13) When a victim's property is no longer needed for evidentiary reasons or needs to be
91 retained pending an appeal, the prosecuting attorney or any law enforcement agency having
92 possession of the property shall, upon request of the victim, return such property to the victim
93 within five working days unless the property is contraband or subject to forfeiture proceedings,
94 or provide written explanation of the reason why such property shall not be returned;

95 (14) An employer may not discharge or discipline any witness, victim or member of a
96 victim's immediate family for honoring a subpoena to testify in a criminal proceeding, **attending**
97 **a criminal proceeding**, or for participating in the preparation of a criminal proceeding, **or**
98 **require any witness, victim, or member of a victim's immediate family to use vacation time,**
99 **personal time, or sick leave for honoring a subpoena to testify in a criminal proceeding,**
100 **attending a criminal proceeding, or participating in the preparation of a criminal**
101 **proceeding;**

102 (15) For victims, to be provided with creditor intercession services by the prosecuting
103 attorney if the victim is unable, as a result of the crime, temporarily to meet financial obligations;

104 (16) For victims and witnesses, the right to speedy disposition of their cases, and for
105 victims, the right to speedy appellate review of their cases, provided that nothing in this
106 subdivision shall prevent the defendant from having sufficient time to prepare such defendant's
107 defense. The attorney general shall provide victims, upon their written request, case status
108 information throughout the appellate process of their cases. The provisions of this subdivision
109 shall apply only to proceedings involving the particular case to which the person is a victim or
110 witness;

111 (17) For victims and witnesses, to be provided by the court, a secure waiting area during
112 court proceedings and to receive notification of the date, time and location of any hearing
113 conducted by the court for reconsideration of any sentence imposed, modification of such
114 sentence or recall and release of any defendant from incarceration;

115 **(18) For victims, the right to receive upon request a photograph taken of the**
116 **defendant prior to release from incarceration.**

117 2. The provisions of subsection 1 of this section shall not be construed to imply any
118 victim who is incarcerated by the department of corrections or any local law enforcement agency
119 has a right to be released to attend any hearing or that the department of corrections or the local
120 law enforcement agency has any duty to transport such incarcerated victim to any hearing.

121 3. Those persons entitled to notice of events pursuant to the provisions of subsection 1
122 of this section shall provide the appropriate person or agency with their current addresses and
123 telephone numbers or the addresses or telephone numbers at which they wish notification to be
124 given.

125 4. Notification by the appropriate person or agency utilizing the statewide automated
126 crime victim notification system as established in section 650.310, RSMo, shall constitute
127 compliance with the victim notification requirement of this section. If notification utilizing the
128 statewide automated crime victim notification system cannot be used, then written notification
129 shall be sent by certified mail to the most current address provided by the victim.

130 5. Victims' rights as established in section 32 of article I of the Missouri Constitution or
131 the laws of this state pertaining to the rights of victims of crime shall be granted and enforced
132 regardless of the desires of a defendant and no privileges of confidentiality shall exist in favor
133 of the defendant to exclude victims or prevent their full participation in each and every phase of
134 parole hearings or probation revocation hearings. The rights of the victims granted in this section
135 are absolute and the policy of this state is that the victim's rights are paramount to the defendant's
136 rights. The victim has an absolute right to be present at any hearing in which the defendant is
137 present before a probation and parole hearing officer.

610.100. 1. As used in sections 610.100 to 610.150, the following words and phrases
2 shall mean:

3 (1) "Arrest", an actual restraint of the person of the defendant, or by his or her
4 submission to the custody of the officer, under authority of a warrant or otherwise for a criminal
5 violation which results in the issuance of a summons or the person being booked;

6 (2) "Arrest report", a record of a law enforcement agency of an arrest and of any
7 detention or confinement incident thereto together with the charge therefor;

8 (3) "Inactive", an investigation in which no further action will be taken by a law
9 enforcement agency or officer for any of the following reasons:

10 (a) A decision by the law enforcement agency not to pursue the case;

11 (b) Expiration of the time to file criminal charges pursuant to the applicable statute of
12 limitations, or ten years after the commission of the offense; whichever date earliest occurs;

13 (c) Finality of the convictions of all persons convicted on the basis of the information
14 contained in the investigative report, by exhaustion of or expiration of all rights of appeal of such
15 persons;

16 (4) "Incident report", a record of a law enforcement agency consisting of the date, time,
17 specific location, name of the victim and immediate facts and circumstances surrounding the
18 initial report of a crime or incident, including any logs of reported crimes, accidents and
19 complaints maintained by that agency;

20 (5) "Investigative report", a record, other than an arrest or incident report, prepared by
21 personnel of a law enforcement agency, inquiring into a crime or suspected crime, either in
22 response to an incident report or in response to evidence developed by law enforcement officers
23 in the course of their duties.

24 **(6) Investigative reports and incident reports, or other law enforcement records**
25 **covered under this section, shall not include any records or documents pertaining to**
26 **internal investigations by law enforcement agencies into matters of fitness and conduct of**
27 **law enforcement officers employed by such investigating law enforcement agencies and**
28 **used solely in connection with such officers' employment, as described in subdivision (22)**
29 **of section 610.021. However, if such records and documents are used or shared by an**
30 **agency in a criminal investigation involving an officer, provisions regarding incident**
31 **reports, investigative reports, or other documents covered under this section shall apply.**

32 2. Each law enforcement agency of this state, of any county, and of any municipality
33 shall maintain records of all incidents reported to the agency, investigations and arrests made by
34 such law enforcement agency. All incident reports and arrest reports shall be open records.
35 Notwithstanding any other provision of law other than the provisions of subsections 4, 5 and 6
36 of this section or section 320.083, RSMo, investigative reports of all law enforcement agencies
37 are closed records until the investigation becomes inactive. If any person is arrested and not
38 charged with an offense against the law within thirty days of the person's arrest, the arrest report

39 shall thereafter be a closed record except that the disposition portion of the record may be
40 accessed and except as provided in section 610.120.

41 3. Except as provided in subsections 4, 5, 6 and 7 of this section, if any portion of a
42 record or document of a law enforcement officer or agency, other than an arrest report, which
43 would otherwise be open, contains information that is reasonably likely to pose a clear and
44 present danger to the safety of any victim, witness, undercover officer, or other person; or
45 jeopardize a criminal investigation, including records which would disclose the identity of a
46 source wishing to remain confidential or a suspect not in custody; or which would disclose
47 techniques, procedures or guidelines for law enforcement investigations or prosecutions, that
48 portion of the record shall be closed and shall be redacted from any record made available
49 pursuant to this chapter.

50 4. Any person, including a family member of such person within the first degree of
51 consanguinity if such person is deceased or incompetent, attorney for a person, or insurer of a
52 person involved in any incident or whose property is involved in an incident, may obtain any
53 records closed pursuant to this section or section 610.150 for purposes of investigation of any
54 civil claim or defense, as provided by this subsection. Any individual, his or her family member
55 within the first degree of consanguinity if such individual is deceased or incompetent, his or her
56 attorney or insurer, involved in an incident or whose property is involved in an incident, upon
57 written request, may obtain a complete unaltered and unedited incident report concerning the
58 incident, and may obtain access to other records closed by a law enforcement agency pursuant
59 to this section. Within thirty days of such request, the agency shall provide the requested
60 material or file a motion pursuant to this subsection with the circuit court having jurisdiction
61 over the law enforcement agency stating that the safety of the victim, witness or other individual
62 cannot be reasonably ensured, or that a criminal investigation is likely to be jeopardized. If,
63 based on such motion, the court finds for the law enforcement agency, the court shall either order
64 the record closed or order such portion of the record that should be closed to be redacted from
65 any record made available pursuant to this subsection.

66 5. Any person may bring an action pursuant to this section in the circuit court having
67 jurisdiction to authorize disclosure of the information contained in an investigative report of any
68 law enforcement agency, which would otherwise be closed pursuant to this section. The court
69 may order that all or part of the information contained in an investigative report be released to
70 the person bringing the action. In making the determination as to whether information contained
71 in an investigative report shall be disclosed, the court shall consider whether the benefit to the
72 person bringing the action or to the public outweighs any harm to the public, to the law
73 enforcement agency or any of its officers, or to any person identified in the investigative report
74 in regard to the need for law enforcement agencies to effectively investigate and prosecute

75 criminal activity. The investigative report in question may be examined by the court in camera.
76 The court may find that the party seeking disclosure of the investigative report shall bear the
77 reasonable and necessary costs and attorneys' fees of both parties, unless the court finds that the
78 decision of the law enforcement agency not to open the investigative report was substantially
79 unjustified under all relevant circumstances, and in that event, the court may assess such
80 reasonable and necessary costs and attorneys' fees to the law enforcement agency.

81 6. Any person may apply pursuant to this subsection to the circuit court having
82 jurisdiction for an order requiring a law enforcement agency to open incident reports and arrest
83 reports being unlawfully closed pursuant to this section. If the court finds by a preponderance
84 of the evidence that the law enforcement officer or agency has knowingly violated this section,
85 the officer or agency shall be subject to a civil penalty in an amount up to one thousand dollars.
86 If the court finds that there is a knowing violation of this section, the court may order payment
87 by such officer or agency of all costs and attorneys' fees, as provided by section 610.027. If the
88 court finds by a preponderance of the evidence that the law enforcement officer or agency has
89 purposely violated this section, the officer or agency shall be subject to a civil penalty in an
90 amount up to five thousand dollars and the court shall order payment by such officer or agency
91 of all costs and attorney fees, as provided in section 610.027. The court shall determine the
92 amount of the penalty by taking into account the size of the jurisdiction, the seriousness of the
93 offense, and whether the law enforcement officer or agency has violated this section previously.

94 7. The victim of an offense as provided in chapter 566, RSMo, may request that his or
95 her identity be kept confidential until a charge relating to such incident is filed.

**650.010. 1. The department of public safety has the authority to promulgate rules
2 establishing recommended procedures for issuing missing endangered person advisories.
3 Any rule or portion of a rule, as that term is defined in section 536.010, RSMo, that is
4 created under the authority delegated in this section shall become effective only if it
5 complies with and is subject to all of the provisions of chapter 536, RSMo, and if
6 applicable, section 536.028, RSMo. This section and chapter 536, RSMo, are nonseverable
7 and if any of the powers vested with the general assembly pursuant to chapter 536, RSMo,
8 to review, to delay the effective date, or to disapprove and annul a rule are subsequently
9 held unconstitutional, then the grant of rulemaking authority and any rule proposed or
10 adopted after August 28, 2007, shall be invalid and void.**

11 **2. For the purposes of this section, "missing endangered person" means a person
12 whose whereabouts are unknown and who is:**

13 **(1) Physically or mentally disabled or suffering some form of dementia to the
14 degree that the person is dependent upon an agency or another individual;**

15 **(2) Missing under circumstances indicating that the missing person's safety may**
16 **be in danger or that criminal activity may be involved; or**

17 **(3) Missing under involuntary or unknown circumstances.**

650.055. 1. Every individual, in a Missouri circuit court, who pleads guilty to or is
2 found guilty of a felony or any offense under chapter 566, RSMo, or has been determined
3 [beyond a reasonable doubt] to be a sexually violent predator pursuant to sections 632.480 to
4 632.513, RSMo, shall have a blood or scientifically accepted biological sample collected for
5 purposes of DNA profiling analysis:

6 (1) Upon entering or before release from the department of corrections reception and
7 diagnostic centers; or

8 (2) Upon entering or before release from a county jail or detention facility, state
9 correctional facility, or any other detention facility or institution, whether operated by private,
10 local, or state agency, or any mental health facility if committed as a sexually violent predator
11 pursuant to sections 632.480 to 632.513, RSMo; or

12 (3) When the state accepts a person from another state under any interstate compact, or
13 under any other reciprocal agreement with any county, state, or federal agency, or any other
14 provision of law, whether or not the person is confined or released, the acceptance is conditional
15 on the person providing a DNA sample if the person was convicted of, pleaded guilty to, or
16 pleaded nolo contendere to an offense in any other jurisdiction which would be considered a
17 qualifying offense as defined in this section if committed in this state, or if the person was
18 convicted of, pleaded guilty to, or pleaded nolo contendere to any equivalent offense in any other
19 jurisdiction; or

20 (4) If such individual is under the jurisdiction of the department of corrections. Such
21 jurisdiction includes persons currently incarcerated, persons on probation, as defined in section
22 217.650, RSMo, and on parole, as also defined in section 217.650, RSMo.

23 2. The Missouri state highway patrol and department of corrections shall be responsible
24 for ensuring adherence to the law. Any person required to provide a DNA sample pursuant to
25 this section shall be required to provide such sample, without the right of refusal, at a collection
26 site designated by the Missouri state highway patrol and the department of corrections.
27 Authorized personnel collecting or assisting in the collection of samples shall not be liable in any
28 civil or criminal action when the act is performed in a reasonable manner. Such force may be
29 used as necessary to the effectual carrying out and application of such processes and operations.
30 The enforcement of these provisions by the authorities in charge of state correctional institutions
31 and others having custody or jurisdiction over those who have been convicted of, pleaded guilty
32 to, or pleaded nolo contendere to felony offenses which shall not be set aside or reversed is
33 hereby made mandatory. The board of probation or parole shall recommend that an individual

34 who refuses to provide a DNA sample have his or her probation or parole revoked. In the event
35 that a person's DNA sample is not adequate for any reason, the person shall provide another
36 sample for analysis.

37 3. The procedure and rules for the collection, analysis, storage, expungement, use of
38 DNA database records and privacy concerns shall not conflict with procedures and rules
39 applicable to the Missouri DNA profiling system and the Federal Bureau of Investigation's DNA
40 databank system.

41 4. Unauthorized uses or dissemination of individually identifiable DNA information in
42 a database for purposes other than criminal justice or law enforcement is a class A misdemeanor.

43 5. Implementation of sections 650.050 to 650.100 shall be subject to future
44 appropriations to keep Missouri's DNA system compatible with the Federal Bureau of
45 Investigation's DNA databank system.

46 6. All DNA records and biological materials retained in the DNA profiling system are
47 considered closed records pursuant to chapter 610, RSMo. All records containing any
48 information held or maintained by any person or by any agency, department, or political
49 subdivision of the state concerning an individual's DNA profile shall be strictly confidential and
50 shall not be disclosed, except to:

51 (1) Peace officers, as defined in section 590.010, RSMo, and other employees of law
52 enforcement agencies who need to obtain such records to perform their public duties;

53 (2) The attorney general or any assistant attorneys general acting on his or her behalf, as
54 defined in chapter 27, RSMo;

55 (3) Prosecuting attorneys or circuit attorneys as defined in chapter 56, RSMo, and their
56 employees who need to obtain such records to perform their public duties; or

57 (4) Associate circuit judges, circuit judges, judges of the courts of appeals, supreme court
58 judges, and their employees who need to obtain such records to perform their public duties.

59 7. Any person who obtains records pursuant to the provisions of this section shall use
60 such records only for investigative and prosecutorial purposes, including but not limited to use
61 at any criminal trial, hearing, or proceeding; or for law enforcement identification purposes,
62 including identification of human remains. Such records shall be considered strictly confidential
63 and shall only be released as authorized by this section.

64 8. An individual may request expungement of his or her DNA sample and DNA profile
65 through the court issuing the reversal or dismissal. A certified copy of the court order
66 establishing that such conviction has been reversed or guilty plea or plea of nolo contendere has
67 been set aside shall be sent to the Missouri state highway patrol crime laboratory. Upon receipt
68 of the court order, the laboratory will determine that the requesting individual has no other
69 qualifying offense as a result of any separate plea or conviction prior to expungement.

70 (1) A person whose DNA record or DNA profile has been included in the state DNA
71 database in accordance with this section, section 488.5050, RSMo, and sections 650.050,
72 650.052, and 650.100 may request expungement on the grounds that the conviction has been
73 reversed, or the guilty plea or plea of nolo contendere on which the authority for including that
74 person's DNA record or DNA profile was based has been set aside.

75 (2) Upon receipt of a written request for expungement, a certified copy of the final court
76 order reversing the conviction or setting aside the plea and any other information necessary to
77 ascertain the validity of the request, the Missouri state highway patrol crime laboratory shall
78 expunge all DNA records and identifiable information in the database pertaining to the person
79 and destroy the DNA sample of the person, unless the Missouri state highway patrol determines
80 that the person is otherwise obligated to submit a DNA sample. Within thirty days after the
81 receipt of the court order, the Missouri state highway patrol shall notify the individual that it has
82 expunged his or her DNA sample and DNA profile, or the basis for its determination that the
83 person is otherwise obligated to submit a DNA sample.

84 (3) The Missouri state highway patrol is not required to destroy any item of physical
85 evidence obtained from a DNA sample if evidence relating to another person would thereby be
86 destroyed.

87 (4) Any identification, warrant, arrest, or evidentiary use of a DNA match derived from
88 the database shall not be excluded or suppressed from evidence, nor shall any conviction be
89 invalidated or reversed or plea set aside due to the failure to expunge or a delay in expunging
90 DNA records.

650.340. 1. The provisions of this section may be cited and shall be known as the "911
2 Training and Standards Act".

3 2. Initial training requirements for telecommunicators who answer 911 calls that come
4 to public safety answering points shall be as follows:

- 5 (1) Police telecommunicator. 16 hours;
- 6 (2) Fire telecommunicator. 16 hours;
- 7 (3) Emergency medical services telecommunicator 16 hours;
- 8 (4) Joint communication center telecommunicator 40 hours.

9 3. All persons employed as a telecommunicator in this state shall be required to complete
10 ongoing training so long as such person engages in the occupation as a telecommunicator. Such
11 persons shall complete at least [sixteen] **twenty-four** hours of ongoing training every [two] **three**
12 years by such persons or organizations as provided in subsection 6 of this section. **The**
13 **reporting period for the ongoing training under this subsection shall run concurrent with**
14 **the existing continuing education reporting periods for Missouri peace officers pursuant**
15 **to chapter 590, RSMo.**

16 4. Any person employed as a telecommunicator on August 28, 1999, shall not be
17 required to complete the training requirement as provided in subsection 2 of this section. Any
18 person hired as a telecommunicator after August 28, 1999, shall complete the training
19 requirements as provided in subsection 2 of this section within twelve months of the date such
20 person is employed as a telecommunicator.

21 5. The training requirements as provided in subsection 2 of this section shall be waived
22 for any person who furnishes proof to the committee that such person has completed training in
23 another state which are at least as stringent as the training requirements of subsection 2 of this
24 section.

25 6. The department of public safety shall determine by administrative rule the persons or
26 organizations authorized to conduct the training as required by subsection 2 of this section.

27 7. This section shall not apply to an emergency medical dispatcher or agency as defined
28 in section 190.100, RSMo, or a person trained by an entity accredited or certified under section
29 190.131, RSMo, or a person who provides prearrival medical instructions who works for an
30 agency which meets the requirements set forth in section 190.134, RSMo.

650.457. 1. There is established a "Missouri Medal of Valor Review Board", the
2 members of which shall be individuals with knowledge or expertise, whether by experience or
3 training, in the field of public safety, which shall conduct its business in accordance with sections
4 650.450 to 650.460, and be composed of eleven members, all residents of Missouri, and
5 appointed in the following manner:

6 (1) One member shall be either the director of the department of public safety or a
7 designee appointed by the director;

8 (2) One member shall be a police chief;

9 (3) One member shall be a fire chief;

10 (4) One member shall be an elected county sheriff;

11 (5) One member shall be the director of an ambulance district;

12 (6) One member shall be a citizen with experience in law enforcement;

13 (7) One member shall be a citizen with experience in corrections;

14 (8) One member shall be a citizen with experience in fire fighting;

15 (9) One member shall be a citizen with experience in emergency medical services; and

16 (10) Two members shall be appointed at the governor's discretion.

17 2. [The term of a board member shall be four years.] **Members of the Missouri medal
18 of valor board shall be appointed by the governor from a list of qualified candidates
19 submitted to the governor by the director of the department of public safety. The
20 appointments would be for a term of four years; except that, of those members first
21 appointed, three members shall be appointed to serve for two years, four members shall**

22 **be appointed for three years, and four members shall be appointed for four years.**
23 **Members of the board may serve multiple terms.**

24 3. Any vacancy in the membership of the board shall not affect the powers of the board
25 and shall be filled in the same manner as the original appointment.

26 4. (1) The chairman of the board shall be elected by the members of the board from
27 among the members of the board.

28 (2) The board shall conduct its first meeting not later than ninety days after the
29 appointment of the last member appointed of the initial group of members appointed to the
30 board. Thereafter, the board shall meet at the call of the chairman of the board. The board shall
31 meet not less often than once each year and not more than three times a year.

32 (3) A majority of the members shall constitute a quorum to conduct business, but the
33 board may establish a lesser quorum for conducting hearings scheduled by the board. The board
34 may establish by majority vote any other rules for the conduct of the board's business, if such
35 rules are not inconsistent with sections 650.450 to 650.460 or other applicable law.

36 (4) The board shall select candidates as recipients of the medal from among those
37 applications received by the board. Not more often than once each year, the board shall present
38 to the governor the name or names of those it recommends as medal recipients. In a given year,
39 the board shall not be required to select any recipients but may not select more than seven
40 recipients. The governor may in extraordinary cases increase the number of recipients in a given
41 year. The board shall set an annual timetable for fulfilling its duties under sections 650.450 to
42 650.460.

43 (5) The board may secure directly from any department or agency such information as
44 the board considers necessary to carry out its duties. Upon the request of the board, the head of
45 such department or agency may furnish such information to the board.

46 (6) The board shall not disclose any information which may compromise an ongoing law
47 enforcement investigation or is otherwise required by law to be kept confidential.

48 (7) The members of the board shall serve without compensation, except that the
49 members may be reimbursed for reasonable and necessary expenses arising from board activities
50 or business. Such expenses shall be paid by the department of public safety from the fund
51 created pursuant to section 650.460.

**650.470. 1. There is hereby created in the state treasury the "Reverend Nathaniel
2 Cole Memorial Pursuit Reduction Grant", which shall consist of all moneys duly
3 authorized and appropriated by the general assembly, all moneys received from federal
4 funds, gifts, bequests, donations, and any other moneys so designated, and all interest
5 earned on and income generated from moneys in the fund. The state treasurer shall be the
6 custodian of the fund and shall approve disbursements from the fund in accordance with**

7 sections 30.170 and 30.180, RSMo. Moneys in the fund shall be used solely to provide
8 grants in the amount of a fifty percent match to urban police departments which purchase
9 real-time tagging and tracking pursuit management systems.

10 2. Notwithstanding the provisions of section 33.080, RSMo, to the contrary, any
11 moneys remaining in the fund at the end of the biennium shall not revert to the credit of
12 the general revenue fund.

13 3. The state treasurer shall invest moneys in the fund in the same manner as other
14 funds are invested.

15 4. Only urban police departments which have a pursuit policy in place that is
16 consistent with the state laws governing police pursuits shall be eligible for such grants.
17 The director of the department of public safety shall determine an applicant's eligibility
18 according to the requirements of this subsection and shall disqualify from consideration
19 any urban police department that is not in compliance with state laws governing police
20 pursuit.

21 5. Applications for matching grants shall be filed with the department of public
22 safety on forms prescribed and furnished by the director of the department of public
23 safety. The applications shall include the number of pursuits engaged in by the applicant
24 department per year for each of the five years preceding the application.

25 6. The director shall approve all applications which are not disqualified under the
26 provisions of subsection 4 of this section. If funding is not sufficient to award grants to all
27 eligible applicants who were not disqualified by the director of the department of public
28 safety then the director shall determine which applicants shall be awarded grants on the
29 basis of need. Need shall be determined by the average number of pursuits engaged in by
30 a department over the five years preceding application with grants being awarded first to
31 those applicants with the highest average number of pursuits per year. The director shall
32 continue to award grants based on need until funds dip below the dollar amount needed
33 to provide a fifty percent match to the next applicant.

34 7. The director of the department of public safety shall administer the provisions
35 of this section and may adopt all rules and regulations necessary to administer the
36 provisions of this section. Any rule or portion of a rule, as that term is defined in section
37 536.010, RSMo, that is created under the authority delegated in this section shall become
38 effective only if it complies with and is subject to all of the provisions of chapter 536,
39 RSMo, and, if applicable, section 536.028, RSMo. The provisions of this section are
40 nonseverable and if any of the powers vested with the general assembly under chapter 536,
41 RSMo, to review, to delay the effective date, or to disapprove and annul a rule are

42 **subsequently held unconstitutional, then the grant of rulemaking authority and any rule**
43 **proposed or adopted after August 28, 2007, shall be invalid and void.**

44 **8. As used in this section the following terms shall mean:**

45 **(1) "Real-time tagging and tracking pursuit management system", any system**
46 **which deploys a projectile that attaches to a fleeing vehicle during police pursuit and can**
47 **be monitored in real-time using GPS technology;**

48 **(2) "Urban police department", any police department, sheriffs' department, or**
49 **law enforcement agency which is located in a metropolitan area in this state with a**
50 **population of at least four hundred thousand inhabitants.**
