FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Elementary and Secondary Education (DESE)** state there will be no additional costs for their agency. Any cost would be to the unaccredited school districts who are, under current law, responsible for tuition payments for students transferring to an accredited school. DESE was unable to determine how many students would transfer or what the tuition cost would be.

Oversight notes that §167.131.2 states that the rate of tuition to be charged by the district attended and paid by the sending district is the per pupil cost of maintaining the district's grade level grouping which includes the school attended. The cost of maintaining a grade level grouping shall be determined by the board of education of the district but in no case shall it exceed all amounts spent for teachers' wages, incidental purposes, debt service, maintenance and replacements. **Oversight** assumes the cost to unaccredited districts would be more than state aid received per pupil. The cost is unknown, but could exceed \$100,000.

No direct fiscal impact to small businesses would be expected as a result of this proposal.

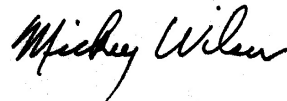
FISCAL DESCRIPTION

Prior to the beginning of the 2009-2010 school year, this proposed legislation requires the Department of Elementary and Secondary Education to develop criteria for the admission or rejection of nonresident students from unaccredited districts who wish to transfer to an adjoining accredited school district. No student can be rejected except for reasons specified in the criteria.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
