

# House Concurrent Resolution No. 14

## 94TH GENERAL ASSEMBLY

### AN ACT

Relating to the ratification of the Equal Rights Amendment to the United States Constitution.

---

*Be it enacted by the General Assembly of the state of Missouri, as follows:*

2       **Whereas**, three years after women won the right to vote, the Equal Rights  
3 Amendment to the United States Constitution, authored by Alice Paul, head of the National  
4 Women's Party, was introduced in Congress by Senator Curtis and Representative Anthony, both  
5 Republicans; and

6       **Whereas**, the Equal Rights Amendment to the United States Constitution passed the  
7 United States Senate and then the United States House of Representatives, and on March 22,  
8 1972, the proposed Amendment to the United States Constitution was sent to the states for  
9 ratification; and  
10

11       **Whereas**, the Equal Rights Amendment to the United States Constitution states:  
12  
13       "Section 1. Equality of rights under the law shall not be denied or abridged by the  
14 United States or by any state on account of sex.  
15       Section 2. The Congress shall have the power to enforce, by appropriate legislation, the  
16 provisions of this article.  
17       Section 3. This amendment shall take effect two years after the date of ratification."; and  
18

19       **Whereas**, Congress placed a deadline of June 30, 1982, on the ratification process  
20 and thirty-five states ratified the proposed Amendment before the deadline; and  
21

22       **Whereas**, Congress may not have the constitutional authority to place a deadline on  
23 the ratification process; and  
24

25       **Whereas**, Article V of the United States Constitution allows the General Assembly  
26 of the State of Missouri to ratify this proposed Amendment to the Constitution of the United  
27 States; and  
28

29       **Whereas**, the General Assembly of the State of Missouri finds that the proposed  
30 Amendment is meaningful and needed as part of the United States Constitution and that the  
31 present political, social and economic conditions are the same as or are even more demanding  
32 today than they were when the proposed Amendment was first submitted for adoption:  
33

34       **Now, therefore, be it resolved** that the members of the House of  
35 Representatives of the Ninety-fourth General Assembly, Second Regular Session, the Senate concurring  
36 therein that the Equal Rights Amendment to the United States Constitution is hereby ratified; and  
37

38       **Be it further resolved** that the Chief Clerk of the House of Representatives be  
39 instructed to prepare a properly inscribed copy of this resolution for the Archivist of the United States,  
40 Washington, D.C.; the Vice President of the United States; the Speaker of the United States House of  
41 Representatives; and each member of the Missouri Congressional Delegation with request that it be  
42 printed in the Congressional Record.
