AN ACT

To amend chapter 290, RSMo, by adding thereto one new section relating to employee rights,
with a penalty provision.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 290, RSMo, is amended by adding thereto one new section, to be
2 known as section 290.600, to read as follows:

290.600. 1. As used in this section the term "labor organization" means any
2 **organization of any kind or agency or employee representation committee or union which**
3 **exists for the purpose in whole or in part of dealing with employers concerning wages, rates**
4 **of pay, hours of work, other conditions of employment, or other forms of compensation.**

5 **2. No person shall be required as a condition or continuation of employment to:**

6 **(1) Become or refrain from becoming a member of a labor organization;**

7 **(2) Pay any dues, fees, assessments, or other similar charges however denominated**
8 **of any kind or amount to a labor organization; or**

9 **(3) In lieu of the payments listed under subdivision (2) of this subsection, pay to any**
10 **charity or other third party any amount equivalent to or on a pro rata basis any dues, fees,**
11 **assessments, or other charges required of members of a labor organization.**

12 **3. Any agreement, understanding, or practice, written or oral, implied or expressed,**
13 **between any labor organization and employer that violates the rights of employees as**

14 guaranteed under this section is declared to be unlawful, null and void, and of no legal effect.

15 **4. Any person who directly or indirectly violates any provision of this section shall**
16 **be guilty of a class C misdemeanor.**

17 **5. (1) Any person injured as a result of any violation or threatened violation of this**
18 **section shall be entitled to injunctive relief against any and all violators or persons**
19 **threatening violations.**

20 **(2) Any person injured as a result of any violation or threatened violation of this**
21 **section may recover any and all damages of any character resulting from such violation or**
22 **threatened violation including costs and reasonable attorney fees. Such remedies shall be**
23 **independent of and in addition to the other penalties and remedies proscribed under this**
24 **section.**

25 **6. It shall be the duty of the prosecuting attorney of each county and of the attorney**
26 **general of this state to investigate complaints of violation or threatened violation of this**
27 **section and to prosecute any person violating this section and to use all means at their**
28 **command to ensure the effective enforcement of this section.**

29 **7. This section shall not apply:**

30 **(1) To employers and employees covered by the federal Railway Labor Act;**

31 **(2) To federal employers and employees;**

32 **(3) To employers and employees on exclusive federal enclaves;**

33 **(4) Where this section conflicts with or is preempted by federal law; or**

34 **(5) To any collective bargaining agreement or any other type of agreement between**
35 **an employer and a labor organization entered into before the effective date of this section**
36 **but shall apply to any new agreement or renewal or extension of any existing collective**
37 **bargaining agreement.**
