AN ACT

To repeal section 195.017, RSMo, and to enact in lieu thereof one new section relating to schedule II controlled substances, with a penalty provision.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Section 195.017, RSMo, is repealed and one new section enacted in lieu thereof, to be known as section 195.017, to read as follows:

195.017. 1. The department of health and senior services shall place a substance in Schedule I if it finds that the substance:

(1) Has high potential for abuse; and

(2) Has no accepted medical use in treatment in the United States or lacks accepted safety for use in treatment under medical supervision.

2. Schedule I:

(1) The controlled substances listed in this subsection are included in Schedule I;

(2) Any of the following opiates, including their isomers, esters, ethers, salts, and salts of isomers, esters, and ethers, unless specifically excepted, whenever the existence of these isomers, esters, ethers and salts is possible within the specific chemical designation:

(a) Acetyl-alpha-methylfentanyl;

(b) Acetylmethadol;

(c) Allylprodine;

(d) Alphacetylmethadol;

Any drug or hormonal substance, chemically and pharmacologically related to testosterone (other than estrogens, progestins, and corticosteroids) that promotes muscle growth, except an anabolic steroid which is expressly intended for administration through implants to cattle or other nonhuman species and which has been approved by the Secretary of Health and Human Services for that administration. If any person prescribes, dispenses, or distributes such steroid for human use, such person shall be considered to have prescribed, dispensed, or distributed an anabolic steroid within the meaning of this paragraph. Unless specifically excepted or unless listed in another schedule, any material, compound, mixture or preparation containing any quantity of the following substances, including its salts, isomers and salts of isomers whenever the existence of such salts of isomers is possible within the specific chemical designation:

386 mixture, or preparation containing any stimulant or depressant substance listed in subdivisions
387 (1) and (2) of this subsection from the application of all or any part of sections 195.010 to
388 195.320 if the compound, mixture, or preparation contains one or more active medicinal
389 ingredients not having a stimulant or depressant effect on the central nervous system, and if the
390 admixtures are included therein in combinations, quantity, proportion, or concentration that
391 vitiate the potential for abuse of the substances which have a stimulant or depressant effect on
392 the central nervous system.

393 7. The department of health and senior services shall place a substance in Schedule IV
394 if it finds that:

395 (1) The substance has a low potential for abuse relative to substances in Schedule III;
396 (2) The substance has currently accepted medical use in treatment in the United States;
397 and

398 (3) Abuse of the substance may lead to limited physical dependence or psychological
399 dependence relative to the substances in Schedule III.

- 463 (qq) Pinazepam;
- 464 (rr) Prazepam;
- 465 (ss) Quazepam;
- 466 (tt) Temazepam;
- 467 (uu) Tetrazepam;
- 468 (vv) Triazolam;
- 469 (ww) Zaleplon;
- 470 (xx) Zolpidem;
- 471 (3) Any material, compound, mixture, or preparation which contains any quantity of the
- 472 following substance including its salts, isomers and salts of isomers whenever the existence of
- 473 such salts, isomers and salts of isomers is possible: fenfluramine;
- 474 (4) Any material, compound, mixture or preparation containing any quantity of the
- 475 following substances having a stimulant effect on the central nervous system, including their
- 476 salts, isomers and salts of isomers:
- 477 (a) Cathine ((+)-norpseudoephedrine);
- 478 (b) Diethylpropion;
- 479 (c) Fencamfamin;

480 (d) Fenproporex;
481 (e) Mazindol;
482 (f) Mefenorex;
483 (g) Modafinil;
484 (h) Pemoline, including organometallic complexes and chelates thereof;
485 (i) Phentermine;
486 (j) Pipradrol;
487 (k) Sibutramine;
488 (l) SPA ((-)-1-dimethylamino-1,2-diphenylethane);
489 (5) Any material, compound, mixture or preparation containing any quantity of the
490 following substance, including its salts:
491 (a) butorphanol;
492 (b) pentazocine;
493 (6) Ephedrine, its salts, optical isomers and salts of optical isomers, when the substance
494 is the only active medicinal ingredient;
495 (7) The department of health and senior services may except by rule any compound,
496 mixture, or preparation containing any depressant substance listed in subdivision (1) of this
497 subsection from the application of all or any part of sections 195.010 to 195.320 if the
498 compound, mixture, or preparation contains one or more active medicinal ingredients not having
499 a depressant effect on the central nervous system, and if the admixtures are included therein in
500 combinations, quantity, proportion, or concentration that vitiate the potential for abuse of the
501 substances which have a depressant effect on the central nervous system.
502 9. The department of health and senior services shall place a substance in Schedule V
503 if it finds that:
504 (1) The substance has low potential for abuse relative to the controlled substances listed
505 in Schedule IV;
506 (2) The substance has currently accepted medical use in treatment in the United States;
507 and
508 (3) The substance has limited physical dependence or psychological dependence liability
509 relative to the controlled substances listed in Schedule IV.
510 10. The controlled substances listed in this subsection are included in Schedule V:
511 (1) Any compound, mixture or preparation containing any of the following narcotic
512 drugs or their salts calculated as the free anhydrous base or alkaloid, in limited quantities as set
513 forth below, which also contains one or more nonnarcotic active medicinal ingredients in
514 sufficient proportion to confer upon the compound, mixture or preparation valuable medicinal
515 qualities other than those possessed by the narcotic drug alone:

516 (a) Not more than two and five-tenths milligrams of diphenoxylate and not less than
517 twenty-five micrograms of atropine sulfate per dosage unit;

518 (b) Not more than one hundred milligrams of opium per one hundred milliliters or per
519 one hundred grams;

520 (c) Not more than five-tenths milligram of difenoxin and not less than twenty-five
521 micrograms of atropine sulfate per dosage unit;

522 (2) Any material, compound, mixture or preparation which contains any quantity of the
523 following substance having a stimulant effect on the central nervous system including its salts,
524 isomers and salts of isomers: pyrovalerone;

525 (3) Any compound, mixture, or preparation containing any detectable quantity of
526 pseudoephedrine or its salts or optical isomers, or salts of optical isomers or any compound,
527 mixture, or preparation containing any detectable quantity of ephedrine or its salts or optical
528 isomers, or salts of optical isomers.

529 11. If any compound, mixture, or preparation as specified in subdivision (3) of
530 subsection 10 of this section is dispensed, sold, or distributed in a pharmacy without a
531 prescription:

532 (1) All packages of any compound, mixture, or preparation containing any detectable
533 quantity of pseudoephedrine, its salts or optical isomers, or salts of optical isomers or ephedrine,
534 its salts or optical isomers, or salts of optical isomers, shall be offered for sale only from behind
535 a pharmacy counter where the public is not permitted, and only by a registered pharmacist or
536 registered pharmacy technician; and

537 (2) Any person purchasing, receiving or otherwise acquiring any compound, mixture,
538 or preparation containing any detectable quantity of pseudoephedrine, its salts or optical isomers,
539 or salts of optical isomers or ephedrine, its salts or optical isomers, or salts of optical isomers
540 shall be at least eighteen years of age; and

541 (3) The pharmacist or registered pharmacy technician shall require any person
542 purchasing, receiving or otherwise acquiring such compound, mixture, or preparation, who is not
543 known to the pharmacist or registered pharmacy technician, to furnish suitable photo
544 identification showing the date of birth of the person.

545 12. Within ninety days of the enactment of this section, pharmacists and registered
546 pharmacy technicians shall implement and maintain a written or electronic log of each
547 transaction. Such log shall include the following information:

548 (1) The name and address of the purchaser;

549 (2) The amount of the compound, mixture, or preparation purchased;

550 (3) The date of each purchase; and

551 (4) The name or initials of the pharmacist or registered pharmacy technician who
552 dispensed the compound, mixture, or preparation to the purchaser.

553 13. No person shall dispense, sell, purchase, receive, or otherwise acquire quantities
554 greater than those specified in this chapter.

555 14. Within thirty days of the enactment of this section, all persons who dispense or offer
556 for sale pseudoephedrine and ephedrine products in a pharmacy shall ensure that all such
557 products are located only behind a pharmacy counter where the public is not permitted.

558 15. Within thirty days of the enactment of this section, any business entity which sells
559 ephedrine or pseudoephedrine products in the course of legitimate business which is in the
560 possession of pseudoephedrine and ephedrine products, and which does not have a state and
561 federal controlled substances registration, shall return these products to a manufacturer or
562 distributor or transfer them to an authorized controlled substances registrant.

563 16. Any person who knowingly or recklessly violates the provisions of subsections 11
564 to 15 of this section is guilty of a class A misdemeanor.

565 17. The scheduling of substances specified in subdivision (3) of subsection 10 of this
566 section and subsections 11, 12, 14, and 15 of this section shall not apply to any compounds,
567 mixtures, or preparations that are in liquid or liquid-filled gel capsule form or to any compound,
568 mixture, or preparation specified in subdivision (3) of subsection 10 of this section which must
569 be dispensed, sold, or distributed in a pharmacy pursuant to a prescription.

570 18. The manufacturer of a drug product or another interested party may apply with the
571 department of health and senior services for an exemption from this section. The department of
572 health and senior services may grant an exemption by rule from this section if the department
573 finds the drug product is not used in the illegal manufacture of methamphetamine or other
574 controlled or dangerous substances. The department of health and senior services shall rely on
575 reports from law enforcement and law enforcement evidentiary laboratories in determining if the
576 proposed product can be used to manufacture illicit controlled substances.

577 19. The department of health and senior services shall revise and republish the schedules
578 annually.

579 20. The department of health and senior services shall promulgate rules under chapter
580 536, RSMo, regarding the security and storage of Schedule V controlled substances, as described
581 in subdivision (3) of subsection 10 of this section, for distributors as registered by the department
582 of health and senior services.
