HB 1644 -- Tax Deduction for Corporate Federal Income Tax Liability

Currently, a corporation is limited to a state income tax deduction of 50% of its federal income tax less certain tax credits. Beginning January 1, 2008, this bill allows full deductibility from state income tax of all federal income tax liability for corporations without a reduction for tax credits claimed.
