

HB 1873 -- Real Estate Transactions

Sponsor: Yates

Currently, all moneys accepted by a settlement agent for closing a real estate transaction must be certified funds unless the buyer, seller, or lender is a financial institution. This bill exempts real estate transactions of less than \$2,500 from the requirement that they be certified funds.

The bill contains an emergency clause.
