HB 1904 -- State Housing Development Commission

Currently, the State Housing Development Commission cannot have outstanding bonds or notes in an aggregate principle amount exceeding \$200 million at any one time. This bill specifies that any conduit revenue bonds or notes of the commission on which the payment of all debt service is the responsibility of an approved mortgagor will not be included in the indebtedness limitation.
