HB 2246 -- Corporate Income Tax

Sponsor: Robb

Beginning September 1, 2008, this bill decreases the corporate income tax rate from 6.25% to 5.5%. For the purposes of calculating the apportionment of corporate income, the bill requires the sales factor to be multiplied by three.
