FISCAL ANALYSIS

ASSUMPTION

Officials from the **Department of Transportation** and the **Department of Public Safety – Missouri State Highway Patrol** assume the proposal would have no fiscal impact on their agencies.

Officials from the **Office of State Courts Administrator** assume the proposed legislation would have no fiscal impact on the courts.

Officials from the **Office of Prosecution Services** assume the proposal would have no measurable fiscal impact the Office of Prosecution Services or county prosecutors.

Officials from the **Department of Corrections (DOC)** assume the penalty provisions, the component of the bill to have potential fiscal impact for DOC, is for up to a class D felony.

DOC cannot currently predict the number of new commitments which may result from the creation of the offense(s) outlined in this proposal. An increase in commitments depends on the utilization by prosecutors and the actual sentences imposed by the court.

If additional persons are sentenced to the custody of the DOC due to the provisions of this legislation, the DOC will incur a corresponding increase of direct offender costs either through incarceration (FY08 average of \$15.64 per offender per day, or an annual cost of \$5,709 per inmate) or through supervision provided by the Board of Probation and Parole (FY08 average of \$2.47 per offender per day, or an annual cost of \$902 per offender).

The following factors contribute to DOC's minimal assumption:

- DOC assumes the narrow scope of the crime will not encompass a large number of offenders;
- The low felony status of the crime enhances the possibility of plea-bargaining or imposition of a probation sentence; and
- The probability exists that offenders would be charged with a similar but more serious offense or that sentences may run concurrent to one another.

ASSUMPTION (continued)

In summary, supervision by the DOC through probation or incarceration would result in some additional costs, but it is assumed the impact would be \$0 or a minimal amount that could be absorbed within existing resources.

Officials from the **Department of Revenue (DOR)** assume motorcycle stunt driving offenses are moving violations and will have two points assessed. In addition, if the person is convicted of a felony, twelve points will be assessed under section 302.302 RSMo.

DOR assumes the proposal will require a MODL code to be assigned to the offense of motorcycle stunt driving. DOR also assumes a twelve point violation will be assessed for a felony offense under section 302.302 RSMo.

DOR provided the following Office of Administration – Information Technology Services Division (COA – ITSD) assumptions: COA – ITSD estimates that this legislation could be implemented utilizing existing resources of 2 existing CITs III for 2 months at a rate of \$4,441. However, if priorities shift and additional FTE/overtime would be needed to implement, the cost will be approximately \$17,764. COA – ITSD plans plan to use existing resources to implement this legislation.

Officials from the **Office of the State Public Defender (SPD)** assume increasing penalties on existing crimes, or creating new crimes, will require more SPD resources. While the number of new cases (or cases with increased penalties) may be too few or uncertain to request additional appropriations for this specific bill, the SPD will continue to request sufficient appropriations to provide competent and effective representation in all its cases.

Oversight assumes the Office of the State Public Defender (SPD) could absorb the costs of the proposed legislation within existing resources. Oversight assumes any significant increase in the workload of the SPD would be reflected in future budget requests.

No direct fiscal impact to small businesses would be expected as a result of this proposal.


FISCAL DESCRIPTION
