Bill Summary: This legislation requires health providers to inform victims of rape or sexual assault of their right to request a drug test to determine if a drug was used to facilitate the rape or sexual assault.

FISCAL ANALYSIS

ASSUMPTION

Section 191.220:

Officials from the **Department of Labor and Industrial Relations**, **Missouri State Highway Patrol** and the **University of Missouri** each assume the proposal would have no fiscal impact on their respective agencies.

Officials from the **Office of the Secretary of State (SOS)** state many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the SOS for Administrative Rules is less than \$2,500. The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, the SOS also recognizes that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what the office can sustain with the core budget. Therefore, the SOS reserves the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

Oversight assumes the SOS could absorb the costs of printing and distributing regulations related to this proposal. If multiple bills pass which require the printing and distribution of regulations at substantial costs, the SOS could request funding through the appropriation process. Any decisions to raise fees to defray costs would likely be made in subsequent fiscal years.

Officials from the **Department of Mental Health** states the Department does not perform rape evaluations, therefore has no fiscal impact.

Officials from the **Department of Public Safety** assume the proposal would have no fiscal impact on their agency. The testing is already included in the Department's SAFE exams.

Officials from the **Department of Health and Senior Services** assume the proposal requires health care personnel involved in the examination and treatment of victims of sexual offenses to inform the victims of their rights to request a drug test for the presence of specific drugs used to facilitate a rape or sexual assault. This may result in many victims choosing to be tested for those drugs who otherwise may not have been tested, resulting in additional costs to the SAFE program.

ASSUMPTION (continued)

On February 4, 2008, Executive Order 08-04 was signed to transfer the Sexual Assault, Forensic Examination Program from the Department of Health and Senior Services to the Department of Public Safety, effective August 28, 2008. Core funding for this program was transferred to the Department of Public Safety in the FY 2009 budget; therefore there would be no impact to the Department of Health and Senior Services.

Officials from the **Department of Social Services** state in FY08 the MO HealthNet Division (MHD) paid for 1,522 initial visits through the fee for service program for treatment associated with a primary diagnosis of sexual abuse. Approximately 43 of these individuals received a lab test that could have tested for date rape drugs. It is assumed that if health providers were required to inform rape victims that the drug test is available to them that additional victims will request and receive the test, though it is not known how many would request the test.

The fiscal impact for this legislation is a range based on the cost if no additional rape victims requested and were provided the test and if all rape victims requested and were provided the test. This figure also assumes that the number of rape victims remain the same.

1,522 initial visits - 43 lab tests already provided = 1,479 new lab tests
1,479 x \$19 (average cost lab test) = \$28,101 for 12 months

FY10 (10 months) - Unknown < \$23,418 (\$8,311 GR)
FY11 (12 months) - Unknown < \$29,366 (\$10,422 GR)
FY12 (12 months) - Unknown < \$30,687 (\$10,891 GR)

A 4.5% inflation factor was applied to costs for FY11 and FY12.

The proposed legislation may have an impact on hospitals and other public and private laboratories as a result of additional testing needed for the presence of specific drugs used to facilitate a rape or sexual assault.

FISCAL DESCRIPTION


Section 191.220:

The proposed legislation establishes Christy's Law which requires all health care personnel involved in the forensic examination and medical treatment of a victim of a sexual offense to inform the victim of his or her right to be tested for the presence of specific drugs used to facilitate a rape or sexual assault, including GHB, rohypnol, ketamine, and ecstasy. Any drug test results will be treated the same as other evidence collected and are to be included with all other evidence and test results gathered during the forensic examination.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
