FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of State Courts Administrator (CTS)** state the proposed legislation would require the courts to adopt a local rule to schedule nonpayment of rent cases within thirty days after the case is filed. In addition, it would require the court to provide centralized filing of such cases.

CTS states the meaning and intent of this proposal is somewhat unclear. Any significant increase will be reflected in future budget requests.
