FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of Administration - Administrative Hearing Commission** state this proposal will have no fiscal impact on their agency.

Officials from the **Department of Elementary and Secondary Education (DESE)** assume that allowing appeals by either the district or the parent to the state board of education would require staffing. The number of appeals would be based on the number and size of the districts that are declared unaccredited. DESE would require 1.0 FTE supervisor and 1.0 FTE administrative assistant to accommodate these requirements.

As to local district cost, DESE assumes unaccredited districts would likely see an increase in the number of students moving out of the district. Any cost would be to the unaccredited school districts who are, under current law, responsible for tuition payments for students transferring to an accredited school. DESE assumes there will be an increased tuition cost to unaccredited districts, but that amount would be unknown.

Oversight assumes legislation is already in place requiring unaccredited districts to pay for tuition and transportation costs for students choosing to transfer to an accredited school district. The proposed legislation requires DESE to establish specific criteria to carry out the provisions of the existing statute and permits an appeals process. If there are a sufficient number of appeals to warrant additional staffing by DESE, funding for additional personal services could be requested through the regular budgetary process.
