Bill Summary: The proposal requires members of the St. Louis City reserve police force to be retired officers of the city. The proposal also provides such reserve officers the same powers as regular officers regardless of whether they are assigned to active duty.

The proposed legislation appears to have no fiscal impact.


This legislation is not federally mandated, would not duplicate any other program, and would not require additional capital improvements or rental space.
