AN ACT

To appropriate money for supplemental purposes for the several departments and offices of state government, and for the purchase of equipment, and for the payment of various claims for refunds, for persons, firms, and corporations, and for other purposes, and to transfer money among certain funds, from the funds designated for the fiscal period ending June 30, 2009.

Be it enacted by the General Assembly of the state of Missouri, as follows:

20	This language does not create any entitlements not established by
21	statute. Upon receipt of a properly completed referral for MO
22	HealthNet funded home and community-based care containing a
23	nurse assessment or physician's order, the department shall review
24	the recommendations regarding services and process the referral
25	within fifteen (15) business days. When information contained in

the referral is sufficient to establish eligibility for MO HealthNet

27	funded long-term care and determine the level of service need as
28	required pursuant to state and federal regulations, the department
29	shall prior-authorize Home and Community-based services and
30	·
31	arrange for the provision of services and the in-home provider
32	shall be reimbursed for one authorized nurse visit to complete the nurse assessment. For authorized referrals, MO HealthNet
