AN ACT

To amend chapter 571, RSMo, by adding thereto one new section relating to conducted electrical devices.

Be it enacted by the General Assembly of the state of Missouri, as follows:

Section A. Chapter 571, RSMo, is amended by adding thereto one new section, to be
2 known as section 571.255, to read as follows:

571.255. 1. As used in this section, the following terms shall mean:

2 (1) "Conducted electrical device" or "CED", any tool or weapon which uses
3 conducted electricity with the express purpose of stunning or incapacitating the individual
4 at whom it is targeted;

5 (2) "Less lethal", a classification of force between non lethal and lethal. This
6 designation applies to uses of force which can only be used when lethal force is justified,
7 but which are considered preferable to lethal force if the situation warrants;

8 (3) "Use of force continuum", the array of options open to law enforcement when
9 responding to situations which require a physical response, when the physical response
10 options are ordered hierarchically so that increasing force is applied by law enforcement
11 agents only in proportion to the threat presented.

12 2. A "Task Force on the Use of Conducted Electrical Devices (CEDs)" is hereby
13 created within the office of administration.

14 3. The task force shall consist of ten members appointed by the governor, with the
15 advice and consent of the senate, including:

16 (1) Two acknowledged medical experts;

- 17 (2) Two acknowledged scientific experts;
18 (3) Two acknowledged legal experts;
19 (4) Two law enforcement experts; and
20 (5) Two private citizens who have been shot by a CED, or whose family member
21 was injured or killed in a CED incident.

22 4. Representation on the task force shall be balanced with the various viewpoints
23 on CED policy being equally represented. It shall be the responsibility of the governor to
24 ensure such requirement is met. The members of the task force shall serve without
25 compensation, but the members shall be reimbursed for necessary expenses incurred in the
26 performance of task force duties. The task force shall be appointed and staffed on or
27 before November 1, 2009. The task force shall elect a chair and secretary from among its
28 members.

29 5. The purpose of the task force shall be to evaluate the safety of CEDs and to make
30 recommendations regarding their use by law enforcement. The task force shall hold public
31 hearings throughout the state, calling before it witnesses to testify, and allowing other
32 interested citizens to comment on issues relevant to the use of CEDs in Missouri.

33 6. The task force shall study all aspects of CED use as administered in the state.
34 The study will include, but not be limited to the following:

35 (1) Gathering a representative sample of law enforcement policies regarding CED
36 use from around the nation;

37 (2) Gathering a fully representative sample of law enforcement policies regarding
38 CED use from across Missouri;

39 (3) Comparing how such policies classify CEDs on the use of force continuum, and
40 specifically reviewing the policies' restrictions and advisories on CED use, training of
41 personnel, requirements for reporting CED use, and requirements of data collection from
42 weapons which have been fired;

43 (4) Examining national and statewide reports on deaths and injuries, and making
44 a review of all scientific CED studies, including laboratory studies;

45 (5) Evaluating the information included in subdivision (4) of this subsection while
46 considering information reported by individuals actually involved in these situations, if
47 available;

48 (6) Gathering national and state data on incidents involving alleged abuse of CEDs.

49 7. The task force shall determine if there are adequate studies on the use and
50 effects of CEDs and if such studies represent independent perspectives. In particular, the
51 task force shall determine if there is a need for further research on certain issues, including
52 how frequently CEDs are used, the effects of CED use on human health, typical operation

53 of CEDs by law enforcement officers, possible circumstances when CED use should be
54 limited, sufficiency of law enforcement training on CED use, and any other issues of
55 interest or concern to the task force.

56 8. The task force shall report its findings and recommendations to the governor,
57 attorney general, and members of the general assembly by January 1, 2011.
