

HB 684 -- Assessed Valuation of Real Property

Sponsor: Gatschenberger

Beginning January 1, 2010, this bill limits the increase in the assessed valuation on residential real property to the percentage of increase in the federal Consumer Price Index in the previous year until the residence is sold or transferred.
