

HB 823 -- Insurance Underwriting

Sponsor: Skaggs

This bill prohibits an insurer from using credit reports or credit scoring as a factor in underwriting an insurance contract issued or renewed on or after August 28, 2009. The Director of the Department of Insurance, Financial Institutions and Professional Registration is authorized to order a civil penalty or forfeiture for a violation of the provisions of the bill.
