FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of Administration - Budget and Planning (BAP)** state this proposal would allow ten million dollars in tax credits annually in order to attract sporting events to Missouri which could therefore lower general and total state revenues by an unknown amount up to ten million dollars annually. This proposal may stimulate other economic activity, but BAP does not have data to estimate the induced revenues. The Department of Economic Development may have such an estimate.

Officials from the **Department of Economic Development (DED)** state the proposed legislation creates a tax credit program to attract sporting events to Missouri. DED is responsible for reviewing the application to determine eligibility, certifying the project, determining the geographic boundaries of the market area for the event and determining the amount of incremental increase in tax revenues directly attributable to the event. The cap is \$10m annual (per fiscal year) and is refundable based on the lesser of either 100% of the eligible costs incurred by the applicant of 90% of the incremental increase in tax revenues.

The creation of this tax credit would result in the need for one additional FTE to administer the program. The FTE would be an Economic Development Incentive Specialist III and would be responsible for reviewing the tax credit applications to make sure they meet the criteria of the program, certifying the project, determining the geographic boundaries of the market area for the event, drafting and sending the tax credit awards and ensuring compliance with the program. The related costs for this FTE include one-time expenditures for systems furniture, a side chair, file cabinet, calculator and telephone and recurring costs for office supplies, computer, professional development and travel. The cap for this new tax credit is \$10 million so there would be a negative impact to total state revenue. However, there would be an offset of unknown short-term positive economic benefits as a result of this increase so the exact amount of the impact cannot be determined.

Oversight assumes DED's estimate of expense and equipment cost for the new FTE could be overstated. If DED is able to use existing desks, file cabinets, chairs, etc., the estimate for equipment for fiscal year 2012 could be reduced by roughly \$6,000.

Officials from the **Department of Revenue (DOR)** state their response to a proposal similar to or identical to this one in a previous session indicated the department planned to absorb the administrative costs to implement the proposal. Due to budget constraints, reduction of staff and the limitations within the department's tax systems, changes cannot be made without significant impact to the department's resources and budget. Therefore, the IT portion of the fiscal impact is

estimated with a level of effort valued at \$22,260 (840 FTE hours to make programming changes to the individual income tax processing system (MINITS) and the corporate income tax processing system (COINS)).

Oversight assumes OA-ITSD (DOR) is provided with core funding to handle a certain amount of activity each year. Oversight assumes OA-ITSD (DOR) could absorb the costs related to this proposal. If multiple bills pass which require additional staffing and duties at substantial costs, OA-ITSD (DOR) could request funding through the appropriation process.

DOR also assumed the need for two additional FTE to administer the tax credits. Personal Tax would need one Revenue Processing Technician per 6,000 claims, and Corporate / Withholding would need one Revenue Processing Technician per 6,000 additional tax credit redemptions. The cost of these two FTE are anticipated to be roughly \$85,000 per year.

Oversight assumes this tax credit is limited in scope, and that the Department of Revenue will not incur the number of credit redemptions (count) that will require additional FTE.

In response to a previous version of this proposal, officials from the **Department of Insurance**, **Financial Institutions and Professional Registration (DIFP)** stated it is unknown how many insurance companies will choose to participate in this program and take advantage of the tax credits. Premium tax revenue is split 50/50 between General Revenue and County Foreign Insurance Fund except for domestic Stock Property and Casualty Companies who pay premium tax to the County Stock Fund. The County Foreign Insurance Fund is later distributed to school districts through out the state. County Stock Funds are later distributed to the school district and county treasurer of the county in which the principal office of the insurer is located. It is unknown how each of these funds may be impacted by tax credits each year.

DIFP also stated it will require minimal contract computer programming to add this new tax credit to the premium tax database and can do so under existing appropriation. However, should multiple bills pass that would require additional updates to the premium tax database, the department may need to request more expense and equipment appropriation through the budget process.

Officials from the **Office of the Secretary of State (SOS)** assume many bills considered by the General Assembly include provisions allowing or requiring agencies to submit rules and regulations to implement the act. The SOS is provided with core funding to handle a certain amount of normal activity resulting from each year's legislative session. The fiscal impact for this fiscal note to the Secretary of State's Office for Administrative Rules is less than \$2,500.

ASSUMPTION (continued)

The SOS recognizes that this is a small amount and does not expect that additional funding would be required to meet these costs. However, we also recognize that many such bills may be passed by the General Assembly in a given year and that collectively the costs may be in excess of what our office can sustain with our core budget. Therefore, we reserve the right to request funding for the cost of supporting administrative rules requirements should the need arise based on a review of the finally approved bills signed by the governor.

Oversight compared the total tax credit issuances relative to the total tax credit redemptions for the previous three years in order to determine a relationship between the two. Oversight discovered that the annual redemptions ranged from 85 percent to 106 percent of the annual issuances. Depending on the program, the redeemed credits may have been issued several years prior and carried forward to the years studied; however, Oversight will utilize an estimated redemption total of 95 percent of tax credits issued. Therefore, if \$10 million credits are issued, Oversight would assume \$9,500,000 credits would be redeemed.

Oversight will range the fiscal impact of the programs from \$0 (no additional tax credits will be issued) to the annual limit of \$10 million. Oversight assumes there would be some positive economic benefit to the state as a result of the changes in this proposal; however, Oversight considers these benefits to be indirect and therefore, have not reflected them in the fiscal note.

This proposal could reduce Total State Revenues.

FISCAL DESCRIPTION

This bill authorizes an income tax credit for the eligible costs, as specified in the bill, for bringing a major sporting event or game to Missouri. Within 60 days of the conclusion of the game, the department, in consultation with the Director of the Department of Revenue, must determine the amount of the incremental increase in tax revenues which are directly attributable or related to the game, eligible event, or related event. Within 60 days of receiving documentation from the applicant of the eligible costs, the Department of Economic Development will issue a refundable tax credit equal to 100% of the eligible costs incurred by the applicant or 90% of the tax revenues within the market area which are directly attributable to the game, or eligible event, whichever is less. The applicant must submit evidence of the eligible costs within 60 days of the game's conclusion.

No more than \$10 million of these tax credits can be issued by the department in any fiscal year, and the credit may be transferred or sold. Game support contracts cannot be certified by the department later than six years from the effective date of the bill; however, the department can certify contracts during this six-year period for games that will be held more than six years from the effective date.

This legislation is not federally mandated, would not duplicate any other program and would not require additional capital improvements or rental space.
