FISCAL ANALYSIS

ASSUMPTION

Officials from the Office of Administration (COA) - Division of Budget and Planning, Missouri Department of Transportation, Office of the Governor, and Missouri Senate assume the proposal will have no fiscal impact on their organizations.

Officials from the **COA** - **Division of Accounting** assume that if the Missouri Accountability Portal website is maintained at the current level, there will be no fiscal impact. If a major change would need to be implemented in the future, funding for salaries/consultants would need to be considered.

Officials from the **COA** - **Information Technology Services Division** state they will have to complete the Missouri Accountability Portal System requests, but believe the requests can be completed with existing resources and there will be no fiscal impact to their division.

Officials from the **Missouri House of Representatives (MHR)** assume that any expenses related to the Joint Committee would be paid from the Senate's Joint Contingent Expense appropriation. Therefore, the proposal will have no impact on the MHR.
