ASSUMPTION

Officials from the Office of State Courts Administrator, Office of Secretary of State and Cass County assume this proposal will have no impact on their respective agencies.

Officials from **Jackson County** state this proposal would cost the county \$250,000 due to transporting wards via sheriff's vehicles, increased manpower hours, and vehicle maintenance and fuel.
