FISCAL ANALYSIS

ASSUMPTION

Officials from the **Office of State Courts Administrator** assume the proposed legislation would have no fiscal impact on the courts.

Officials from the **Department of Public Safety – Missouri State Highway Patrol** assume the proposal would have no fiscal impact on their agency.

Officials from the **Boone County Sheriff's Department (BCSD)** assume there would be a minimal one-time cost associated with initial training of weekend warrant specialists to make such entries. During the week, BCSD already has ex parte service information entered within 24 hours.

Oversight assumes any impact to local governments would be minimal and could be absorbed with existing resources. Oversight will reflect no fiscal impact for this fiscal note.

Officials from the Buchanan County Sheriff's Department, Clark County Sheriff's Department, Jackson County Sheriff's Department, Platte County Sheriff's Department, and the St. Louis County Police Department did not respond to Oversight's request for fiscal impact.
