FISCAL ANALYSIS

ASSUMPTION

Officials at the **Office of the Secretary of State** assume that there is no fiscal impact from this proposal.

Officials at the **City of West Plains** assume a savings of \$5,00 per election not required. Each year one of the council positions is up for election. The next mayoral election is FY 2012.

Officials at the **City of Monett** assume the next election is in FY 2012. If that election does not have to be held due to the number of seats then the City will have a savings \$11,000.

Oversight assumes that the only cities effected by this legislation are the City of West Plains and the City of Monett.

No direct fiscal impact to small businesses would be expected as a result of this proposal.

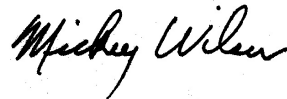
FISCAL DESCRIPTION
